- AN ACT to amend the executive law, in relation to equal pay disclosure with respect to state contracts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The executive law is amended by adding a new article 15-D 2 to read as follows: 3 ARTICLE 15-D 4 EQUAL PAY DISCLOSURE WITH RESPECT TO STATE CONTRACTS 5 SECTION 328-B. DEFINITIONS. б 328-C. EQUAL PAY DISCLOSURE; REPORTING. 7 328-D. PROHIBITIONS IN CONTRACTS; VIOLATIONS. 8 S 328-B. DEFINITIONS. AS USED IN THIS ARTICLE, THE FOLLOWING TERMS 9 SHALL HAVE THE FOLLOWING MEANINGS: 1. "EQUAL PAY REPORT" SHALL MEAN A SUMMARY OF DATA, IN A FORM CONSIST-10 WITH REGULATIONS PROMULGATED BY THE COMPTROLLER PURSUANT TO SECTION 11 ENT12 THREE HUNDRED TWENTY-EIGHT-C OF THIS ARTICLE, ON EMPLOYEE COMPENSATION 13 BY GENDER, RACE, ETHNICITY, SPECIFIED JOB CATEGORIES, AND OTHER RELEVANT 14 DATA. 15 "CONTRACTING AGENCY" SHALL MEAN A STATE AGENCY WHICH IS A PARTY OR 2. 16 A PROPOSED PARTY TO A STATE CONTRACT. 17 3. "CONTRACTOR" SHALL MEAN AN INDIVIDUAL, A BUSINESS ENTERPRISE, 18 INCLUDING A SOLE PROPRIETORSHIP, A PARTNERSHIP, A CORPORATION, A LIMITED 19 LIABILITY COMPANY, A NOT-FOR-PROFIT CORPORATION, OR ANY OTHER PARTY TO A 20 STATE CONTRACT, AS DEFINED IN SUBDIVISION EIGHT OF THIS SECTION OR A EXPLANATION--Matter in ITALICS (underscored) is new; matter in brackets [] is old law to be omitted.

FOR THE PURPOSES OF THIS ARTICLE, "CONTRAC-2 3 TOR" SHALL NOT INCLUDE A SMALL BUSINESS, AS DEFINED IN SUBDIVISION NINE 4 OF THIS SECTION. 5 4. "STATE CONTRACT" SHALL MEAN: 41 (A) A WRITTEN AGREEMENT OR PURCHASE ORDER INSTRUMENT, PROVIDING FOR A 42 43 TOTAL EXPENDITURE IN EXCESS OF FIFTY THOUSAND DOLLARS, WHICH IS SUBJECT 44 TO APPROVAL BY THE COMPTROLLER PURSUANT TO SECTION ONE HUNDRED TWELVE OF 45 THE STATE FINANCE LAW, WHEREBY: (I) A CONTRACTING AGENCY, EXCEPT THE OF GENERAL SERVICES IS COMMITTED TO EXPEND OR DOES EXPEND FUNDS 46 OFFICE 47 IN RETURN FOR LABOR, SERVICES INCLUDING, BUT NOT LIMITED TO, LEGAL, 48 FINANCIAL AND OTHER PROFESSIONAL SERVICES, SUPPLIES, EQUIPMENT, MATERI-49 ALS OR ANY COMBINATION OF THE FOREGOING, TO BE PERFORMED FOR, OR 50 RENDERED OR FURNISHED TO THE CONTRACTING AGENCY; (II) A CONTRACTING 51 AGENCY, EXCEPT THE OFFICE OF GENERAL SERVICES IS COMMITTED TO EXPEND OR EXPEND FUNDS FOR THE ACQUISITION, CONSTRUCTION, DEMOLITION, 52 DOES REPLACEMENT, MAJOR REPAIR OR RENOVATION OF REAL PROPERTY AND IMPROVE-53 54 MENTS THEREON; OR (III) THE OWNER OF A STATE ASSISTED HOUSING PROJECT IS 55 COMMITTED TO EXPEND OR DOES EXPEND FUNDS FOR THE ACQUISITION, 1 CONSTRUCTION, DEMOLITION, REPLACEMENT, MAJOR REPAIR OR RENOVATION OF 2 REAL PROPERTY AND IMPROVEMENTS THEREON FOR SUCH PROJECT.

3 A WRITTEN AGREEMENT OR PURCHASE ORDER INSTRUMENT, PROVIDING FOR A (B) 4 TOTAL EXPENDITURE IN EXCESS OF EIGHTY-FIVE THOUSAND DOLLARS, WHICH IS 5 SUBJECT TO APPROVAL BY THE COMPTROLLER PURSUANT TO SECTION ONE HUNDRED 6 TWELVE OF THE STATE FINANCE LAW, WHEREBY THE OFFICE OF GENERAL SERVICES 7 COMMITTED TO OR DOES EXPEND FUNDS IN RETURN FOR LABOR, SERVICES IS 8 INCLUDING, BUT NOT LIMITED TO, LEGAL, FINANCIAL AND OTHER PROFESSIONAL SERVICES, SUPPLIES, EQUIPMENT, MATERIALS OR ANY COMBINATION OF THE FORE-9 10 GOING, TO BE PERFORMED FOR, OR RENDERED OR FURNISHED TO THE OFFICE OF 11 GENERAL SERVICES.

12 9. "SMALL BUSINESS" AS USED IN THIS SECTION, SHALL MEAN A BUSINESS 13 INDEPENDENTLY OWNED AND OPERATED, NOT DOMINANT IN ITS FIELD, AND EMPLOY-14 ING NOT MORE THAN ONE HUNDRED INDIVIDUALS.

15 S 328-C. EQUAL PAY DISCLOSURE; REPORTING. 1. ALL CONTRACTORS, AS A 16 CONDITION UPON ENTERING INTO A CONTRACT WITH THE STATE, SHALL BE 17 REQUIRED TO SUBMIT EQUAL PAY REPORTS, IN SUCH FORM AS THE COMPTROLLER 18 MAY PRESCRIBE BY REGULATION PURSUANT TO SUBDIVISION THREE OF THIS 19 SECTION. SUCH REPORTS SHALL INCLUDE, BUT NOT BE LIMITED TO, A SUMMARY OF THE CONTRACTOR'S WORKFORCE PAY AVERAGES, CALCULATED BY JOB CATEGORY, 20 GENDER, RACE, AND ETHNICITY, AND THE DIFFERENCE BETWEEN PAY AVERAGES IN 21 22 EACH CATEGORY, EXPRESSED AS AN ABSOLUTE PERCENTAGE.

THE STATE COMPTROLLER SHALL SUBMIT A REPORT TO THE GOVERNOR, THE 23 2. ATTORNEY GENERAL, THE COMMISSIONER OF THE OFFICE OF GENERAL SERVICES, 24 25 COMMISSIONER OF THE DEPARTMENT OF LABOR, THE COMMISSIONER OF THE THE THE26 DIVISION OF HUMAN RIGHTS, THE SPEAKER OF THE ASSEMBLY, TEMPORARY 27 PRESIDENT OF THE SENATE AND THE LEGISLATIVE FISCAL COMMITTEES SUMMARIZ-28 ING DATA RELATED TO THE EQUAL PAY REPORTS SUBMITTED BY CONTRACTORS. SUCH 29 REPORT SHALL BE MADE ANNUALLY, ON A FISCAL YEAR BASIS BY THE FIRST OF JULY OF THE NEXT SUCCEEDING YEAR FOLLOWING ENACTMENT OF THIS SECTION. 30

(A) THE INFORMATION REQUIRED BY THIS SUBDIVISION SHALL BE PROVIDED IN
 ELECTRONIC FORMAT IN SUCH FORM AS PRESCRIBED BY THE STATE COMPTROLLER
 SUCH THAT THE DATA CAN BE SEARCHED AND SORTED.

(B) ALL REPORTS REQUIRED UNDER THIS SUBDIVISION SHALL BE AVAILABLE FOR
PUBLIC INSPECTION AND COPYING PURSUANT TO SECTION EIGHTY-SEVEN OF THE
PUBLIC OFFICERS LAW PROVIDED THAT IN DISCLOSING SUCH REPORTS PURSUANT TO
THE PUBLIC OFFICERS LAW, THE STATE COMPTROLLER SHALL REDACT THE NAME AND
SOCIAL SECURITY NUMBER OF ANY INDIVIDUAL EMPLOYEE THAT IS INCLUDED IN
SUCH DOCUMENT.

40 3. THE STATE COMPTROLLER, IN CONSULTATION WITH THE COMMISSIONER OF THE 41 OFFICE OF GENERAL SERVICES, SHALL PROMULGATE REGULATIONS:

42 (A) REGARDING THE CONTENT AND THE TIMELY AND PROPER FILING OF EQUAL 43 PAY REPORTS BY CONTRACTORS; AND

44 (B) SETTING FORTH MEASURES AND PROCEDURES TO REQUIRE ALL CONTRACTING 45 AGENCIES, WHERE PRACTICABLE, FEASIBLE AND APPROPRIATE, TO ASSESS THE EOUAL PAY PRACTICES OF CONTRACTORS SUBMITTING BIDS OR PROPOSALS 46 IΝ 47 CONNECTION WITH THE AWARD OF A STATE CONTRACT. SUCH RULES AND REGU-LATIONS SHALL TAKE INTO ACCOUNT: THE NATURE OF THE LABOR, SERVICES, 48 49 SUPPLIES, EQUIPMENT OR MATERIALS BEING PROCURED BY THE STATE AGENCY; THE 50 METHOD OF PROCUREMENT REQUIRED TO BE USED BY A STATE AGENCY TO AWARD THE 51 CONTRACT; THE EOUAL PAY REPORTS REQUIRED TO BE SUBMITTED PURSUANT TO SUBDIVISION ONE OF THIS SECTION; AND SUCH OTHER FACTORS AS THE COMP-52 TROLLER DEEMS APPROPRIATE OR NECESSARY TO PROMOTE THE AWARD OF STATE 53 CONTRACTS TO CONTRACTORS HAVING SOUND EQUAL PAY PRACTICES. SUCH ASSESS-54 55 SHALL NOT PERMIT THE AUTOMATIC REJECTION OF A BID OR PROCUREMENT MENT 56 PROPOSAL BASED ON THE LACK OF ADHERENCE TO EQUAL PAY PRACTICES. EACH BID 1 OR PROPOSAL SHALL BE ANALYZED ON AN INDIVIDUAL PER BID OR PER PROPOSAL 2 BASIS WITH THE CONTRACTOR'S EQUAL PAY PRACTICES CONSIDERED AS ONLY A 3 PART OF A WIDER CONSIDERATION OF SEVERAL FACTORS WHEN DECIDING TO AWARD 4 OR DECLINE TO AWARD A BID OR PROPOSAL.

5 S 328-D. PROHIBITIONS IN CONTRACTS; VIOLATIONS. EVERY CONTRACTING 6 AGENCY SHALL INCLUDE A PROVISION IN ITS STATE CONTRACTS EXPRESSLY 7 PROVIDING THAT ANY CONTRACTOR WHO WILLFULLY AND INTENTIONALLY FAILS TO 8 COMPLY WITH THE REQUIREMENTS OF THIS ARTICLE AS SET FORTH IN SUCH STATE 9 CONTRACT SHALL BE LIABLE TO THE CONTRACTING AGENCY FOR LIQUIDATED OR 10 OTHER APPROPRIATE DAMAGES AND SHALL PROVIDE FOR OTHER APPROPRIATE REME-11 DIES ON ACCOUNT OF SUCH BREACH.

12 S 2. This act shall take effect on the first of January next succeed-13 ing the date upon which it shall have become a law and shall apply to 14 all contracts with the state entered into on or after such effective 15 date.
