AN ACT to amend the real property tax law and the tax law, in relation to transitioning the school tax relief (STAR) exemption into a personal income tax credit, and to repeal subdivision 5 of section 520 of the real property tax law relating thereto (Part A); to amend the real property tax law, in relation to the maximum amount of tax savings allowable under the STAR program (Part B); to amend the real property tax law in relation to making the income verification program mandatory (Part C); to amend the real property tax law, in relation to allowing applications for exemptions to be filed after the taxable status date in certain cases (Part D); to amend the tax law and the administrative code of the city of New York, in relation to establishing a new school tax reduction credit for residents of a city with a population over one million (Part E); to amend the real property tax law, in relation to authorizing the commissioner of taxation and finance to make direct payments of STAR tax savings to property owners in certain cases (Part F); to amend the tax law, in relation to making permanent, provisions relating to mandatory electronic filing of tax documents, improving sales tax compliance and updating tax preparer penalties; to amend chapter 61 of the laws of 2011, amending the real property tax law and other laws relating to establishing standards for electronic tax administration, in relation to the effectiveness thereof; and to repeal certain provisions of the tax law and the administrative code of the city of New York relating thereto (Part G); to amend the public housing law, in relation to extending the credit against income tax for persons or entities investing in low-income housing (Part H); to amend the tax law, in relation to extending the hire a veteran credit for an additional two years (Part I); to amend the tax law, in relation to extending the empire state commercial production tax credit (Part J); to amend chapter 604 of the laws of 2011, amending the tax law relating to the credit for companies who

provide transportation to people with disabilities, in relation to extending the expiration of such provision (Part K); to amend part I of chapter 58 of the laws of 2006, amending the tax law relating to providing an enhanced earned income tax credit, in relation to making the enhanced earned income tax credit permanent (Part L); to amend part N of chapter 61 of the laws of 2005 amending the tax law relating to certain transactions and related information and relating to the voluntary compliance initiative, in relation to permanently extending the disclosure and penalty provisions for transactions that present the potential for tax avoidance (Part M); to amend the tax law, in relation to extending the clean heating fuel credit for three years and updating the credit to reflect new minimum biodiesel fuel thresholds (Part N); to amend the economic development law and the tax law, in relation to extending the excelsior jobs program for five years (Part O); to amend the tax law and the administrative code of the City of New York in relation to making corrections to the corporate tax reform provisions (Part P); to amend the tax law and the administrative code of the city of New York, in relation to the time for filing reports (Part Q); to amend the tax law, in relation to the business income base rate and expanding the small business subtraction modification (Part R); to amend the education law and the tax law, in relation to enacting the "parental choice in education act" (Part S); to amend the tax law, in relation to establishing a tax credit for New York state thruway tolls (Part T); to amend chapter 109 of the laws of 2006 amending the tax law and other laws relating to providing exemptions, reimbursements and credits from various taxes for certain alternative fuels, in relation to extending the alternative fuels tax exemptions for five years (Part U); to amend the tax law, in relation to exempting from alcoholic beverage tax certain alcoholic beverages furnished at no charge by certain licensees to customers or prospective customers at a tasting held in accordance with the alcoholic beverage control law, and to expand the beer production credit to include wine, liquor and cider (Part V); to amend the tax law, in relation to authorizing jeopardy assessments on cigarette and tobacco product taxes assessed under article 20 thereof (Part W); to amend the tax law and the administrative code of the city of New York, in relation to allowing room remarketers to purchase occupancies from hotel operators exempt from sales tax under certain circumstances (Part X); to amend the tax law, in relation to charitable contributions and charitable activities being considered in determining domicile for estate tax purposes (Part Y); to amend the state finance law, in relation to creating the aviation purpose account and ensuring that the funds deposited in the aviation purpose account are used for airport improvement projects; to amend the tax law, in relation to provide for the distribution of revenues under section 301-e of such law; to exempt sales of fuel sold for use in commercial aircraft and general aviation aircraft from the prepayment of sales tax imposed pursuant to the authority of section 1102(a) (1) (ii) of such law; and to exclude sales of fuel sold for use in commercial aircraft and general aviation aircraft from the operation of sales and use taxes imposed pursuant to the authority of section 1210(a) of such law (Part Z); to amend the racing, pari-mutuel wagering and breeding law, in relation to equine lab testing provider restrictions removal (Part AA); to amend the racing, pari-mutuel wagering and breeding law and the tax law, in relation to reducing purse amounts paid from the VLT program and to increasing racing regulatory fee (Part BB); to amend

the racing, pari-mutuel wagering and breeding law, in relation to the timing of harness track reimbursements and other technical amendments (Part CC); to amend the tax law, in relation to the payment of vendors' fees (Part DD); to amend the tax law, in relation to vendor fees at vendor tracks (Part EE); to amend the racing, pari-mutuel wagering and breeding law, in relation to licenses for simulcast facilities, sums relating to track simulcast, simulcast of out-of-state thoroughbred races, simulcasting of races run by out-of-state harness tracks and distributions of wagers; to amend chapter 281 of the laws of 1994 amending the racing, pari-mutuel wagering and breeding law and other laws relating to simulcasting; to amend chapter 346 of the laws of 1990 amending the racing, pari-mutuel wagering and breeding law and other laws relating to simulcasting and the imposition of certain taxes, in relation to extending certain provision thereof; and to amend the racing, pari-mutuel and breeding law, in relation to extending certain provisions thereof (Part FF); to amend the tax law, in relation to capital awards to vendor tracks (Part GG); and to amend the state finance law, in relation to allocations from the commercial gaming revenue fund; and to amend the tax law, in relation to commissions payable to certain vendor racetracks (Part HH)

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act enacts into law major components of legislation
2 which are necessary to implement the state fiscal plan for the 2016-2017
3 state fiscal year. Each component is wholly contained within a Part
4 identified as Parts A through HH. The effective date for each particular
5 provision contained within such Part is set forth in the last section of
6 such Part. Any provision in any section contained within a Part, includ-
7 ing the effective date of the Part, which makes a reference to a section
8 "of this act", when used in connection with that particular component,
9 shall be deemed to mean and refer to the corresponding section of the
10 Part in which it is found. Section three of this act sets forth the
11 general effective date of this act.

PART A

13 Section 1. Paragraph (a) of subdivision 6 of section 425 of the real
14 property tax law, as amended by chapter 6 of the laws of 2010, and as
15 further amended by subdivision (b) of section 1 of part W of chapter 56
16 of the laws of 2010, is amended to read as follows:

17 (a) Generally. All owners of the property who primarily reside thereon
18 AND WHO ARE NOT SUBJECT TO THE PROVISIONS OF SUBDIVISION SIXTEEN OF THIS
19 SECTION must jointly file an application for exemption with the assessor
20 on or before the appropriate taxable status date. Such application may
21 be filed by mail if it is enclosed in a postpaid envelope properly
22 addressed to the appropriate assessor, deposited in a post office or
23 official depository under the exclusive care of the United States postal
24 service, and postmarked by the United States postal service on or before
25 the applicable taxable status date. Each such application shall be made
26 on a form prescribed by the commissioner, which shall require the appli-
27 cant or applicants to agree to notify the assessor if their primary
28 residence changes while their property is receiving the exemption. The
29 assessor may request that proof of residency be submitted with the

1 application. If the applicant requests a receipt from the assessor as
2 proof of submission of the application, the assessor shall provide such
3 receipt. If such request is made by other than personal request, the
4 applicant shall provide the assessor with a self-addressed postpaid
5 envelope in which to mail the receipt.

6 S 2. Section 425 of the real property tax law is amended by adding a
7 new subdivision 16 to read as follows:

8 16. TRANSITION TO PERSONAL INCOME TAX CREDIT. (A) BEGINNING WITH
9 ASSESSMENT ROLLS USED TO LEVY SCHOOL DISTRICT TAXES FOR THE TWO THOUSAND
10 SIXTEEN--TWO THOUSAND SEVENTEEN SCHOOL YEAR, NO APPLICATION FOR AN
11 EXEMPTION UNDER THIS SECTION MAY BE FILED OR APPROVED UNLESS AT LEAST
12 ONE OF THE APPLICANTS HELD TITLE TO THE PROPERTY ON THE TAXABLE STATUS
13 DATE OF THE ASSESSMENT ROLL THAT WAS USED TO LEVY SCHOOL DISTRICT TAXES
14 FOR THE TWO THOUSAND FIFTEEN--TWO THOUSAND SIXTEEN SCHOOL YEAR AND THE
15 PROPERTY WAS GRANTED AN EXEMPTION PURSUANT TO THIS SECTION ON THAT
16 ASSESSMENT ROLL. IN THE EVENT THAT AN APPLICATION IS SUBMITTED TO THE
17 ASSESSOR THAT CANNOT BE APPROVED DUE TO THIS RESTRICTION, THE ASSESSOR
18 SHALL NOTIFY THE APPLICANT THAT HE OR SHE IS REQUIRED BY LAW TO DENY THE
19 APPLICATION, BUT THAT, IN LIEU OF A STAR EXEMPTION, THE APPLICANT MAY
20 CLAIM THE PERSONAL INCOME TAX CREDIT AUTHORIZED BY SUBSECTION (EEE) OF
21 SECTION SIX HUNDRED SIX OF THE TAX LAW IF ELIGIBLE, AND THAT THE APPLI-
22 CANT MAY CONTACT THE DEPARTMENT OF TAXATION AND FINANCE FOR FURTHER
23 INFORMATION. THE COMMISSIONER SHALL PROVIDE A FORM FOR ASSESSORS TO
24 USE, AT THEIR OPTION, WHEN MAKING THIS NOTIFICATION. NO STAR EXEMPTION
25 MAY BE GRANTED ON THE BASIS OF AN APPLICATION THAT IS NOT APPROVABLE DUE
26 TO THIS RESTRICTION.

27 (B) IF THE OWNERS OF A PARCEL THAT IS RECEIVING THE STAR EXEMPTION
28 AUTHORIZED BY THIS SECTION WANT TO CLAIM THE PERSONAL INCOME TAX CREDIT
29 AUTHORIZED BY SUBSECTION (EEE) OF SECTION SIX HUNDRED SIX OF THE TAX LAW
30 IN LIEU OF SUCH EXEMPTION, THEY ALL MUST RENOUNCE THAT EXEMPTION IN THE
31 MANNER PROVIDED BY SECTION FOUR HUNDRED NINETY-SIX OF THIS CHAPTER, AND
32 MUST PAY ANY REQUIRED TAXES, INTEREST AND PENALTIES, ON OR BEFORE DECEM-
33 BER THIRTY-FIRST OF THE TAXABLE YEAR FOR WHICH THEY WANT TO CLAIM THE
34 CREDIT. ANY SUCH RENUNCIATION SHALL BE IRREVOCABLE.

35 (C) THE PROVISIONS OF THIS SUBDIVISION SHALL APPLY TO ALL APPLICATIONS
36 FOR STAR EXEMPTIONS BEGINNING WITH ASSESSMENT ROLLS USED TO LEVY SCHOOL
37 DISTRICT TAXES FOR THE TWO THOUSAND SIXTEEN--TWO THOUSAND SEVENTEEN
38 SCHOOL YEAR, INCLUDING THOSE SUBMITTED PRIOR TO THE EFFECTIVE DATE OF
39 THIS SUBDIVISION. IF ANY APPLICATION WAS APPROVED PRIOR TO THE EFFECTIVE
40 DATE OF THIS SUBDIVISION THAT IS NOT APPROVABLE HEREUNDER, SUCH APPROVAL
41 SHALL BE DEEMED VOID, AND THE ASSESSOR SHALL PROVIDE THE APPLICANT WITH
42 THE NOTICE REQUIRED BY PARAGRAPH (A) OF THIS SUBDIVISION.

43 S 3. Subdivision 2 of section 496 of the real property tax law, as
44 added by section 3 of part N of chapter 58 of the laws of 2011, is
45 amended to read as follows:

46 2. An application to renounce an exemption shall be made on a form
47 prescribed by the commissioner and shall be filed with the county direc-
48 tor of real property tax services no later than ten years after the levy
49 of taxes upon the assessment roll on which the renounced exemption
50 appears. The county director, after consulting with the assessor as
51 appropriate, shall compute the total amount owed on account of the
52 renounced exemption as follows:

53 (a) For each assessment roll on which the renounced exemption appears,
54 the assessed value that was exempted shall be multiplied by the tax rate
55 or rates that were applied to that assessment roll. Interest shall then
56 be added to each such product at the rate prescribed by section nine

1 hundred twenty-four-a of this chapter or such other law as may be appli-
2 cable for each month or portion thereon since the levy of taxes upon
3 such assessment roll.

4 (b) The sum of the calculations made pursuant to paragraph (a) of this
5 subdivision with respect to all of the assessment rolls in question
6 shall be determined.

7 (c) A processing fee of five hundred dollars shall be added to the sum
8 determined pursuant to paragraph (b) of this subdivision, UNLESS THE
9 PROVISIONS OF PARAGRAPH (D) OF THIS SUBDIVISION ARE APPLICABLE.

10 (D) IF THE APPLICANT IS RENOUNCING A STAR EXEMPTION IN ORDER TO QUALI-
11 FY FOR THE PERSONAL INCOME TAX CREDIT AUTHORIZED BY SUBSECTION (EEE) OF
12 SECTION SIX HUNDRED SIX OF THE TAX LAW, AND NO OTHER EXEMPTIONS ARE
13 BEING RENOUNCED ON THE SAME APPLICATION, NO PROCESSING FEE SHALL BE
14 APPLICABLE.

15 S 4. Subdivision 3 of section 520 of the real property tax law, as
16 added by chapter 635 of the laws of 1978, is amended to read as follows:

17 3. For purposes of any fiscal year or years during which title to such
18 property is transferred, such property shall be deemed to have been
19 omitted and the assessed value thereof shall be entered on the assess-
20 ment roll to be used for the next tax levy by or for each municipal
21 corporation in which such property is located in the same manner as
22 provided by title three of article five of this chapter with respect to
23 a parcel omitted from the assessment roll of the previous year. A pro
24 rata tax shall be extended against the property for the unexpired
25 portion of each fiscal year. Such real property shall be taxed at the
26 tax rate or tax rates for the fiscal year during which the transfer
27 occurred. The amount of tax or taxes levied pursuant to this subdivi-
28 sion shall be deducted from the aggregate amount of taxes to be levied
29 for the fiscal year immediately succeeding the fiscal year during which
30 the transfer occurred; PROVIDED, HOWEVER, THAT WHERE THE PROPERTY IS
31 RECEIVING A SCHOOL TAX RELIEF (STAR) EXEMPTION AUTHORIZED BY SECTION
32 FOUR HUNDRED TWENTY-FIVE OF THIS CHAPTER, THE PORTION OF THE TAX OR
33 TAXES LEVIED THAT EQUALS THE RECOVERED STAR TAX SAVINGS SHALL BE APPLIED
34 TO REDUCE THE AMOUNT OF AID PAYABLE TO THE SCHOOL DISTRICT UNDER SUBDI-
35 VISION THREE OF SECTION THIRTEEN HUNDRED SIX-A OF THIS CHAPTER.

36 S 5. Subdivision 5 of section 520 of the real property tax law is
37 REPEALED.

38 S 6. Section 606 of the tax law is amended by adding a new subsection
39 (eee) to read as follows:

40 (EEE) SCHOOL TAX RELIEF (STAR) CREDIT. (1) DEFINITIONS. FOR PURPOSES
41 OF THIS SUBSECTION:

42 (A) "QUALIFIED TAXPAYER" MEANS A RESIDENT INDIVIDUAL OF THE STATE, WHO
43 MAINTAINED HIS OR HER PRIMARY RESIDENCE IN THIS STATE ON DECEMBER THIR-
44 TY-FIRST OF THE TAXABLE YEAR, WHO WAS AN OWNER OF THAT PROPERTY ON THAT
45 DATE, WHO CANNOT RECEIVE THE STAR EXEMPTION ON THAT PROPERTY EITHER
46 BECAUSE (I) HE OR SHE IS PRECLUDED FROM FILING AN APPLICATION FOR THE
47 STAR EXEMPTION ON THAT PROPERTY PURSUANT TO PARAGRAPH (A) OF SUBDIVISION
48 SIXTEEN OF SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL PROPERTY TAX
49 LAW, OR BECAUSE (II) HE OR SHE HAS IRREVOCABLY RENOUNCED HIS OR HER
50 CLAIM TO SUCH EXEMPTION IN CONJUNCTION WITH ALL OTHER OWNERS PURSUANT TO
51 PARAGRAPH (B) OF SUCH SUBDIVISION, AND WHO IS REQUIRED OR CHOOSES TO
52 FILE A RETURN UNDER THIS ARTICLE.

53 (B) "AFFILIATED INCOME" SHALL MEAN THE COMBINED INCOME OF ALL OF THE
54 OWNERS OF THE PARCEL WHO RESIDED PRIMARILY THEREON AS OF DECEMBER THIR-
55 TY-FIRST OF THE TAXABLE YEAR, AND OF ANY OWNERS' SPOUSES RESIDING PRIMA-
56 RILY THEREON AS OF SUCH DATE; PROVIDED THAT THE INCOME TO BE SO COMBINED

1 SHALL BE THE "ADJUSTED GROSS INCOME" FOR THE TAXABLE YEAR AS REPORTED
2 FOR FEDERAL INCOME TAX PURPOSES, OR THAT WOULD BE REPORTED AS ADJUSTED
3 GROSS INCOME IF A FEDERAL INCOME TAX RETURN WERE REQUIRED TO BE FILED,
4 REDUCED BY DISTRIBUTIONS, TO THE EXTENT INCLUDED IN FEDERAL ADJUSTED
5 GROSS INCOME, RECEIVED FROM AN INDIVIDUAL RETIREMENT ACCOUNT AND AN
6 INDIVIDUAL RETIREMENT ANNUITY.

7 (C) "ASSOCIATED FISCAL YEAR" MEANS THE SCHOOL DISTRICT FISCAL YEAR
8 THAT BEGAN ON JULY FIRST OF THE TAXABLE YEAR OR, IN THE CASE OF A CITY
9 SCHOOL DISTRICT THAT IS SUBJECT TO ARTICLE FIFTY-TWO OF THE EDUCATION
10 LAW, THE CITY FISCAL YEAR THAT BEGAN ON JULY FIRST OF THE TAXABLE YEAR.

11 (D) "OWNER" MEANS:

12 (I) A PERSON WHO OWNS A PARCEL IN FEE SIMPLE ABSOLUTE OR AS A TENANT
13 IN COMMON, A JOINT TENANT OR A TENANT BY THE ENTIRETY,

14 (II) AN OWNER OF A PRESENT INTEREST IN A PARCEL UNDER A LIFE ESTATE,

15 (III) A VENDEE IN POSSESSION UNDER AN INSTALLMENT CONTRACT OF SALE,

16 (IV) A BENEFICIAL OWNER UNDER A TRUST,

17 (V) A TENANT-STOCKHOLDER OF A COOPERATIVE APARTMENT CORPORATION WHO
18 RESIDES IN A PORTION OF REAL PROPERTY OWNED BY SUCH COOPERATIVE APART-
19 MENT CORPORATION, TO THE EXTENT REPRESENTED BY HIS OR HER SHARE OR
20 SHARES OF STOCK IN SUCH CORPORATION AS DETERMINED BY ITS OR THEIR
21 PROPORTIONAL RELATIONSHIP TO THE TOTAL OUTSTANDING STOCK OF THE CORPO-
22 RATION, INCLUDING THAT OWNED BY THE CORPORATION,

23 (VI) A RESIDENT OF A FARM DWELLING THAT IS OWNED EITHER BY A CORPO-
24 RATION OF WHICH THE RESIDENT IS A SHAREHOLDER, A PARTNERSHIP OF WHICH
25 THE RESIDENT IS A PARTNER, OR BY A LIMITED LIABILITY COMPANY OF WHICH
26 THE RESIDENT IS AN OWNER, OR

27 (VII) A RESIDENT OF A DWELLING, OTHER THAN A FARM DWELLING, THAT IS
28 OWNED BY A LIMITED PARTNERSHIP OF WHICH THE RESIDENT IS A PARTNER,
29 PROVIDED THAT THE LIMITED PARTNERSHIP THAT HOLDS TITLE TO THE PROPERTY
30 DOES NOT ENGAGE IN ANY COMMERCIAL ACTIVITY, THAT THE LIMITED PARTNERSHIP
31 WAS LAWFULLY CREATED TO HOLD TITLE SOLELY FOR ESTATE PLANNING AND ASSET
32 PROTECTION PURPOSES, AND THAT THE PARTNER OR PARTNERS WHO PRIMARILY
33 RESIDE THEREON PERSONALLY PAY ALL OF THE REAL PROPERTY TAXES AND OTHER
34 COSTS ASSOCIATED WITH THE PROPERTY'S OWNERSHIP.

35 (E) "QUALIFYING TAXES" MEANS THE SCHOOL DISTRICT TAXES THAT WERE
36 LEVIED UPON THE TAXPAYER'S PRIMARY RESIDENCE FOR THE ASSOCIATED FISCAL
37 YEAR THAT WERE ACTUALLY PAID BY THE TAXPAYER DURING THE TAXABLE YEAR;
38 OR, IN THE CASE OF A CITY SCHOOL DISTRICT THAT IS SUBJECT TO ARTICLE
39 FIFTY-TWO OF THE EDUCATION LAW, THE COMBINED CITY AND SCHOOL DISTRICT
40 TAXES THAT WERE LEVIED UPON THE TAXPAYER'S PRIMARY RESIDENCE FOR THE
41 ASSOCIATED FISCAL YEAR THAT WERE ACTUALLY PAID BY THE TAXPAYER DURING
42 THE TAXABLE YEAR. IN NO CASE SHALL THE TERM "QUALIFYING TAXES" BE
43 CONSTRUED TO INCLUDE PENALTIES OR INTEREST.

44 (F) "STAR EXEMPTION" MEANS THE SCHOOL TAX RELIEF (STAR) EXEMPTION
45 AUTHORIZED BY SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL PROPERTY TAX
46 LAW.

47 (G) "STAR TAX SAVINGS" MEANS THE TAX SAVING ATTRIBUTABLE TO THE STAR
48 EXEMPTION WITHIN A PORTION OF A SCHOOL DISTRICT, AS DETERMINED BY THE
49 COMMISSIONER PURSUANT TO SUBDIVISION TWO OF SECTION THIRTEEN HUNDRED
50 SIX-A OF THE REAL PROPERTY TAX LAW.

51 (H) "STAR TAX SAVINGS FIGURE" MEANS THE AVERAGE OF THE STAR TAX
52 SAVINGS IN THE VARIOUS PORTIONS OF A SCHOOL DISTRICT IN THE ASSOCIATED
53 FISCAL YEAR, AS DETERMINED BY THE COMMISSIONER. TWO STAR TAX SAVINGS
54 FIGURES SHALL BE DETERMINED FOR EACH SCHOOL DISTRICT, ONE RELATING TO
55 THE BASIC STAR EXEMPTION, AND THE OTHER RELATING TO THE ENHANCED STAR
56 EXEMPTION.

1 (2) ALLOWANCE OF CREDIT. A QUALIFIED TAXPAYER SHALL BE ALLOWED A CRED-
2 IT AS PROVIDED IN PARAGRAPH THREE OR FOUR OF THIS SUBSECTION, WHICHEVER
3 IS APPLICABLE, AGAINST THE TAXES IMPOSED BY THIS ARTICLE REDUCED BY THE
4 CREDITS PERMITTED BY THIS ARTICLE, PROVIDED THAT THE REQUIREMENTS SET
5 FORTH IN THE APPLICABLE SUBSECTION ARE SATISFIED. IF THE CREDIT EXCEEDS
6 THE TAX AS SO REDUCED FOR SUCH YEAR UNDER THIS ARTICLE, THE EXCESS SHALL
7 BE TREATED AS AN OVERPAYMENT, TO BE CREDITED OR REFUNDED, WITHOUT INTER-

9 TO SECTION SIX HUNDRED FIFTY-ONE OF THIS ARTICLE, A QUALIFIED TAXPAYER
10 MAY NEVERTHELESS RECEIVE THE FULL AMOUNT OF THE CREDIT TO BE CREDITED OR
11 REPAID AS AN OVERPAYMENT, WITHOUT INTEREST.

12 (3) DETERMINATION OF BASIC STAR CREDIT. (A) BEGINNING WITH TAXABLE
13 YEARS AFTER TWO THOUSAND FIFTEEN, A BASIC STAR CREDIT SHALL BE AVAILABLE
14 TO A QUALIFIED TAXPAYER IF THE AFFILIATED INCOME OF THE PARCEL THAT
15 SERVES AS THE TAXPAYER'S PRIMARY RESIDENCE IS LESS THAN OR EQUAL TO FIVE
16 HUNDRED THOUSAND DOLLARS.

17 (B) SUBJECT TO THE PROVISIONS OF SUBPARAGRAPH (C) OF THIS PARAGRAPH,
18 SUCH BASIC STAR CREDIT SHALL BE THE LESSER OF:

19 (I) THE BASIC STAR TAX SAVINGS FIGURE FOR THE SCHOOL DISTRICT, OR

20 (II) THE TAXPAYER'S QUALIFYING TAXES.

21 (C) IF THE QUALIFYING TAXES PAID BY THE TAXPAYER CONSTITUTED ONLY A
22 PORTION OF THE TOTAL SCHOOL DISTRICT TAXES THAT WERE LEVIED UPON THE
23 TAXPAYER'S PRIMARY RESIDENCE FOR THE ASSOCIATED FISCAL YEAR OR, IN THE
24 CASE OF A CITY SCHOOL DISTRICT THAT IS SUBJECT TO ARTICLE FIFTY-TWO OF
25 THE EDUCATION LAW, IF THE QUALIFYING TAXES PAID BY THE TAXPAYER CONSTI-
26 TUTED ONLY A PORTION OF THE TOTAL COMBINED CITY AND SCHOOL DISTRICT
27 TAXES THAT WERE LEVIED UPON THE TAXPAYER'S PRIMARY RESIDENCE FOR THE
28 ASSOCIATED FISCAL YEAR, THE CREDIT ALLOWABLE TO SUCH TAXPAYER SHALL BE
29 EQUAL TO THE AMOUNT DETERMINED PURSUANT TO SUBPARAGRAPH (B) OF THIS
30 PARAGRAPH MULTIPLIED BY THE PERCENTAGE THAT SUCH PORTION REPRESENTS.

31 (4) DETERMINATION OF ENHANCED STAR CREDIT. (A) BEGINNING WITH TAXABLE
32 YEARS AFTER TWO THOUSAND FIFTEEN, AN ENHANCED STAR CREDIT SHALL BE
33 AVAILABLE TO A QUALIFIED TAXPAYER WHERE BOTH OF THE FOLLOWING CONDITIONS
34 ARE SATISFIED:

35 (I) ALL OF THE OWNERS OF THE PARCEL THAT SERVES AS THE TAXPAYER'S
36 PRIMARY RESIDENCE ARE AT LEAST SIXTY-FIVE YEARS OF AGE AS OF DECEMBER
37 THIRTY-FIRST OF THE TAXABLE YEAR OR, IN THE CASE OF PROPERTY OWNED BY A
38 MARRIED COUPLE OR BY SIBLINGS, AT LEAST ONE OF THE OWNERS IS AT LEAST
39 SIXTY-FIVE YEARS OF AGE AS OF THAT DATE. THE TERMS "SIBLINGS" AS USED
40 HEREIN SHALL HAVE THE SAME MEANING AS SET FORTH IN SECTION FOUR HUNDRED
41 SIXTY-SEVEN OF THE REAL PROPERTY TAX LAW. IN THE CASE OF PROPERTY OWNED
42 BY A MARRIED COUPLE, ONE OF WHOM IS SIXTY-FIVE YEARS OF AGE OR OVER, THE
43 CREDIT, ONCE ALLOWED, SHALL NOT BE DISALLOWED BECAUSE OF THE DEATH OF
44 THE OLDER SPOUSE SO LONG AS THE SURVIVING SPOUSE IS AT LEAST SIXTY-TWO
45 YEARS OF AGE AS OF DECEMBER THIRTY-FIRST OF THE TAXABLE YEAR.

46 (II) THE AFFILIATED INCOME OF THE PARCEL THAT SERVES AS THE TAXPAYER'S
47 PRIMARY RESIDENCE IS LESS THAN OR EQUAL TO THE INCOME STANDARD FOR THE
48 TAXABLE YEAR ESTABLISHED BY THE COMMISSIONER FOR THE CORRESPONDING
49 "INCOME TAX YEAR" PURSUANT TO CLAUSE (C) OF SUBPARAGRAPH (I) OF PARA-
50 GRAPH (B) OF SUBDIVISION FOUR OF SECTION FOUR HUNDRED TWENTY-FIVE OF THE
51 REAL PROPERTY TAX LAW FOR PURPOSES OF THE ENHANCED STAR EXEMPTION.

52 (B) SUBJECT TO THE PROVISIONS OF SUBPARAGRAPH (C) OF THIS PARAGRAPH,
53 SUCH CREDIT SHALL BE THE LESSER OF:

54 (I) THE ENHANCED STAR TAX SAVINGS FIGURE FOR THE SCHOOL DISTRICT, OR

55 (II) THE TAXPAYER'S QUALIFYING TAXES.

1 (C) IF THE QUALIFYING TAXES PAID BY THE TAXPAYER CONSTITUTED ONLY A
2 PORTION OF THE TOTAL SCHOOL DISTRICT TAXES THAT WERE LEVIED UPON THE
3 TAXPAYER'S PRIMARY RESIDENCE FOR THE ASSOCIATED FISCAL YEAR OR, IN THE
4 CASE OF A CITY SCHOOL DISTRICT THAT IS SUBJECT TO ARTICLE FIFTY-TWO OF
5 THE EDUCATION LAW, IF THE QUALIFYING TAXES PAID BY THE TAXPAYER CONSTI-

18 SUBDIVISION SIXTEEN OF SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL
19 PROPERTY TAX LAW.

20 (6) SPECIAL CASES. (A) IN THE CASE OF PROPERTY CONSISTING OF A COOPER-
21 ATIVE APARTMENT CORPORATION THAT IS DESCRIBED BY PARAGRAPH (K) OF SUBDI-
22 VISION TWO OF SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL PROPERTY TAX
23 LAW, THE AMOUNT OF THE CREDIT ALLOWABLE WITH RESPECT TO A COOPERATIVE
24 APARTMENT SHALL BE EQUAL TO SIXTY PERCENT OF THE BASIC STAR TAX SAVINGS
25 FIGURE FOR THE SCHOOL DISTRICT, OR SIXTY PERCENT OF THE ENHANCED STAR
26 TAX SAVINGS FIGURE FOR THE SCHOOL DISTRICT, WHICHEVER IS APPLICABLE.
27 PROVIDED, HOWEVER, THAT IN THE CASE OF A COOPERATIVE APARTMENT CORPO-
28 RATION THAT IS DESCRIBED BY SUBPARAGRAPH (IV) OF PARAGRAPH (K) OF SUBDI-
29 VISION TWO OF SECTION FOUR HUNDRED TWENTY-FIVE OF THE REAL PROPERTY TAX
30 LAW, THE CREDIT ALLOWABLE WITH RESPECT TO A COOPERATIVE APARTMENT SHALL
31 BE EQUAL TO TWENTY PERCENT OF SUCH FIGURE.

32 (B) IN THE CASE OF PROPERTY CONSISTING OF A MOBILE HOME THAT IS
33 DESCRIBED IN PARAGRAPH (1) OF SUBDIVISION TWO OF SECTION FOUR HUNDRED
34 TWENTY-FIVE OF THE REAL PROPERTY TAX LAW, THE AMOUNT OF THE CREDIT
35 ALLOWABLE WITH RESPECT TO SUCH MOBILE HOME SHALL BE EQUAL TO TWENTY-FIVE
36 PERCENT OF THE BASIC STAR TAX SAVINGS FIGURE FOR THE SCHOOL DISTRICT,
37 OR TWENTY-FIVE PERCENT OF THE ENHANCED STAR TAX SAVINGS FIGURE FOR THE
38 SCHOOL DISTRICT, WHICHEVER IS APPLICABLE.

39 (C) IN THE CASE OF A PRIMARY RESIDENCE THAT IS LOCATED IN TWO OR MORE
40 SCHOOL DISTRICTS, THE APPLICABLE BASIC OR ENHANCED STAR TAX SAVINGS
41 FIGURE SHALL BE DETERMINED AS FOLLOWS:

42 (I) DETERMINE THE SUM OF THE TOTAL SCHOOL DISTRICT TAXES THAT WERE
43 LEVIED UPON THE TAXPAYER'S PRIMARY RESIDENCE FOR THE ASSOCIATED FISCAL
44 YEAR BY EACH OF THE SCHOOL DISTRICTS IN WHICH THE RESIDENCE IS LOCATED;

45 (II) FOR EACH SUCH SCHOOL DISTRICT, DIVIDE THE TOTAL SCHOOL DISTRICT

48 CLAUSE (I) OF THIS SUBPARAGRAPH. EXPRESS THE RESULT AS A PERCENTAGE WITH
49 TWO DECIMAL PLACES;

50 (III) FOR EACH SUCH SCHOOL DISTRICT, MULTIPLY THE PERCENTAGE DETER-
51 MINED IN CLAUSE (II) OF THIS SUBPARAGRAPH BY THE BASIC OR ENHANCED STAR
52 TAX SAVINGS FIGURE, WHICHEVER IS APPLICABLE; AND

53 (IV) ADD THE PRODUCTS DETERMINED IN CLAUSE (III) OF THIS SUBPARAGRAPH.

54 (7) DISCLOSURE OF INCOMES. WHERE THE COMMISSIONER HAS DENIED A TAXPAY-
55 ER'S CLAIM FOR THE CREDIT AUTHORIZED BY THIS SUBSECTION IN WHOLE OR IN
56 PART ON THE GROUNDS THAT THE AFFILIATED INCOME OF THE PARCEL IN QUESTION

1 EXCEEDS THE APPLICABLE LIMIT, THE COMMISSIONER SHALL HAVE THE AUTHORITY
2 TO REVEAL TO THAT TAXPAYER THE NAMES AND INCOMES OF THE OTHER TAXPAYERS
3 WHOSE INCOMES WERE INCLUDED IN THE COMPUTATION OF SUCH AFFILIATED
4 INCOME.

5 (8) PROOF OF CLAIM. THE COMMISSIONER MAY REQUIRE A QUALIFIED TAXPAYER
6 TO FURNISH THE FOLLOWING INFORMATION IN SUPPORT OF HIS OR HER CLAIM FOR
7 CREDIT UNDER THIS SUBSECTION: AFFILIATED INCOME, THE TOTAL SCHOOL
8 DISTRICT TAXES LEVIED ON THE PROPERTY FOR THE ASSOCIATED FISCAL YEAR OR,
9 IN THE CASE OF A CITY SCHOOL DISTRICT THAT IS SUBJECT TO ARTICLE FIFTY-
10 TWO OF THE EDUCATION LAW, THE TOTAL COMBINED CITY AND SCHOOL DISTRICT
11 TAXES LEVIED ON THE PROPERTY FOR THE ASSOCIATED FISCAL YEAR, THE QUALI-
12 FYING TAXES PAID BY THE TAXPAYER, THE NAMES AND TAXPAYER IDENTIFICATION
13 NUMBERS OF ALL OWNERS OF THE PROPERTY AND SPOUSES WHO PRIMARILY RESIDE
14 ON THE PROPERTY, THE PARCEL IDENTIFICATION NUMBER AND ALL OTHER INFORMA-
15 TION THAT MAY BE REQUIRED BY THE COMMISSIONER TO DETERMINE THE CREDIT.

26 AND SIX HUNDRED FIFTY-NINE OF THIS ARTICLE AND THE PROVISIONS OF PART

28 THE JUDICIAL REVIEW OF THE DECISIONS OF THE COMMISSIONER, EXCEPT SO MUCH

55 SHALL BE REDUCED BY THE AMOUNT OF THE CREDIT CLAIMED UNDER THIS

55 AND DID NOT DO SO;

(C) Applications that would allow an enhanced exemption to resume after having been discontinued;

(D) Applications submitted by a person or persons who had previously qualified for the enhanced exemption but not in the assessing unit in question; and

(E) Applications with respect to which the department [of taxation and finance] has advised the assessor [through the commissioner] that it is unable to determine whether a participant or participants in the STAR income verification program satisfy the income eligibility requirements.

S 2. This act shall take effect immediately and shall apply to the administration of the enhanced STAR exemption authorized by subdivision 4 of section 425 of the real property tax law beginning with final assessment rolls to be completed in 2017.

SUCH REQUEST SHALL CONTAIN AN EXPLANATION OF WHY THE DEADLINE WAS MISSED, AND SHALL BE ACCOMPANIED BY A RENEWAL APPLICATION, REFLECTING THE FACTS AND CIRCUMSTANCES AS THEY EXISTED ON THE TAXABLE STATUS DATE. AFTER CONSULTING WITH THE ASSESSOR, THE COMMISSIONER MAY EXTEND THE FILING DEADLINE AND GRANT THE EXEMPTION IF THE COMMISSIONER IS SATISFIED THAT (I) GOOD CAUSE EXISTED FOR THE FAILURE TO FILE THE RENEWAL APPLICATION BY THE TAXABLE STATUS DATE, AND THAT (II) THE APPLICANT IS OTHERWISE ENTITLED TO THE EXEMPTION. THE COMMISSIONER SHALL MAIL NOTICE OF HIS OR HER DETERMINATION TO SUCH OWNER AND THE ASSESSOR. IF THE DETERMINATION STATES THAT THE COMMISSIONER HAS GRANTED THE EXEMPTION, THE ASSESSOR SHALL THEREUPON BE AUTHORIZED AND DIRECTED TO CORRECT THE ASSESSMENT ROLL ACCORDINGLY, OR, IF ANOTHER PERSON HAS CUSTODY OR CONTROL OF THE ASSESSMENT ROLL, TO DIRECT THAT PERSON TO MAKE THE APPROPRIATE CORRECTIONS. IF THE CORRECTION IS NOT MADE BEFORE SCHOOL TAXES ARE LEVIED, THE FAILURE TO TAKE THE EXEMPTION INTO ACCOUNT IN THE COMPUTATION OF THE TAX SHALL BE DEEMED A "CLERICAL ERROR" FOR PURPOSES OF TITLE THREE OF ARTICLE FIVE OF THIS CHAPTER, AND SHALL BE CORRECTED ACCORDINGLY.

1 SUCH REQUEST SHALL CONTAIN AN EXPLANATION OF WHY THE DEADLINE WAS
2 MISSED, AND SHALL BE ACCOMPANIED BY A RENEWAL APPLICATION, REFLECTING

The taxpayer shall be allowed to claim only the amount listed on the certificate of tax credit for that taxable year. Such certificate must be attached to the taxpayer's return. No cost or expense paid or incurred by the taxpayer shall be the basis for more than one component of this credit or any other tax credit, except as provided in section three hundred fifty-five of the economic development law.

45 cation services to file an annual return, which shall contain any data

48 eto a certification by the head of the provider of telecommunication
49 services making the same, or of the owner or of a partner or member
50 thereof, or of a principal officer of the corporation, if such business

(3) by or for every unincorporated business other than a partnership, for taxable years beginning after nineteen hundred ninety-six but before two thousand nine, having unincorporated business gross income, determined for purposes of this subdivision without any deduction for the cost of goods sold or services performed, of more than seventy-five thousand dollars, or having unincorporated business taxable income of more than thirty-five thousand dollars; and

(4) by or for every unincorporated business, for taxable years beginning after two thousand eight, having unincorporated business gross income, determined for purposes of this subdivision without any deduction for the cost of goods sold or services performed, of more than ninety-five thousand dollars.

(b) Decedents. The return for any deceased individual shall be made and filed by his or her executor, administrator, or other person charged with his or her property. If a final return of a decedent is for a fractional part of a year, the due date of such return shall be, FOR TAXABLE YEARS BEGINNING BEFORE JANUARY FIRST, TWO THOUSAND SIXTEEN, the fifteenth day of the fourth month following the close of the twelve-month period [which] THAT began with the first day of such fractional part of the year, AND, FOR TAXABLE YEARS BEGINNING ON OR AFTER JANUARY FIRST, TWO THOUSAND SIXTEEN, THE FIFTEENTH DAY OF THE THIRD MONTH FOLLOWING THE CLOSE OF THE TWELVE-MONTH PERIOD THAT BEGAN WITH THE FIRST DAY OF SUCH FRACTIONAL PART OF THE YEAR.

20 ISSUE CERTIFICATES OF RECEIPT PURSUANT TO THIS ARTICLE.

21 9. "PUBLIC SCHOOL" MEANS ANY FREE ELEMENTARY OR SECONDARY SCHOOL IN
22 THIS STATE PURSUANT TO ARTICLE ELEVEN OF THE CONSTITUTION, BUT SHALL NOT
23 INCLUDE A CHARTER SCHOOL AUTHORIZED BY ARTICLE FIFTY-SIX OF THIS CHAP-
24 TER.

25 10. "QUALIFIED CONTRIBUTION" MEANS THE AUTHORIZED CONTRIBUTION MADE BY
26 A TAXPAYER TO A PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZA-
27 TION, LOCAL EDUCATION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION
28 LISTED IN THE CONTRIBUTION AUTHORIZATION CERTIFICATE ISSUED TO THE
29 TAXPAYER FOR WHICH THE TAXPAYER HAS RECEIVED A CERTIFICATE OF RECEIPT
30 FROM SUCH ENTITY, FUND OR ORGANIZATION. A CONTRIBUTION DOES NOT QUALIFY
31 IF THE TAXPAYER DESIGNATES THE TAXPAYER'S CONTRIBUTION TO AN ENTITY OR
32 ORGANIZATION FOR THE DIRECT BENEFIT OF ANY PARTICULAR OR SPECIFIED
33 STUDENT.

34 11. "QUALIFIED SCHOOL" MEANS A PUBLIC SCHOOL OR NON-PUBLIC SCHOOL
35 LOCATED IN THIS STATE.

36 12. "SCHOLARSHIP" MEANS AN EDUCATIONAL SCHOLARSHIP OR TUITION GRANT
37 AWARDED TO AN ELIGIBLE PUPIL TO ATTEND A QUALIFIED SCHOOL IN AN AMOUNT
38 NOT TO EXCEED THE TUITION CHARGED TO ATTEND SUCH SCHOOL LESS ANY OTHER
39 EDUCATIONAL SCHOLARSHIP OR TUITION GRANT RECEIVED BY SUCH ELIGIBLE PUPIL
40 OR HIS OR HER PARENT, PARENTS, LEGAL GUARDIAN, OR LEGAL GUARDIANS FOR
41 SUCH ELIGIBLE PUPIL'S TUITION; PROVIDED, HOWEVER, IN THE CASE OF AN
42 ELIGIBLE PUPIL ATTENDING A PUBLIC SCHOOL OF A DISTRICT OF WHICH SUCH
43 PUPIL IS NOT A RESIDENT, THE AMOUNT OF THE EDUCATIONAL SCHOLARSHIP OR
44 TUITION GRANT AWARDED MAY NOT EXCEED THE TUITION CHARGED BY THE PUBLIC
45 SCHOOL PURSUANT TO PARAGRAPH D OF SUBDIVISION FOUR OF SECTION THIRTY-TWO
46 HUNDRED TWO OF THIS CHAPTER, BUT ONLY IF THE SCHOOL DISTRICT OF WHICH
47 SUCH PUPIL IS A RESIDENT IS NOT REQUIRED TO PAY FOR SUCH TUITION.

48 13. "SCHOOL IMPROVEMENT ORGANIZATION" MEANS A NOT-FOR-PROFIT ENTITY
49 THAT: (A) IS EXEMPT FROM TAXATION UNDER PARAGRAPH THREE OF SUBSECTION
50 (C) OF SECTION FIVE HUNDRED ONE OF THE INTERNAL REVENUE CODE; (B) USES
51 AT LEAST NINETY PERCENT OF THE QUALIFIED CONTRIBUTIONS RECEIVED DURING
52 THE CALENDAR YEAR AND ANY INCOME DERIVED FROM QUALIFIED CONTRIBUTIONS
53 DURING SUCH MONTHS TO ASSIST PUBLIC SCHOOLS OR PUBLIC SCHOOL DISTRICTS
54 LOCATED IN THIS STATE IN THEIR PROVISION OF EDUCATIONAL PROGRAMS, EITHER
55 BY MAKING CONTRIBUTIONS TO ONE OR MORE PUBLIC SCHOOLS OR PUBLIC SCHOOL
56 DISTRICTS LOCATED IN THIS STATE OR PROVIDING EDUCATIONAL PROGRAMS TO, OR

1 IN CONJUNCTION WITH, ONE OR MORE PUBLIC SCHOOLS OR PUBLIC SCHOOL
2 DISTRICTS LOCATED IN THIS STATE; (C) DEPOSITS AND HOLDS QUALIFIED
3 CONTRIBUTIONS AND ANY INCOME DERIVED FROM QUALIFIED CONTRIBUTIONS IN AN
4 ACCOUNT THAT IS SEPARATE FROM THE ORGANIZATION'S OPERATING OR OTHER
5 FUNDS UNTIL SUCH QUALIFIED CONTRIBUTIONS OR INCOME ARE WITHDRAWN FOR
6 USE; AND (D) IS APPROVED TO ISSUE CERTIFICATES OF RECEIPT PURSUANT TO
7 THIS ARTICLE. SUCH TERM INCLUDES A PRE-KINDERGARTEN PROGRAM OR
8 NOT-FOR-PROFIT ENTITY THAT ALLOWS THE TAXPAYER TO CHOOSE TO DONATE TO A
9 PROGRAM PROJECT OR INITIATIVE FOR USE IN A PUBLIC SCHOOL.

10 S 1211. APPROVAL TO ISSUE CERTIFICATES OF RECEIPT. 1. PUBLIC SCHOOLS
11 AND PUBLIC SCHOOL DISTRICTS. ALL PUBLIC SCHOOLS AND PUBLIC SCHOOL
12 DISTRICTS SHALL BE APPROVED TO ISSUE CERTIFICATES OF RECEIPT FOR QUALI-
13 FIED CONTRIBUTIONS IN ACCORDANCE WITH SECTION FORTY-TWO OF THE TAX LAW,
14 PROVIDED, HOWEVER, THAT SUCH PUBLIC SCHOOL OR PUBLIC SCHOOL DISTRICT
15 SHALL NOT BE APPROVED IF EITHER: (A) SUCH PUBLIC SCHOOL OR PUBLIC SCHOOL
16 DISTRICT FAILS TO DEPOSIT AND HOLD QUALIFIED CONTRIBUTIONS AND ANY

18 RATE FROM THE SCHOOL OR SCHOOL DISTRICT'S OPERATING OR OTHER FUNDS UNTIL
19 SUCH QUALIFIED CONTRIBUTIONS OR INCOME ARE WITHDRAWN FOR USE; OR (B) THE
20 COMMISSIONER HAS REVOKED SUCH APPROVAL FOR SUCH PUBLIC SCHOOL OR PUBLIC
21 SCHOOL DISTRICT PURSUANT TO SECTION TWELVE HUNDRED FOURTEEN OF THIS
22 ARTICLE.

23 2. SCHOOL IMPROVEMENT ORGANIZATIONS, EDUCATIONAL SCHOLARSHIP ORGANIZA-
24 TIONS AND LOCAL EDUCATION FUNDS. NO SCHOOL IMPROVEMENT ORGANIZATION,
25 EDUCATIONAL SCHOLARSHIP ORGANIZATION OR LOCAL EDUCATION FUND SHALL ISSUE
26 ANY CERTIFICATES OF RECEIPT WITHOUT FILING AN APPLICATION PURSUANT TO
27 SECTION TWELVE HUNDRED TWELVE OF THIS ARTICLE AND RECEIVING APPROVAL
28 PURSUANT TO SECTION TWELVE HUNDRED THIRTEEN OF THIS ARTICLE.

29 S 1212. APPLICATIONS FOR APPROVAL TO ISSUE CERTIFICATES OF RECEIPT.
30 EACH SCHOOL IMPROVEMENT ORGANIZATION, EDUCATIONAL SCHOLARSHIP ORGANIZA-
31 TION AND LOCAL EDUCATION FUND SHALL SUBMIT AN APPLICATION TO THE COMMIS-
32 SIONER FOR APPROVAL TO ISSUE CERTIFICATES OF RECEIPT IN THE FORM AND
33 MANNER PRESCRIBED BY THE COMMISSIONER, PROVIDED THAT SUCH APPLICATION
34 SHALL INCLUDE: (A) SUBMISSION OF DOCUMENTATION THAT SUCH SCHOOL IMPROVE-
35 MENT ORGANIZATION, LOCAL EDUCATION FUND OR EDUCATIONAL SCHOLARSHIP
36 ORGANIZATION HAS BEEN GRANTED EXEMPTION FROM TAXATION UNDER PARAGRAPH

43 S 1213. APPLICATION APPROVAL FOR CERTIFICATES OF RECEIPT. 1. IN GENER-
44 AL. THE COMMISSIONER SHALL REVIEW EACH APPLICATION TO ISSUE CERTIFICATES
45 OF RECEIPT PURSUANT TO THIS ARTICLE. THE COMMISSIONER SHALL PUBLISH

52 FINANCE, MAY REVOKE THE APPROVAL OF A SCHOOL IMPROVEMENT ORGANIZATION,
53 EDUCATIONAL SCHOLARSHIP ORGANIZATION, LOCAL EDUCATION FUND, PUBLIC
54 SCHOOL OR PUBLIC SCHOOL DISTRICT TO ISSUE CERTIFICATES OF RECEIPT UPON A
55 FINDING THAT SUCH ORGANIZATION, FUND, SCHOOL OR SCHOOL DISTRICT HAS

1 VIOLATIONS SHALL INCLUDE, BUT NOT BE LIMITED TO, ANY OF THE FOLLOWING:
2 (A) FAILURE TO MEET THE REQUIREMENTS OF THIS ARTICLE OR SECTION
3 FORTY-TWO OF THE TAX LAW; (B) THE FAILURE TO MAINTAIN FULL AND ADEQUATE
4 RECORDS WITH RESPECT TO THE RECEIPT OF QUALIFIED CONTRIBUTIONS; (C) THE
5 FAILURE TO SUPPLY SUCH RECORDS TO THE COMMISSIONER, THE DEPARTMENT, OR
6 THE DEPARTMENT OF TAXATION AND FINANCE WHEN REQUESTED; OR (D) THE FAIL-
7 URE TO PROVIDE NOTICE TO THE DEPARTMENT OF TAXATION AND FINANCE OF THE
8 ISSUANCE OR NON-ISSUANCE OF CERTIFICATES OF RECEIPT PURSUANT TO SECTION
9 FORTY-TWO OF THE TAX LAW; PROVIDED, HOWEVER, THAT THE COMMISSIONER SHALL

18 TION, LOCAL EDUCATION FUND, PUBLIC SCHOOL, OR PUBLIC SCHOOL DISTRICT AND
19 TO THE DEPARTMENT OF TAXATION AND FINANCE. THE COMMISSIONER SHALL ESTAB-
20 LISH AN APPEALS PROCESS FOR DETERMINATIONS REVOKING APPROVALS.

21 S 1215. REPORTING AND RECORDKEEPING. 1. REPORTING. EACH EDUCATIONAL
22 SCHOLARSHIP ORGANIZATION, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCA-
23 TION FUND, PUBLIC SCHOOL AND PUBLIC SCHOOL DISTRICT THAT RECEIVES QUALI-
24 FIED CONTRIBUTIONS SHALL REPORT TO THE COMMISSIONER AND THE DEPARTMENT
25 OF TAXATION AND FINANCE BY JANUARY THIRTY-FIRST OF EACH CALENDAR YEAR.
26 SUCH REPORT SHALL BE IN THE FORM AND MANNER PRESCRIBED BY THE COMMIS-
27 SIONER IN CONSULTATION WITH THE COMMISSIONER OF TAXATION AND FINANCE.

28 2. RECORDKEEPING. EACH EDUCATIONAL SCHOLARSHIP ORGANIZATION, SCHOOL
29 IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND, PUBLIC SCHOOL AND PUBLIC
30 SCHOOL DISTRICT THAT ISSUED AT LEAST ONE CERTIFICATE OF RECEIPT SHALL
31 MAINTAIN RECORDS INCLUDING: (A) NOTIFICATIONS RECEIVED FROM THE DEPART-
32 MENT OF TAXATION AND FINANCE; (B) NOTIFICATIONS MADE TO THE DEPARTMENT
33 OF TAXATION AND FINANCE; (C) COPIES OF QUALIFIED CONTRIBUTIONS RECEIVED;
34 (D) COPIES OF THE DEPOSIT OF SUCH QUALIFIED CONTRIBUTIONS; (E) COPIES OF
35 ISSUED CERTIFICATES OF RECEIPT; (F) ANNUAL FINANCIAL STATEMENTS; (G) IN
36 THE CASE OF SCHOOL IMPROVEMENT ORGANIZATIONS, EDUCATIONAL SCHOLARSHIP
37 ORGANIZATIONS AND LOCAL EDUCATION FUNDS, THE APPLICATION SUBMITTED
38 PURSUANT TO SECTION TWELVE HUNDRED TWELVE OF THIS ARTICLE AND THE
39 APPROVAL ISSUED BY THE COMMISSIONER; AND (H) ANY OTHER INFORMATION
40 PRESCRIBED BY THE COMMISSIONER. SUCH RECORDS SHALL BE MAINTAINED BY THE
41 ENTITY OR ORGANIZATION FOR FIVE YEARS.

42 S 1216. JOINT ANNUAL REPORT. ON OR BEFORE THE LAST DAY OF MAY FOR
43 EACH CALENDAR YEAR, THE COMMISSIONER OF TAXATION AND FINANCE AND THE
44 COMMISSIONER, JOINTLY, SHALL SUBMIT A WRITTEN REPORT AS PROVIDED IN
45 SUBDIVISION (K) OF SECTION FORTY-TWO OF THE TAX LAW.

46 S 1217. COMMISSIONER; POWERS. THE COMMISSIONER SHALL PROMULGATE ON AN

5 DONATIONS AND CONTRIBUTIONS MADE PURSUANT TO ARTICLE TWENTY-FIVE OF THIS
6 CHAPTER, AND ANY INCOME DERIVED THEREFROM, SHALL BE DISREGARDED FOR THE
7 PURPOSES OF ALL APPORTIONMENTS, COMPUTATIONS, AND DETERMINATIONS OF
8 STATE AID.

9 S 4. The tax law is amended by adding a new section 42 to read as
10 follows:

11 S 42. EDUCATION SCHOLARSHIP AND PROGRAM TAX CREDIT. (A) DEFINITIONS.

19 (B) ALLOWANCE OF CREDIT. A TAXPAYER SUBJECT TO TAX UNDER ARTICLE
20 NINE-A OR TWENTY-TWO OF THIS CHAPTER SHALL BE ALLOWED AN EDUCATION SCHOLARSHIP AND PROGRAM TAX CREDIT AGAINST SUCH TAX, PURSUANT TO THE PROVISIONS REFERENCED IN SUBDIVISION (1) OF THIS SECTION, WITH RESPECT TO QUALIFIED CONTRIBUTIONS MADE DURING THE TAXABLE YEAR.

24 (C) AMOUNT OF CREDIT. THE AMOUNT OF THE CREDIT SHALL BE THE LESSER OF
25 SEVENTY-FIVE PER CENT OF THE TAXPAYER'S TOTAL QUALIFIED CONTRIBUTIONS OR
26 ONE MILLION DOLLARS. IF THE TAXPAYER IS A PARTNER IN A PARTNERSHIP OR

31 (D) INFORMATION TO BE POSTED ON THE DEPARTMENT'S WEBSITE. BEGINNING
32 ON THE SIXTEENTH DAY OF JANUARY OF EACH YEAR, THE COMMISSIONER SHALL
33 MAINTAIN ON THE DEPARTMENT'S WEBSITE A RUNNING TOTAL OF THE AMOUNT OF
34 AVAILABLE CREDIT FOR WHICH TAXPAYERS MAY APPLY PURSUANT TO THIS SECTION.
35 ADDITIONALLY, THE COMMISSIONER SHALL MAINTAIN ON THE DEPARTMENT'S
36 WEBSITE A LIST OF THE SCHOOL IMPROVEMENT ORGANIZATIONS, LOCAL EDUCATION
37 FUNDS AND EDUCATIONAL SCHOLARSHIP ORGANIZATIONS APPROVED TO ISSUE
38 CERTIFICATES OF RECEIPT PURSUANT TO ARTICLE TWENTY-FIVE OF THE EDUCATION
39 LAW. THE COMMISSIONER SHALL ALSO MAINTAIN ON THE DEPARTMENT'S WEBSITE A
40 LIST OF PUBLIC EDUCATION ENTITIES, SCHOOL IMPROVEMENT ORGANIZATIONS,
41 LOCAL EDUCATION FUNDS AND EDUCATIONAL SCHOLARSHIP ORGANIZATIONS WHOSE
42 APPROVAL TO ISSUE CERTIFICATES OF RECEIPT HAS BEEN REVOKED, ALONG WITH
43 THE DATE OF SUCH REVOCATION.

44 (E) APPLICATIONS FOR CONTRIBUTION AUTHORIZATION CERTIFICATES. PRIOR TO
45 MAKING A CONTRIBUTION TO A PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT
46 ORGANIZATION, LOCAL EDUCATION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION, THE TAXPAYER SHALL APPLY TO THE DEPARTMENT FOR A CONTRIBUTION AUTHORIZATION CERTIFICATE FOR SUCH CONTRIBUTION. SUCH APPLICATION SHALL BE IN THE FORM AND MANNER PRESCRIBED BY THE DEPARTMENT. THE DEPARTMENT MAY ALLOW TAXPAYERS TO MAKE MULTIPLE APPLICATIONS ON THE SAME FORM, PROVIDED THAT EACH CONTRIBUTION LISTED ON SUCH APPLICATION SHALL BE TREATED AS A SEPARATE APPLICATION AND THAT THE DEPARTMENT SHALL ISSUE SEPARATE CONTRIBUTION AUTHORIZATION CERTIFICATES FOR EACH SUCH APPLICATION.

55 (F) CONTRIBUTION AUTHORIZATION CERTIFICATES. 1. ISSUANCE OF CERTIFICATES. THE COMMISSIONER SHALL ISSUE CONTRIBUTION AUTHORIZATION CERTIFICATES.

1 ICATES IN TWO PHASES. IN PHASE ONE, WHICH BEGINS ON THE FIRST DAY OF
2 JANUARY AND ENDS ON THE FIFTEENTH DAY OF JANUARY, THE COMMISSIONER SHALL
3 ACCEPT APPLICATIONS FOR CONTRIBUTION AUTHORIZATION CERTIFICATES, BUT
4 SHALL NOT ISSUE ANY SUCH CERTIFICATES. COMMENCING AFTER THE SIXTEENTH
5 DAY OF JANUARY, THE COMMISSIONER SHALL ISSUE CONTRIBUTION AUTHORIZATION

9 SUBDIVISION (H) OF THIS SECTION, PHASE ONE OF THE APPLICATIONS SHALL BE
10 ALLOCATED IN TWO STEPS. IN STEP ONE, THE CREDIT CAP SHALL BE DIVIDED BY
11 THE NUMBER OF APPLICATIONS TO DETERMINE A BASE ALLOCATION. EACH APPLICA-
12 TION REQUESTING THE BASE ALLOCATION OR LESS SHALL BE APPROVED. IN STEP
13 TWO, THE REMAINING FUNDS SHALL BE CALCULATED AND ALLOCATED AMONG THE
14 OTHER APPLICATIONS ON A DOLLAR PRO RATA BASIS. IF THE CREDIT CAP IS NOT
15 EXCEEDED, PHASE TWO COMMENCES ON JANUARY SIXTEENTH AND ENDS ON NOVEMBER
16 FIRST, DURING WHICH PERIOD THE COMMISSIONER SHALL ISSUE CONTRIBUTION
17 AUTHORIZATION CERTIFICATES ON A FIRST-COME FIRST-SERVED BASIS BASED UPON
18 THE DATE THE DEPARTMENT RECEIVED THE TAXPAYER'S APPLICATION FOR SUCH
19 CERTIFICATE; PROVIDED, HOWEVER, THAT IF ON ANY DAY THE DEPARTMENT
20 RECEIVES APPLICATIONS REQUESTING CONTRIBUTION AUTHORIZATION CERTIFICATES
21 FOR CONTRIBUTIONS THAT IN THE AGGREGATE EXCEED THE AMOUNT OF THE REMAIN-
22 ING AVAILABLE CREDIT ON SUCH DAY, THE AUTHORIZED CONTRIBUTION AMOUNT
23 LISTED IN EACH CONTRIBUTION AUTHORIZATION CERTIFICATE SHALL BE THE
24 TAXPAYER'S PRO-RATA SHARE OF THE REMAINING AVAILABLE CREDIT. FOR
25 PURPOSES OF DETERMINING A TAXPAYER'S PRO-RATA SHARE OF REMAINING AVAIL-
26 ABLE CREDIT, THE COMMISSIONER SHALL MULTIPLY THE AMOUNT OF REMAINING
27 AVAILABLE CREDIT BY A FRACTION, THE NUMERATOR OF WHICH EQUALS THE TOTAL
28 CONTRIBUTION AMOUNT LISTED ON THE TAXPAYER'S APPLICATION AND THE DENOMI-
29 NATOR OF WHICH EQUALS THE AGGREGATE AMOUNT OF CONTRIBUTIONS LISTED ON
30 THE APPLICATIONS FOR CONTRIBUTION AUTHORIZATION CERTIFICATES RECEIVED ON
31 SUCH DAY. CONTRIBUTION AUTHORIZATION CERTIFICATES FOR APPLICATIONS
32 RECEIVED DURING PHASE ONE SHALL BE MAILED NO LATER THAN THE FIFTH DAY OF
33 FEBRUARY. CONTRIBUTION AUTHORIZATION CERTIFICATES FOR APPLICATIONS
34 RECEIVED DURING PHASE TWO SHALL BE MAILED WITHIN TWENTY DAYS OF RECEIPT
35 OF SUCH APPLICATIONS. PROVIDED, HOWEVER, THAT NO CONTRIBUTION AUTHORI-
36 ZATION CERTIFICATES FOR APPLICATIONS RECEIVED DURING PHASE TWO SHALL BE
37 ISSUED UNTIL ALL OF THE CONTRIBUTION AUTHORIZATION CERTIFICATES FOR
38 APPLICATIONS RECEIVED DURING PHASE ONE HAVE BEEN ISSUED.

39 2. CONTRIBUTION AUTHORIZATION CERTIFICATE CONTENTS. EACH CONTRIBUTION
40 AUTHORIZATION CERTIFICATE SHALL STATE: (I) THE DATE SUCH CERTIFICATION
41 WAS ISSUED; (II) THE DATE BY WHICH THE AUTHORIZED CONTRIBUTION LISTED IN
42 THE CERTIFICATE MUST BE MADE, WHICH SHALL BE NO LATER THAN NOVEMBER
43 THIRTIETH OF THE YEAR FOR WHICH THE CONTRIBUTION AUTHORIZATION CERTIF-
44 ICATE WAS ISSUED; (III) THE TAXPAYER'S NAME AND ADDRESS; (IV) THE AMOUNT
45 OF AUTHORIZED CONTRIBUTIONS; (V) THE CONTRIBUTION AUTHORIZATION CERTIF-
46 ICATE'S CERTIFICATE NUMBER; (VI) THE NAME AND ADDRESS OF THE PUBLIC
47 EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND
48 OR EDUCATIONAL SCHOLARSHIP ORGANIZATION FOR WHICH THE TAXPAYER MAY MAKE
49 THE AUTHORIZED CONTRIBUTION; AND (VII) ANY OTHER INFORMATION THAT THE
50 COMMISSIONER DEEMS NECESSARY.

51 3. NOTIFICATION OF THE ISSUANCE OF A CONTRIBUTION AUTHORIZATION
52 CERTIFICATE. UPON ISSUANCE OF A CONTRIBUTION AUTHORIZATION CERTIFICATE,
53 THE COMMISSIONER SHALL NOTIFY THE EDUCATIONAL SCHOLARSHIP ORGANIZATION,
54 PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION OR LOCAL EDUCA-
55 TION FUND OF THE ISSUANCE OF THE CONTRIBUTION AUTHORIZATION CERTIFICATE
56 TO A TAXPAYER. SUCH NOTIFICATION SHALL INCLUDE: (I) THE TAXPAYER'S NAME

1 AND ADDRESS; (II) THE DATE SUCH CERTIFICATE WAS ISSUED; (III) THE DATE
2 BY WHICH THE AUTHORIZED CONTRIBUTION LISTED IN THE NOTIFICATION MUST BE
3 MADE BY THE TAXPAYER; (IV) THE AMOUNT OF THE AUTHORIZED CONTRIBUTION;
4 (V) CONTRIBUTION AUTHORIZATION CERTIFICATE; AND (VI) ANY OTHER INFORMA-
5 TION THAT THE COMMISSIONER DEEMS NECESSARY.

6 (G) CERTIFICATE OF RECEIPT. 1. IN GENERAL. NO PUBLIC EDUCATION ENTITY,
7 SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND, OR EDUCATIONAL
8 SCHOLARSHIP ORGANIZATION SHALL ISSUE A CERTIFICATE OF RECEIPT FOR ANY
9 CONTRIBUTION MADE BY A TAXPAYER UNLESS SUCH PUBLIC EDUCATION ENTITY,
10 SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND, OR EDUCATIONAL
11 SCHOLARSHIP ORGANIZATION HAS BEEN APPROVED TO ISSUE CERTIFICATES OF
12 RECEIPT PURSUANT TO ARTICLE TWENTY-FIVE OF THE EDUCATION LAW. NO PUBLIC
13 EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND,
14 OR EDUCATIONAL SCHOLARSHIP ORGANIZATION SHALL ISSUE A CERTIFICATE OF
15 RECEIPT FOR A CONTRIBUTION MADE BY A TAXPAYER UNLESS SUCH PUBLIC EDUCA-
16 TION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND, OR
17 EDUCATIONAL SCHOLARSHIP ORGANIZATION HAS RECEIVED NOTICE FROM THE
18 DEPARTMENT THAT THE DEPARTMENT ISSUED A CREDIT AUTHORIZATION CERTIFICATE
19 TO THE TAXPAYER FOR SUCH CONTRIBUTION.

20 2. TIMELY CONTRIBUTION. IF A TAXPAYER MAKES AN AUTHORIZED CONTRIBUTION
21 TO THE PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL
22 EDUCATION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION SET FORTH ON THE
23 AUTHORIZATION CERTIFICATE ISSUED TO THE TAXPAYER NO LATER THAN THE DATE
24 BY WHICH SUCH AUTHORIZED CONTRIBUTION IS REQUIRED TO BE MADE, SUCH
25 PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCA-
26 TION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION SHALL, WITHIN THIRTY
27 DAYS OF RECEIPT OF THE AUTHORIZED CONTRIBUTION, ISSUE TO THE TAXPAYER A
28 WRITTEN CERTIFICATE OF RECEIPT; PROVIDED, HOWEVER, THAT IF THE TAXPAYER
29 CONTRIBUTES AN AMOUNT THAT IS LESS THAN THE AMOUNT LISTED ON THE TAXPAY-
30 ER'S CONTRIBUTION AUTHORIZATION CERTIFICATE, THE TAXPAYER SHALL NOT BE
31 ISSUED A CERTIFICATE OF RECEIPT FOR SUCH CONTRIBUTION.

32 3. CERTIFICATE OF RECEIPT CONTENTS. EACH CERTIFICATE OF RECEIPT SHALL
33 STATE: (I) THE NAME AND ADDRESS OF THE ISSUING PUBLIC EDUCATION ENTITY,
34 SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCATION FUND, OR OR EDUCATIONAL
35 SCHOLARSHIP ORGANIZATION; (II) THE TAXPAYER'S NAME AND ADDRESS; (III)
36 THE DATE FOR EACH CONTRIBUTION; (IV) THE AMOUNT OF EACH CONTRIBUTION AND
37 THE CORRESPONDING CONTRIBUTION AUTHORIZATION CERTIFICATE NUMBER; (V) THE
38 TOTAL AMOUNT OF CONTRIBUTIONS; AND (VI) ANY OTHER INFORMATION THAT THE
39 COMMISSIONER DEEMS NECESSARY.

40 4. NOTIFICATION TO THE DEPARTMENT OF THE ISSUANCE OF A CERTIFICATE OF
41 RECEIPT. UPON THE ISSUANCE OF A CERTIFICATE OF RECEIPT, THE ISSUING
42 PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION, LOCAL EDUCA-
43 TION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION SHALL, WITHIN THIRTY
44 DAYS OF ISSUING THE CERTIFICATE OF RECEIPT, PROVIDE THE DEPARTMENT WITH
45 NOTIFICATION OF THE ISSUANCE OF SUCH CERTIFICATE IN THE FORM AND MANNER
46 PRESCRIBED BY THE DEPARTMENT.

47 5. NOTIFICATION TO THE DEPARTMENT OF THE NON-ISSUANCE OF A CERTIFICATE
48 OF RECEIPT. EACH PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZA-
49 TION, LOCAL EDUCATION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION THAT
50 RECEIVED NOTIFICATION FROM THE DEPARTMENT PURSUANT TO SUBDIVISION (F) OF
51 THIS SECTION REGARDING THE ISSUANCE OF A CONTRIBUTION AUTHORIZATION
52 CERTIFICATE TO A TAXPAYER SHALL, WITHIN THIRTY DAYS OF THE EXPIRATION
53 DATE FOR SUCH AUTHORIZED CONTRIBUTION, PROVIDE NOTIFICATION TO THE
54 DEPARTMENT FOR EACH TAXPAYER THAT FAILED TO MAKE THE AUTHORIZED CONTRIB-
55 UTION TO SUCH PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGANIZATION,

1 LOCAL EDUCATION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION IN THE
2 FORM AND MANNER PRESCRIBED BY THE DEPARTMENT.

3 6. FAILURE TO NOTIFY THE DEPARTMENT. WITHIN THIRTY DAYS OF DISCOVERY
4 OF THE FAILURE OF ANY PUBLIC EDUCATION ENTITY, SCHOOL IMPROVEMENT ORGAN-
5 IZATION, LOCAL EDUCATION FUND, OR EDUCATIONAL SCHOLARSHIP ORGANIZATION
6 TO COMPLY WITH THE NOTIFICATION REQUIREMENTS PRESCRIBED BY PARAGRAPHS
7 FOUR AND/OR FIVE OF THIS SUBDIVISION, THE COMMISSIONER SHALL ISSUE A
8 NOTICE OF COMPLIANCE FAILURE TO SUCH ENTITY, PROGRAM FUND OR ORGANIZA-
9 TION. SUCH ENTITY, PROGRAM FUND OR ORGANIZATION SHALL HAVE THIRTY DAYS
10 FROM THE DATE OF SUCH NOTICE TO MAKE THE NOTIFICATIONS PRESCRIBED BY
11 PARAGRAPHS FOUR AND/OR FIVE OF THIS SUBDIVISION. SUCH PERIOD MAY BE
12 EXTENDED FOR AN ADDITIONAL THIRTY DAYS UPON THE REQUEST OF THE ENTITY,
13 PROGRAM FUND OR ORGANIZATION. UPON THE EXPIRATION OF THE PERIOD FOR

18 (H) CREDIT CAP. THE MAXIMUM PERMITTED CREDITS UNDER THIS SECTION
19 AVAILABLE ANNUALLY FOR CALENDAR YEAR TWO THOUSAND SEVENTEEN AND ALL
20 FOLLOWING YEARS TO ALL TAXPAYERS FOR QUALIFIED CONTRIBUTIONS TO PUBLIC
21 EDUCATION ENTITIES, SCHOOL IMPROVEMENT ORGANIZATIONS, AND LOCAL EDUCA-
22 TION FUNDS SHALL BE TWENTY MILLION DOLLARS. THE MAXIMUM PERMITTED CRED-

26 MILLION DOLLARS.

27 (I) ADDITIONS TO THE CREDIT CAP. UNISSUED CERTIFICATES OF RECEIPT. ANY
28 AMOUNTS FOR WHICH THE DEPARTMENT RECEIVES NOTIFICATION OF NON-ISSUANCE
29 OF A CERTIFICATE OF RECEIPT SHALL BE ADDED TO THE CAP PRESCRIBED IN
30 SUBDIVISION (H) OF THIS SECTION FOR THE IMMEDIATELY FOLLOWING YEAR.

31 (J) OTHER REQUIREMENTS; MISCELLANEOUS. RECORD KEEPING. EACH TAXPAYER
32 SHALL, FOR EACH TAXABLE YEAR FOR WHICH THE EDUCATION SCHOLARSHIP AND
33 PROGRAM TAX CREDIT PROVIDE FOR UNDER THIS SECTION IS CLAIMED, MAINTAIN
34 RECORDS OF THE FOLLOWING INFORMATION: (I) CONTRIBUTION AUTHORIZATION
35 CERTIFICATES OBTAINED PURSUANT TO SUBDIVISION (F) OF THIS SECTION, AND
36 (II) CERTIFICATES OF RECEIPT OBTAINED PURSUANT TO SUBDIVISION (G) OF
37 THIS SECTION.

38 (K) JOINT ANNUAL REPORT. ON OR BEFORE THE LAST DAY OF MAY FOR EACH
39 CALENDAR YEAR, FOR THE IMMEDIATELY PRECEDING YEAR, THE COMMISSIONER AND
40 THE COMMISSIONER OF EDUCATION SHALL JOINTLY SUBMIT A WRITTEN REPORT TO
41 THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, THE SPEAKER OF THE
42 ASSEMBLY, THE CHAIRMAN OF THE SENATE FINANCE COMMITTEE AND THE CHAIRMAN
43 OF THE ASSEMBLY WAYS AND MEANS COMMITTEE REGARDING THE CREDIT. SUCH

(4) AMOUNT OF CREDIT. THE AMOUNT OF THE CREDIT SHALL BE EQUAL TO THE LESSER OF FIVE HUNDRED DOLLARS PER ELIGIBLE STUDENT OR THE ACTUAL AMOUNT OF QUALIFIED PRIMARY OR SECONDARY EDUCATION TUITION EXPENSES PAID BY THE TAXPAYER PER ELIGIBLE STUDENT DURING THE TAXABLE YEAR.

(5) REFUNDABILITY. S 13. Severability. If any provision of this act or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

9 PERCENT OF THE SUM OF ALL NEW YORK STATE THRUWAY TOLLS PAID BY THE

23 (4) NOTWITHSTANDING ANY OTHER LAW TO THE CONTRARY, THE AMOUNT OF ANY
24 CLAIM MADE FOR A NEW YORK STATE THRUWAY TOLLS TAX CREDIT MAY BE VERIFIED
25 THROUGH E-ZPASS TOLL RECEIPT RECORDS CREATED AND MAINTAINED BY THE ENTI-
26 TY AUTHORIZED TO ISSUE THE E-ZPASS ACCOUNT AND MADE AVAILABLE TO, AND
27 UPON REQUEST BY, THE DEPARTMENT FOR THIS PURPOSE.

SUCH FARM VEHICLE SHALL BE PRINCIPALLY USED FOR THE TRANSPORTATION OF AGRICULTURAL OR DAIRY COMMODITIES OR SUPPLIES, OR USED IN CONJUNCTION WITH LUMBERING OPERATIONS CONNECTED WITH BUT ONLY INCIDENTAL TO THE OPERATION OF A FARM.

(C) "E-ZPASS INDIVIDUAL ACCOUNT" MEANS A PREPAID E-ZPASS ACCOUNT ISSUED BY AN AUTHORIZED ENTITY IN AN INDIVIDUAL'S NAME.

(D) "E-ZPASS BUSINESS ACCOUNT" MEANS A PREPAID E-ZPASS ACCOUNT ISSUED BY AN AUTHORIZED ENTITY IN A CORPORATION'S OR COMMERCIAL ENTERPRISE'S NAME.

(E) "E-ZPASS COMMERCIAL ACCOUNT" MEANS A POST-PAID E-ZPASS ACCOUNT ISSUED BY AN AUTHORIZED ENTITY IN A CORPORATION'S OR COMMERCIAL ENTERPRISE'S NAME.

(3)(A) THE CREDIT FOR A TAXPAYER HOLDING AN E-ZPASS INDIVIDUAL ACCOUNT OR ACCOUNTS SHALL BE IN AN AMOUNT EQUAL TO FIFTY PERCENT OF THE SUM OF ALL NEW YORK STATE THRUWAY TOLLS PAID BY THE TAXPAYER THROUGH SUCH AN ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR. TO QUALIFY FOR THE CREDIT, THE TAXPAYER MUST HAVE PAID AT LEAST FIFTY DOLLARS IN NEW YORK STATE THRUWAY TOLLS THROUGH SUCH ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR.

(B) THE CREDIT FOR A TAXPAYER HOLDING AN E-ZPASS BUSINESS OR COMMERCIAL ACCOUNT OR ACCOUNTS SHALL BE IN AN AMOUNT EQUAL TO FIFTY PERCENT OF THE SUM OF ALL NEW YORK STATE THRUWAY TOLLS PAID BY THE TAXPAYER THROUGH SUCH AN ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR. TO QUALIFY FOR THE CREDIT, THE TAXPAYER MUST HAVE PAID ONE HUNDRED DOLLARS OR MORE IN NEW YORK STATE THRUWAY TOLLS THROUGH SUCH ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR. A TAXPAYER THAT PAYS TEN THOUSAND DOLLARS OR MORE IN NEW YORK STATE THRUWAY TOLLS THROUGH AN E-ZPASS BUSINESS OR COMMERCIAL ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR DOES NOT QUALIFY FOR THE CREDIT IN ANY AMOUNT IN THAT TAXABLE YEAR.

(C) THE CREDIT FOR A TAXPAYER OWNING AND OPERATING A FARM VEHICLE AND HOLDING AN E-ZPASS BUSINESS OR COMMERCIAL ACCOUNT OR ACCOUNTS SHALL BE IN AN AMOUNT EQUAL TO ONE HUNDRED PERCENT OF THE SUM OF ALL NEW YORK STATE THRUWAY TOLLS PAID BY THE TAXPAYER THROUGH SUCH AN ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR FOR THAT FARM VEHICLE, PROVIDED THE QUALIFYING NEW YORK STATE THRUWAY TOLLS WERE INCURRED IN CONNECTION WITH FARM OPERATIONS.

(D) A TAXPAYER MAY CLAIM THE CREDIT PROVIDED FOR IN SUBPARAGRAPH (A), (B) OR (C) OF THIS PARAGRAPH IN A TAXABLE YEAR BUT MAY NOT CLAIM A CREDIT UNDER MORE THAN ONE SUBPARAGRAPH OF THIS PARAGRAPH IN THE SAME TAXABLE YEAR.

(E) IF A TAXPAYER HAS MORE THAN ONE E-ZPASS TRANSPONDER ON AN ACCOUNT OR HAS MORE THAN ONE ACCOUNT, ALL THE NEW YORK STATE THRUWAY TOLLS PAID BY THE TAXPAYER FOR ALL E-ZPASS TRANSPONDERS AND ALL ACCOUNTS SHALL BE AGGREGATED FOR PURPOSES OF APPLYING THE MINIMUM AND MAXIMUM AMOUNTS OF NEW YORK STATE THRUWAY TOLLS REFERENCED IN SUBPARAGRAPHS (A) AND (B) OF THIS PARAGRAPH.

(4) NOTWITHSTANDING ANY OTHER LAW TO THE CONTRARY, THE AMOUNT OF ANY CLAIM MADE FOR A NEW YORK STATE THRUWAY TOLLS TAX CREDIT MAY BE VERIFIED THROUGH E-ZPASS TOLL RECEIPTS RECORDS CREATED AND MAINTAINED BY THE ENTITY AUTHORIZED TO ISSUE THE E-ZPASS ACCOUNT AND MADE AVAILABLE TO, AND UPON REQUEST BY, THE DEPARTMENT OF TAXATION AND FINANCE FOR THIS PURPOSE.

(3) (A) THE CREDIT FOR A TAXPAYER HOLDING AN E-ZPASS BUSINESS OR COMMERCIAL ACCOUNT OR ACCOUNTS SHALL BE IN AN AMOUNT EQUAL TO FIFTY PERCENT OF THE SUM OF ALL NEW YORK STATE THRUWAY TOLLS PAID BY THE TAXPAYER THROUGH SUCH AN ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR. TO QUALIFY FOR THE CREDIT, THE TAXPAYER MUST HAVE PAID ONE HUNDRED DOLLARS OR MORE IN NEW YORK STATE THRUWAY TOLLS THROUGH SUCH ACCOUNT OR ACCOUNTS DURING THE TAXABLE YEAR. (B) IF A TAXPAYER HAS MORE THAN ONE E-ZPASS TRANSPONDER ON AN ACCOUNT OR HAS MORE THAN ONE ACCOUNT, ALL THE NEW YORK STATE THRUWAY TOLLS PAID BY THE TAXPAYER FOR ALL E-ZPASS TRANSPONDERS AND ALL ACCOUNTS SHALL BE AGGREGATED FOR PURPOSES OF APPLYING THE MINIMUM AND MAXIMUM AMOUNTS OF NEW YORK STATE THRUWAY TOLLS REFERENCED IN SUBPARAGRAPH (A) OF THIS PARAGRAPH.

33 entire consideration shall be treated as rent subject to tax under para-
34 graph one of this subdivision; provided, however, that where the amount
35 of the rent for occupancy is stated separately from the price of such
36 property, services, amusement charges, or other items, on any sales
37 slip, invoice, receipt, or other statement given the occupant, and such
38 rent is reasonable in relation to the value of such property, services,

41 S 2. Section 1115 of the tax law is amended by adding a new subdivi-

52 EXEMPTION OR RESALE CERTIFICATES IN SUBPARAGRAPH (I) OF PARAGRAPH ONE OF
53 SUBDIVISION (C) OF SECTION ELEVEN HUNDRED THIRTY-TWO OF THIS ARTICLE.

S 3. Paragraph 4 of subdivision a of section 11-2502 of the administrative code of the city of New York, as amended by section 4 of part Q of chapter 59 of the laws of 2012, is amended to read as follows:

(4) (i) When occupancy is provided, for a single consideration, with property, services, amusement charges, or any other items, the separate sale of which is not subject to tax under this chapter, AND THE RENT PAID FOR SUCH OCCUPANCY DOES NOT QUALIFY FOR THE EXEMPTION IN SUBDIVISION 1 OF THIS SECTION, the entire consideration shall be treated as rent subject to tax under paragraph one of this subdivision; provided, however, that where the amount of the rent for occupancy is stated separately from the price of such property, services, amusement charges or other items on any sales slip, invoice, receipt, or other statement given the occupant and such rent is reasonable in relation to the value of such property, services, amusement charges, or other items, only such separately stated rent will be subject to tax under this subdivision.

(ii) In regard to the collection of tax on occupancies by remarketers, when occupancy is provided, for a single consideration, with property, services, amusement charges, or any other items, whether or not such other items are taxable, the rent portion of the consideration for such sale shall be computed as follows: the total consideration for the sale multiplied by a fraction, the numerator of which shall be the consideration paid to the hotel for the occupancy and the denominator of which shall be the consideration paid to the hotel for the occupancy plus the consideration paid to the providers of the other items being sold, or by any other reasonable method pursuant to which the rent portion of consideration would be no less than the computation of rent portion of consideration under subparagraph (i) of this paragraph. Nothing herein shall be construed to subject to tax or exempt from tax any service or property or amusement charge or other items otherwise subject to tax or exempt from tax under this chapter.

S 4. Section 11-2502 of the administrative code of the city of New York is amended by adding a new subdivision 1 to read as follows:

1. AN OCCUPANCY THAT AN OPERATOR CONVEYS OR FURNISHES TO A ROOM REMARKETER THAT THE ROOM REMARKETER INTENDS TO CONVEY OR FURNISH, DIRECTLY OR INDIRECTLY, TO AN OCCUPANT FOR RENT SHALL BE EXEMPT FROM THE TAXES IMPOSED BY THIS SECTION, PROVIDED THAT SUCH ROOM REMARKETER FURNISHES THE OPERATOR WITH A CERTIFICATE IN SUCH FORM AND CONTAINING SUCH INFORMATION AS MAY BE PRESCRIBED BY THE COMMISSIONER OF FINANCE. 2 SECTION ONE HUNDRED SEVENTY OF THE INTERNAL REVENUE CODE, OR TO A
3 NOT-FOR-PROFIT ORGANIZATION, AS DEFINED IN SUBDIVISION SEVEN OF SECTION
4 ONE HUNDRED SEVENTY-NINE-Q OF THE STATE FINANCE LAW, SHALL NOT BE USED
5 IN ANY MANNER TO DETERMINE WHERE AN INDIVIDUAL IS DOMICILED AT THE TIME

7 S 3. This act shall take effect immediately.

30 S 3. Section 312 of the tax law, as amended by section 32 of part K of
31 chapter 61 of the laws of 2011, is amended to read as follows:

32 S 312. Deposit and disposition of revenue.-- (a) Except as otherwise
33 provided, of all taxes, interest and penalties collected or received on
34 or after April first, two thousand one, from the taxes imposed by
35 [sections] SECTION three hundred one-a [and three hundred one-e] of this
36 article, (i) initially eighty and three-tenths percent shall be deposit-
37 ed, as prescribed by subdivision (d) of section three hundred one-j of
38 this article and (ii) nineteen and seven-tenths percent shall be depos-
39 ited in such mass transportation operating assistance fund to the credit
40 of the metropolitan mass transportation operating assistance account and
41 the public transportation systems operating assistance account thereof

44 twenty-fifth day of each month commencing with April, two thousand one,
45 the comptroller shall deduct the amount of six hundred twenty-five thou-

47 and penalties collected or received pursuant to such [sections] SECTION
48 three hundred one-a [and three hundred one-e] and shall deposit such
49 amount in the dedicated fund accounts pursuant to subdivision (d) of
50 section three hundred one-j of this article. Provided, further, that
51 commencing January fifteenth, nineteen hundred ninety-one, and on or
52 before the tenth day of March and the fifteenth day of June and Septem-
53 ber of such year, the commissioner shall, based on information supplied
54 by taxpayers and other appropriate sources, estimate the amount of the

1 utility credit authorized by section three hundred one-d of this article
2 which has been accrued to reduce tax liability under section one hundred
3 eighty-six-a of this chapter during the period covered by such estimate
4 and certify to the state comptroller such estimated amount. The comp-
5 troller shall forthwith, after receiving such certificate, deduct the
6 amount of such credit so certified by the commissioner prior to any
7 deposit or disposition of the taxes, interest and penalties collected or

14 setting forth the amount of any required adjustment to the amount of
15 actual credit usage previously certified. After receiving the certif-
16 icate of the commissioner with respect to actual credit usage or modifi-
17 cation of the same, the comptroller shall forthwith adjust general fund
18 receipts and the revenues to be deposited or disposed of under this
19 article to reflect the difference so certified by the commissioner. The
20 commissioner shall not be liable for any overestimate or underestimate

5 except kero-jet fuel when imported by an airline for use in its
6 airplanes, AND EXCEPT AVIATION GASOLINE SOLD FOR USE IN COMMERCIAL
7 AIRCRAFT AND GENERAL AVIATION AIRCRAFT.

8 S 5. Subparagraph (i) of paragraph 1 of subdivision (a) of section
9 1210 of the tax law, as amended by section 3 of part Z of chapter 59 of
10 the laws of 2015, is amended to read as follows:

11 (i) Any local law, ordinance or resolution enacted by any city of less
12 than one million or by any county or school district, imposing the taxes
13 authorized by this subdivision, shall, notwithstanding any provision of
14 law to the contrary, exclude from the operation of such local taxes all
15 sales of tangible personal property for use or consumption directly and
16 predominantly in the production of tangible personal property, gas,
17 electricity, refrigeration or steam, for sale, by manufacturing, proc-
18 essing, generating, assembly, refining, mining or extracting; and all
19 sales of tangible personal property for use or consumption predominantly
20 either in the production of tangible personal property, for sale, by

25 six of subdivision (a) or subdivision (d) of section eleven hundred
26 nineteen of this chapter.

27 S 6. Subparagraphs (xii) and (xiii) of paragraph 4 of subdivision (a)
28 of section 1210 of tax law, as amended by section 3 of part Z of chapter
29 59 of the laws of 2015, are amended and a new subparagraph (xiv) is
30 added to read as follows:

31 (xii) shall omit, unless such city elects otherwise, the exemption for
32 residential solar energy systems equipment and electricity provided in
33 subdivision (ee) of section eleven hundred fifteen of this chapter;
34 [and] (xiii) shall omit, unless such city elects otherwise, the
35 exemption for commercial solar energy systems equipment and electricity
36 provided in subdivision (ii) of section eleven hundred fifteen of this
37 chapter; AND (XIV) SHALL EXCLUDE FROM THE OPERATION OF SUCH LOCAL TAXES
38 ALL SALES OF FUEL SOLD FOR USE IN COMMERCIAL AIRCRAFT AND GENERAL
39 AVIATION AIRCRAFT. Any reference in this chapter or in any local law,
40 ordinance or resolution enacted pursuant to the authority of this arti-
41 cle to former subdivisions (n) or (p) of this section shall be deemed to
42 be a reference to clauses (xii) or (xiii) of this paragraph, respective-
43 ly, and any such local law, ordinance or resolution that provides the
44 exemptions provided in such former subdivisions (n) and/or (p) shall be
45 deemed instead to provide the exemptions provided in clauses (xii)
46 and/or (xiii) of this paragraph.

47 S 7. Notwithstanding any law to the contrary, the comptroller is here-
48 by authorized and directed to transfer from the general fund for deposit
49 into the mass transportation operating assistance fund, pursuant to
50 section 88-a of the state finance law and the dedicated mass transporta-
51 tion trust fund, pursuant to section 89-c of the state finance law, upon
52 request of the director of the budget, on or before March 31 of each
53 year, an amount equal to the amount of revenue received by the commis-
54 sioner of taxation and finance during the state fiscal year from petro-
55 leum business taxes imposed pursuant to the authority of section 301-e

11 Section 1. Subdivision 2 of section 228 of the racing, pari-mutuel
12 wagering and breeding law, as amended by chapter 18 of the laws of 2008,
13 the opening paragraph as amended by chapter 236 of the laws of 2015, is
14 amended to read as follows:

15 2. The New York state gaming commission shall, as a condition of
16 racing, require any franchised corporation and every other corporation
17 subject to its jurisdiction to withhold one percent of all purses,
18 except that for the franchised corporation, starting on September first,
19 two thousand seven and continuing through August thirty-first, two thou-
20 sand sixteen, two percent of all purses shall be withheld, and, in the
21 case of the franchised corporation, to pay such sum to the horsemen's
22 organization or its successor that was first entitled to receive
23 payments pursuant to this section in accordance with rules of the
24 commission adopted effective November third, nineteen hundred eighty-
25 three representing at least fifty-one percent of the owners and trainers
26 [utilizing] USING the facilities of such franchised corporation, on the
27 condition that such horsemen's organization shall expend [as much as is
28 necessary, but not to exceed] one-half of one percent of such total
29 sum[,] TO CONDUCT EQUINE DRUG TESTING RESEARCH AND to acquire and main-
30 tain the equipment required to [establish a program at a state college
31 within this state with an approved equine science program to] test for
32 the presence of DRUGS, INCLUDING BUT NOT LIMITED TO steroids, in horses
33 AT A SUITABLE LABORATORY, AS THE GAMING COMMISSION MAY DETERMINE IN ITS
34 DISCRETION, provided further that the qualified organization shall also,
35 in an amount to be determined by its board of directors, annually
36 include in its expenditures for benevolence programs, funds to support
37 an organization providing services necessary to backstretch employees,
38 and, in the case of every other corporation, to pay such one percent sum
39 of purses to the horsemen's organization or its successor that was first
40 entitled to receive payments pursuant to this section in accordance with
41 rules of the commission adopted effective May twenty-third, nineteen
42 hundred eighty-six representing at least fifty-one percent of the owners
43 and trainers [utilizing] USING the facilities of such corporation.

44 In either case, any other horsemen's organization may apply to the
45 [board] COMMISSION to be approved as the qualified organization to
46 receive payment of the one percent of all purses by submitting to the
47 [board] COMMISSION proof of both, that (i) it represents more than
48 fifty-one percent of all the owners and trainers [utilizing] USING the
49 same facilities and (ii) the horsemen's organization previously approved
50 as qualified by the [board] COMMISSION does not represent fifty-one
51 percent of all the owners and trainers [utilizing] USING the same facil-
52 ities. If the [board] COMMISSION is satisfied that the documentation
53 submitted with the application of any other horsemen's organization is

conclusive with respect to items (i) and (ii) of this paragraph, it may approve the applicant as the qualified recipient organization.

In the best interests of racing, upon receipt of such an application, the [board] COMMISSION may direct the payments to the previously qualified horsemen's organization to continue uninterrupted, or it may direct the payments to be withheld and placed in interest-bearing accounts for a period not to exceed ninety days, during which time the [board] COMMISSION shall review and approve or disapprove the application. Funds held in such manner shall be paid to the organization approved by the [board] COMMISSION. In no event shall the [board] COMMISSION accept more than one such application in any calendar year from the same horsemen's organization.

The funds authorized to be paid by the [board] COMMISSION are to be used exclusively for the benefit of those horsemen racing in New York state through the administrative purposes of such qualified organization, benevolent activities on behalf of backstretch employees, and for the promotion of equine research.

S 2. Section 902 of the racing, pari-mutuel wagering and breeding law, as amended by chapter 60 of the laws of 1993, subdivision 1 as amended by chapter 15 of the laws of 2010, and subdivision 2 as amended by chapter 18 of the laws of 2008, is amended to read as follows:

S 902. Equine drug testing and expenses. 1. In order to assure the public's confidence and continue the high degree of integrity in racing at the pari-mutuel betting tracks, equine drug testing at race meetings shall be conducted by a [state college within this state with an approved equine science program] SUITABLE LABORATORY, AS THE GAMING COMMISSION MAY DETERMINE IN ITS DISCRETION. The [state racing and wagering board] GAMING COMMISSION shall promulgate any rules and regulations necessary to implement the provisions of this section, including administrative penalties of loss of purse money, fines, or denial, suspension[,] or revocation of a license for racing drugged horses.

2. Notwithstanding any inconsistent provision of law, all costs and expenses of the [state racing and wagering board] GAMING COMMISSION for equine drug testing and research shall be paid from an appropriation from the state treasury, on the certification of the [chairman] CHAIR of the [state racing and wagering board] GAMING COMMISSION, upon the audit and warrant of the comptroller and pursuant to a plan developed by the [state racing and wagering board] GAMING COMMISSION as approved by the director of the budget.

S 3. This act shall take effect immediately; provided, however, section two of this act shall take effect upon expiration of an existing contract with a New York state college within the state with an approved equine science program, pursuant to section 902 of the racing, pari-mutuel wagering and breeding law; provided that the gaming commission shall notify the legislative bill drafting commission upon the occurrence of the enactment of the legislation provided for in section two of this act in order that the commission may maintain an accurate and timely effective data base of the official text of the laws of the state of New York in furtherance of effectuating the provisions of section 44 of the legislative law and section 70-b of the public officers law.

Section 1. Subdivision 1 of section 236 of the racing, pari-mutuel wagering and breeding law, as amended by chapter 18 of the laws of 2008, is amended to read as follows:

1 1. Every corporation authorized under this chapter to conduct pari-mu-
2 tuel betting at a race meeting on races run thereat, except as provided
3 in section two hundred thirty-eight of this article with respect to the
4 franchised corporation, shall distribute all sums deposited in any pari-
5 mutuel pool to the holders of winning tickets therein, providing such
6 tickets be presented for payment before April first of the year follow-
7 ing the year of their purchase, less an amount [which] THAT shall be
8 established and retained by such racing corporation of between fourteen
9 to twenty [per centum] PERCENT of the total deposits in pools resulting
10 from regular on-track bets and less sixteen to twenty-two [per centum]
11 PERCENT of the total deposits in pools resulting from multiple on-track
12 bets and less twenty to thirty [per centum] PERCENT of the total depos-
13 its in pools resulting from exotic on-track bets and less twenty to
14 thirty-six [per centum] PERCENT of the total pools resulting from super
15 exotic on-track bets, plus the breaks. The retention rate to be estab-
16 lished is subject to the prior approval of the [racing and wagering
17 board] GAMING COMMISSION. Such rate may not be changed more than once
18 per calendar quarter to be effective on the first day of the calendar
19 quarter. "Exotic bets" and "multiple bets" shall have the meanings set
20 forth in section five hundred nineteen of this chapter and breaks are
21 hereby defined as [the odd cents over any multiple of ten, or for exotic
22 bets over any multiple of fifty, or for super exotic bets, over any
23 multiple of one hundred, calculated on the basis of one dollar, other-
24 wise payable to a patron provided, however, that effective after October
25 fifteenth, nineteen hundred ninety-four breaks are hereby defined as]
26 the odd cents over any multiple of five for payoffs greater than one
27 dollar five cents but less than five dollars, over any multiple of ten
28 for payoffs greater than five dollars but less than twenty-five dollars,
29 over any multiple of twenty-five for payoffs greater than twenty-five
30 dollars but less than two hundred fifty dollars, or over any multiple of
31 fifty for payoffs over two hundred fifty dollars. "Super exotic bets"
32 shall have the meaning set forth in section three hundred one of this
33 chapter. Of the amount so retained there shall be paid by such corpo-
34 ration to the department of taxation and finance as a reasonable tax by
35 the state for the privilege of conducting pari-mutuel betting on the
36 races run at the race meeting held by such corporation, which tax is
37 hereby levied, the following percentages of the total pool, plus fifty-
38 five [per centum] PERCENT of the breaks; the applicable rates for regu-
39 lar and multiple bets shall be one and one-half [per centum] PERCENT;
40 the applicable rates for exotic bets shall be six and three-quarter [per
41 centum] PERCENT and the applicable rate for super exotic bets shall be
42 seven and three-quarter [per centum] PERCENT. Effective on and after
43 September first, nineteen hundred ninety-four, the applicable tax rate
44 shall be one [per centum] PERCENT of all wagers, provided that, an
45 amount equal to one-half the difference between the taxation rate for
46 on-track regular, multiple and exotic bets as of December thirty-first,
47 nineteen hundred ninety-three and the rates on such on-track wagers as
48 herein provided shall be used exclusively for purses. Provided, however,
49 that for any twelve-month period beginning on April first in nineteen
50 hundred ninety and any year thereafter, each of the applicable rates set
51 forth above shall be increased by one-quarter of one [per centum]
52 PERCENT on all on-track bets of any such racing corporation that did not
53 expend an amount equal to at least one-half of one [per centum] PERCENT
54 of its on-track bets during the immediately preceding calendar year for
55 enhancements consisting of capital improvements as defined by section
56 two hundred thirty-seven of this article, repairs to its physical plant,

1 structures, and equipment used in its racing or wagering operations as
2 certified by the [state racing and wagering board] GAMING COMMISSION to
3 the commissioner of taxation and finance no later than eighty days after
4 the close of such calendar year, and five special events at each track
5 in each calendar year, not otherwise conducted in the ordinary course of
6 business, the purpose of which shall be to encourage, attract and
7 promote track attendance and encourage new and continued patronage,
8 which events shall be [approved by the racing and wagering board]
9 SUBJECT TO THE PRIOR APPROVAL OF THE GAMING COMMISSION for purposes of
10 this subdivision. In the determination of the amounts expended for such
11 enhancements, the [board] GAMING COMMISSION may consider the immediately
12 preceding [twelve month] TWELVE-MONTH calendar period or the average of
13 the two immediately preceding [twelve month] TWELVE-MONTH calendar peri-
14 ods. Provided further, however, that of the portion of the increased
15 amounts retained by such corporation above those amounts retained in
16 nineteen hundred eighty-four, an amount of such increase shall be
17 distributed to purses in the same proportion as commissions and purses
18 were distributed during nineteen hundred eighty-four as certified by the
19 [board] GAMING COMMISSION. Such corporation in the second zone shall
20 receive a credit against the daily tax imposed by this subdivision in an
21 amount equal to FOUR-TENTHS OF one [per centum] PERCENT of total daily
22 pools resulting from the simulcast of such corporation's races to
23 licensed facilities operated by regional off-track betting corporations
24 in accordance with section one thousand eight of this chapter, provided
25 however, that sixty [per centum] PERCENT of the amount of such credit
26 shall be used exclusively to increase purses for overnight races
27 conducted by such corporation; and, provided further, that in no event
28 shall such total daily credit exceed FOUR-TENTHS OF one [per centum]
29 PERCENT of the total daily pool of such corporation. [Provided, however,
30 that on and after September first, nineteen hundred ninety-four such
31 credit shall be four-tenths percent of total daily pools resulting from
32 such simulcasting and that in no event shall such total daily credit
33 equal four-tenths percent of the total daily pool of such corporation.]

34 Such corporation shall pay to the New York state thoroughbred breeding
35 and development fund one-half of one [per centum] PERCENT of the total
36 daily on-track pari-mutuel pools from regular, multiple and exotic bets,
37 and three [per centum] PERCENT of super exotic bets. The corporation
38 shall receive credit as a reduction of the tax by the state for the
39 privilege of conducting pari-mutuel betting for the amounts, except
40 amounts paid from super exotic betting pools, paid to the New York state
41 thoroughbred breeding and development fund after January first, nineteen
42 hundred seventy-eight.

43 Such corporation shall distribute to purses an amount equal to fifty
44 [per centum] PERCENT of any compensation it receives from simulcasting
45 or from wagering conducted outside the United States. Such corporation
46 shall pay to the [racing and wagering board] GAMING COMMISSION as a
47 regulatory fee, which fee is hereby levied, [fifty hundredths]
48 SIX-TENTHS of one [per centum] PERCENT of the total daily on-track pari-
49 mutuel pools of such corporation.

50 S 2. Paragraph (d) of subdivision 1 of section 238 of the racing,
51 pari-mutuel wagering and breeding law, as amended by chapter 18 of the
52 laws of 2008, is amended to read as follows:

53 (d) (I) The pari-mutuel tax rate authorized by paragraph (a) of this
54 subdivision shall be effective so long as a franchised corporation noti-
55 fies the [racing and wagering board] GAMING COMMISSION by August
56 fifteenth of each year that such pari-mutuel tax rate is effective of

1 its intent to conduct a race meeting at Aqueduct racetrack during the
2 months of December, January, February, March and April. For purposes of
3 this paragraph such race meeting shall consist of not less than ninety-
4 five days of racing. Not later than May first of each year that such
5 pari-mutuel tax rate is effective, the [racing and wagering board]
6 GAMING COMMISSION shall determine whether a race meeting at Aqueduct
7 racetrack consisted of the number of days as required by this paragraph.
8 In determining the number of race days, cancellation of a race day
9 because of an act of God[, which] THAT the [racing and wagering board]
10 GAMING COMMISSION approves or because of weather conditions that are
11 unsafe or hazardous which the [racing and wagering board] GAMING COMMIS-
12 SION approves shall not be construed as a failure to conduct a race day.
13 Additionally, cancellation of a race day because of circumstances beyond
14 the control of such franchised corporation for which the [racing and
15 wagering board] GAMING COMMISSION gives approval shall not be construed
16 as a failure to conduct a race day. If the [racing and wagering board]
17 GAMING COMMISSION determines that the number of days of racing as
18 required by this paragraph have not occurred then the pari-mutuel tax
19 rate in paragraph (a) of this subdivision shall revert to the pari-mutu-
20 el tax rates in effect prior to January first, nineteen hundred ninety-
21 five.

22 (II) Such franchised corporation shall pay to the [racing and wagering
23 board] GAMING COMMISSION as a regulatory fee, which fee is hereby
24 levied, [fifty hundredths] SIX-TENTHS of one [per centum] PERCENT of the
25 total daily on-track pari-mutuel pools of such franchised corporation.

26 S 3. Paragraph d of subdivision 1 of section 318 of the racing, pari-
27 mutuel wagering and breeding law, as amended by section 3 of part B of

29 d. Every harness racing association or corporation shall pay to the
30 [board] GAMING COMMISSION as a regulatory fee, which fee is hereby
31 levied, [fifty hundredths] SIX-TENTHS of one percent of the total daily
32 on-track pari-mutuel pools of such association or corporation.

33 S 4. The opening paragraph and the opening paragraph of subdivision 1
34 of section 527 of the racing, pari-mutuel wagering and breeding law, the
35 opening paragraph as amended by chapter 18 of the laws of 2008 and the
36 opening paragraph of subdivision 1 as amended by chapter 300 of the laws
37 of 2015, are amended to read as follows:

38 Each regional corporation conducting off-track betting shall distrib-
39 ute all sums deposited in any pari-mutuel pool through such corporation
40 to the holders of winning tickets therein, providing such tickets be
41 presented for payment prior to April first of the year following the
42 year of their purchase, less an amount [which] THAT it shall retain at
43 the same rate established by the track accepting wagers from each such
44 regional corporation.

45 The disposition of the retained commission from pools resulting from
46 regular, multiple or exotic bets, as the case may be, whether placed on
47 races run within a region or outside a region, conducted by racing
48 corporations, harness racing associations or corporations, quarter horse
49 racing associations or corporations or races run outside the state shall
50 be governed by the tables in paragraphs a and b of this subdivision. The
51 rate denominated "state tax" shall represent the rate of a reasonable
52 tax imposed upon the retained commission for the privilege of conducting
53 off-track pari-mutuel betting, which tax is hereby levied and shall be
54 payable in the manner set forth in this section. Each off-track betting
55 corporation shall pay to the [racing and wagering board] GAMING COMMIS-
56 SION as a regulatory fee, which fee is hereby levied, [fifty hundredths]

SIX-TENTHS of one percent of the total daily pools of such corporation. Each corporation shall also pay twenty [per centum] PERCENT of the breaks derived from bets on harness races and fifty [per centum] PERCENT of the breaks derived from bets on all other races to the agriculture and New York State horse breeding and development fund and to the thoroughbred breeding and development fund, the total of such payments to be apportioned fifty [per centum] PERCENT to each such fund. For the purposes of this section, the New York city, Suffolk, Nassau, and the Catskill regions shall constitute a single region and any thoroughbred track located within the Capital District region shall be deemed to be within such single region. A "regional meeting" shall refer to either harness or thoroughbred meetings, or both, except that a franchised corporation shall not be a regional track for the purpose of receiving distributions from bets on thoroughbred races conducted by a thoroughbred track in the Catskill region conducting a mixed meeting. With the exception of a harness racing association or corporation first licensed to conduct pari-mutuel wagering at a track located in Tioga or Saratoga county after January first, two thousand five, racing corporations first licensed to conduct pari-mutuel racing after January first, nineteen hundred eighty-six or a harness racing association or corporation first licensed to conduct pari-mutuel wagering at a track located in Genesee County after January first, two thousand five, and quarter horse tracks shall not be "regional tracks"; if there is more than one harness track within a region, such tracks shall evenly divide payments made pursuant to the tables in paragraphs a and b of this subdivision when neither track is running. In the event a track elects to reduce its retained percentage from any or all of its pari-mutuel pools, the payments to the track holding the race and the regional track required by paragraphs a and b of this subdivision shall be reduced in proportion to such reduction. Nothing in this section shall be construed to authorize the conduct of off-track betting contrary to the provisions of section five hundred twenty-three of this article.

S 5. Paragraph a of subdivision 1 of section 904 of the racing, pari-mutuel wagering and breeding law, as amended by chapter 18 of the laws of 2008, are amended to read as follows:

a. The applicable state tax provided for in paragraphs a and b of subdivision one of section five hundred twenty-seven of this chapter shall be one-half [per centum] PERCENT for regular, multiple and exotic bets. Any harness racing or association or corporation, or thoroughbred racing corporation authorized pursuant to this section shall pay to the [racing and wagering board] GAMING COMMISSION as a regulatory fee, which fee is hereby levied, [fifty hundredths] SIX-TENTHS of one percent of the total daily pari-mutuel pools.

S 6. Paragraph g of subdivision 3 of section 1007 of the racing, pari-mutuel wagering and breeding law, as amended by chapter 18 of the laws of 2008, is amended to read as follows:

g. Any harness racing or association or corporation, or thoroughbred racing corporation authorized pursuant to this section shall pay to the [racing and wagering board] GAMING COMMISSION as a regulatory fee, which fee is hereby levied, [fifty hundredths] SIX-TENTHS of one percent of the total daily pari-mutuel pools.

S 7. Paragraph b of subdivision 3 of section 1008 of the racing, pari-mutuel wagering and breeding law, as amended by section 7 of part B of chapter 59 of the laws of 2005, is amended to read as follows:

b. Of the sums received by the sending track, fifty percent shall be distributed to purses in addition to moneys distributed pursuant to

1 section five hundred twenty-seven of this chapter. The off-track betting
2 corporation shall pay to the [racing and wagering board] GAMING COMMIS-
3 SION as a regulatory fee, which fee is hereby levied, [fifty hundredths]
4 SIX-TENTHS of one percent of the total daily pools.

5 S 8. Paragraph d of subdivision 4 of section 1009 of the racing, pari-
6 mutuel wagering and breeding law, as amended by section 8 of part B of
7 chapter 59 of the laws of 2005, is amended to read as follows:

8 d. The operator shall pay to the [racing and wagering board] GAMING
9 COMMISSION as a regulatory fee, which fee is hereby levied, [fifty
10 hundredths] SIX-TENTHS of one percent of the total daily pools.

11 S 9. Subparagraph (iv) of paragraph i of subdivision 1 of section 1014
12 of the racing, pari-mutuel wagering and breeding law, as amended by
13 chapter 18 of the laws of 2008, is amended to read as follows:

14 (iv) Any thoroughbred racing corporation or harness racing association
15 or corporation or off-track betting corporation authorized pursuant to
16 this section shall pay to the [racing and wagering board] GAMING COMMIS-
17 SION as a regulatory fee, which fee is hereby levied, [fifty hundredths]
18 SIX-TENTHS of one percent of all wagering pools.

19 S 10. Paragraph e of subdivision 3 of section 1015 of the racing,
20 pari-mutuel wagering and breeding law, as amended by chapter 18 of the
21 laws of 2008, is amended to read as follows:

22 e. Any thoroughbred racing corporation or harness racing association
23 or corporation or off-track betting corporation authorized pursuant to
24 this section shall pay to the [racing and wagering board] GAMING COMMIS-
25 SION as a regulatory fee, which fee is hereby levied, [fifty hundredths]
26 SIX-TENTHS of one percent of all wagering pools.

27 S 11. Clause (B) of subparagraph 2 of paragraph b of subdivision 1 of
28 section 1016 of the racing, pari-mutuel wagering and breeding law, as
29 amended by chapter 18 of the laws of 2008, is amended to read as
30 follows:

31 (B) Any harness racing or association or corporation or thoroughbred
32 racing corporation authorized pursuant to this section shall pay to the
33 [racing and wagering board] GAMING COMMISSION as a regulatory fee, which
34 fee is hereby levied, [fifty hundredths] SIX-TENTHS of one percent of
35 the total daily pari-mutuel pools.

36 S 12. Paragraph b of subdivision 2 of section 1018 of the racing,
37 pari-mutuel wagering and breeding law, as amended by chapter 18 of the
38 laws of 2008, is amended to read as follows:

39 b. Any thoroughbred racing corporation or harness racing association
40 or corporation or off-track betting corporation shall pay to the [racing
41 and wagering board] GAMING COMMISSION as a regulatory fee, which fee is
42 hereby levied, [fifty hundredths] SIX-TENTHS of one percent of all
43 wagering pools.

44 S 13. Paragraph 2 of subdivision b of section 1612 of the tax law, as
45 amended by section 1 of part 00 of chapter 59 of the laws of 2014, is

47 2. As consideration for the operation of a video lottery gaming facil-
48 ity, the division, shall cause the investment in the racing industry of
49 a portion of the vendor fee received pursuant to paragraph one of this
50 subdivision in the manner set forth in this subdivision. With the
51 exception of Aqueduct racetrack or a facility in the county of Nassau or
52 Suffolk operated by a corporation established pursuant to section five
53 hundred two of the racing, pari-mutuel wagering and breeding law, each
54 such track shall dedicate a portion of its vendor fees, received pursu-
55 ant to clause (A), (B), (C), (D), (E), (F), or (G) of subparagraph (ii)

28 sixty miles from any gaming facility in a contiguous state such vendor
29 fee shall, for a period of [eight] NINE years commencing April first,
30 two thousand eight, be at a rate of forty-one percent of the total
31 revenue wagered at the vendor track after payout for prizes pursuant to
32 this chapter, after which time such rate shall be as for all tracks in
33 clause (C) of this subparagraph.

34 S 2. This act shall take effect immediately and shall be deemed to
35 have been in full force and effect on and after April 1, 2016.

PART FF

37 Section 1. Paragraph (a) of subdivision 1 of section 1003 of the
38 racing, pari-mutuel wagering and breeding law, as amended by section 1
39 of part NN of chapter 59 of the laws of 2015, is amended to read as
40 follows:

41 (a) Any racing association or corporation or regional off-track
42 betting corporation, authorized to conduct pari-mutuel wagering under
43 this chapter, desiring to display the simulcast of horse races on which
44 pari-mutuel betting shall be permitted in the manner and subject to the
45 conditions provided for in this article may apply to the commission for
46 a license so to do. Applications for licenses shall be in such form as
47 may be prescribed by the commission and shall contain such information
48 or other material or evidence as the commission may require. No license
49 shall be issued by the commission authorizing the simulcast transmission
50 of thoroughbred races from a track located in Suffolk county. The fee
51 for such licenses shall be five hundred dollars per simulcast facility
52 and for account wagering licensees that do not operate either a simul-

1 cast facility that is open to the public within the state of New York or
2 a licensed racetrack within the state, twenty thousand dollars per year
3 payable by the licensee to the commission for deposit into the general
4 fund. Except as provided in this section, the commission shall not
5 approve any application to conduct simulcasting into individual or group
6 residences, homes or other areas for the purposes of or in connection
7 with pari-mutuel wagering. The commission may approve simulcasting into
8 residences, homes or other areas to be conducted jointly by one or more
9 regional off-track betting corporations and one or more of the follow-
10 ing: a franchised corporation, thoroughbred racing corporation or a
11 harness racing corporation or association; provided (i) the simulcasting
12 consists only of those races on which pari-mutuel betting is authorized
13 by this chapter at one or more simulcast facilities for each of the
14 contracting off-track betting corporations which shall include wagers
15 made in accordance with section one thousand fifteen, one thousand
16 sixteen and one thousand seventeen of this article; provided further
17 that the contract provisions or other simulcast arrangements for such
18 simulcast facility shall be no less favorable than those in effect on
19 January first, two thousand five; (ii) that each off-track betting
20 corporation having within its geographic boundaries such residences,
21 homes or other areas technically capable of receiving the simulcast
22 signal shall be a contracting party; (iii) the distribution of revenues
23 shall be subject to contractual agreement of the parties except that
24 statutory payments to non-contracting parties, if any, may not be
25 reduced; provided, however, that nothing herein to the contrary shall
26 prevent a track from televising its races on an irregular basis primari-
27 ly for promotional or marketing purposes as found by the commission. For
28 purposes of this paragraph, the provisions of section one thousand thir-
29 teen of this article shall not apply. Any agreement authorizing an
30 in-home simulcasting experiment commencing prior to May fifteenth, nine-
31 teen hundred ninety-five, may, and all its terms, be extended until June
32 thirtieth, two thousand [sixteen] SEVENTEEN; provided, however, that any
33 party to such agreement may elect to terminate such agreement upon
34 conveying written notice to all other parties of such agreement at least
35 forty-five days prior to the effective date of the termination, via
36 registered mail. Any party to an agreement receiving such notice of an
37 intent to terminate, may request the commission to mediate between the
38 parties new terms and conditions in a replacement agreement between the
39 parties as will permit continuation of an in-home experiment until June
40 thirtieth, two thousand [sixteen] SEVENTEEN; and (iv) no in-home simul-
41 casting in the thoroughbred special betting district shall occur without
42 the approval of the regional thoroughbred track.

43 S. 2. Subparagraph (iii) of paragraph d of subdivision 3 of section
44 1007 of the racing, pari-mutuel wagering and breeding law, as amended by
45 section 2 of part NN of chapter 59 of the laws of 2015, is amended to
46 read as follows:

47 (iii) Of the sums retained by a receiving track located in Westchester
48 county on races received from a franchised corporation, for the period
49 commencing January first, two thousand eight and continuing through June
50 thirtieth, two thousand [sixteen] SEVENTEEN, the amount used exclusively
51 for purses to be awarded at races conducted by such receiving track
52 shall be computed as follows: of the sums so retained, two and one-half
53 percent of the total pools. Such amount shall be increased or decreased
54 in the amount of fifty percent of the difference in total commissions
55 determined by comparing the total commissions available after July twen-
56 ty-first, nineteen hundred ninety-five to the total commissions that

1 would have been available to such track prior to July twenty-first,
2 nineteen hundred ninety-five.

3 S 3. The opening paragraph of subdivision 1 of section 1014 of the
4 racing, pari-mutuel wagering and breeding law, as amended by section 3
5 of part NN of chapter 59 of the laws of 2015, is amended to read as
6 follows:

7 The provisions of this section shall govern the simulcasting of races
8 conducted at thoroughbred tracks located in another state or country on
9 any day during which a franchised corporation is conducting a race meet-
10 ing in Saratoga county at Saratoga thoroughbred racetrack until June
11 thirtieth, two thousand [sixteen] SEVENTEEN and on any day regardless of
12 whether or not a franchised corporation is conducting a race meeting in
13 Saratoga county at Saratoga thoroughbred racetrack after June thirtieth,
14 two thousand [sixteen] SEVENTEEN. On any day on which a franchised
15 corporation has not scheduled a racing program but a thoroughbred racing
16 corporation located within the state is conducting racing, every off-
17 track betting corporation branch office and every simulcasting facility
18 licensed in accordance with section one thousand seven (that have
19 entered into a written agreement with such facility's representative
20 horsemen's organization, as approved by the commission), one thousand
21 eight, or one thousand nine of this article shall be authorized to
22 accept wagers and display the live simulcast signal from thoroughbred
23 tracks located in another state or foreign country subject to the
24 following provisions:

25 S 4. Subdivision 1 of section 1015 of the racing, pari-mutuel wagering
26 and breeding law, as amended by section 4 of part NN of chapter 59 of
27 the laws of 2015, is amended to read as follows:

28 1. The provisions of this section shall govern the simulcasting of
29 races conducted at harness tracks located in another state or country
30 during the period July first, nineteen hundred ninety-four through June
31 thirtieth, two thousand [sixteen] SEVENTEEN. This section shall super-
32 sede all inconsistent provisions of this chapter.

33 S 5. The opening paragraph of subdivision 1 of section 1016 of the
34 racing, pari-mutuel wagering and breeding law, as amended by section 5
35 of part NN of chapter 59 of the laws of 2015, is amended to read as
36 follows:

37 The provisions of this section shall govern the simulcasting of races
38 conducted at thoroughbred tracks located in another state or country on
39 any day during which a franchised corporation is not conducting a race
40 meeting in Saratoga county at Saratoga thoroughbred racetrack until June
41 thirtieth, two thousand [sixteen] SEVENTEEN. Every off-track betting
42 corporation branch office and every simulcasting facility licensed in
43 accordance with section one thousand seven that have entered into a
44 written agreement with such facility's representative horsemen's organ-
45 ization as approved by the commission, one thousand eight or one thou-
46 sand nine of this article shall be authorized to accept wagers and
47 display the live full-card simulcast signal of thoroughbred tracks
48 (which may include quarter horse or mixed meetings provided that all
49 such wagering on such races shall be construed to be thoroughbred races)
50 located in another state or foreign country, subject to the following
51 provisions; provided, however, no such written agreement shall be
52 required of a franchised corporation licensed in accordance with section
53 one thousand seven of this article:

54 S 6. The opening paragraph of section 1018 of the racing, pari-mutuel
55 wagering and breeding law, as amended by section 6 of part NN of chapter
56 59 of the laws of 2015, is amended to read as follows:

1 Notwithstanding any other provision of this chapter, for the period
2 July twenty-fifth, two thousand one through September eighth, two thou-
3 sand [fifteen] SIXTEEN, when a franchised corporation is conducting a
4 race meeting within the state at Saratoga Race Course, every off-track
5 betting corporation branch office and every simulcasting facility
6 licensed in accordance with section one thousand seven (that has entered
7 into a written agreement with such facility's representative horsemen's
8 organization as approved by the commission), one thousand eight or one
9 thousand nine of this article shall be authorized to accept wagers and
10 display the live simulcast signal from thoroughbred tracks located in
11 another state, provided that such facility shall accept wagers on races
12 run at all in-state thoroughbred tracks which are conducting racing
13 programs subject to the following provisions; provided, however, no such
14 written agreement shall be required of a franchised corporation licensed
15 in accordance with section one thousand seven of this article.

16 S 7. Section 32 of chapter 281 of the laws of 1994, amending the
17 racing, pari-mutuel wagering and breeding law and other laws relating
18 to simulcasting, as amended by section 7 of part NN of chapter 59 of the
19 laws of 2015, is amended to read as follows:

20 S 32. This act shall take effect immediately and the pari-mutuel tax
21 reductions in section six of this act shall expire and be deemed
22 repealed on July 1, [2016] 2017; provided, however, that nothing
23 contained herein shall be deemed to affect the application, qualifica-
24 tion, expiration, or repeal of any provision of law amended by any
25 section of this act, and such provisions shall be applied or qualified
26 or shall expire or be deemed repealed in the same manner, to the same
27 extent and on the same date as the case may be as otherwise provided by
28 law; provided further, however, that sections twenty-three and twenty-

40 be deemed repealed on July 1, [2016] 2017; and section eighteen of this

44 S 9. Paragraph (a) of subdivision 1 of section 238 of the racing,
45 pari-mutuel wagering and breeding law, as amended by section 9 of part
46 NN of chapter 59 of the laws of 2015, is amended to read as follows:

47 (a) The franchised corporation authorized under this chapter to
48 conduct pari-mutuel betting at a race meeting or races run thereat shall
49 distribute all sums deposited in any pari-mutuel pool to the holders of
50 winning tickets therein, provided such tickets be presented for payment
51 before April first of the year following the year of their purchase,
52 less an amount which shall be established and retained by such fran-
53 chised corporation of between twelve to seventeen per centum of the
54 total deposits in pools resulting from on-track regular bets, and four-
55 teen to twenty-one per centum of the total deposits in pools resulting
56 from on-track multiple bets and fifteen to twenty-five per centum of the

1 total deposits in pools resulting from on-track exotic bets and fifteen

8 hundred nineteen of this chapter. "Super exotic bets" shall have the
9 meaning set forth in section three hundred one of this chapter. For
10 purposes of this section, a "pick six bet" shall mean a single bet or
11 wager on the outcomes of six races. The breaks are hereby defined as the
12 odd cents over any multiple of five for payoffs greater than one dollar
13 five cents but less than five dollars, over any multiple of ten for
14 payoffs greater than five dollars but less than twenty-five dollars,
15 over any multiple of twenty-five for payoffs greater than twenty-five
16 dollars but less than two hundred fifty dollars, or over any multiple of
17 fifty for payoffs over two hundred fifty dollars. Out of the amount so
18 retained there shall be paid by such franchised corporation to the
19 commissioner of taxation and finance, as a reasonable tax by the state
20 for the privilege of conducting pari-mutuel betting on the races run at
21 the race meetings held by such franchised corporation, the following
22 percentages of the total pool for regular and multiple bets five per
23 centum of regular bets and four per centum of multiple bets plus twenty
24 per centum of the breaks; for exotic wagers seven and one-half per
25 centum plus twenty per centum of the breaks, and for super exotic bets
26 seven and one-half per centum plus fifty per centum of the breaks. For
27 the period June first, nineteen hundred ninety-five through September
28 ninth, nineteen hundred ninety-nine, such tax on regular wagers shall be
29 three per centum and such tax on multiple wagers shall be two and one-
30 half per centum, plus twenty per centum of the breaks. For the period
31 September tenth, nineteen hundred ninety-nine through March thirty-
32 first, two thousand one, such tax on all wagers shall be two and six-
33 tenths per centum and for the period April first, two thousand one
34 through December thirty-first, two thousand [sixteen] SEVENTEEN, such
35 tax on all wagers shall be one and six-tenths per centum, plus, in each
36 such period, twenty per centum of the breaks. Payment to the New York
37 state thoroughbred breeding and development fund by such franchised
38 corporation shall be one-half of one per centum of total daily on-track
39 pari-mutuel pools resulting from regular, multiple and exotic bets and
40 three per centum of super exotic bets provided, however, that for the
41 period September tenth, nineteen hundred ninety-nine through March thir-
42 ty-first, two thousand one, such payment shall be six-tenths of one per
43 centum of regular, multiple and exotic pools and for the period April
44 first, two thousand one through December thirty-first, two thousand
45 [sixteen] SEVENTEEN, such payment shall be seven-tenths of one per
46 centum of such pools.
47 S 10. This act shall take effect immediately.

49 Section 1. Clause (H) of subparagraph (ii) of paragraph 1 of subdivi-
50 sion b of section 1612 of the tax law, as amended by section 1 of part
51 MM of chapter 59 of the laws of 2015, is amended to read as follows:
52 (H) notwithstanding clauses (A), (B), (C), (D), (E), (F) and (G) of
53 this subparagraph, the track operator of a vendor track shall be eligi-
54 ble for a vendor's capital award of up to four percent of the total

1 revenue wagered at the vendor track after payout for prizes pursuant to
2 this chapter, which shall be used exclusively for capital project
3 investments to improve the facilities of the vendor track which promote
4 or encourage increased attendance at the video lottery gaming facility
5 including, but not limited to hotels, other lodging facilities, enter-
6 tainment facilities, retail facilities, dining facilities, events
7 arenas, parking garages and other improvements that enhance facility
8 amenities; provided that such capital investments shall be approved by

17 thousand one hundred video gaming machines, and except for a vendor
18 track located west of State Route 14 from Sodus Point to the Pennsylv-

20 co-invest an amount of capital expenditure equal to its cumulative
21 vendor's capital award. For all tracks, except for Aqueduct racetrack,
22 the amount of any vendor's capital award that is not used during any one
23 year period may be carried over into subsequent years ending before
24 April first, two thousand [sixteen] SEVENTEEN. Any amount attributable
25 to a capital expenditure approved prior to April first, two thousand
26 [sixteen]SEVENTEEN and completed before April first, two thousand [eigh-
27 teen] NINETEEN; or approved prior to April first, two thousand [twenty]
28 TWENTY-ONE and completed before April first, two thousand [twenty-two]
29 TWENTY-THREE for a vendor track located west of State Route 14 from
30 Sodus Point to the Pennsylvania border within New York, shall be eligi-
31 ble to receive the vendor's capital award. In the event that a vendor
32 track's capital expenditures, approved by the division prior to April
33 first, two thousand [sixteen] SEVENTEEN and completed prior to April
34 first, two thousand [eighteen] NINETEEN, exceed the vendor track's cumu-
35 lative capital award during the five year period ending April first, two
36 thousand [sixteen] SEVENTEEN, the vendor shall continue to receive the
37 capital award after April first, two thousand [sixteen] SEVENTEEN until
38 such approved capital expenditures are paid to the vendor track subject
39 to any required co-investment. In no event shall any vendor track that
40 receives a vendor fee pursuant to clause (F) or (G) of this subparagraph
41 be eligible for a vendor's capital award under this section. Any opera-
42 tor of a vendor track which has received a vendor's capital award,
43 choosing to divest the capital improvement toward which the award was
44 applied, prior to the full depreciation of the capital improvement in
45 accordance with generally accepted accounting principles, shall reim-
46 burse the state in amounts equal to the total of any such awards. Any
47 capital award not approved for a capital expenditure at a video lottery
48 gaming facility by April first, two thousand [sixteen] SEVENTEEN shall
49 be deposited into the state lottery fund for education aid; and
50 S 2. This act shall take effect immediately.

8 (G) Notwithstanding any provision to the contrary, when a vendor track
9 is located within regions one, two, or five of development zone two as
10 defined by section thirteen hundred ten of the racing, pari-mutuel
11 wagering and breeding law, such vendor track shall receive an additional
12 commission at a rate equal to the percentage of revenue wagered at the
13 vendor track after payout for prizes pursuant to this chapter, WHICH
14 PERCENTAGE SHALL BE ONE HUNDRED, less [ten percent] THE SUM OF THE
15 PERCENTAGES OF NET REVENUE WAGERED AT THE VENDOR TRACK retained by the
16 commission for operation, administration, and procurement purposes; and
17 [payment of] the vendor's fee, marketing allowance[,] and capital award
18 paid TO THE VENDOR TRACK pursuant to this chapter; and the effective tax
19 rate paid on all gross gaming revenue paid by a gaming facility within
20 the same region pursuant to section thirteen hundred fifty-one of the
21 racing, pari-mutuel wagering and breeding law, PROVIDED, HOWEVER, SUCH
22 ADDITIONAL COMMISSION SHALL BE APPLIED TO REVENUE WAGERED AT THE VENDOR
23 TRACK AFTER PAYOUT FOR PRIZES ONLY WHILE A GAMING FACILITY IN THE SAME
24 REGION IS OPEN AND OPERATIONAL PURSUANT TO AN OPERATION CERTIFICATE
25 ISSUED PURSUANT TO SECTION THIRTEEN HUNDRED THIRTY-ONE OF THE RACING,
26 PARI-MUTUEL WAGERING AND BREEDING LAW. The additional commission SET
27 FORTH IN THIS CLAUSE shall be paid to the vendor track within sixty days
28 after the conclusion of the state fiscal year based on the calculated
29 percentage during the previous fiscal year.

30 S 3. This act shall take effect immediately and shall be deemed to
31 have been in full force and effect on and after January 1, 2014.

32 S 2. Severability clause. If any clause, sentence, paragraph, subdivi-
33 sion, section or part of this act shall be adjudged by any court of
34 competent jurisdiction to be invalid, such judgment shall not affect,
35 impair, or invalidate the remainder thereof, but shall be confined in
36 its operation to the clause, sentence, paragraph, subdivision, section
37 or part thereof directly involved in the controversy in which such judg-
38 ment shall have been rendered. It is hereby declared to be the intent of
39 the legislature that this act would have been enacted even if such
40 invalid provisions had not been included herein.

41 S 3. This act shall take effect immediately provided, however, that
