AN ACT to amend the education law, in relation to establishing that all school districts are approved evaluators of preschool students suspected of having a disability

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraphs (a) and (c) of subdivision 9-a of section 4410 2 of the education law, paragraph (a) as amended by chapter 581 of the 3 laws of 2011 and paragraph (c) as added by chapter 82 of the laws of 4 1995, are amended to read as follows:

5 (a) A [school district or a] group of appropriately licensed and/or б certified professionals associated with a public or private agency may 7 apply to the commissioner for approval as an evaluator on a form prescribed by the commissioner. The commissioner shall approve evalu-ators pursuant to this subdivision consistent with the approval process 8 9 10 the multi-disciplinary evaluation component of programs approved for pursuant to subdivision nine of this section consistent with regulations 11 adopted pursuant to such subdivision. ALL SCHOOL DISTRICTS ARE DEEMED 12 13 APPROVED EVALUATORS OF PRESCHOOL STUDENTS SUSPECTED OF HAVING A DISABIL-ITY WITHOUT THE NEED TO SUBMIT AN APPLICATION TO THE COMMISSIONER. 14

15 Such application shall include, but not be limited to, a description of the multi-disciplinary evaluation services proposed to be provided 16 and a demonstration that all agency employees and staff who provide such 17 18 evaluation services shall have appropriate licensure and/or certification and that the individual who shall have direct supervision 19 20 responsibilities over such staff shall have an appropriate level of 21 experience in providing evaluation or services to preschool or kindergarten-aged children with disabilities. To be eligible for approval as 22 an evaluator under this subdivision on and after July first, two thou-23 sand eleven, 24 a group of appropriately licensed or certified profes-25 sionals shall be formed as a limited liability company or professional 26 services corporation established pursuant to article fifteen of the business corporation law, article twelve or thirteen of the 27 limited

1 liability company law or article eight-B of the partnership law. The 2 approval of any groups of licensed or certified professionals that are 3 in existence on July first, two thousand eleven and would not be eligi-4 ble for approval thereafter shall terminate on July first, two thousand 5 thirteen.

б (c) The commissioner shall establish a billing and reimbursement 7 system for services provided by SCHOOL DISTRICTS AND evaluators approved 8 pursuant to the provisions of this subdivision consistent with billing and reimbursement for evaluation services provided by evaluators 9 10 approved pursuant to the provisions of subdivision nine of this section. S 2. This act shall take effect immediately; provided, however, that 11 the amendments to subdivision 9-a of section 4410 of the education law 12 made by section one of this act shall not affect the expiration of such 13 section and shall be deemed to expire therewith. 14
