AN ACT to amend the public health law, in relation to reporting of opioid overdose data; and providing for the repeal of certain provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision 5 of section 3309 of the public health law, as  
2 amended by chapter 42 of the laws of 2014, is amended and a new subdivi-  
3 sion 6 is added to read as follows:  
4 5. The commissioner shall publish findings on statewide opioid over-  
5 dose data that reviews overdose death rates and other information to  
6 ascertain changes in the cause and rates of OPIOID OVERDOSES, INCLUDING  
7 fatal opioid overdoses. The report [may be part of existing state  
8 mortality reports issued by the department, and] shall be submitted  
9 annually, ON OR BEFORE OCTOBER FIRST, to the governor, the temporary  
10 president of the senate, the speaker of the assembly[, ] and the chairs  
11 of the senate and assembly health committees, AND SHALL BE MADE PUBLIC  
12 ON THE DEPARTMENT'S INTERNET WEBSITE. The report shall include, at a  
13 minimum, the following information ON A COUNTY BASIS:  
14 (a) information on opioid OVERDOSES AND OPIOID overdose deaths,  
15 including age, gender, ethnicity, and geographic location;  
16 (b) data on emergency room utilization for the treatment of opioid  
17 overdose;  
18 (c) data on utilization of pre-hospital services;  
19 (d) data on THE DISPENSING AND utilization of opioid antagonists; and  
20 (e) any other information necessary to ascertain the success of the  
21 program, AREAS OF THE STATE WHICH ARE EXPERIENCING PARTICULARLY HIGH  
22 RATES OF OVERDOSES, WAYS TO DETERMINE IF SERVICES, RESOURCES AND  
23 RESPONSES IN PARTICULAR AREAS OF THE STATE ARE HAVING A POSITIVE IMPACT  
24 ON REDUCING OVERDOSES, and ways to further reduce overdoses.

1 6. THE COMMISSIONER SHALL PROVIDE THE CURRENT INFORMATION AND DATA  
2 SPECIFIED IN SUBDIVISION FIVE OF THIS SECTION TO EACH COUNTY ON A MONTH-  
3 LY BASIS. SUCH INFORMATION AND DATA MAY BE UTILIZED BY A COUNTY OR ANY  
4 COMBINATION THEREOF AS IT WORKS TO ADDRESS THE OPIOID EPIDEMIC.

5 S 2. This act shall take effect immediately, provided that subdivision  
6 6 of section 3309 of the public health law, as added by section one of  
7 this act, shall expire and be deemed repealed March 31, 2021.
