AN ACT to amend the public health law, in relation to designating certain substances as schedule I opiates; and to amend the penal law, in relation to the sale of preparations, compounds mixtures and substances containing heroin and an opiate

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision (b) of schedule I of section 3306 of the public  
2 health law is amended by adding three new paragraphs 56, 57 and 58 to  
3 read as follows:

4 (56) ACETYLFENTANYL (N-(1-PHENETHYLPIPERIDIN-4-YL)-N-PHENYLACETAMIDE).

5 (57) BUTYRYL FENTANYL (N- (L-PHENETHYLPIPERIDIN-4-YL) -N-PHENYLBUTYR-  
6 AMIDE), ITS ISOMERS, ESTERS, ETHERS, SALTS AND SALTS OF ISOMERS, ESTERS  
7 AND ETHERS.

8 (58) BETA-HYDROXYTHIOFENTANYL(N-[1-[2-HYDROXY-2-(THIOPEN-2-YL)ETHYL]  
9 PIPERIDIN-4-YL]-N-PHENYLPROPIONAMIDE), ITS ISOMERS, ESTERS, ETHERS,  
10 SALTS AND SALTS OF ISOMERS, ESTERS AND ETHERS.

11 S 2. Subdivision 7 of section 220.41 of the penal law, as amended by  
12 chapter 75 of the laws of 1995, is amended and a new subdivision 8 is  
13 added to read as follows:

14 7. methadone and the methadone weighs three hundred sixty milligrams  
15 or more[.]; OR

16 8. ONE OR MORE PREPARATIONS, COMPOUNDS, MIXTURES OR SUBSTANCES  
17 CONTAINING HEROIN AND AN OPIATE, DEFINED IN SUBDIVISION (B) OF SCHEDULE  
18 I OF SECTION THIRTY-THREE HUNDRED SIX OF THE PUBLIC HEALTH LAW, AND THE  
19 PREPARATIONS, COMPOUNDS, MIXTURES OR SUBSTANCES ARE OF AN AGGREGATE  
20 WEIGHT OF ONE-QUARTER OUNCE OR MORE.

21 S 3. Subdivision 2 of section 220.43 of the penal law, as amended by  
22 chapter 75 of the laws of 1995, is amended and a new subdivision 3 is  
23 added to read as follows:

1 2. methadone and the methadone weighs two thousand eight hundred

3 3. ONE OR MORE PREPARATIONS, COMPOUNDS, MIXTURES OR SUBSTANCES  
4 CONTAINING HEROIN AND AN OPIATE, DEFINED IN SUBDIVISION (B) OF SCHEDULE  
5 I OF SECTION THIRTY-THREE HUNDRED SIX OF THE PUBLIC HEALTH LAW, AND THE  
6 PREPARATIONS, COMPOUNDS, MIXTURES OR SUBSTANCES ARE OF AN AGGREGATE  
7 WEIGHT OF ONE OUNCE OR MORE.

8 S 4. This act shall take effect on the ninetieth day after it shall  
9 have become a law.
