AN ACT to amend the environmental conservation law, in relation to hunting in the county of Broome

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907
2 of the environmental conservation law, as amended by chapter 73 of the
3 laws of 2015, is amended to read as follows:

50 section 11-0907 of the environmental conservation law made by section
51 two of this act shall be subject to the expiration and reversion of such
52 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as
53 amended, when upon such date section three of this act shall take
54 effect.
