AN ACT to amend the election law, in relation to publishing certain candidate website information

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The election law is amended by adding a new section 4-123
2 to read as follows:
3 S 4-123. PUBLICATION OF CANDIDATE WEBSITES. 1. THE STATE BOARD OF
4 ELECTIONS SHALL PUBLISH ON ITS WEBSITE THE CAMPAIGN WEBSITE ADDRESS
5 DESIGNATED BY THE GOVERNOR, LIEUTENANT GOVERNOR, ATTORNEY GENERAL, STATE
6 COMPTROLLER, MEMBER OF THE STATE SENATE AND MEMBER OF THE STATE ASSEMBLY
7 ON THE BALLOT AT THE NEXT PRIMARY, SPECIAL OR GENERAL ELECTION, EXCEPT
8 AS PROVIDED IN SUBDIVISION TWO OF THIS SECTION. SUCH CANDIDATE MAY NOTI-
9 FY THE STATE BOARD OF ELECTIONS OF HIS OR HER WEBSITE ADDRESS ON SUCH
10 CANDIDATE'S PETITION COVER SHEET OR IN A SEPARATE WRITING SIGNED BY THE
11 CANDIDATE. ANY CANDIDATE WHO DOES NOT PROVIDE A WEBSITE ADDRESS SHALL BE
12 LISTED AS HAVING NOT PROVIDED A WEBSITE ADDRESS FOR PUBLICATION.
13 2. THE STATE BOARD OF ELECTIONS SHALL NOT PUBLISH ANY WEBSITE ADDRESS
14 FOUND TO BE UNRELATED TO A CANDIDACY FOR PUBLIC OFFICE. SUCH DENIAL TO
15 PUBLISH A WEBSITE ADDRESS SHALL BE REVIEWED ONLY IN A SPECIAL PROCEEDING
16 BROUGHT BY THE CANDIDATE PURSUANT TO ARTICLE SEVENTY-EIGHT OF THE CIVIL
17 PRACTICE LAW AND RULES.
18 3. THE STATE BOARD OF ELECTIONS SHALL PROMINENTLY DISPLAY THE FOLLOW-
19 ING DISCLAIMER WITH RELATION TO THE LIST OF CANDIDATE WEBSITE ADDRESSES:
20 "THE WEBSITE ADDRESSES PUBLISHED HERE ARE DESIGNATED BY THE CANDIDATE.
21 THE STATE BOARD OF ELECTIONS IS NOT RESPONSIBLE FOR AND EXPRESSES NO
22 OPINION AS TO THE CONTENT OF CANDIDATE WEBSITES."
23 S 2. The state board of elections shall, within six months of the
24 effective date of this act, promulgate rules or regulations to implement
25 the provisions of this act which shall include the time of publication
26 and the format for publication of the list of website addresses and
