AN ACT to amend the executive law, in relation to designating the Claverack Creek, the Taghkanic Creek and the Agawamuck Creek as parts of the inland waterway system

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 4 of section 911 of the executive law, as amended by chapter 133 of the laws of 2012, paragraph (a) as separately amended by chapters 92 and 97 of the laws of 2015, paragraph (b) as separately amended by chapters 95, 96 and 97 of the laws of 2015 and paragraph (c) as amended by chapter 98 of the laws of 2015, is amended to read as follows:

7 "Inland waterways" shall mean (a) the state's major inland lakes 8 consisting of lakes Ballston, Big Tupper, Black, Campfire, Canadarago, 9 Canandaigua, Cayuga, Champlain, Chateaugay, Chautauqua, Conesus, Cranberry, Echo (in the county of Westchester), George, Great Sacandaga, 10 Indian, Keuka, Long, Mirror, Oneida, Onondaga, Otisco, Otsego, 11 Honeoye, Owasco, Peach, Placid, Raquette, Ronkonkoma, Sacandaga, 12 13 Skaneateles, Silver (in the county of Wyoming) and Schroon, Seneca, Saranac, and the Fulton chain of lakes; (b) the state's major rivers 14 15 comprised of the Allegheny, Ausable, Battenkill, Black, Boquet, Bronx, Canisteo, Chaumont (including Chaumont bay), Chemung, Cohocton, 16 Genesee, Grasse, Great Chazy, Hoosic, Hudson north of the 17 ware, Deer, 18 federal dam at Troy, Indian, Little (in the Adirondack park), Little Ausable, Little Salmon (including north and south branches), Mad, Mettowee, Mohawk, Oswegatchie, Pocantico, Racquette, Sacandaga, Salmon, 19 20 21 Saw Mill, Schroon, Susquehanna, Tioga, Tioughnioga, Wallkill and Buffalo rivers, and the north and middle branches of the Moose 22 the state's major creeks comprised of the 18 Mile Creek 23 river; (c) located in Erie county, Bushkill, Cattaraugus, Cincinnati, 24 East Kill, 25 Esopus (including upper and lower branches), Fish (including east and 26 west branches), Gooseberry, Little Sandy, Onondaga, Sandy, Schoharie,

Wynantskill, CLAVERACK, TAGHKANIC AND AGAWAMUCK; (d) the Barge Canal System as defined in section two of the canal law; and (e) the adjacent shorelands to the extent that such inland waters and adjacent lands are strongly influenced by each other including, but not limited to, islands, wetlands, beaches, dunes, barrier islands, cliffs, bluffs and erosion prone areas.
