AN ACT to amend the election law, in relation to including e-mail addresses in voter registration data

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraphs (k) and (l) of subdivision 5 of section 5-210 of the election law, as amended by chapter 179 of the laws of 2005, subparagraph (xii) of paragraph (k) as added by chapter 362 of the laws of 2008, are amended to read as follows:

5 (k) The form shall also include space for the following information, 6 which must be contained on the inside of the form after it is folded for 7 mailing:

8 (i) A space for the applicant to indicate whether or not he or she has 9 ever voted or registered to vote before and, if so, the approximate year 10 in which such applicant last voted or registered and his or her name and 11 address at the time.

12 (ii) The name and residence address of the applicant including the zip 13 code and apartment number, if any.

14 (iii) A SPACE FOR THE FURNISHING OF AN E-MAIL ADDRESS, THE FURNISHING SHALL BE OPTIONAL, TOGETHER WITH A NOTICE STATING THAT IF AN 15 OF WHICH E-MAIL ADDRESS IS FURNISHED, ALL NOTICES AND COMMUNICATIONS OTHERWISE 16 REQUIRED TO 17 BE SENT BY THE STATE BOARD OF ELECTIONS TO THE VOTER BY POSTAL MAIL SHALL BE SENT BY E-MAIL IN ADDITION TO POSTAL MAIL. 18 COUNTY 19 BOARDS OF ELECTIONS AND THE BOARD OF ELECTIONS OF THE CITY OF NEW YORK 20 SHALL HAVE THE OPTION OF SENDING NOTICES AND COMMUNICATIONS OTHERWISE REQUIRED TO BE SENT TO THE VOTER BY POSTAL MAIL BY E-MAIL IN ADDITION TO 21 POSTAL MAIL IF THE VOTER FURNISHES AN EMAIL ADDRESS. 22

applicant does not have either such number, a space for the applicant to 1 2 indicate he or she does not have either. 3 [(v)] (VI) A space for the applicant to indicate whether or not he or 4 she is a citizen of the United States and the statement "If you checked 5 "no" in response to this question, do not complete this form." 6 (VII) A space for the applicant to answer the question "Will [(vi)] 7 you be 18 years of age on or before election day?" and the statement "If 8 you checked "no" in response to this question, do not complete this form unless you will be 18 by the end of the year." 9 10 [(vii)] (VIII) A statement informing the applicant that if the form is submitted by mail and the applicant is registering for the first time, 11 certain information or documents must be submitted with the mail-in 12 registration form in order to avoid additional identification require-13 14 ments upon voting for the first time. Such information and documents 15 are: 16 (A) a driver's license or department of motor vehicles non-driver 17 photo ID number; or 18 last four digits of the individual's social security number; (B) the 19 or 20 (C) a copy of a current and valid photo identification; or 21 (D) a copy of a current utility bill, bank statement, government 22 check, paycheck or other government document that shows the name and address of the voter. 23 24 [(viii)] (IX) The gender of the applicant (optional). 25 [(ix)] (X) A space for the applicant to indicate his or her choice of 26 party enrollment, with a clear alternative provided for the applicant to 27 decline to affiliate with any party. [(x)] (XI) The telephone number of the applicant (optional). 28 29 (XII) A place for the applicant to execute the form on a line [(xi)] which is clearly labeled "signature of applicant" preceded by the 30 following specific form of affirmation: 31 32 AFFIDAVIT: I swear or affirm that: 33 * I am a citizen of the United States. 34 * I will have lived in the county, city, or village for at least 30 35 days before the election. * I meet all the requirements to register to vote in New York 36 37 State. 38 * This is my signature or mark on the line below. 39 * All the information contained on this application is true. Ι understand that if it is not true I can be convicted and fined up 40 to \$5,000 and/or jailed for up to four years. 41 which form of affirmation shall be followed by a space for the date and 42 43 the aforementioned line for the applicant's signature. 44 [(xii)] (XIII) A space for the applicant to register in the New York 45 life registry for organ and tissue donations established state donate 46 pursuant to section forty-three hundred ten of the public health law. 47 (1) The mail voter registration application form developed by the 48 federal election commission pursuant to the provisions of section nine of the National Voter Registration Act of 1993 42 USC 1973gg-7 shall be 49 50 deemed to meet the requirements of this section. Any application for 51 registration received on such an application form shall be accepted if the applicant is otherwise eligible to register to vote pursuant to the 52 provisions of this article. A VOTER WHOSE REGISTRATION 53 IS ACCEPTED 54 PURSUANT TO THE PROVISIONS OF THIS PARAGRAPH SHALL BE PERMITTED TO FURNISH AN E-MAIL ADDRESS TO THE BOARD OF ELECTIONS, WHICH FURNISHING 55

1 SHALL CARRY THE SAME NOTICE AND HAVE THE SAME EFFECT AS PROVIDED BY 2 SUBPARAGRAPH (III) OF PARAGRAPH (K) OF THIS SUBDIVISION.

3 S 2. Paragraph d of subdivision 4 of section 5-500 of the election 4 law, as amended by chapter 659 of the laws of 1994, is amended to read 5 as follows:

6 The residence address at which the voter claims to reside and post d. 7 office address, if not the same; and the number or designation of the room, apartment, or floor occupied by the voter if he OR SHE does not 8 claim the entire building as his OR HER residence; AND IN ADDITION, 9 10 SPACE FOR THE FURNISHING OF AN E-MAIL ADDRESS, THE FURNISHING OF WHICH SHALL BE OPTIONAL, TOGETHER WITH A NOTICE STATING THAT 11 IF AN E-MAIL IS FURNISHED, ALL NOTICES AND COMMUNICATIONS OTHERWISE REQUIRED ADDRESS 12 TO BE SENT BY THE STATE BOARD OF ELECTIONS TO THE VOTER BY POSTAL 13 MAIL 14 SHALL BE SENT BY E-MAIL IN ADDITION TO POSTAL MAIL. COUNTY BOARDS OF 15 ELECTIONS AND THE BOARD OF ELECTIONS OF THE CITY OF NEW YORK SHALL HAVE 16 THE OPTION OF SENDING NOTICES AND COMMUNICATIONS OTHERWISE REQUIRED TO 17 BE SENT TO THE VOTER BY POSTAL MAIL BY E-MAIL IN ADDITION TO POSTAL MAIL IF THE VOTER FURNISHES AN E-MAIL ADDRESS; 18

This act shall take effect one year after it shall have become a 20 law; provided that the state board of elections is authorized to promul-21 gate any and all rules and regulations and take any other measures 22 necessary to implement this act on its effective date on or before such 23 date.
