AN ACT to amend the family court act and the domestic relations law, in relation to reducing a parent's child support obligation by the amount of social security dependent benefits received by the child

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph 1 of paragraph (b) of subdivision 1 of section  
2 413 of the family court act, as amended by chapter 567 of the laws of  
3 1989, is amended to read as follows:  
4 (1) "Basic child support obligation" shall mean the sum derived by  
5 adding the amounts determined by the application of subparagraphs two  
6 and three of paragraph (c) of this subdivision except as increased  
7 pursuant to subparagraphs four, five, six and seven of such paragraph  
8 AND DECREASED PURSUANT TO SUBPARAGRAPH EIGHT OF SUCH PARAGRAPH.  
9 S 2. Clause (iii) of subparagraph 5 of paragraph (b) of subdivision 1  
10 of section 413 of the family court act, as amended by chapter 567 of the  
11 laws of 1989, is amended to read as follows:  
12 (iii) to the extent not already included in gross income in clauses  
13 (i) and (ii) of this subparagraph, the amount of income or compensation  
14 voluntarily deferred and income received, if any, from the following  
15 sources:  
16 (A) workers' compensation,  
17 (B) disability benefits,  
18 (C) unemployment insurance benefits,  
19 (D) social security benefits,

7 S 3. Paragraph (c) of subdivision 1 of section 413 of the family court  
8 act is amended by adding a new subparagraph 8 to read as follows:

10 THE EARNINGS OF A PARENT SHALL BE CREDITED AS CHILD SUPPORT TO THE

12 S 4. Subparagraph 1 of paragraph (b) of subdivision 1-b of section 240  
13 of the domestic relations law, as added by chapter 567 of the laws of  
14 1989, is amended to read as follows:

15 (1) "Basic child support obligation" shall mean the sum derived by  
16 adding the amounts determined by the application of subparagraphs two  
17 and three of paragraph (c) of this subdivision except as increased  
18 pursuant to subparagraphs four, five, six and seven of such paragraph

37 S 6. Paragraph (c) of subdivision 1-b of section 240 of the domestic  
38 relations law is amended by adding a new subparagraph 8 to read as  
39 follows:

40 (8) SOCIAL SECURITY BENEFITS RECEIVED BY THE CHILD OR CHILDREN DUE TO  
41 THE EARNINGS OF A PARENT SHALL BE CREDITED AS CHILD SUPPORT TO THE  
42 PARENT UPON WHOSE EARNING RECORD IT IS BASED.

43 S 7. This act shall take effect immediately.
