- AN ACT to amend the social services law and the not-for-profit corporation law, in relation to inquiring into past military service on applications for public welfare

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 20 of the social services law is 2 amended by adding a new paragraph (j) to read as follows:

3 (J) TO ENSURE THE PROVISION, ON ANY FORM REQUIRED TO BE COMPLETED AT 4 APPLICATION OR RECERTIFICATION FOR THE PURPOSE OF OBTAINING FINANCIAL 5 ASSISTANCE PURSUANT TO THIS CHAPTER, THE FORM SHALL CONTAIN A CHECK-OFF 6 OUESTION ASKING WHETHER THE APPLICANT OR RECIPIENT OR A MEMBER OF HIS OR 7 HER FAMILY SERVED IN THE UNITED STATES MILITARY, AND AN OPTION TO ANSWER 8 THE AFFIRMATIVE. WHERE THE APPLICANT OR RECIPIENT ANSWERS IN THE IN AFFIRMATIVE TO SUCH QUESTION, THE STATE DEPARTMENT OF 9 SOCIAL SERVICES 10 THAT CONTACT INFORMATION FOR THE STATE DIVISION OF VETER-SHALL ENSURE 11 ANS' AFFAIRS IS PROVIDED TO SUCH APPLICANT OR RECIPIENT, IN ADDITION ΤO ANY OTHER MATERIALS PROVIDED. 12

13 S 2. Section 202 of the not-for-profit corporation law is amended by 14 adding a new paragraph (g) to read as follows:

(G) EVERY CORPORATION RECEIVING ANY KIND OF STATE FUNDING SHALL ENSURE 15 16 THE PROVISION ON ANY FORM REQUIRED TO BE COMPLETED AT APPLICATION OR RECERTIFICATION FOR THE PURPOSE OF OBTAINING FINANCIAL ASSISTANCE PURSU-17 ANT TO THIS CHAPTER, THAT THE APPLICATION FORM SHALL CONTAIN A CHECK-OFF 18 QUESTION ASKING WHETHER THE APPLICANT OR RECIPIENT OR A MEMBER OF HIS OR 19 20 HER FAMILY SERVED IN THE UNITED STATES MILITARY, AND AN OPTION TO ANSWER 21 THE AFFIRMATIVE. WHERE THE APPLICANT OR RECIPIENT ANSWERS IN THE IN22 AFFIRMATIVE TO SUCH QUESTION, THE NOT-FOR-PROFIT CORPORATION SHALL ENSURE THAT CONTACT INFORMATION FOR THE STATE DIVISION OF VETERANS' 23
