AN ACT to amend the insurance law, in relation to mandatory health insurance coverage for acupuncture services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is 2 amended by adding a new paragraph 33 to read as follows:

3 EVERY POLICY ISSUED WITHIN THE HEALTH BENEFIT EXCHANGE ESTAB-(33) LISHED PURSUANT TO SECTION 1311 OF THE AFFORDABLE CARE ACT, 42 U.S.C. S 4 5 18031, SHALL PROVIDE COVERAGE FOR ACUPUNCTURE TREATMENT AS DEFINED IN 6 SECTION EIGHT THOUSAND TWO HUNDRED ELEVEN OF THE EDUCATION LAW PROVIDED 7 BY AN INDIVIDUAL LICENSED, AUTHORIZED, OR CERTIFIED PURSUANT TO ARTICLE 8 ONE HUNDRED SIXTY OF THE EDUCATION LAW. HOWEVER, ACUPUNCTURE TREATMENT 9 AND SERVICES MAY BE SUBJECT TO REASONABLE DEDUCTIBLE, CO-PAYMENT AND CO-INSURANCE AMOUNT, REASONABLE FEE OR BENEFIT LIMITS, AND REASONABLE 10 UTILIZATION REVIEW, PROVIDED THAT ANY SUCH AMOUNTS, LIMITS OR REVIEW 11 SHALL BE NO GREATER THAN OTHER ESSENTIAL HEALTH BENEFITS COVERED BY THE 12 POLICY AND PROVIDED FURTHER THAT ANY SUCH AMOUNTS, LIMITS, OR REVIEW 13 14 SHALL NOT FUNCTION TO DIRECT TREATMENT IN A MANNER DISCRIMINATIVE ACUPUNCTURE TREATMENT. NOTHING HEREIN 15 AGAINST SHALL BE CONSTRUED AS 16 IMPENDING OR PREVENTING EITHER THE PROVISION OR COVERAGE OF ACUPUNCTURE TREATMENT AND SERVICES BY DULY LICENSED OR CERTIFIED ACUPUNCTURIST, 17 18 WITHIN THE LAWFUL SCOPE OF THE PRACTICE OF ACUPUNCTURE, IN HOSPITAL 19 FACILITIES ON A STAFF OR EMPLOYEE BASIS.

20 S 2. Section 4303 of the insurance law is amended by adding a new 21 subsection (qq) to read as follows:

(QQ) EVERY POLICY ISSUED WITHIN THE HEALTH BENEFIT EXCHANGE ESTABLISHED PURSUANT TO SECTION 1311 OF THE AFFORDABLE CARE ACT, 42 U.S.C. S
18031, SHALL PROVIDE COVERAGE FOR ACUPUNCTURE TREATMENT AS DEFINED IN
SECTION EIGHT THOUSAND TWO HUNDRED ELEVEN OF THE EDUCATION LAW PROVIDED
BY AN INDIVIDUAL LICENSED, AUTHORIZED, OR CERTIFIED PURSUANT TO ARTICLE
ONE HUNDRED SIXTY OF THE EDUCATION LAW. HOWEVER, ACUPUNCTURE TREATMENT
AND SERVICES MAY BE SUBJECT TO REASONABLE DEDUCTIBLE, CO-PAYMENT AND

CO-INSURANCE AMOUNT, REASONABLE FEE OR BENEFIT LIMITS, AND REASONABLE 1 UTILIZATION REVIEW, PROVIDED THAT ANY SUCH AMOUNTS, LIMITS OR REVIEW 2 3 SHALL BE NO GREATER THAN OTHER ESSENTIAL HEALTH BENEFITS COVERED BY THE 4 POLICY AND PROVIDED FURTHER THAT ANY SUCH AMOUNTS, LIMITS, OR REVIEW SHALL NOT FUNCTION TO DIRECT TREATMENT IN A MANNER DISCRIMINATIVE AGAINST ACUPUNCTURE TREATMENT. NOTHING HEREIN SHALL BE CONSTRUED AS 5 6 7 IMPEDING OR PREVENTING EITHER THE PROVISION OR COVERAGE OF ACUPUNCTURE 8 TREATMENT AND SERVICES BY DULY LICENSED OR CERTIFIED ACUPUNCTURISTS, WITHIN THE LAWFUL SCOPE OF THE PRACTICE OF ACUPUNCTURE, IN HOSPITAL 9 10 FACILITIES ON A STAFF OR EMPLOYEES BASIS.

11 S 3. This act shall take effect on the ninetieth day after it shall 12 have become a law and shall apply to policies and contracts issued, 13 renewed, modified, altered or amended on or after such effective date.
