AN ACT to amend chapter 91 of the laws of 2002, amending the education law and other laws relating to reorganization of the New York city school construction authority, board of education and community boards, in relation to the effectiveness thereof; to amend chapter 345 of the laws of 2009, amending the education law and other laws relating to the New York city board of education, chancellor, community councils and community superintendents, in relation to the effectiveness thereof; to amend the education law, in relation to the New York city school district system and establishing an education inspector for the New York city school district; and to amend the New York city charter and the education law, in relation to the New York city community school district system and providing for the repeal of certain provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 34 of chapter 91 of the laws of 2002 amending the  
2 education law and other laws relating to reorganization of the New York  
3 city school construction authority, board of education and community  
4 boards, as amended by section 1 of subpart D of part B of chapter 20 of  
5 the laws of 2015, is amended to read as follows:  
6 S 34. This act shall take effect July 1, 2002; provided, that sections  
7 one through twenty, twenty-four, and twenty-six through thirty of this  
8 act shall expire and be deemed repealed [June 30, 2016] JUNE 30, 2017;  
9 provided, further, that notwithstanding any provision of article 5 of  
10 the general construction law, on [June 30, 2016] JUNE 30, 2017 the  
11 provisions of subdivisions 3, 5, and 8, paragraph b of subdivision 13,  
12 subdivision 14, paragraphs b, d, and e of subdivision 15, and subdivi-  
13 sions 17 and 21 of section 2554 of the education law as repealed by  
14 section three of this act, subdivision 1 of section 2590-b of the educa-  
15 tion law as repealed by section six of this act, paragraph (a) of subdivi-  
16 sion 2 of section 2590-b of the education law as repealed by section  
17 seven of this act, section 2590-c of the education law as repealed by

1 section eight of this act, paragraph c of subdivision 2 of section  
2 2590-d of the education law as repealed by section twenty-six of this  
3 act, subdivision 1 of section 2590-e of the education law as repealed by  
4 section twenty-seven of this act, subdivision 28 of section 2590-h of  
5 the education law as repealed by section twenty-eight of this act,  
6 subdivision 30 of section 2590-h of the education law as repealed by  
7 section twenty-nine of this act, subdivision 30-a of section 2590-h of

17 S 2. Subdivision 12 of section 17 of chapter 345 of the laws of 2009  
18 amending the education law and other laws relating to the New York city  
19 board of education, chancellor, community councils and community super-  
20 intendants, as amended by section 2 of subpart D of part B of chapter 20  
21 of the laws of 2015, is amended to read as follows:

22 12. any provision in sections one, two, three, four, five, six, seven,  
23 eight, nine, ten and eleven of this act not otherwise set to expire  
24 pursuant to section 34 of chapter 91 of the laws of 2002, as amended, or  
25 section 17 of chapter 123 of the laws of 2003, as amended, shall expire  
26 and be deemed repealed [June 30, 2016] JUNE 30, 2017.

27 S 3. Paragraph (a) of subdivision 1 of section 2590-b of the education  
28 law, as amended by chapter 345 of the laws of 2009, is amended to read  
29 as follows:

30 (a) The board of education of the city school district of the city of  
31 New York is hereby continued. Such board of education shall consist of  
32 thirteen appointed members: one member to be appointed by each borough  
33 president of the city of New York; and eight members to be appointed by  
34 the mayor of the city of New York. The chancellor AND THE EDUCATION  
35 INSPECTOR shall serve as [an] ex-officio non-voting [member] MEMBERS of  
36 the city board. The city board shall elect its own chairperson from  
37 among its voting members. All thirteen appointed members shall serve at  
38 the pleasure of the appointing authority and shall not be employed in  
39 any capacity by the city of New York, or a subdivision thereof, or the  
40 city board. No appointed member of the city board shall also be a  
41 member, officer, or employee of any public corporation, authority, or  
42 commission where the mayor of the city of New York has a majority of the  
43 appointments. ANY LOBBYIST OR CLIENT OF A LOBBYIST, REGISTERED WITH THE  
44 NEW YORK CITY CLERK, SHALL NOT BE ELIGIBLE TO SERVE AS AN APPOINTED  
45 MEMBER FOR A PERIOD OF TWO YEARS FROM THE LAST ENGAGEMENT OF LOBBYING OR  
46 LOBBYING ACTIVITIES, AS SUCH TERMS ARE DEFINED BY SUBDIVISION (C) OF  
47 SECTION 3-211 OF THE ADMINISTRATIVE CODE OF THE CITY OF NEW YORK. Each  
48 borough president's appointee shall be a resident of the borough for  
49 which the borough president appointing him or her was elected and shall  
50 be the parent of a child attending a public school within the city  
51 school district of the city of New York. Each mayoral appointee shall  
52 be a resident of the city and two shall be parents of a child attending  
53 a public school within the city district. All parent members shall be  
54 eligible to continue to serve on the city board for two years following  
55 the conclusion of their child's attendance at a public school within the  
56 city district. Any vacancy shall be filled by appointment by the appro-

1 puate appointing authority within ninety days of such vacancy. Notwith-  
2 standing any provision of local law, the members of the board shall not  
3 have staff, offices, or vehicles assigned to them or receive compen-  
4 sation for their services, but shall be reimbursed for the actual and  
5 necessary expenses incurred by them in the performance of their duties.

6 S 4. Section 2590-g of the education law is amended by adding a new  
7 subdivision 12-a to read as follows:

8 12-A. PROVIDE INFORMATION, DATA, ESTIMATES AND STATISTICS REGARDING  
9 ALL MATTERS RELATING TO THE CITY DISTRICT, AS REQUESTED BY MEMBERS AND  
10 OFFICERS OF THE SENATE, ASSEMBLY, AND GOVERNOR'S OFFICE, IN A TIMELY  
11 FASHION. SUCH INFORMATION SHALL BE MAINTAINED AND UPDATED IN A TIMELY  
12 FASHION AND SHALL AT A MINIMUM INCLUDE DATA RELATING TO: (A) NEW YORK  
13 CITY DEPARTMENT OF EDUCATION SCHOOL CHARACTERISTICS INCLUDING GRADES  
14 SERVED, NUMBER OF TEACHERS, STUDENT ENROLLMENT, SCHOOL TYPE, SCHOOL  
15 CHARACTERISTICS, QUALITY REVIEW SCORES, GRADUATION RATES AND AVERAGE  
16 CLASS SIZE; (B) NEW YORK CITY DEPARTMENT OF EDUCATION PRINCIPAL CHARAC-  
17 TERISTICS INCLUDING CURRENT EMPLOYMENT STATUS, EDUCATION LEVEL, YEARS OF  
18 EXPERIENCE AND TENURE STATUS; (C) NEW YORK CITY DEPARTMENT OF EDUCATION  
19 TEACHER CHARACTERISTICS INCLUDING CURRENT EMPLOYMENT STATUS, EDUCATION  
20 LEVEL, YEARS OF TEACHING EXPERIENCE, TENURE STATUS, SUBJECT AREA TAUGHT,  
21 NUMBER OF STUDENTS TAUGHT, NUMBER OF CLASSES TAUGHT PER DAY AND ATTRI-  
22 TION RATE; (D) NEW YORK CITY DEPARTMENT OF EDUCATION STUDENT CHARACTER-  
23 ISTICS INCLUDING GRADE LEVEL, SCHOOL ATTENDANCE, AND OTHER DEMOGRAPHICS;  
24 (E) GIFTED AND TALENTED PROGRAMS APPLICATION DATA INCLUDING ADMISSION  
25 DECISIONS, STUDENT DEMOGRAPHICS AND STUDENT TEST SCORES; (F) PRE-KINDER-  
26 GARTEN PROGRAMS INCLUDING PROGRAM LOCATIONS, CAPACITY, STUDENT ENROLL-  
27 MENT, NUMBER OF TEACHERS, TEACHER CHARACTERISTICS, STUDENT ATTENDANCE,  
28 STUDENT DEMOGRAPHICS AND EFFECTIVENESS DATA; (G) FUNDING FOR NEW YORK  
29 CITY DEPARTMENT OF EDUCATION SCHOOLS INCLUDING DEPARTMENT FUNDING BY  
30 DOLLARS, EXPENDITURES BY CATEGORY AND EXTERNAL FUNDING IN DOLLARS; (H)  
31 FUNDING FOR NEW YORK CITY DEPARTMENT OF EDUCATION PROGRAMS INCLUDING  
32 DEPARTMENT FUNDING IN DOLLARS, AND EXTERNAL FUNDING IN DOLLARS; AND (I)  
33 GENERAL NEW YORK CITY DEPARTMENT OF EDUCATION BUDGET. PROVIDED, HOWEV-  
34 ER, THAT ALL INQUIRIES MADE IN ACCORDANCE WITH THIS SUBDIVISION SHALL  
35 COMPLY WITH APPLICABLE STATE AND FEDERAL PRIVACY LAWS.

36 S 5. Subdivision 2 of section 2590-p of the education law is amended  
37 by adding a new paragraph i to read as follows:

38 I. OVERCROWDING AND UNDERUTILIZATION. THE PLAN SHALL IDENTIFY THE TEN  
39 MOST OVERCROWDED AND THE TEN MOST UNDERUTILIZED SCHOOL BUILDINGS AND  
40 SHALL DETAIL STEPS TO BE TAKEN TO ADDRESS SUCH ISSUES.

41 S 6. Section 2590-q of the education law is amended by adding a new  
42 subdivision 19 to read as follows:

43 19. WITH RESPECT TO SPECIAL, FEDERAL, STATE, AND PRIVATE FUNDS, THE  
44 CHANCELLOR SHALL REPORT THE DISTRIBUTION OF SUCH FUNDS BY INDIVIDUAL  
45 SCHOOL, AND ON A PER PUPIL BASIS FOR EACH INDIVIDUAL SCHOOL TO THE  
46 GOVERNOR, TEMPORARY PRESIDENT OF THE SENATE, SPEAKER OF THE ASSEMBLY,  
47 AND SPEAKER OF THE CITY COUNCIL ON OR BEFORE MAY FIRST OF EACH YEAR.

48 S 7. The opening paragraph of section 2590-r of the education law, as  
49 amended by chapter 345 of the laws of 2009, is amended to read as  
50 follows:

51 The chancellor shall, in consultation with the city board and communi-  
52 ty district superintendents, establish in regulations a comprehensive  
53 process of school-based budgeting and expenditure reporting no later  
54 than November first, nineteen hundred ninety-eight. ANY REPORT PREPARED  
55 IN ACCORDANCE WITH THIS SECTION SHALL BE PUBLICLY AVAILABLE ON THE  
56 WEBSITE OF THE NEW YORK CITY DEPARTMENT OF EDUCATION. Notwithstanding

1 any provision of section twenty-five hundred ninety-q of this article to  
2 the contrary, such regulations shall include provisions for:

3 S 8. The education law is amended by adding a new section 2590-v to  
4 read as follows:

5 S 2590-V. EDUCATION INSPECTOR. 1. THERE IS HEREBY ESTABLISHED AN  
6 EDUCATION INSPECTOR FOR THE NEW YORK CITY SCHOOL DISTRICT, HEREINAFTER  
7 IN THIS SECTION REFERRED TO AS THE INSPECTOR, WHO SHALL BE APPOINTED BY  
8 THE GOVERNOR, BY AND WITH THE ADVICE AND CONSENT OF THE SENATE AND SHALL  
9 HOLD OFFICE AT THE PLEASURE OF THE GOVERNOR. THE INSPECTOR SHALL PROVIDE  
10 OVERSIGHT, GUIDANCE, AND TECHNICAL ASSISTANCE RELATED TO THE EDUCATIONAL  
11 AND FISCAL POLICIES, PRACTICES, PROGRAMS, AND DECISIONS OF THE CITY  
12 DISTRICT, CITY BOARD, CHANCELLOR AND MAYOR OF THE CITY OF NEW YORK. THE  
13 INSPECTOR SHALL HAVE EXPERIENCE IN ONE OR MORE OF THE FOLLOWING AREAS:  
14 SCHOOL DISTRICT FINANCES; EARLY CHILDHOOD, ELEMENTARY, AND/OR SECONDARY  
15 EDUCATION; THE OPERATION OF SCHOOL DISTRICTS IN NEW YORK; EDUCATION OF  
16 STUDENTS WITH DISABILITIES; AND/OR EDUCATION OF ENGLISH LANGUAGE LEAR-  
17 NERS.

18 2. THE INSPECTOR SHALL BE ENTITLED TO ATTEND ALL MEETINGS OF THE CITY  
19 BOARD, INCLUDING EXECUTIVE SESSIONS. THE INSPECTOR SHALL HAVE ACCESS TO  
20 ALL EDUCATIONAL FACILITIES AND RECORDS, INCLUDING BUT NOT LIMITED TO  
21 ELECTRONIC INFORMATION SYSTEMS, DATABASES, AND PLANNING DOCUMENTS, OF  
22 THE CITY BOARD, ANY COMMUNITY DISTRICT EDUCATION COUNCIL, THE DEPARTMENT  
23 OF EDUCATION, AND ANY PUBLIC SCHOOL. THE CITY BOARD, MAYOR, CHANCELLOR  
24 AND THE DEPARTMENT OF EDUCATION SHALL FULLY COOPERATE WITH REQUESTS FOR  
25 INFORMATION MADE BY THE INSPECTOR. THE INSPECTOR MAY ESTABLISH MONTHLY  
26 REPORTING REQUIREMENTS UPON THE CITY BOARD, CHANCELLOR, AND/OR THE  
27 DEPARTMENT OF EDUCATION CONTAINING ANY INFORMATION REQUIRED BY THE  
28 INSPECTOR.

29 2-A. THE INSPECTOR MAY APPEAL ANY DECISION OF THE CITY BOARD TO THE  
30 COMMISSIONER PURSUANT TO SECTION THREE HUNDRED TEN OF THIS CHAPTER. UPON  
31 APPEAL THE CITY BOARD MUST DEMONSTRATE THAT THEIR ACTION WAS IN THE BEST  
32 INTERESTS OF THE STUDENTS OF THE CITY OF NEW YORK. THE INSPECTOR SHALL  
33 BE DEEMED TO BE AN AGGRIEVED PARTY AND SHALL BE CONSIDERED TO HAVE  
34 STANDING TO BRING SUCH APPEAL.

35 2-B. THE INSPECTOR SHALL INVESTIGATE AND REVIEW ALL APPOINTMENTS TO  
36 THE CITY BOARD AND ALL CONTRACTS RATIFIED BY THE CITY BOARD FOR  
37 CONFLICTS OF INTEREST AND SELF-DEALING. IF THE INSPECTOR FINDS THAT  
38 THERE IS A CONFLICT OF INTEREST OR SELF-DEALING IN ANY APPOINTMENT OR  
39 CONTRACT, HE OR SHE SHALL HAVE THE AUTHORITY TO VOID SUCH APPOINTMENT OR  
40 CONTRACT. ACTIONS TAKEN BY THE INSPECTOR IN ACCORDANCE WITH THIS SUBDI-  
41 VISION MAY BE APPEALED TO THE COMMISSIONER, PURSUANT TO SECTION THREE  
42 HUNDRED TEN OF THIS CHAPTER.

43 2-C. THE INSPECTOR SHALL HAVE ACCESS TO RESOLUTIONS PASSED BY ALL  
44 COMMUNITY DISTRICT EDUCATION COUNCILS AND CITY-WIDE EDUCATION COUNCILS.  
45 IN THE EVENT THAT THE INSPECTOR DETERMINES A RESOLUTION CONTAINS A  
46 GRIEVANCE THAT HAS NOT BEEN RESPONDED TO BY THE CHANCELLOR FOR A PERIOD  
47 OF FORTY-FIVE DAYS OR MORE, THE INSPECTOR SHALL INVESTIGATE SUCH GRIEV-  
48 ANCE. THE INSPECTOR SHALL NOTIFY THE COMMISSIONER AND THE PUBLIC OF HIS  
49 OR HER FINDINGS IN WRITING.

50 3. (A) THE INSPECTOR SHALL BE REQUIRED TO:

51 (I) EVALUATE AND MAKE RECOMMENDATIONS ON THE CURRENT PROCESS THE CITY  
52 DISTRICT HAS FOR DISTRIBUTING FUNDING TO SCHOOLS AND IF SUCH DISTRIB-  
53 UTION OCCURS IN A MANNER THAT IS FAIR, EQUITABLE, AND TRANSPARENT;

54 (II) EVALUATE AND MAKE RECOMMENDATIONS REGARDING THE DISCIPLINARY  
55 PROCEDURES FOR STUDENTS, TEACHERS, AND OTHER STAFF AND THE OVERALL SAFE-  
56 TY OF SCHOOLS IN THE CITY DISTRICT;

1 (III) EVALUATE AND MAKE RECOMMENDATIONS ON THE DISCIPLINARY PROCESS  
2 FOR STAFF THAT ENGAGES IN BEHAVIOR THAT IS DANGEROUS OR OTHERWISE UNBE-  
3 COMING OF THE PROFESSION;

4 (IV) EVALUATE AND MAKE RECOMMENDATIONS ON THE CITY DISTRICTS POLICY  
5 FOR DETERMINING CO-LOCATIONS OF CHARTER SCHOOLS AND POLICY FOR COMPLI-  
6 ANCE WITH PARAGRAPH (E) OF SUBDIVISION THREE OF SECTION TWENTY-EIGHT  
7 HUNDRED FIFTY-THREE OF THIS CHAPTER;

8 (V) EVALUATE AND MAKE RECOMMENDATIONS ON HOW THE CITY DISTRICT CAN  
9 ATTRACT AND RETAIN HIGHLY EFFECTIVE AND EFFECTIVE TEACHERS IN SCHOOLS,  
10 ESPECIALLY THOSE DEEMED TO BE FAILING OR PERSISTENTLY FAILING;

11 (VI) EVALUATE AND MAKE RECOMMENDATIONS ON THE CITY DISTRICTS CURRENT  
12 PROCESS FOR EDUCATING STUDENTS WITH DISABILITIES AND ENGLISH LANGUAGE  
13 LEARNERS AND IF THESE STUDENTS ARE RECEIVING ALL OF THE SERVICES THEY  
14 ARE ENTITLED TO;

15 (VII) EVALUATE AND MAKE RECOMMENDATIONS ON HOW WELL THE CITY DISTRICT  
16 IS ENGAGING PARENTS AND COMMUNITY MEMBERS;

17 (VIII) EVALUATE AND MAKE RECOMMENDATIONS ON THE EDUCATION GOALS AND  
18 POLICIES OF THE MAYOR, CHANCELLOR, AND CITY BOARD AND ANY PROGRESS MADE  
19 ON GOALS AND POLICIES IN EFFECT AT THE TIME OF THIS SECTION TAKING  
20 EFFECT; AND

21 (IX) EVALUATE AND MAKE RECOMMENDATIONS ON ANY OTHER AREA OF EDUCATION  
22 PERTINENT TO THE CITY DISTRICT AS DETERMINED BY THE INSPECTOR.

23 (B) THE INSPECTOR SHALL REPORT THE EVALUATIONS AND RECOMMENDATIONS  
24 REQUIRED BY PARAGRAPH (A) OF THIS SUBDIVISION TO THE GOVERNOR, TEMPORARY  
25 PRESIDENT OF THE SENATE, AND SPEAKER OF THE ASSEMBLY BY MAY FIRST, TWO  
26 THOUSAND SEVENTEEN.

27 S 9. Paragraphs 20 and 21 of subdivision d and subdivision i of  
28 section 2800 of the New York city charter, paragraph 20 of subdivision d  
29 and subdivision i as amended and paragraph 21 of subdivision d as added  
30 by a vote of the people of the city of New York at the general election  
31 held in November 1989, are amended and a new paragraph 22 is added to  
32 subdivision d to read as follows:

33 (20) Within budgetary appropriations for such purposes, disseminate  
34 information about city services and programs, process complaints,  
35 requests, and inquiries of residents of the community district; [and]

36 (21) Conduct substantial public outreach, including identifying the  
37 organizations active in the community district, maintaining a list of  
38 the names and mailing addresses of such community organizations, and  
39 making such names and, with the consent of the organization, mailing  
40 addresses available to the public upon request[.]; AND

41 (22) COORDINATE WITH THE COMMUNITY EDUCATION COUNCIL, AS ESTABLISHED  
42 UNDER ARTICLE FIFTY-TWO-A OF THE EDUCATION LAW, WHOSE BOUNDARIES ARE  
43 EQUAL TO THOSE OF THE COMMUNITY DISTRICT. THIS COORDINATION SHALL  
44 INCLUDE, BUT SHALL NOT BE LIMITED TO, MAKING SPACE AVAILABLE FOR MONTHLY  
45 MEETINGS, HELPING TO PUBLICIZE MEETINGS OF THE COMMUNITY EDUCATION COUN-  
46 CIL, ALLOWING COMMUNITY BOARD STAFF TO PROVIDE CLERICAL AND ADMINISTRA-  
47 TIVE SUPPORT TO THE MEMBERS OF THE COMMUNITY EDUCATION COUNCIL, RECEIV-  
48 ING REPORTS FROM THE COMMUNITY EDUCATION COUNCIL INCLUDING AN ANNUAL  
49 REPORT CARD ON THE CONDITION OF SCHOOLS IN THE COMMUNITY DISTRICT AND  
50 ANY PROPOSED OR PENDING CHANGES IN EDUCATION POLICY, AND HELPING DISSEM-  
51 INATE INFORMATION ON EDUCATION ISSUES PREPARED BY THE COMMUNITY EDUCA-  
52 TION COUNCIL TO PARENTS AND OTHER COMMUNITY ORGANIZATIONS AND MEMBERS.

53 i. Each community board may create committees on matters relating to  
54 its duties and responsibilities. It may include on such committees  
55 persons with a residence or significant interest in the community who  
56 are not members of the board, but each such committee shall have a

1 member of the board as its chairperson. EACH COMMUNITY BOARD SHALL  
2 RESERVE A SEAT ON THEIR YOUTH AND EDUCATION COMMITTEE FOR ONE MEMBER OF  
3 THEIR RESPECTIVE COMMUNITY EDUCATION COUNCIL, PROVIDED, HOWEVER, THAT IF  
4 ANY COMMUNITY BOARD DOES NOT HAVE A YOUTH AND EDUCATION COMMITTEE, SUCH  
5 MEMBER OF THEIR RESPECTIVE COMMUNITY EDUCATION COUNCIL SHALL SIT ON A  
6 COMMITTEE MOST RELEVANT TO YOUTH AND EDUCATION ISSUES. SUCH MEMBER SHALL  
7 BE SELECTED BY MAJORITY VOTE OF THE COMMUNITY EDUCATION COUNCIL. Except  
8 as otherwise provided by law, meetings of such committees shall be open  
9 to the public.

10 S 10. Subparagraph 2 of paragraph (b) of subdivision 6 of section  
11 2590-c of the education law, as amended by chapter 103 of the laws of  
12 2014, is amended to read as follows:

13 (2) If such vacancy results in the council not having at least one  
14 member who is a parent of a student who is an English language learner  
15 or who has been an English language learner within the preceding two  
16 years, or results in the council not having at least one member who is a  
17 parent of a student with an individualized education program, the  
18 [community council] BOROUGH PRESIDENT shall select a parent having such  
19 qualifications to fill the vacancy.

20 S 11. Paragraph (c) of subdivision 6 of section 2590-c of the educa-  
21 tion law, as amended by chapter 345 of the laws of 2009, is amended to  
22 read as follows:

23 (c) If the vacancy is not filled by the community council within sixty  
24 days after it is declared due to a tie vote for such appointment, the  
25 [chancellor] BOROUGH PRESIDENT shall vote with the community council, to  
26 break such tie vote. If the community council has failed to fill the  
27 vacancy within sixty days after it is declared because of any other  
28 reason, the chancellor shall order the community council to do so pursu-

6 14. Hold public meetings at least every month with the superintendent

16 22. APPOINT ONE OF ITS MEMBERS, BY MAJORITY VOTE, TO ITS RESPECTIVE

18 THAT FOCUSES ON SIMILAR ISSUES. SUCH MEMBER SHALL SERVE AS A LIAISON

24 SIGNIFICANT CHANGES TO THE SCHOOLS IN THEIR COMMUNITY SCHOOL DISTRICTS.
