AN ACT to amend the civil service law, in relation to excused leave to undertake a screening for prostate cancer

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 159-c of the civil service law, as amended by chapter 111 of the laws of 2007, subdivision 1 and subdivision 2 as amended by chapter 391 of the laws of 2008, is amended to read as follows:

159-c. Excused leave to undertake a screening for prostate cancer. 5 Every public officer, employee of this state, employee of any coun-6 ty, employee of any community college, employee of any public authority, 7 employee of any public benefit corporation, employee of any board of cooperative educational services (BOCES), employee of any vocational 9 education and extension board, or a school district enumerated in section one of chapter five hundred sixty-six of the laws of nineteen 10 hundred sixty-seven, employee of any municipality, employee of any 11 school district or any employee of a participating employer in the New 12 York state and local employees' retirement system or any employee of a 13 14 participating employer in the New York state teachers' retirement system 15 shall be entitled to absent himself and shall be deemed to have a paid 16 leave of absence from his duties or service as such public officer, 17 employee of this state, employee of any county, employee of any community college, employee of any public authority, employee of any public 18 19 benefit corporation, employee of any board of cooperative educational 20 services (BOCES), employee of any vocational education and extension 21 board, or a school district enumerated in section one of chapter five 22 hundred sixty-six of the laws of nineteen hundred sixty-seven, 23 of any municipality, employee of any school district, or any employee of participating employer in the New York state and local employees' 24 25 retirement system or any employee of a participating employer in the New York state teachers' retirement system for a sufficient period of time, 27 not to exceed four hours on an annual basis, to undertake a screening 28 for prostate cancer.

2. The entire period of the leave of absence granted pursuant to this section shall be excused leave and shall not be charged against any other leave such public officer, employee of this state, employee of any county, employee of any community college, employee of any public authority, employee of any public benefit corporation, employee of any 5 board of cooperative educational services (BOCES), employee of any voca-6 7 tional education and extension board, or a school district enumerated in section one of chapter five hundred sixty-six of the laws of 8 nineteen hundred sixty-seven, employee of any municipality, employee of any 9 10 school district or any employee of a participating employer in the New York state and local employees' retirement system or any employee of a 11 participating employer in the New York state teachers' retirement system 12 is otherwise entitled to. 13
