6 (E) A REPRESENTATIVE OF COMMUNITY BOARD NUMBER FOUR;

7 (F) A LOCAL BUSINESS REPRESENTATIVE APPOINTED BY COMMUNITY BOARD  
8 NUMBER THREE;

9 (G) A LOCAL BUSINESS REPRESENTATIVE APPOINTED BY COMMUNITY BOARD  
10 NUMBER FOUR;

11 (H) THE COMMISSIONER OF SANITATION, OR HIS OR HER DESIGNEE;

12 (I) THE COMMISSIONER OF HEALTH AND MENTAL HYGIENE, OR HIS OR HER  
13 DESIGNEE;

14 (J) THE CHAIRMAN OF THE STATE LIQUOR AUTHORITY, OR HIS OR HER DESIG-  
15 NEE; AND

16 (K) THE COMMISSIONER OF THE FIRE DEPARTMENT.

17 (2) THE MEMBERS OF THE COMMISSION ON ROOSEVELT AVENUE SHALL RECEIVE NO  
18 COMPENSATION FOR THEIR SERVICES PURSUANT TO THIS SECTION.

19 C. WITHIN ONE YEAR OF THE EFFECTIVE DATE OF THIS SECTION THE COMMIS-  
20 SION ON ROOSEVELT AVENUE SHALL ESTABLISH AND SUBMIT TO THE GOVERNOR,  
21 STATE LEGISLATURE, MAYOR AND COUNCIL AN ACTION PLAN FOR ROOSEVELT  
22 AVENUE. SUCH PLAN SHALL INCLUDE THE COMMISSION'S FINDINGS, CONCLUSIONS  
23 AND RECOMMENDATIONS, AND A COMPREHENSIVE PLAN THAT IDENTIFIES LONG-TERM  
24 SOLUTIONS TO PERSISTENT CRIME AND HAMPERED ECONOMIC DEVELOPMENT ALONG  
25 ROOSEVELT AVENUE IN THE BOROUGH OF QUEENS, BETWEEN SEVENTY-FOURTH STREET  
26 AND ONE HUNDRED FOURTEENTH STREET.

27 S 2. This act shall take effect on the thirtieth day after it shall  
28 have become a law, and shall expire and be deemed repealed five years  
29 after such date.
