AN ACT to amend the education law, in relation to establishing a parent and student training center within the City University of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 2590-v 2 to read as follows:

3 S 2590-V. PARENT TRAINING. 1. THE CITY UNIVERSITY OF NEW YORK SHALL OPERATE A PARENT AND STUDENT TRAINING CENTER, KNOWN AS THE PARENT TRAIN-4 5 ING CENTER ("CENTER") FOR THE SUPPORT AND TRAINING OF PARENTS OR PERSONS 6 IN PARENTAL RELATION TO A STUDENT OR STUDENTS ATTENDING PUBLIC SCHOOL IN 7 CITY OF NEW YORK. SUCH TRAINING SHALL OCCUR IN EACH OF THE FIVE THE 8 BOROUGHS. THE CENTER SHALL DESIGN AND IMPLEMENT PROGRAMS FOR PARENT ENGAGEMENT WITHIN PUBLIC SCHOOLS IN THE CITY OF NEW YORK, COORDINATING, 9 WHERE APPROPRIATE, WITH THE CITY SCHOOL DISTRICT OF 10 THE CITY OF NEW YORK. THE CENTER SHALL: 11

12 (A) CONDUCT TRAINING AND SUPPORT PROGRAMS FOR PARENTS IN ORDER TO 13 INCREASE THEIR CAPACITY TO PARTICIPATE IN AND ENGAGE WITH LOCAL, DISTRICT, AND CITY-WIDE SCHOOL GOVERNANCE AND PARTICIPATORY STRUCTURES 14 DESIGNED TO SUPPORT AND INCLUDE PARENTAL AND STUDENT INPUT INCLUDING BUT 15 NOT LIMITED TO SCHOOL LEADERSHIP TEAMS, COMMUNITY EDUCATION COUNCILS, 16 17 DISTRICT LEADERSHIP TEAMS, PARENT ASSOCIATIONS, CITY-WIDE COUNCILS AND OTHER EXISTING FORMAL GOVERNANCE AND PARTICIPATORY STRUCTURES DESIGNED 18 19 TO SUPPORT AND INCLUDE PARENTAL AND STUDENT INPUT;

20 CONDUCT OUTREACH AND RECRUITMENT (B) TO INCREASE DIVERSITY IN THE ABOVE LISTED GOVERNANCE AND PARTICIPATORY STRUCTURES TO BETTER 21 REFLECT THE DIVERSE COMPOSITION OF THE REPRESENTED COMMUNITY, WITH AN EMPHASIS 22 23 ON PROVIDING RESOURCES AND TRAINING IN COMMUNITY DISTRICTS WHERE GRADU-24 ATION AND RETENTION RATES ARE IN THE LOWER HALF OF THE CITY-WIDE GRADU-25 ATION AND RETENTION RATES;

(C) IMPLEMENT PROGRAMS TO ENHANCE PARENTS' ABILITY TO SUPPORT
STUDENTS' EDUCATIONAL SUCCESS, INCLUDING SUPPORT FOR PARENTS TO HELP
THEM COMMUNICATE WITH SCHOOL ADMINISTRATORS AND TEACHERS, TRACK THEIR
CHILD'S PERFORMANCE, AND FOSTER AN ENVIRONMENT FOR LEARNING AT HOME;
(D) ASSIST PARENTS AND STUDENTS IN INTERACTING WITH CITY SCHOOL

6 DISTRICT PERSONNEL AND IN DEVELOPING AN UNDERSTANDING OF THE FUNCTION, 7 STRUCTURE AND OPERATIONS OF THE CITY OF NEW YORK DEPARTMENT OF EDUCA-8 TION, INCLUDING PROVIDING BASIC INFORMATION CONCERNING SPECIAL EDUCATION 9 PROGRAMS, GIFTED AND TALENTED PROGRAMS, ENGLISH LANGUAGE LEARNER 10 PROGRAMS, SCHOOL IMPROVEMENT STRATEGIES, SCHOOL BUDGET, ENROLLMENT PROCEDURES, AND STATE AND CITY STRUCTURES AND POLICIES THAT IMPACT 11 EDUCATION, AND THE EFFECT OF SUCH STRATEGIES, PROCEDURES, STRUCTURES AND 12 POLICIES ON THE EDUCATION BEING PROVIDED BY THE STUDENT'S SCHOOL; 13

(E) ENCOURAGE STUDENT BASED COLLEGE COUNSELING INITIATIVES DESIGNED TO
 INCREASE THE RATE OF COLLEGE ENROLLMENT AND TRAIN STUDENTS TO BECOME
 YOUTH LEADERS, INCLUDING BUT NOT LIMITED TO STUDENT SUCCESS CENTERS.

17 2. PRIORITY IN DESIGNING AND IMPLEMENTING PROGRAMS SHALL BE GIVEN TO 18 SCHOOLS AND DISTRICTS IN WHICH THERE IS LOW OVERALL ACADEMIC ACHIEVEMENT 19 BY STUDENTS OR WHICH HAVE A HIGH DENSITY OF ENGLISH LANGUAGE LEARNING 20 STUDENTS OR LOW-INCOME FAMILIES. SCHOOLS WITH INEFFECTIVE PARENT ASSOCI-21 ATIONS OR WITHOUT PARENT ASSOCIATIONS SHALL RECEIVE TARGET SUPPORT.

3. UPON REQUEST BY THE CENTER, THE CITY SCHOOL DISTRICT SHALL PROVIDE THE CENTER WITH NAMES AND CONTACT INFORMATION OF THE OFFICERS OF PARENT ASSOCIATIONS, MEMBERS OF COUNCILS OF PRESIDENTS, MEMBERS OF THE CHANCELLOR'S PARENT ADVISORY COUNCIL, MEMBERS OF COMMUNITY EDUCATION COUNCILS, MEMBERS OF SCHOOL LEADERSHIP TEAMS, MEMBERS OF DISTRICT LEAD-ERSHIP TEAMS, AND MEMBERS OF THE CITY-WIDE COUNCILS, PROVIDED THIS INFORMATION IS PUBLICLY AVAILABLE.

4. THE CENTER SHALL BE STRICTLY NON-PARTISAN, SHALL NOT ENGAGE IN ISSUES OF ADVOCACY, AND SHALL REMAIN NEUTRAL IN ALL POLICY MATTERS AND DISPUTES.

5. THE CITY OF NEW YORK SHALL PROVIDE ANNUAL FUNDING TO THE CENTER IN AN AMOUNT EQUAL TO THAT PROVIDED IN AN APPROPRIATION BY THE STATE, BUT NOT TO EXCEED EIGHT HUNDRED THOUSAND DOLLARS PER YEAR.

35 S 2. This act shall take effect immediately.
