- AN ACT to amend part 0 of chapter 59 of the laws of 2016, relating to reports by the office for people with developmental disabilities relating to housing needs, in relation to the office for people with developmental disabilities transformation panel; and in relation to the effectiveness thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 2 of part 0 of chapter 59 of the laws of 2016, 2 relating to reports by the office for people with developmental disabil-3 ities relating to housing needs, is renumbered section 3 and amended, 4 and a new section 2 is added to read as follows:
