AN ACT to amend the mental hygiene law, in relation to the preparation of educational materials to be provided to health care providers to be disseminated to individuals with confirmed or suspected substance use disorders; and to amend the public health law, in relation to establishing guidelines for hospital substance use disorder policies and procedures

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 19.07 of the mental hygiene law is amended by
2 adding a new subdivision (l) to read as follows:
3 (L) THE OFFICE OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES, IN CONSUL-
4 TATION WITH THE DEPARTMENT OF HEALTH, SHALL DEVELOP OR UTILIZE EXISTING
5 EDUCATIONAL MATERIALS TO BE PROVIDED TO HEALTH CARE PROVIDERS TO DISSEM-
6 INATE TO CONFIRMED OR SUSPECTED INDIVIDUALS WITH SUBSTANCE USE DISORDERS
7 DURING DISCHARGE PLANNING PURSUANT TO SECTION TWENTY-EIGHT HUNDRED
8 THREE-I OF THE PUBLIC HEALTH LAW FROM A GENERAL HOSPITAL. SUCH MATERIALS
9 SHALL INCLUDE INFORMATION REGARDING TREATMENT AND RECOVERY SERVICES,
10 INCLUDING BUT NOT LIMITED TO HOW TO RECOGNIZE THE NEED FOR TREATMENT
11 SERVICES, INFORMATION FOR INDIVIDUALS TO DETERMINE WHAT TREATMENT
12 RESOURCES ARE AVAILABLE TO THEM, AND ANY OTHER INFORMATION THE COMMIS-
13 SIONER DEEMS APPROPRIATE.
14 S 2. The public health law is amended by adding a new section 2803-u
15 to read as follows:
16 S 2803-U. HOSPITAL SUBSTANCE USE DISORDER POLICIES AND PROCEDURES. 1.
17 EVERY GENERAL HOSPITAL SHALL:
18 (A) DEVELOP, MAINTAIN AND DISSEMINATE WRITTEN POLICIES AND PROCEDURES
19 FOR THE IDENTIFICATION, ASSESSMENT AND REFERRAL OF CONFIRMED OR
20 SUSPECTED CASES OF SUBSTANCE USE DISORDERS AS DEFINED IN SECTION 1.03 OF
21 THE MENTAL HYGIENE LAW;

1 (B) ESTABLISH AND IMPLEMENT A TRAINING PROGRAM FOR ALL CURRENT AND NEW
2 EMPLOYEES ENGAGED IN PROVIDING DIRECT CLINICAL SERVICES TO PATIENTS
3 REGARDING THE POLICIES AND PROCEDURES ESTABLISHED PURSUANT TO THIS
4 SECTION; AND

5 (C) IF THE HOSPITAL DOES NOT HAVE OTHER ARRANGEMENTS FOR PROVIDING OR
6 COORDINATING THE PROVISION OF SERVICES TO INDIVIDUALS WITH SUBSTANCE USE
7 DISORDERS, CONTACT A SUBSTANCE USE DISORDER SERVICES PROGRAM THAT
8 PROVIDES BEHAVIORAL HEALTH SERVICES, AS DEFINED IN SECTION 1.03 OF THE
9 MENTAL HYGIENE LAW, IN THE GEOGRAPHIC AREA SERVED BY SUCH HOSPITAL TO
10 COORDINATE THE PROVISION OF SERVICES TO INDIVIDUALS WITH SUBSTANCE USE
11 DISORDERS.

12 2. UPON ADMITTANCE, COMMENCEMENT OF TREATMENT, OR DISCHARGE OF A
13 CONFIRMED OR SUSPECTED INDIVIDUAL WITH A SUBSTANCE USE DISORDER, SUCH
14 HOSPITAL SHALL INFORM THE INDIVIDUAL, ORALLY AND IN WRITING, OF THE
15 AVAILABILITY OF THE SUBSTANCE USE DISORDER TREATMENT SERVICES, INCLUDING
16 BUT NOT LIMITED TO MEDICATION-ASSISTED TREATMENT, THAT MAY BE AVAILABLE
17 TO THEM THROUGH A SUBSTANCE USE DISORDER SERVICES PROGRAM.

18 3. THE COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF THE
19 OFFICE OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES, SHALL MAKE REGU-
20 LATIONS AS MAY BE NECESSARY AND PROPER TO CARRY OUT THE PROVISIONS OF
21 THIS SECTION.

22 S 3. This act shall take effect on the one hundred eightieth day after
23 it shall have become a law; provided, however, that the commissioner of
24 health, the commissioner of alcoholism and substance abuse services, and
25 general hospitals shall, respectively, make regulations and take other
26 actions reasonably necessary to implement this act on such date.
