AN ACT to amend the general business law, in relation to retention of construction contracts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 756-c of the general business law, as added by 2 chapter 127 of the laws of 2002, is amended to read as follows:

3 756-c. Retention. By mutual agreement of the relevant parties an S 4 owner may retain a reasonable amount of the contract sum as retainage[. AND FOR ANY CONSTRUCTION CONTRACTS, EXCLUDING CONSTRUCTION CONTRACTS 5 A] FINANCED BY A PUBLIC BENEFIT CORPORATION, SUCH RETAINAGE SHALL BE DEPOS-6 7 A SEPARATE INTEREST BEARING ESCROW ACCOUNT WITH A THIRD PARTY ITED IN8 ESCROW AGENT. AS OF THE TIME OF THE DEPOSIT OF THE RETAINAGE, THE SOLE SEPARATE PROPERTY OF THE 9 FUNDS SHALL BECOME THE AND RETAINED 10 CONTRACTOR. INTEREST ON THE RETAINED FUNDS SHALL ACCRUE AT AN INTEREST 11 AT LEAST EOUAL TO THE PREVAILING INTEREST RATE PAID ON DEPOSITS BY RATE THE ESCROW AGENT. ALSO, A contractor or subcontractor may [also] retain 12 a reasonable amount for retainage so long as the amount does not exceed 13 14 the actual percentage [retained] DEPOSITED IN ESCROW by the owner. 15 [Retainage] THE ESCROWED RETAINAGE shall be released by the [owner] OWNER'S WRITTEN DIRECTION TO THE ESCROW AGENT TO DELIVER THE 16 ESCROWED RETAINAGE to the contractor no later than thirty days after the final 17 approval of the work under a construction contract. In the event that an 18 19 owner fails to release THE ESCROWED retainage as required by this arti-20 cle, or the contractor or subcontractor fails to release a proportionate 21 amount of retainage to the relevant parties WITHIN FIVE DAYS after 22 receipt of THE ESCROWED retainage from the owner, (I) the owner[, contractor, or subcontractor, as the case may be, shall be subject to 23 the payment of interest at the rate of one percent per month on the date 24 25 retention was due and owing] SHALL BE SUBJECT TO THE PAYMENT OF INTER-26 IN ADDITION TO THE ESCROW INTEREST, AT THE RATE OF ONE PERCENT PER EST, 27 MONTH COMMENCING ON THE DATE THE RETAINAGE WAS DUE TO BE RELEASED FROM THE CONTRACTOR OR SUBCONTRACTOR, AS THE CASE MAY BE, 28 ESCROW; AND (II)

SHALL BE SUBJECT TO THE PAYMENT OF INTEREST ON THE AMOUNT OF RETAINAGE
