AN ACT to amend the state finance law, in relation to state contracts for landscape architecture

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 136-a of the state finance law, as amended by chapter 746 of the laws of 1982, subdivision 4 as amended by chapter 383 of the laws of 1994, is amended to read as follows:

2     S 136-a. Contracts for architectural, engineering, LANDSCAPE ARCHITECTURE and surveying services. 1. As used in this section: the term "professional firm" shall be defined as any individual or sole proprietorship, partnership, corporation, association or other legal entity permitted by law to practice the professions of architecture, engineering, LANDSCAPE ARCHITECTURE or surveying.

3     The term "state department" shall be defined as those state government departments, divisions or commissions empowered by the state to enter into contractual agreements on behalf of the state of New York.

4     2. It is the policy of New York state to negotiate contracts for architectural and/or engineering services and/or LANDSCAPING ARCHITECTURE AND/OR surveying services on the basis of demonstrated competence and qualification for the type of professional services required and at fair and reasonable fees.

5     3. In the procurement of architectural, engineering, LANDSCAPE ARCHITECTURE and surveying services, the requiring state department shall encourage professional firms engaged in the lawful practice of the profession to submit an annual statement of qualifications and performance data. The requiring state department for each proposed project shall evaluate current statements of qualifications and performance data on file with the department. If desired, the requiring state department may conduct discussions with three or more professional firms regarding anticipated design concepts and proposed methods of approach to the assignment. The state department shall select, in order of preference,

1 based upon criteria established by the requiring state department, no  
2 less than three professional firms deemed to be the most highly quali-  
3 fied to provide the services required.

4 4. The requiring state department shall negotiate a contract with the  
5 highest qualified professional firm for architectural and/or engineering  
6 services and/or LANDSCAPE ARCHITECTURE SERVICE AND/OR surveying services  
7 at compensation which the department determines in writing to be fair  
8 and reasonable to the state of New York. In making this decision, the  
9 department shall take into account the estimated value of the services  
10 to be rendered, including the costs, the scope, complexity, and profes-  
11 sional nature thereof. The department shall not refuse to negotiate  
12 with a professional firm solely because the ratio of the "allowable  
13 indirect costs" to direct labor costs of the professional firm or the  
14 hourly labor rate in any labor category of the professional firm exceeds  
15 a limitation generally set by the department in the determination of the  
16 reasonableness of the estimated cost of services to be rendered by the  
17 professional firm, but rather the department should also consider the  
18 reasonableness of cost based on the total estimated cost of the service  
19 of the professional firm which should include, among other things, all  
20 the direct labor costs of the professional firm for such services plus  
21 all "allowable indirect costs," other direct costs, and negotiated  
22 profit of the professional firm. "Allowable indirect costs" of a profes-  
23 sional firm are defined as those costs generally associated with over-  
24 head which cannot be specifically identified with a single project or  
25 contract and are considered reasonable and allowable under specific  
26 state contract or allowability limits. Should the requiring state  
27 department be unable to negotiate a satisfactory contract with the  
28 professional firm considered to be the most qualified, at a fee the  
29 department determines to be fair and reasonable to the state of New  
30 York, negotiations with that professional firm shall be formally termi-  
31 nated. The requiring state department shall then undertake negotiations  
32 with the second most qualified professional firm. Failing accord with  
33 the second most qualified professional firm, the department shall  
34 formally terminate negotiations. The requiring state department shall  
35 then undertake negotiations with the third most qualified professional  
36 firm. Should the requiring state department be unable to negotiate a  
37 satisfactory contract with any of the selected professional firms, it  
38 shall select additional professional firms in order of their competence  
39 and qualification and it shall continue negotiations in accordance with  
40 this section until an agreement is reached.

41 5. This legislation shall only apply to engineering and/or architec-  
42 tural services and/or LANDSCAPE ARCHITECTURE AND/OR surveying services  
43 in excess of twenty-five thousand dollars.

44 S 2. This act shall take effect on the sixtieth day after it shall  
45 become a law.
