AN ACT to amend the alcoholic beverage control law, in relation to the training of applicants, licensees and servers of alcoholic beverages; and to repeal certain provisions of such law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 12 of section 17 of the alcoholic beverage 1 control law, as amended by chapter 549 of the laws of 2001, is REPEALED. 2 3 2. Subdivision 10 of section 18 of the alcoholic beverage control S 4 law is REPEALED. 5 S 3. The alcoholic beverage control law is amended by adding a new 6 section 18-a to read as follows: 7 TRAINING AWARENESS PROGRAMS. 1. THE CHAIRMAN SHALL S 18-A. ALCOHOL 8 DEVELOP AND ESTABLISH MINIMUM CRITERIA FOR RETAIL LICENSEE ALCOHOL TRAINING AWARENESS PROGRAMS AND SERVER ALCOHOL AWARENESS. 9 10 (A) SUCH CRITERIA SHALL INCLUDE THE MINIMUM REOUIREMENTS FOR THE CURRICULUM OF LICENSE AND SERVER TRAINING PROGRAMS. THERE SHALL BE SEPA-11 RATE SERVER TRAINING PROGRAMS FOR EMPLOYEES OF ON-PREMISES AND OFF-PREM-12 13 ISES RETAIL LICENSEES. 14 SUCH CRITERIA SHALL INCLUDE THE FORM OF A CERTIFICATE OF (B) COMPLETION OR RENEWAL THEREOF TO BE ISSUED IN RESPECT TO EACH SUCH TYPE 15 16 OF PROGRAM. (C) RETAIL LICENSEE PROGRAMS SHALL INCLUDE, BUT SHALL NOT BE LIMITED 17 18 TRAINING ON THE PREVENTION OF SALES AND SERVICE OF ALCOHOLIC BEVER-TO, AGES TO PERSONS UNDER THE AGE OF TWENTY-ONE AND INTOXICATED PATRONS, AND 19 OPERATING THE LICENSED PREMISES IN COMPLIANCE WITH THIS CHAPTER AND THE 20 RULES OF THE AUTHORITY. 21 22 (D) SERVER PROGRAMS SHALL INCLUDE, BUT SHALL NOT BE LIMITED TO, TRAIN-23 ING ON THE PREVENTION OF SALES AND SERVICE OF ALCOHOLIC BEVERAGES TO PERSONS UNDER THE AGE OF TWENTY-ONE AND INTOXICATED PATRONS. 24 EXPLANATION--Matter in ITALICS (underscored) is new; matter in brackets [] is old law to be omitted.

PERSON, PARTNERSHIP, LIMITED LIABILITY COMPANY OR CORPORATION THAT HAS

(D) EACH CERTIFIED TRAINING PROVIDER SHALL TRANSMIT A OUARTERLY REPORT 29 30 THE AUTHORITY WITH THE NAMES, ADDRESSES AND DATES OF ATTENDANCE OF TO ALL THE INDIVIDUALS WHO SUCCESSFULLY COMPLETED AN APPROVED PROGRAM. SUCH 31 32 TRANSMITTAL SHALL BE IN A FORM AND MANNER PRESCRIBED BY THE AUTHORITY. 5. give and administer an] A CERTIFIED TRAINING PROVIDER FOR A LICENSEE OR 1 2 SERVER alcohol training awareness program [pursuant to subdivision 3 twelve of] AS PROVIDED FOR IN section [seventeen] EIGHTEEN-A of this 4 chapter. Such licensee shall have diligently implemented and complied 5 with all of the provisions of the approved training program. In such 6 proceeding to revoke, cancel or suspend a license pursuant to section one hundred eighteen of this chapter, the licensee must prove each 7 8 element of such affirmative defense by a preponderance of the credible evidence. Evidence of three unlawful sales of alcoholic beverages by 9 10 any employee of a licensee to persons under twenty-one years of age, within a two year period, shall be considered by the authority in deter-11 mining whether the licensee had diligently implemented such an approved 12 13 program.

14 S 5. Subdivision 7 of section 65 of the alcoholic beverage control 15 law, as added by chapter 435 of the laws of 2010, is amended to read as 16 follows:

7. In any proceeding pursuant to section one hundred eighteen of this chapter to revoke, cancel or suspend a license to sell alcoholic beverages, in which proceeding a charge is sustained that a person violated subdivision one or two of this section and the licensee has not had any adjudicated violation of this chapter at the licensed premises where the violation occurred within the previous five year period; and

23 (a) at the time of such violation the person that committed such 24 violation held a valid certificate of completion [or renewal] from [an 25 entity authorized to give and administer an] A CERTIFIED TRAINING 26 PROVIDER FOR A LICENSEE OR SERVER alcohol training awareness program [pursuant to subdivision twelve of] AS PROVIDED FOR IN section [seven-27 28 teen] EIGHTEEN-A of this chapter, the civil penalty related to such 29 offense shall be recovery of, as provided for in section one hundred twelve of this chapter, the penal sum of the bond on file during the 30 period in which the violation took place; or 31

32 (b) at the time of such violation the licensee has not had any adjudi-33 cated violations of this chapter at the licensed premises where the violation occurred within the previous five year period, any civil 34 penalty imposed shall be reduced by twenty-five percent if the licensee 35 submits written proof, within ninety days of the imposition of such 36 37 civil penalty, that all of the licensee's employees involved in the direct sale or service of alcoholic beverages to the public at the 38 39 licensed premises where the violation occurred have obtained a valid 40 certificate of completion [or renewal] from [an entity authorized to give and administer an] A CERTIFIED TRAINING PROVIDER FOR A LICENSEE OR 41 SERVER alcohol training awareness program [pursuant to subdivision 42 43 twelve of] AS PROVIDED FOR IN section [seventeen] EIGHTEEN-A of this 44 chapter.

For the purposes of this subdivision, the five year period shall be 46 measured from the dates that the violations occurred.

47 S 6. The alcoholic beverage control law is amended by adding a new 48 section 106-c to read as follows:

49 S 106-C. REQUIRED TRAINING FOR ON-PREMISES LICENSEES AND EMPLOYEES. 1. 50 EVERY LICENSEE HOLDING A LICENSE UNDER SECTION FIFTY-FIVE, FIFTY-FIVE-A, 51 EIGHTY-ONE, EIGHTY-ONE-A, SIXTY-FOUR, SIXTY-FOUR-A, SIXTY-FOUR-B, THIS CHAPTER SHALL HAVE A PERSON WHO 52 SIXTY-FOUR-C OR SIXTY-FOUR-D OF HOLDS A VALID CERTIFICATE OF COMPLETION FROM AN APPROVED LICENSEE ALCO-53 54 HOL AWARENESS TRAINING PROGRAM AS PROVIDED FOR IN SECTION EIGHTEEN-A OF 55 THIS CHAPTER.

(A) IN THE CASE OF AN INDIVIDUAL HOLDING A LICENSE, SUCH PERSON SHALL 1 2 BE THE LICENSEE; 3 (B) IN THE CASE OF A PARTNERSHIP HOLDING A LICENSE, SUCH PERSON SHALL 4 BE ONE OF THE PARTNERS; 5 (C) IN THE CASE OF A CORPORATION HOLDING A LICENSE, SUCH PERSON SHALL 6 BE ONE OF THE OFFICERS OR DIRECTORS; AND 7 (D) IN THE CASE OF A LIMITED LIABILITY COMPANY, SUCH PERSON SHALL BE 8 ONE OF THE MEMBERS. 9 2. (A) NO LICENSEE HOLDING A LICENSE UNDER SECTION FIFTY-FIVE, FIFTY-10 EIGHTY-ONE, EIGHTY-ONE-A, SIXTY-FOUR, SIXTY-FOUR-A, FIVE-A, SIXTY-FOUR-B, SIXTY-FOUR-C OR SIXTY-FOUR-D OF THIS CHAPTER SHALL EMPLOY 11 A PERSON TO PERFORM ANY OF THE FOLLOWING DUTIES UNLESS SUCH PERSON HOLDS 12 A VALID CERTIFICATE OF COMPLETION FROM AN APPROVED SERVER ALCOHOL AWARE-13 14 NESS TRAINING PROGRAM AS PROVIDED FOR IN SECTION EIGHTEEN-A OF THIS 15 CHAPTER: (I) ANY PERSON WHO SELLS OR SERVES ALCOHOLIC BEVERAGES TO PATRONS 16 OF 17 THE LICENSED PREMISES; 18 (II)ANY PERSON WHO CHECKS IDENTIFICATION OF PATRONS IN OR ENTERING 19 THE LICENSED PREMISES; (III) ANY PERSON PROVIDING SECURITY IN OR ABOUT THE LICENSED PREMISES; 20 21 (IV) ANY PERSON WHO SUPERVISES PERSONS PERFORMING THE DUTIES SET FORTH 22 IN SUBPARAGRAPH (I), (II) OR (III) OF THIS PARAGRAPH. 23 (B) FOR PURPOSES OF THIS SUBDIVISION, "EMPLOY" SHALL INCLUDE PERSONS EMPLOYED DIRECTLY BY THE LICENSEE AND ANY OTHER PERSON DIRECTLY OR INDI-24 25 RECTLY HIRED OR RETAINED TO PERFORM SERVICES FOR THE LICENSEE. 26 (C) THE PROVISIONS OF THIS SUBDIVISION SHALL NOT APPLY TO ANY PERSON WHO HAS BEEN DIRECTLY EMPLOYED BY THE LICENSEE FOR LESS THAN SIXTY DAYS. 27 28 S 7. Section 109 of the alcoholic beverage control law is amended by 29 adding a new subdivision 3 to read as follows: 30 3. NO APPLICATION FOR THE RENEWAL OF A LICENSE UNDER SECTION 31 FIFTY-FIVE-A, EIGHTY-ONE, EIGHTY-ONE-A, FIFTY-FIVE, SIXTY-FOUR, 32 SIXTY-FOUR-A, SIXTY-FOUR-B, SIXTY-FOUR-C OR SIXTY-FOUR-D OF THIS CHAPTER 33 SHALL BE APPROVED UNLESS THE LICENSEE SUBMITS PROOF OF COMPLIANCE WITH 34 THE PROVISIONS OF SUBDIVISION ONE OF SECTION ONE HUNDRED SIX-C OF THIS 35 ARTICLE. 36 S 8. Section 110 of the alcoholic beverage control law is amended by 37 adding a new subdivision 3-a to read as follows: 3-A. NO APPLICATION FOR A LICENSE UNDER 38 SECTION FIFTY-FIVE, 39 FIFTY-FIVE-A, EIGHTY-ONE, EIGHTY-ONE-A, SIXTY-FOUR, SIXTY-FOUR-A, 40 SIXTY-FOUR-B, SIXTY-FOUR-C OR SIXTY-FOUR-D OF THIS CHAPTER SHALL BE 41 APPROVED UNLESS THE LICENSEE SUBMITS PROOF OF COMPLIANCE WITH THE PROVISIONS OF SUBDIVISION ONE OF SECTION ONE HUNDRED SIX-C OF THIS ARTI-42 43 CLE. 44 S 9. Subdivision 7 of section 110-b of the alcoholic beverage control 45 law, as amended by chapter 560 of the laws of 2011, is amended to read 46 as follows: 47 7. The liquor authority shall require such notification to be on a 48 standardized form that can be obtained on the internet or from the liquor authority and such notification to include: 49 50 (a) the trade name or "doing business as" name, if any, of the estab-51 lishment; 52 (b) the full name of the applicant; (c) the street address of the establishment, including the floor 53 54 location or room number, if applicable; 55 (d) the mailing address of the establishment, if different than the 56 street address;

(e) the name, address and telephone number of the attorney or repre-1 2 sentative of the applicant, if any;

(f) a statement indicating whether the application is for:

(i) a new establishment;

(ii) a transfer of an existing licensed business;(iii) a renewal of an existing license; or

(iv) an alteration of an existing licensed premises;

(g) if the establishment is a transfer or previously licensed prem-8 ises, the name of the old establishment and such establishment's license 9 10 serial number;

(h) in the case of a renewal or alteration application, the license 11 12 serial number of the applicant; [and]

(i) the type of license[.]; AND 13

14 (J) A STATEMENT THAT THE APPLICANT IS IN COMPLIANCE WITH THE 15 PROVISIONS OF SUBDIVISION ONE OF SECTION ONE HUNDRED SIX-C OF THIS ARTI-16 CLE.

17 S 10. This act shall take effect on the one hundred eightieth day after it shall have become a law provided, however, that section one of 18 19 this act shall take effect upon the expiration and reversion of section 17 of the alcoholic beverage control law as provided in section 4 of 20 21 chapter 118 of the laws of 2012, as amended.
