AN ACT to amend the retirement and social security law, in relation to a waiver of earnings limitation for certain retirees of the New York state and local police and fire retirement system who are employed by the state university

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subparagraphs 6 and 7 of paragraph (a) of subdivision 2 of section 211 of the retirement and social security law, subparagraph 6 as amended by chapter 753 of the laws of 1976 and subparagraph 7 as amended by chapter 840 of the laws of 1983, are amended and a new subparagraph 8 is added to read as follows:

(6) the chancellor of state university if such person is to be employed in the unclassified service of the state university of New York, or in the professional service at the state colleges of agriculture, home economics, veterinary medicine or industrial and labor relations, the state agricultural experiment station at Geneva or any other institution or agency under the management and control of Cornell university as representative of the board of trustees of university of New York, or at the state college of ceramics under the management and control of Alfred university as representative of board of trustees of THE state university of New York or in the unclassified service of a community college other than those in the city of York, OR IF SUCH PERSON IS A RETIRED MEMBER OF THE NEW YORK STATE AND LOCAL POLICE AND FIRE RETIREMENT SYSTEM AND IS TO BE EMPLOYED AS A
