AN ACT to amend the vehicle and traffic law, in relation to adding a bicycle and pedestrian safety component to the pre-licensing driver's education course

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph (i) of paragraph (a) and paragraphs (b) and 2 (d) of subdivision 4 of section 502 of the vehicle and traffic law, 3 subparagraph (i) of paragraph (a) as amended by chapter 458 of the laws 4 of 2011 and paragraphs (b) and (d) as amended by chapter 585 of the laws 5 of 2002, are amended and a new paragraph (c-3) is added to read as 6 follows:

7 (i) Upon submission of an application for a driver's license, the applicant shall be required to take and pass a test, or submit evidence 8 of passage of a test, with respect to the laws relating to traffic, the 9 laws relating to driving while ability is impaired and while intoxicat-10 ed, under the overpowering influence of "Road Rage", or "Work Zone Safe-11 ty" awareness as defined by the commissioner, the law relating to exer-12 cising due care to avoid colliding with a parked, stopped or standing 13 authorized emergency vehicle or hazard vehicle pursuant to section elev-14 en hundred forty-four-a of this chapter, the ability to read and compre-15 16 hend traffic signs and symbols, BICYCLE AND PEDESTRIAN SAFETY, and such 17 other matters as the commissioner may prescribe, and to satisfactorily 18 complete a course prescribed by the commissioner of not less than four hours and not more than five hours, consisting of classroom driver 19 training and highway safety instruction or the equivalent thereof. 20 Such include at least seven written questions concerning the 21 test shall effects of consumption of alcohol or drugs on the ability of a person to 22 operate a motor vehicle and the legal and financial consequences result-23 24 ing from violations of section eleven hundred ninety-two of this chap-

ter, prohibiting the operation of a motor vehicle while under the influ-1 2 ence of alcohol or drugs. Such test shall include one or more written 3 questions concerning the devastating effects of "Road Rage" on the abil-4 ity of a person to operate a motor vehicle and the legal and financial 5 consequences resulting from assaulting, threatening or interfering with 6 lawful conduct of another person legally using the roadway. Such the 7 test shall include one or more questions concerning the potential 8 dangers to persons and equipment resulting from the unsafe operation of 9 a motor vehicle in a work zone. Such test may include one or more ques-10 tions concerning the law for exercising due care to avoid colliding with parked, stopped or standing authorized emergency vehicle or hazard 11 а 12 vehicle pursuant to section eleven hundred forty-four-a of this chapter. 13 SUCH TEST SHALL INCLUDE ONE OR MORE QUESTIONS CONCERNING BICYCLE AND 14 PEDESTRIAN SAFETY. Such test shall be administered by the commissioner. 15 The commissioner shall cause the applicant to take a vision test and a test for color blindness. Upon passage of the vision test, the applica-16 17 tion may be accepted and the application fee shall be payable.

18 (b) Upon successful completion of the requirements set forth in para-19 graph (a) of this subdivision which shall include an alcohol and drug education component as described in paragraph (c) of this subdivision, a 20 21 "Road Rage" awareness component as described in paragraph (c-1) of this subdivision [and], a "Work Zone Safety" awareness component as described 22 paragraph (c-2) of this subdivision, AND A "BICYCLE AND PEDESTRIAN 23 in 24 SAFETY" COMPONENT AS DESCRIBED IN PARAGRAPH (C-3) OF THIS SUBDIVISION, 25 the commissioner shall cause the applicant to take a road test in a 26 representative vehicle of a type prescribed by the commissioner which shall be appropriate to the type of license for which application is 27 28 made, except that the commissioner may waive the road test requirements 29 for certain classes of applicants. The commissioner shall have the power 30 establish a program to allow persons other than employees of the to department to conduct road tests in representative vehicles when such 31 32 tests are required for applicants to obtain a class A, B or C license. 33 If she chooses to do so, she shall set forth her reasons in writing and 34 conduct a public hearing on the matter. She shall only establish such a 35 program after holding the public hearing.

(C-3) "BICYCLE AND PEDESTRIAN SAFETY" COMPONENT. (I) THE COMMISSIONER 36 37 SHALL PROVIDE IN THE PRE-LICENSING COURSE, SET FORTH IN PARAGRAPH (B) OF 38 THIS SUBDIVISION, A MANDATORY COMPONENT IN "BICYCLE AND PEDESTRIAN SAFE-39 TY" EDUCATION AS A PREREQUISITE FOR OBTAINING A LICENSE TO OPERATE A 40 MOTOR VEHICLE. THE PURPOSE OF THE COMPONENT IS TO EDUCATE PROSPECTIVE THE POTENTIAL DANGERS TO PEDESTRIANS, BICYCLISTS, IN-LINE 41 LICENSEES ON 42 SKATERS, SCOOTER RIDERS, SKATEBOARDERS AND OTHER NON-MOTORIZED VEHICLES 43 CREATED BY MOTOR VEHICLES.

44 THECOMMISSIONER SHALL ESTABLISH A CURRICULUM FOR THE "BICYCLE (II)45 AND PEDESTRIAN SAFETY" COMPONENT WHICH SHALL INCLUDE BUT NOT BE LIMITED SAFELY PASSING A CYCLIST ON THE ROAD, SPECIAL CONSIDERATIONS WHILE 46 TO: 47 DRIVING IN URBAN AREAS, BICYCLE LANES AS DEFINED IN SECTION ONE HUNDRED 48 TWO-A OF THIS CHAPTER AND OTHER ROADWAY DESIGNS EMPLOYED IN NEW YORK 49 STATE FOR THE SAFETY OF PEDESTRIANS AND CYCLISTS, HOW TO NAVIGATE AN 50 WITH PEDESTRIANS AND CYCLISTS, EXITING A VEHICLE WITHOUT INTERSECTION 51 ENDANGERING PEDESTRIANS AND CYCLISTS, THE REOUIREMENT THAT DRIVERS EXER-CISE DUE CARE TO AVOID COLLISION WITH A BICYCLIST OR PEDESTRIAN 52 ON THE ROAD PURSUANT TO SECTION ELEVEN HUNDRED FORTY-SIX OF THIS CHAPTER. 53

54 (III) IN DEVELOPING SUCH CURRICULUM, THE COMMISSIONER SHALL CONSULT 55 WITH THE COMMISSIONER OF TRANSPORTATION, THE COMMISSIONER OF TRANSPORTA-56 TION OF THE CITY OF NEW YORK AND BICYCLE AND PEDESTRIAN ADVOCATES.

(d) The commissioner shall make available for distribution upon regis-1 2 tration at each location where the pre-licensing course will be given, instructional handbooks outlining the content of the entire curriculum 3 4 of the pre-licensing course including the information required to be included in the course pursuant to paragraphs (c), (c-1) [and], (c-2) AND (C-3) of this subdivision. The commissioner shall also provide for 5 б 7 the additional training of the instructors necessary for the competent instruction of the alcohol and drug education [and], "Road Rage" aware-8 ness [and], "Work Zone Safety" awareness AND "BICYCLE AND PEDESTRIAN SAFETY" subject matters of the pre-licensing course. 9 10
