- AN ACT to amend the public health law, the tax law and the state finance law, in relation to providing for taxpayer gifts for women's cancers education and prevention and establishing the women's cancers education and prevention fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 207 of the public health law is 2 amended by adding a new paragraph (1) to read as follows:

3 (L) THE DANGERS OF WOMEN'S CANCERS, INCLUDING WAYS TO PREVENT AND
4 SEVERITY OF SUCH DISEASES. FOR PURPOSES OF THIS PARAGRAPH, WOMEN'S
5 CANCERS SHALL MEAN AND INCLUDE: CERVICAL, ENDOMETRIAL, GESTATIONAL
6 TROPHOBLASTIC TUMOR, OVARIAN, UTERINE SARCOMA, VAGINAL, AND VULVAR.

7 S 2. The tax law is amended by adding a new section 209-I to read as 8 follows:

9 S 209-I. GIFT FOR WOMEN'S CANCERS EDUCATION AND PREVENTION. A TAXPAY-YEAR MAY ELECT TO CONTRIBUTE TO THE SUPPORT OF THE 10 IN ANY TAXABLE ER WOMEN'S CANCERS EDUCATION AND PREVENTION FUND. SUCH CONTRIBUTION 11 SHALL 12 ANY WHOLE DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF THE ΒE IN 13 STATE TAX OWED BY SUCH TAXPAYER. THE COMMISSIONER SHALL INCLUDE SPACE ON THE CORPORATE INCOME TAX RETURN TO ENABLE A TAXPAYER TO MAKE 14 SUCH NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ALL REVENUES 15 CONTRIBUTION. COLLECTED PURSUANT TO THIS SECTION SHALL BE CREDITED 16 TO THE WOMEN'S

1 CANCERS EDUCATION AND PREVENTION FUND AND SHALL BE USED ONLY FOR THOSE 2 PURPOSES ENUMERATED IN SECTION NINETY-SEVEN-LLLL OF THE STATE FINANCE 3 LAW.

4 S 3. Part 2 of article 22 of the tax law is amended by adding a new 5 section 630-d to read as follows:

6 S 630-D. GIFT FOR WOMEN'S CANCERS EDUCATION AND PREVENTION. AN INDI-7 VIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE WOMEN'S 8 CANCERS EDUCATION AND PREVENTION FUND. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY 9 10 SUCH INDIVIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE PERSONAL TAX RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIBUTION. 11 INCOME NOTWITHSTANDING ANY OTHER PROVISION OF LAW ALL REVENUES COLLECTED PURSU-12 ANT TO THIS SECTION SHALL BE CREDITED TO THE WOMEN'S CANCERS EDUCATION 13 14 AND PREVENTION FUND AND USED ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION NINETY-SEVEN-LLLL OF THE STATE FINANCE LAW. 15

16 S 4. The state finance law is amended by adding a new section 97-1111 17 to read as follows:

18 S 97-LLLL. WOMEN'S CANCERS EDUCATION AND PREVENTION FUND. 1. THERE IS 19 HEREBY ESTABLISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF TAXATION 20 AND FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS THE 21 "WOMEN'S CANCERS EDUCATION AND PREVENTION FUND".

SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED BY THE DEPARTMENT 22 2. OF TAXATION AND FINANCE, PURSUANT TO THE PROVISIONS OF SECTION TWO 23 HUNDRED NINE-I AND SECTION SIX HUNDRED THIRTY-D OF THE TAX LAW, AND ALL 24 25 OTHER MONEYS APPROPRIATED, CREDITED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED IN THIS SECTION 26 27 SHALL PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS OR BEQUESTS FOR THE PURPOSES OF THE FUND AS DEFINED IN THIS SECTION AND DEPOSITING THEM INTO 28 29 THE FUND ACCORDING TO LAW.

3. MONIES OF THE FUND SHALL BE EXPENDED ONLY FOR WOMEN'S CANCERS
EDUCATION AND PREVENTION PROJECTS. AS USED IN THIS SECTION, "WOMEN'S
CANCERS EDUCATION AND PREVENTION PROJECTS" MEANS EDUCATIONAL PROJECTS,
INCLUDING GRANTS FOR WOMEN'S CANCERS EDUCATION AND PREVENTION PROGRAMS,
WHICH ARE APPROVED BY THE DEPARTMENT OF HEALTH.

35 4. MONIES SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF 36 THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMMISSIONER 37 OF HEALTH.

5. TO THE EXTENT PRACTICABLE, THE COMMISSIONER OF HEALTH SHALL ENSURE THAT ALL MONIES RECEIVED DURING A FISCAL YEAR ARE EXPENDED PRIOR TO THE END OF THAT FISCAL YEAR.

41 S 5. This act shall take effect immediately.
