AN ACT to amend the insurance law, in relation to mandatory health
insurance coverage for cleft lip and cleft palate

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is
2 amended by adding a new paragraph 32 to read as follows:
3 (32) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR
4 COMPREHENSIVE-TYPE COVERAGE SHALL INCLUDE COVERAGE FOR CLEFT LIP AND
5 CLEFT PALATE. THIS SHALL INCLUDE COVERAGE NOT ONLY FOR TREATMENT OF THE
6 GROSS ABNORMALITIES OF LIP AND PALATE BUT ALSO FOR ANY CONDITION OR
7 ILLNESS WHICH IS RELATED TO OR DEVELOPED AS A RESULT OF CLEFT LIP AND/OR
8 PALATE. COVERAGE SHALL INCLUDE, BUT NOT BE LIMITED TO, EXPENSES FOR THE
9 FOLLOWING:
10 (A) ORAL SURGERY OF THE LIP, PALATE, JAW AND RELATED STRUCTURES. THIS
11 SHALL INCLUDE BONE GRAFTS;
12 (B) FACIAL SURGERY OF THE LIP, PALATE, JAW, NOSE AND RELATED STRUC-
13 TURES. THIS SHALL INCLUDE BONE GRAFTS;
14 (C) PROSTHETIC TREATMENT AND APPLIANCES AND PROSTHODONTIA, INCLUDING
15 OBTURATORS, SPEECH APPLIANCES, AND FEEDING APPLIANCES;
16 (D) ORTHODONTIC TREATMENT AND APPLIANCES AND ORTHODONTIA;
17 (E) PREVENTIVE AND RESTORATIVE DENTISTRY;
18 (F) OTOLARYNGOLOGY TREATMENT AND MANAGEMENT;
19 (G) AUDIOLOGICAL TREATMENT AND DEVICES;
20 (H) SPEECH/LANGUAGE TREATMENT; AND
21 (I) PSYCHOLOGICAL COUNSELING AND GENETIC COUNSELING.
22 COVERAGE SHALL INCLUDE EXPENSES FOR ASSESSMENT, EVALUATION, TREATMENT,
23 MANAGEMENT, AND FOLLOW-UP CARE. COVERAGE SHALL NOT BE DENIED ON THE

3 S 2. Subsection (1) of section 3221 of the insurance law is amended by
4 adding a new paragraph 19 to read as follows:

5 (19) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR
6 COMPREHENSIVE-TYPE COVERAGE SHALL INCLUDE COVERAGE FOR CLEFT LIP AND
7 CLEFT PALATE. THIS SHALL INCLUDE COVERAGE NOT ONLY FOR TREATMENT OF THE
8 GROSS ABNORMALITIES OF LIP AND PALATE BUT ALSO FOR ANY CONDITION OR
9 ILLNESS WHICH IS RELATED TO OR DEVELOPED AS A RESULT OF CLEFT LIP AND/OR

28 S 3. Section 4303 of the insurance law is amended by adding a new
29 subsection (pp) to read as follows:

30 (PP) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR
31 COMPREHENSIVE-TYPE COVERAGE SHALL INCLUDE COVERAGE FOR CLEFT LIP AND
32 CLEFT PALATE. THIS SHALL INCLUDE COVERAGE NOT ONLY FOR TREATMENT OF THE
33 GROSS ABNORMALITIES OF LIP AND PALATE BUT ALSO FOR ANY CONDITION OR
34 ILLNESS WHICH IS RELATED TO OR DEVELOPED AS A RESULT OF CLEFT LIP AND/OR
35 PALATE. COVERAGE SHALL INCLUDE, BUT NOT BE LIMITED TO, EXPENSES FOR THE
36 FOLLOWING:

53 S 4. This act shall take effect on the ninetieth day after it shall
54 have become a law and shall apply to policies and contracts issued,
55 renewed, modified, altered or amended on or after such date.
