- AN ACT to amend the civil service law, in relation to reduction of positions in the New York city departments of sanitation and correction based upon seniority with an employer

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 80 of the civil service law is amended by adding a 2 new subdivision 1-g to read as follows:

3 NOTWITHSTANDING THE PROVISIONS OF 1-G. SUBDIVISION ONE OF THIS 4 ANY OF THE UNIFORMED FORCE OF THE DEPARTMENT OF SANITATION OR SECTION, THE DEPARTMENT OF CORRECTION OF THE CITY OF NEW YORK SHALL BE SUBJECT TO 5 6 THE FOLLOWING PROCEDURE. WHERE, BECAUSE OF ECONOMY, CONSOLIDATION OR 7 FUNCTIONS, CURTAILMENT OF ACTIVITIES OR OTHERWISE, POSI-ABOLITION OF 8 TIONS IN THE COMPETITIVE CLASS ARE ABOLISHED OR REDUCED IN RANK OR SALA-9 RY GRADE, SUSPENSION OR DEMOTION, AS THE CASE MAY BE, AMONG INCUMBENTS 10 HOLDING THE SAME OR SIMILAR POSITIONS SHALL BE MADE IN THE INVERSE ORDER ORIGINAL APPOINTMENT ON A PERMANENT BASIS IN THE GRADE OR TITLE IN 11 OF THE SERVICE OF THE GOVERNMENTAL JURISDICTION IN WHICH SUCH ABOLITION 12 OR 13 REDUCTION OF POSITIONS OCCURS, SUBJECT TO THE PROVISIONS OF SUBDIVISION SEVEN OF SECTION EIGHTY-FIVE OF THIS CHAPTER. NOTWITHSTANDING THE PROVISIONS OF THIS SUBDIVISION, HOWEVER, UPON THE ABOLITION OR REDUCTION 14 15 POSITIONS, THOSE EMPLOYEES WHO HAVE NOT COMPLETED THEIR PROBATIONARY 16 OF SERVICE SHALL BE SUSPENDED OR DEMOTED, AS THE CASE MAY BE, 17 BEFORE ANY PERMANENT INCUMBENTS, AND AMONG SUCH PROBATIONARY EMPLOYEES THE ORDER OF 18 19 SUSPENSION OR DEMOTION SHALL BE DETERMINED AS IF SUCH EMPLOYEES WERE 20 PERMANENT INCUMBENTS.

21 S 2. This act shall take effect immediately.
