AN ACT to amend the real property tax law, the administrative code of the city of New York and the real property law, in relation to classifying properties held in condominium and cooperative form for assessment purposes as class one-a properties; and to amend the general municipal law and the education law, in relation to establishing limitations upon school district and local government tax levies in the city of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 1802 of the real property tax law,
2 as separately amended by chapters 123 and 529 of the laws of 1990, para-
3 graph class one as amended by chapter 332 of the laws of 2008, is
4 amended to read as follows:
5 1. All real property, for the purposes of this article, in a special
6 assessing unit shall be classified as follows:
7 Class one: (a) all one, two and three family residential real proper-
8 ty, including such dwellings used in part for nonresidential
9 purposes but which are used primarily for residential purposes,
10 except such property held in cooperative or condominium forms of
11 ownership other than (i) property defined in subparagraphs (b)
12 and (c) of this paragraph and (ii) property which contains no
13 more than three dwelling units held in condominium form of
14 ownership and which was classified within this class on a previ-
15 ous assessment roll; and provided that, notwithstanding the
16 provisions of paragraph (g) of subdivision twelve of section one
17 hundred two of this chapter, a mobile home or a trailer shall

1 not be classified within this class unless it is owner-occupied
2 and separately assessed; and (b) residential real property not
3 more than three stories in height held in condominium form of
4 ownership, provided that no dwelling unit therein previously was
5 on an assessment roll as a dwelling unit in other than condomi-
6 nium form of ownership; and (c) residential real property
7 consisting of one family house structures owned by the occupant,
8 situated on land held in cooperative ownership by owner occupi-
9 ers, provided that; (i) such house structures and land consti-
10 tuted bungalow colonies in existence prior to nineteen hundred
11 forty; and (ii) the land is held in cooperative ownership for
12 the sole purpose of maintaining one family residences for
13 members own use; and (d) all vacant land located within a
14 special assessing unit which is a city (i) other than such land
15 in the borough of Manhattan, provided that any such vacant land
16 which is not zoned residential must be situated immediately
17 adjacent to property improved with a residential structure as
18 defined in subparagraphs (a) and (b) of this paragraph, be owned
19 by the same owner as such immediately adjacent residential prop-
20 erty immediately prior to and since January 1, 1989, and have a
21 total area not exceeding 10,000 square feet; and (ii) located in
22 the borough of Manhattan north of or adjacent to the north side
23 of 110th street provided such vacant land was classified within
24 this class on the assessment roll with a taxable status date of
25 January 5, 2008 and the owner of such land has entered into a
26 recorded agreement with a governmental entity on or before
27 December 31, 2008 requiring construction of housing affordable
28 to persons or families of low income in accordance with the
29 provisions of the private housing finance law. Notwithstanding
30 the foregoing, such vacant land shall be classified according to
31 its use on the assessment roll with a taxable status date imme-
32 diately following commencement of construction, provided
33 further, that construction pursuant to an approved plan for
34 affordable housing shall commence no later than December 31,
35 2010; and (e) all vacant land located within a special assessing
36 unit which is not a city, provided that such vacant land which
37 is not zoned residential must be situated immediately adjacent
38 to real property defined in subparagraph (a), (b) or (c) of this
39 paragraph and be owned by the same person or persons who own the
40 real property defined in such subparagraph immediately prior to
41 and since January 1, 2003;

42 CLASS ONE-A: ALL OTHER RESIDENTIAL REAL PROPERTY HELD IN CONDOMINIUM
43 OR COOPERATIVE FORM OF OWNERSHIP WHICH IS NOT DESIGNATED AS
44 CLASS ONE; THE DEPARTMENT OF FINANCE OF ANY CITY ENACTING A
45 LOCAL LAW PURSUANT TO THIS SECTION SHALL RECLASSIFY CLASS ONE-A
46 PROPERTIES USED PRIMARILY TO GENERATE RENTAL INCOME TO CLASS
47 TWO. THE DEPARTMENT OF FINANCE OF ANY CITY ENACTING A LOCAL LAW
48 PURSUANT TO THIS SECTION SHALL HAVE, IN ADDITION TO ANY OTHER
49 FUNCTIONS, POWERS AND DUTIES WHICH HAVE BEEN OR MAY BE CONFERRED
50 ON IT BY LAW, THE POWER TO MAKE AND PROMULGATE RULES TO CARRY
51 OUT THE PURPOSES OF THIS SECTION INCLUDING, BUT NOT LIMITED TO,
52 RULES DEFINING THE CLASS ONE-A PROPERTIES PRIMARILY USED TO
53 GENERATE RENTAL INCOME, AND RELATING TO THE TIMING, FORM AND
54 MANNER OF ANY CERTIFICATION REQUIRED TO BE SUBMITTED UNDER THIS
55 SECTION. IF A PROPERTY PREVIOUSLY RECLASSIFIED FROM CLASS ONE-A
56 TO CLASS TWO CEASES TO BE USED PRIMARILY TO GENERATE RENTAL

1 INCOME, THE DEPARTMENT SHALL RECLASSIFY SUCH PROPERTY TO CLASS
2 ONE-A. THE DEPARTMENT SHALL USE A FIVE-YEAR PERIOD WHEN DETER-
3 MINING WHETHER A PROPERTY IS USED PRIMARILY TO GENERATE RENTAL
4 INCOME;

5 CLASS TWO: ALL OTHER RESIDENTIAL REAL PROPERTY WHICH IS NOT DESIGNATED
6 AS CLASS ONE OR CLASS ONE-A, except hotels and motels and other
7 similar commercial property;

8 Class three: utility real property and property subject to former
9 section four hundred seventy of this chapter;

10 Class four: all other real property which is not designated as class
11 one, CLASS ONE-A, class two, or class three.

12 S 2. Subdivision 1, paragraph (c) of subdivision 2 and subdivision 4
13 of section 307-a of the real property tax law, as added by section 1 of
14 part G of chapter 63 of the laws of 2003, are amended to read as
15 follows:

16 1. Generally. Notwithstanding any provision of any general, special
17 or local law to the contrary, any city with a population of one million
18 or more is hereby authorized and empowered to adopt and amend local laws
19 in accordance with this section imposing an additional tax on certain
20 class one AND CLASS ONE-A properties, as such properties are defined in
21 section eighteen hundred two of this chapter, excluding vacant land.

22 (c) "Net real property tax" means the real property tax assessed on A
23 class one OR CLASS ONE-A property after deduction for any exemption or
24 abatement received pursuant to this chapter.

25 4. Property subject to additional tax. Such surcharge shall be imposed
26 on class one AND CLASS ONE-A property, excluding vacant land, that
27 provides rental income and is not the primary residence of the owner or
28 owners of such class one OR CLASS ONE-A property, or the primary resi-
29 dence of the parent or child of such owner or owners.

30 S 3. Paragraph (d) of subdivision 2 of section 425 of the real proper-
31 ty tax law, as added by section 1 of part B of chapter 389 of the laws
32 of 1997 and as further amended by subdivision (b) of section 1 of part W
33 of chapter 56 of the laws of 2010, is amended to read as follows:

34 (d) Equalization adjustment. To account for the variance in the level
35 of assessment among assessing units, the figure determined in paragraph
36 (c) of this subdivision shall be multiplied by an "equalization factor,"
37 which shall be the appropriate state equalization rate or special equal-
38 ization rate established by the commissioner. Provided, that in the case
39 of a special assessing unit, (i) the equalization factor for class one
40 in each school district portion shall be the class equalization rate for
41 class one in the portion, [and] (ii) THE EQUALIZATION FACTOR FOR CLASS
42 ONE-A IN EACH SCHOOL DISTRICT PORTION SHALL BE THE EQUALIZATION RATE FOR
43 CLASS ONE IN THE PORTION, MULTIPLIED BY THE LATEST TAX RATE FOR CLASS
44 ONE IN THE PORTION, AND THEN DIVIDED BY THE LATEST TAX RATE FOR CLASS
45 ONE-A IN THE PORTION, AND (III) the equalization factor for class two in
46 each school district portion shall be the equalization factor for class
47 one in the portion, multiplied by the latest tax rate for class one in
48 the portion, and then divided by the latest tax rate for class two in
49 the portion. Provided further, that in any instance when school district
50 taxes are levied upon an assessment roll which predates the latest final
51 assessment roll, the equalization factor shall be the state equalization
52 rate for the assessment roll upon which school district taxes are to be
53 levied.

54 S 4. Paragraph (f) of subdivision 1 of section 467-a of the real prop-
55 erty tax law, as added by chapter 273 of the laws of 1996, is amended to
56 read as follows:

1 (f) "Property" means real property designated as class [two] ONE-A,
2 pursuant to section eighteen hundred two of this chapter, held in the
3 cooperative or condominium form of ownership.

4 S 5. Subdivision 7 of section 499-aaa of the real property tax law, as
5 added by chapter 461 of the laws of 2008, is amended to read as follows:

6 7. "Eligible building" shall mean a class one, CLASS ONE-A, class two
7 or class four real property, as defined in subdivision one of section
8 eighteen hundred two of this chapter, located within a city having a
9 population of one million or more persons. No building shall be eligible
10 for more than one tax abatement pursuant to this title.

11 S 6. Subdivision 7 of section 499-aaaa of the real property tax law,
12 as added by chapter 473 of the laws of 2008, is amended to read as
13 follows:

14 7. "Eligible building" shall mean a class one, CLASS ONE-A, class two
15 or class four real property, as defined in subdivision one of section
16 eighteen hundred two of this chapter, located within a city having a
17 population of one million or more persons. No building shall be eligible
18 for more than one tax abatement pursuant to this title.

19 S 7. Paragraph (b) of subdivision 3 of section 522 of the real proper-
20 ty tax law, as added by chapter 714 of the laws of 1982, is amended to
21 read as follows:

22 (b) in a special assessing unit, the determination, pursuant to
23 section eighteen hundred two of this chapter, of whether real property
24 is included in class one, ONE-A, two, three or four.

25 S 8. Subdivision 10 of section 523-b of the real property tax law, as
26 added by chapter 593 of the laws of 1998, is amended to read as follows:

27 10. On or before April first, each year the commission shall mail to
28 each applicant, who has filed an application for the correction of the
29 assessment, a notice of the commission's determination of such appli-
30 cant's assessment. Such notice shall also contain the statement as to
31 the final determination of the assessment review commission, or a state-
32 ment that the commission has not yet made a determination as to the
33 final assessed valuation which shall be made as soon as the petitioners
34 application is reviewed or heard. If the applicants property is a prop-
35 erty defined in subdivision one of section eighteen hundred two of this
36 chapter as "Class 1", the commissions determination shall contain the
37 statement: "If you are dissatisfied with the determination of the
38 Assessment Review Commission and you are the owner of a one, two or
39 three family residential structure or residential real property not more
40 than three stories in height held in condominium form of ownership,
41 provided that no dwelling unit therein previously was on an assessment
42 roll as a dwelling unit in other than condominium form of ownership, and
43 you reside at such residence, you may seek judicial review of your
44 assessment either under title one of article seven of the real property
45 tax law or under small claims assessment review law provided by title
46 one-A of article seven of the real property tax law." Such notice shall
47 also state that the last date to file petitions for judicial review and
48 the location where small claims assessment review petitions may be
49 obtained.

50 Each applicant that has filed an application of a property as defined
51 in subdivision one of section eighteen hundred two of this chapter as
52 "CLASS 1-A", "Class 2", "Class 3" or "Class 4", shall receive a notice
53 as to the final determination of the assessment review commission or a
54 statement that the commission has not yet made a determination as to the
55 final assessed valuation which shall be made as soon as the petitioners
56 application is reviewed or heard. Such applicants determinations shall

1 contain the statement: "If you are dissatisfied with the determination
2 of the Assessment Review Commission you may seek judicial review of your
3 assessment under title one of article seven of the real property tax
4 law." Such notice shall also state the last date to file petitions for
5 judicial review. A final determination when rendered shall contain the
6 same statement. Failure to mail any such notice or failure of the appli-
7 cant to receive the same shall not affect the validity of the assess-
8 ment.

9 S 9. Paragraph (b) of subdivision 3 of section 701 of the real proper-
10 ty tax law, as added by chapter 714 of the laws of 1982, is amended to
11 read as follows:

12 (b) In a special assessing unit, the determination, pursuant to
13 section eighteen hundred two of this chapter, of whether real property
14 is included in class one, ONE-A, two, three or four.

15 S 10. Subparagraph 2 of paragraph (a) of subdivision 3 of section 720
16 of the real property tax law, as amended by chapter 679 of the laws of
17 1986, is amended to read as follows:

18 (2) "Major type of property" in special assessing units, for assess-
19 ments on rolls completed after December thirty-first, nineteen hundred
20 eighty-one, shall mean classes one, ONE-A, two, three and four as
21 defined in subdivision one of section eighteen hundred two of this chap-
22 ter.

23 S 11. The opening paragraph of subdivision 1 of section 1805 of the
24 real property tax law, as amended by chapter 935 of the laws of 1984, is
25 amended and two new subdivisions 1-a and 1-b are added to read as
26 follows:

27 The assessor of any special assessing unit shall not increase the
28 assessment of any individual parcel classified in class one OR CLASS
29 ONE-A in any one year, as measured from the assessment on the previous
30 year's assessment roll, by more than six percent and shall not increase
31 such assessment by more than twenty percent in any five-year period. The
32 first such five-year period shall be measured from the individual
33 assessment appearing on the assessment roll completed in nineteen
34 hundred eighty; provided that if such parcel would not have been subject
35 to the provisions of this subdivision in nineteen hundred eighty had
36 this subdivision then been in effect, the first such five-year period
37 shall be measured from the first year after nineteen hundred eighty in
38 which this subdivision applied to such parcel or would have applied to
39 such parcel had this subdivision been in effect in such year.

40 If, in respect to any individual parcel classified in class one on the
41 assessment roll completed and applicable for the year nineteen hundred
42 eighty-two, the assessment for the year nineteen hundred eighty-one
43 exceeds by more than twenty percent the assessment for the year nineteen
44 hundred eighty, such assessor shall compute the actual assessments to be
45 entered on assessment rolls applicable to the years nineteen hundred
46 eighty-two through nineteen hundred ninety as follows:

47 1-A. ASSESSMENT ROLLS COMPUTED FOR CLASS ONE-A SHALL INCLUDE ANY
48 OUTSTANDING PHASED-IN INCREASES ACCRUED PRIOR TO THE EFFECTIVE DATE OF
49 THE CHAPTER OF THE LAWS OF TWO THOUSAND FIFTEEN WHICH ADDED THIS SUBDI-
50 VISION PURSUANT TO SUBDIVISION THREE OF THIS SECTION.

51 1-B. CLASS ONE-A PARCELS SHALL BE ASSESSED IN A METHOD COMPARABLE TO
52 CLASS ONE PARCELS.

53 S 12. Subdivisions e and f of section 11-208.1 of the administrative
54 code of the city of New York, subdivision e as amended by local law
55 number 41 of the city of New York for the year 1986 and subdivision f as

1 amended by chapter 385 of the laws of 2006, are amended to read as
2 follows:

3 e. As used in this section, the term "income-producing property" means
4 property owned for the purpose of securing an income from the property
5 itself, but shall not include property with an assessed value of forty
6 thousand dollars or less, or residential property containing ten or
7 fewer dwelling units or property classified in class one, ONE-A or two
8 as defined in article eighteen of the real property tax law containing
9 six or fewer dwelling units and one retail store.

10 f. Except in accordance with proper judicial order or as otherwise
11 provided by law, it shall be unlawful for the commissioner, any officer
12 or employee of the department, the president or a commissioner or
13 employee of the tax commission, any person engaged or retained by the
14 department or the tax commission on an independent contract basis, or
15 any person, who, pursuant to this section, is permitted to inspect any
16 income and expense statement or to whom a copy, an abstract or a portion
17 of any such statement is furnished, to divulge or make known in any
18 manner except as provided in this subdivision, the amount of income
19 and/or expense or any particulars set forth or disclosed in any such
20 statement required under this section. The commissioner, the president
21 of the tax commission, or any commissioner or officer or employee of the
22 department or the tax commission charged with the custody of such state-
23 ments shall not be required to produce any income and expense statement
24 or evidence of anything contained in them in any action or proceeding in
25 any court, except on behalf of the department or the tax commission.
26 Nothing herein shall be construed to prohibit the delivery to an owner
27 or his or her duly authorized representative of a certified copy of any
28 statement filed by such owner pursuant to this section or to prohibit
29 the publication of statistics so classified as to prevent the identifi-
30 cation of particular statements and the items thereof, or making known
31 aggregate income and expense information disclosed with respect to prop-
32 erty classified as class four as defined in article eighteen of the real
33 property tax law without identifying information about individual leas-
34 es, or making known a range as determined by the commissioner within
35 which the income and expenses of a property classified as CLASS ONE-A OR
36 class two falls, or the inspection by the legal representatives of the
37 department or of the tax commission of the statement of any owner who
38 shall bring an action to correct the assessment. Any violation of the
39 provisions of this subdivision shall be punished by a fine not exceeding
40 one thousand dollars or by imprisonment not exceeding one year, or both,
41 at the discretion of the court, and if the offender be an officer or
42 employee of the department or the tax commission, the offender shall be
43 dismissed from office.

44 S 13. Subdivision a of section 11-238 of the administrative code of
45 the city of New York, as amended by local law number 27 of the city of
46 New York for the year 2006, is amended to read as follows:

47 a. Imposition of surcharge. A real property tax surcharge is hereby
48 imposed on class one AND CLASS ONE-A property, as defined in section
49 eighteen hundred two of the real property tax law, excluding vacant
50 land, that provides rental income and is not the primary residence of
51 the owner or owners of such class one OR CLASS ONE-A property, or the
52 primary residence of the parent or child of such owner or owners, in an
53 amount equal to zero percent of the net real property taxes for fiscal
54 years beginning on or after July first, two thousand six. As used in
55 this section, "net real property tax" means the real property tax

1 assessed on class one property after deduction for any exemption or
2 abatement received pursuant to the real property tax law or this title.

3 S 14. Subdivisions a, a-1, a-2, a-3, a-4 and a-5 of section 11-319 of
4 the administrative code of the city of New York, subdivisions a, a-1,
5 a-2 and a-3 as amended and subdivisions a-4 and a-5 as added by local
6 law number 15 of the city of New York for the year 2011, are amended to
7 read as follows:

8 a. A tax lien or tax liens on a property or any component of the
9 amount thereof may be sold by the city as authorized by subdivision b of
10 this section, when such tax lien or tax liens shall have remained unpaid
11 in whole or in part for one year, provided, however, that a tax lien or
12 tax liens on any class one property or on class [two] ONE-A property
13 [that is a residential condominium or residential cooperative], as such
14 classes of property are defined in subdivision one of section eighteen
15 hundred two of the real property tax law, may be sold by the city only
16 when the real property tax component of such tax lien or tax liens shall
17 have remained unpaid in whole or in part for three years or, in the case
18 of any class two residential property owned by a company organized
19 pursuant to article XI of the state private housing finance law [that is
20 not a residential condominium or a residential cooperative], as such
21 class of property is defined in subdivision one of section eighteen
22 hundred two of the real property tax law, for two years, and equals or
23 exceeds the sum of five thousand dollars or, in the case of abandoned
24 class one property or abandoned class [two] ONE-A property [that is a
25 residential condominium or residential cooperative], for eighteen
26 months, and after such sale, shall be transferred, in the manner
27 provided by this chapter, and provided, further, however, that (i) the
28 real property tax component of such tax lien may not be sold pursuant to
29 this subdivision on any residential real property in class one that is
30 receiving an exemption pursuant to section 11-245.3 or 11-245.4 of this
31 title, or pursuant to section four hundred fifty-eight of the real prop-
32 erty tax law with respect to real property purchased with payments
33 received as prisoner of war compensation from the United States govern-
34 ment, or pursuant to paragraph (b) or (c) of subdivision two of section
35 four hundred fifty-eight-a of the real property tax law, or where the
36 owner of such residential real property in class one is receiving bene-
37 fits in accordance with department of finance memorandum 05-3, or any
38 successor memorandum thereto, relating to active duty military person-
39 nel, or where the owner of such residential real property in class one
40 has been allowed a credit pursuant to subsection (e) of section six
41 hundred six of the tax law for the calendar year in which the date of
42 the first publication, pursuant to subdivision a of section 11-320 of
43 this chapter, of the notice of sale, occurs or for the calendar year
44 immediately preceding such date and (ii) the sewer rents component,
45 sewer surcharges component or water rents component of such tax lien may
46 not be sold pursuant to this subdivision on any one family residential
47 real property in class one or on any two or three family residential
48 real property in class one that is receiving an exemption pursuant to
49 section 11-245.3 or 11-245.4 of this title, or pursuant to section four
50 hundred fifty-eight of the real property tax law with respect to real
51 property purchased with payments received as prisoner of war compen-
52 sation from the United States government, or pursuant to paragraph (b)
53 or (c) of subdivision two of section four hundred fifty-eight-a of the
54 real property tax law, or where the owner of any two or three family
55 residential real property in class one is receiving benefits in accord-
56 ance with department of finance memorandum 05-3, or any successor memo-

1 random thereto, relating to active duty military personnel, or where the
2 owner of any two or three family residential real property in class one
3 has been allowed a credit pursuant to subsection (e) of section six
4 hundred six of the tax law for the calendar year in which the date of
5 the first publication, pursuant to subdivision a of section 11-320 of
6 this chapter, of the notice of sale, occurs or for the calendar year
7 immediately preceding such date. A tax lien or tax liens on any property
8 classified as a class two property, except [a class two property that is
9 a residential condominium or residential cooperative, or] a class two
10 residential property owned by a company organized pursuant to article XI
11 of the state private housing finance law [that is not a residential
12 condominium or a residential cooperative], or class three property, as
13 such classes of property are defined in subdivision one of section eight-
14 teen hundred two of the real property tax law, shall not be sold by the
15 city unless such tax lien or tax liens include a real property tax
16 component as of the date of the first publication, pursuant to subdivi-
17 sion a of section 11-320 of this chapter, of the notice of sale.
18 Notwithstanding any provision of this subdivision to the contrary, any
19 such tax lien or tax liens that remain unpaid in whole or in part after
20 such date may be sold regardless of whether such tax lien or tax liens
21 include a real property tax component. A tax lien or tax liens on a
22 property classified as a class four property, as such class of property
23 is defined in subdivision one of section eighteen hundred two of the
24 real property tax law, shall not be sold by the city unless such tax
25 lien or tax liens include a real property tax component or sewer rents
26 component or sewer surcharges component or water rents component or
27 emergency repair charges component, where such emergency repair charges
28 accrued on or after January first, two thousand six and are made a lien
29 pursuant to section 27-2144 of this code, as of the date of the first
30 publication, pursuant to subdivision a of section 11-320 of this chap-
31 ter, of the notice of sale, provided, however, that any tax lien or tax
32 liens that remain unpaid in whole or in part after such date may be sold
33 regardless of whether such tax lien or tax liens include a real property
34 tax component, sewer rents component, sewer surcharges component, water
35 rents component or emergency repair charges component. For purposes of
36 this subdivision, the words "real property tax" shall not include an
37 assessment or charge upon property imposed pursuant to section 25-411 of
38 the administrative code. A sale of a tax lien or tax liens shall
39 include, in addition to such lien or liens that have remained unpaid in
40 whole or in part for one year, or, in the case of any class one property
41 or class [two] ONE-A property [that is a residential condominium or
42 residential cooperative], when the real property tax component of such
43 lien or liens has remained unpaid in whole or in part for three years,
44 or, in the case of any class two residential property owned by a company
45 organized pursuant to article XI of the state private housing finance
46 law [that is not a residential condominium or a residential cooper-
47 ative], when the real property tax component of such lien or liens has
48 remained unpaid in whole or in part for two years, and equals or exceeds
49 the sum of five thousand dollars, any taxes, assessments, sewer rents,
50 sewer surcharges, water rents, any other charges that are made a lien
51 subject to the provisions of this chapter, the costs of any advertise-
52 ments and notices given pursuant to this chapter, any other charges that
53 are due and payable, a surcharge pursuant to section 11-332 of this

45 where such water rents, sewer rents or sewer surcharges component of

32 eleven, the emergency repair charges component or alternative enforce-
33 ment expenses and fees component, where such emergency repair charges
34 accrued on or after January first, two thousand six and are made a lien
35 pursuant to section 27-2144 of this code, or where such alternative
36 enforcement expenses and fees are made a lien pursuant to section
37 27-2153 of this code, of any tax lien on any class of real property, as
38 such real property is defined in subdivision one of section eighteen
39 hundred two of the real property tax law, may be sold by the city pursu-

4 than ten days preceding the date of the sale of a tax lien or tax liens,
5 whether any such parcel is a distressed property as defined in subdivi-

7 determined to be a distressed property shall not be included in such

42 S 20. Paragraph 5 of subdivision c of section 11-405 of the adminis-
43 trative code of the city of New York, as added by local law number 37 of
44 the city of New York for the year 1996, is amended to read as follows:

45 (5) Notwithstanding paragraph one, two or three of this subdivision,
46 with respect to installment agreements duly made, executed and filed on
47 or after the date on which this paragraph takes effect, the commissioner
48 of finance may also exclude or thereafter remove from such list any
49 parcel of class one, CLASS ONE-A or class two real property, other than

21 AND THE RATE OF TAX IMPOSED DURING THE FISCAL YEAR IMMEDIATELY PRECEDING

25 S 2023-C. LIMITATIONS UPON NEW YORK CITY SCHOOL DISTRICT TAX LEVIES.
26 NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, BEGINNING IN
27 THE FISCAL YEAR COMMENCING ON OR AFTER JULY FIRST, TWO THOUSAND SIXTEEN,
28 THE ANNUAL PERCENTAGE CHANGE IN THE TAX RATE FOR TAXES LEVIED BY OR ON
29 BEHALF OF ANY SCHOOL DISTRICT IN THE CITY OF NEW YORK AND THE COUNTIES
30 CONTAINED THEREIN FOR SCHOOL DISTRICT PURPOSES FOR CLASS ONE-A PROPER-
31 TIES SHALL NOT EXCEED THE ANNUAL PERCENTAGE CHANGE IN SUCH TAX RATE FOR
32 CLASS ONE PROPERTIES, AS SUCH CLASSES OF PROPERTY ARE DEFINED IN SUBDI-
33 VISION ONE OF SECTION EIGHTEEN HUNDRED TWO OF THE REAL PROPERTY TAX LAW.
34 FOR PURPOSES OF THIS SUBDIVISION "ANNUAL PERCENTAGE CHANGE" SHALL MEAN
35 THE PERCENTAGE DIFFERENCE BETWEEN THE RATE OF TAX IMPOSED DURING THE
36 COMING FISCAL YEAR AND THE RATE OF TAX IMPOSED DURING THE FISCAL YEAR
37 IMMEDIATELY PRECEDING THE COMING FISCAL YEAR.

38 S 23. Subdivision 1 of section 581 of the real property tax law is
39 amended by adding a new paragraph (d) to read as follows:

40 (D) THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVISION SHALL NOT
41 APPLY TO PROPERTIES CLASSIFIED AS "CLASS ONE-A".

42 S 24. Subdivision 1 of section 339-y of the real property law, as
43 amended by chapter 218 of the laws of 1986, subparagraph (ii) of para-
44 graph (d) as amended by chapter 223 of the laws of 1989, paragraph (e)
45 as added by chapter 135 of the laws of 1996 and paragraph (f) as added
46 by chapter 293 of the laws of 1997, is amended to read as follows:

47 1. (a) With respect to all property submitted to the provisions of
48 this article other than property which is the subject of a qualified
49 leasehold condominium, each unit and its common interest, not including
50 any personal property, shall be deemed to be a parcel and shall be
51 subject to separate assessment and taxation by each assessing unit,
52 school district, special district, county or other taxing unit, for all
53 types of taxes authorized by law including but not limited to special ad
54 valorem levies and special assessments, except that the foregoing shall
55 not apply to a unit held under lease or sublease unless the declaration
56 requires the unit owner to pay all taxes attributable to his unit.

1 Neither the building, the property nor any of the common elements shall
2 be deemed to be a parcel.

3 (b) [In no event shall the aggregate of the assessment of the units
4 plus their common interests exceed the total valuation of the property
5 were the property assessed as a parcel.

6 (c)] For the purposes of this and the next succeeding section the
7 terms "assessing unit", "assessment", "parcel", "special ad valorem
8 levy", "special assessment", "special district", "taxation" and "taxes"
9 shall have the meanings specified in section one hundred two of the real
10 property tax law.

11 [(d) The provisions of paragraph (b) of this subdivision shall not
12 apply to such real property classified within:

13 (i) on and after January first, nineteen hundred eighty-six, class one
14 of section one thousand eight hundred two of the real property tax law;
15 or

16 (ii) on and after January first, nineteen hundred eighty-four, the
17 homestead class of an approved assessing unit which has adopted the
18 provisions of section one thousand nine hundred three of the real prop-
19 erty tax law, or the homestead class of the portion outside an approved
20 assessing unit of an eligible split school district which has adopted
21 the provisions of section nineteen hundred three-a of the real property
22 tax law; provided, however, that, in an approved assessing unit which
23 adopted the provisions of section one thousand nine hundred three of the
24 real property tax law prior to the effective date of this subdivision,
25 paragraph (b) of this subdivision shall apply to all such real property

26 (i) which is classified within the homestead class pursuant to paragraph
27 one of subdivision (e) of section one thousand nine hundred one of the
28 real property tax law and (ii) which, regardless of classification, was
29 on the assessment roll prior to the effective date of this subdivision
30 unless the governing body of such approved assessing unit provides by
31 local law adopted after a public hearing, prior to the taxable status
32 date of such assessing unit next occurring after December thirty-first,
33 nineteen hundred eighty-three, that such paragraph (b) shall not apply
34 to such real property to which this clause applies. Provided further,
35 however, real property subject to the provisions of this subparagraph
36 shall be assessed pursuant to subdivision two of section five hundred
37 eighty-one of the real property tax law.

38 (e)] (C) On the first assessment roll with a taxable status date on or
39 after the effective date of a declaration filed with the recording offi-
40 cer and on every assessment roll thereafter, the assessor shall enter
41 each unit as a parcel, as provided in paragraph (a) of this subdivision,
42 based upon the condition and ownership of each such unit on the appro-
43 priate valuation and taxable status dates. Units owned by a developer
44 may be entered as a single parcel with a parcel description correspond-
45 ing to the entire development, including the land under such develop-
46 ment, and excluding those units appearing separately. Upon the first
47 assessment roll where each unit is separately assessed, only an individ-
48 ual unit and its common interest shall constitute a parcel.

49 [(f) The provisions of paragraph (b) of this subdivision shall not
50 apply to a converted condominium unit in a municipal corporation other
51 than a special assessing unit, which has adopted, prior to the taxable
52 status date of the assessment roll upon which its taxes will be levied,
53 a local law or, for a school district, a resolution providing that the
54 provisions of paragraph (b) of this subdivision shall not apply to a
55 converted condominium unit within that municipal corporation. A
56 converted condominium unit for purposes of this paragraph shall mean a

1 dwelling unit held in condominium form of ownership that has previously
2 been on an assessment roll as a dwelling unit in other than condominium
3 form of ownership, and has not been previously subject to the provisions
4 of paragraph (b) of this subdivision.]

5 S 25. The New York city department of finance shall prepare a method-
6 ology to adjust class shares.

7 S 26. This act shall take effect on the first of January next succeed-
8 ing the date on which it shall have become a law and shall apply to
9 assessment rolls prepared pursuant to a taxable status date occurring on
10 or after such date; provided, however, that effective immediately, the
11 addition, amendment and/or repeal of any rule or regulation necessary
12 for the implementation of this act on its effective date is authorized
13 and directed to be made and completed on or before such effective date.
