AN ACT to amend the penal law and the alcoholic beverage control law, in relation to imposing additional fines when a person fails to pay his or her fines or fails to complete counseling or community service when mandated

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 221.05 of the penal law, as added by chapter 360 of 2 the laws of 1977, is amended to read as follows:

S 221.05 Unlawful possession of marihuana.

4 1. A person is guilty of unlawful possession of marihuana when he OR 5 SHE knowingly and unlawfully possesses marihuana.

6 Unlawful possession of marihuana is a violation punishable only by a 7 fine of not more than one hundred dollars. However, where the defendant has previously been convicted of an offense defined in this article or 8 9 article [220] TWO HUNDRED TWENTY of this chapter, committed within the 10 three years immediately preceding such violation, it shall be punishable only by a fine of not more than two hundred dollars, if the defend-11 (a) ant was previously convicted of one such offense committed during 12 such period, and (b) by a fine of not more than two hundred fifty dollars or 13 a term of imprisonment not in excess of fifteen days or both, 14 if the 15 defendant was previously convicted of two such offenses committed during 16 such period.

17 2. IN THE EVENT A PERSON WHO HAS BEEN CONVICTED OF UNLAWFUL POSSESSION FAILS TO PAY SUCH FINE AS MAY BE SET BY THE COURT WITHIN 18 OF MARIHUANA ONE HUNDRED TWENTY DAYS AFTER THE DECISION OF THE COURT, THEN IN ADDI-19 TO SUCH FINE, THE COURT MAY IMPOSE AN ADDITIONAL FINE OF NOT MORE 20 TION 21 THAN TWO HUNDRED FIFTY DOLLARS.

22 3. NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, SECTION 23 120.20 OF THE CRIMINAL PROCEDURE LAW SHALL APPLY IN THE EVENT A PERSON

8 S 2. Subdivision 3 of section 65-c of the alcoholic beverage control 9 law, as amended by chapter 137 of the laws of 2001, is amended to read 10 as follows:

11 3. (A) Any person who unlawfully possesses an alcoholic beverage with intent to consume may be summoned before and examined by a court having 12 jurisdiction of that charge; provided, however, that nothing contained 13 14 herein shall authorize, or be construed to authorize, a peace officer as 15 defined in subdivision thirty-three of section 1.20 of the criminal procedure law or a police officer as defined in subdivision thirty-four 16 17 section 1.20 of such law to arrest a person who unlawfully possesses of an alcoholic beverage with intent to consume. If a determination is made 18 19 sustaining such charge the court may impose a fine not exceeding fifty dollars and/or completion of an alcohol awareness program established 20 21 pursuant to section 19.25 of the mental hygiene law and/or an appropri-22 ate amount of community service not to exceed thirty hours.

23 (B) IN THE EVENT A PERSON WHO HAS BEEN DETERMINED TO HAVE UNLAWFULLY POSSESSED AN ALCOHOLIC BEVERAGE WITH INTENT TO CONSUME FAILS TO PAY SUCH 24 25 FINE AS MAY BE SET BY THE COURT, OR COMPLETE AN ALCOHOL AWARENESS 26 PROGRAM ESTABLISHED PURSUANT TO SECTION 19.25 OF THE MENTAL HYGIENE LAW AND/OR COMMUNITY SERVICE AS REQUIRED BY THE COURT WITHIN ONE 27 HUNDRED 28 DAYS AFTER THE DECISION OF THE COURT, THEN IN ADDITION TO SUCH TWENTY 29 FINE, PROGRAM AND/OR COMMUNITY SERVICE, THE COURT MAY IMPOSE AN ADDI-TIONAL FINE OF NOT MORE THAN TWO HUNDRED FIFTY DOLLARS. 30

(C) NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, 31 SECTION 120.20 OF THE CRIMINAL PROCEDURE LAW SHALL APPLY IN THE EVENT A 32 33 HAS BEEN ALLEGED TO HAVE VIOLATED THIS SECTION FAILS TO PERSON WHO 34 APPEAR BEFORE THE COURT ON THE DATE SET BY THE COURT; ARTICLES FOUR FOUR HUNDRED TWENTY OF THE CRIMINAL PROCEDURE LAW AND 35 HUNDRED TEN AND ARTICLE TWENTY OF THE JUDICIARY LAW SHALL APPLY IN THE EVENT A 36 PERSON 37 WHO HAS BEEN FOUND TO HAVE UNLAWFULLY POSSESSED AN ALCOHOLIC BEVERAGE WITH INTENT TO CONSUME IN VIOLATION OF THIS SECTION FAILS TO PAY SUCH FINE AS MAY BE SET BY THE COURT, OR COMPLETE AN ALCOHOL AWARENESS 38 39 40 PROGRAM ESTABLISHED PURSUANT TO SECTION 19.25 OF THE MENTAL HYGIENE LAW SERVICE AS REQUIRED BY THE COURT, WITHIN ONE HUNDRED 41 AND/OR COMMUNITY TWENTY DAYS AFTER THE DECISION OF THE COURT. 42
