AN ACT to amend the vehicle and traffic law, in relation to authorizing distinctive license plates for recipients of the conspicuous service cross

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 404-x to read as follows:

3 S 404-X. DISTINCTIVE PLATES FOR CONSPICUOUS SERVICE CROSS RECIPIENTS. 1. ANY CONSPICUOUS SERVICE CROSS RECIPIENT RESIDING IN THIS STATE OR THE 4 5 SPOUSE OF ANY SUCH RECIPIENT SHALL, UPON REQUEST, BE ISSUED A LICENSE PLATE BEARING THE WORDS "CONSPICUOUS SERVICE CROSS RECIPIENT". IF A б 7 PLATE IS ISSUED TO A CONSPICUOUS SERVICE CROSS RECIPIENT DISTINCTIVE 8 PURSUANT TO THIS SECTION, SUCH A DISTINCTIVE PLATE SHALL NOT BE ISSUED THE SPOUSE OF SUCH CONSPICUOUS SERVICE CROSS RECIPIENT. APPLICATION 9 TO FOR SAID LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM 10 AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE. 11

12 2. THE DISTINCTIVE PLATE AUTHORIZED BY THIS SECTION SHALL BE ISSUED 13 UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE APPLICANT OR THE 14 SPOUSE OF THE APPLICANT IS A CONSPICUOUS SERVICE CROSS RECIPIENT.

3. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED 15 16 IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THE REGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE; 17 18 PROVIDED, HOWEVER, THAT AN ADDITIONAL, ONE-TIME SERVICE CHARGE OF TEN DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH ANNUAL SERVICE 19 CHARGE PURSUANT TO THE PROVISIONS OF SECTION FOUR HUNDRED 20 SHALL BE DEPOSITED FOUR-OO OF THIS ARTICLE TO THE CREDIT OF THE DEPARTMENT OF 21 MOTOR VEHI-22 DISTINCTIVE PLATE DEVELOPMENT FUND ESTABLISHED BY CLES SECTION 23 NINETY-FIVE-G OF THE STATE FINANCE LAW AND SHALL BEUSED FOR THE
