AN ACT to amend the civil practice law and rules, the criminal procedure law and the executive law, in relation to the use in evidence of the fact of possession of a condom

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The civil practice law and rules is amended by adding a new 2 section 4519-a to read as follows:
- 3 S 4519-A. POSSESSION OF CONDOMS; RECEIPT INTO EVIDENCE. POSSESSION OF A CONDOM MAY NOT BE RECEIVED IN EVIDENCE IN ANY TRIAL, HEARING OR 5 PROCEEDING PURSUANT TO SUBDIVISION ONE OF SECTION TWELVE AND ARTICLE TEN 6 OF THE MULTIPLE DWELLING LAW, SECTION TWELVE-A OF THE PUBLIC HEALTH LAW, 7 SECTION TWO HUNDRED THIRTY-ONE OF THE REAL PROPERTY LAW OR SUBDIVISION FIVE OF SECTION SEVEN HUNDRED ELEVEN AND SECTION SEVEN HUNDRED FIFTEEN THE REAL PROPERTY ACTIONS AND PROCEEDINGS LAW AS EVIDENCE OF PROSTI-9 10 TUTION, PATRONIZING A PROSTITUTE, PROMOTING PROSTITUTION, PERMITTING 11 PROSTITUTION, MAINTAINING A PREMISES FOR PROSTITUTION, LEWDNESS OR 12 ASSIGNATION, OR MAINTAINING A BAWDY HOUSE.
- 13 S 2. The criminal procedure law is amended by adding a new section 14 60.47 to read as follows:
- 15 S 60.47 POSSESSION OF CONDOMS; RECEIPT INTO EVIDENCE.
- 16 EVIDENCE THAT A PERSON WAS IN POSSESSION OF ONE OR MORE CONDOMS MAY 17 NOT BE ADMITTED AT ANY TRIAL, HEARING OR OTHER PROCEEDING IN A PROSE-18 CUTION FOR ANY OFFENSE, OR AN ATTEMPT TO COMMIT ANY OFFENSE, DEFINED IN

- S 3. Section 841 of the executive law is amended by adding a new subdivision 7-b to read as follows:
