AN ACT to amend the real property tax law, in relation to veteran occupied primary residences owned by a limited liability company

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 458 of the real property tax law is amended by 2 adding a new subdivision 11 to read as follows:

3 11. NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, THE 4 PROVISIONS OF THIS SECTION SHALL APPLY TO ANY REAL PROPERTY OWNED BY A 5 LIMITED LIABILITY COMPANY, AS DEFINED BY SUBDIVISION (M) OF SECTION ONE 6 HUNDRED TWO OF THE LIMITED LIABILITY COMPANY LAW, ΙF SUCH LIMITED 7 COMPANY IS OWNED BY SUCH PERSON OR PERSONS TO WHOM THE LIABILITY 8 EXEMPTION WOULD BE GRANTED HAD SUCH PERSON OR PERSONS OWNED THE REAL 9 PROPERTY IN OUESTION RATHER THAN THE LIMITED LIABILITY COMPANY.

10 S 2. Paragraph (c) of subdivision 1 of section 458-a of the real prop-11 erty tax law, as amended by chapter 100 of the laws of 1988, is amended 12 to read as follows:

(c) "Qualified owner" means a veteran, the spouse of a veteran 13 [or], 14 the unremarried surviving spouse of a veteran, OR A LIMITED LIABILITY COMPANY, AS DEFINED BY SUBDIVISION (M) OF SECTION ONE HUNDRED TWO OF THE 15 LIMITED LIABILITY COMPANY LAW, IF SUCH LIMITED LIABILITY COMPANY 16 IS 17 OWNED BY SUCH PERSON OR PERSONS TO WHOM THE EXEMPTION WOULD BE GRANTED HAD SUCH PERSON OR PERSONS OWNED THE REAL PROPERTY IN QUESTION 18 RATHER 19 THAN THE LIMITED LIABILITY COMPANY. Where property is owned by more than 20 one qualified owner, the exemption to which each is entitled may be combined. Where a veteran is also the unremarried surviving spouse of a 21 such person may also receive any exemption to which the 22 veteran, 23 deceased spouse was entitled.

24 S 3. This act shall take effect immediately.
