Introduced by M. of A. BUCHWALD, ABINANTI, GALEF -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the executive law, in relation to designating Campfire lake, Echo lake and Pocantico river as inland waterways for purposes of waterfront revitalization

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     Section 1. Paragraph (a) of subdivision 4 of section 911 of the execu-  
2     tive law, as separately amended by chapters 300 and 308 of the laws of  
3     2014, is amended to read as follows:  
4     (a) the state's major inland lakes consisting of lakes Ballston, Big  
5     Tupper, Black, CAMPFIRE, Canadarago, Canandaigua, Cayuga, Champlain,  
6     Chateaugay, Chautauqua, Conesus, Cranberry, ECHO (IN THE COUNTY OF WEST-  
7     CHESTER), George, Great Sacandaga, [Honoeye] HONEOYE, Indian, Keuka,  
8     Long, Mirror, Oneida, Onondaga, Otisco, Otsego, Owasco, Placid,  
9     Raquette, Ronkonkoma, Sacandaga, Saratoga, Schroon, Seneca, Skaneateles,  
10    Silver (in the county of Wyoming) and Saranac, and the Fulton chain of  
11    lakes;  
12    S 2. Paragraph (b) of subdivision 4 of section 911 of the executive  
13    law, as separately amended by chapters 265, 272, 298, 310, and 311 of  
14    the laws of 2014, is amended to read as follows:  
15    (b) the state's major rivers comprised of the Allegheny, Ausable,  
16    Battenkill, Black, Boquet, Canisteo, Chaumont (including Chaumont bay),  
17    Chemung, Cohocton, Delaware, Deer, Genesee, Grasse, Great Chazy, Hoosic,  
18    Hudson north of the federal dam at Troy, Indian, Little (in the Adiron-  
19    dack park), Little Ausable, Little Salmon (including north and south  
20    branches), Mad, Mettowiee, Mohawk, Oswegatchie, POCANTICO, Racquette,  
21    Sacandaga, Salmon, Saranac, Schroon, Susquehanna, Tioga, Tioughnioga,  
22    Wallkill and Buffalo rivers, and the north and middle branches of the  
23    Moose river;  
24    S 3. This act shall take effect immediately.
