AN ACT to amend the highway law, in relation to designating a portion of  
the state highway system as the "Trooper Christopher G. Skinner Memo-  
rial Highway"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 342-x of the highway law, as added by chapter 387  
2     of the laws of 1991, is amended to read as follows:  
3     S 342-x. Portion of state highway system to be designated as "The  
4     American Legion Memorial Highway". All that portion of the state highway  
5     system beginning at the Pennsylvania - New York line travelling north on  
6     INTERSTATE route [81] EIGHTY-ONE to the Canada - New York line, WITH THE  
7     EXCEPTION OF THAT PORTION OF INTERSTATE ROUTE EIGHTY-ONE BETWEEN EXITS  
8     SIX AND SEVEN THEREOF, shall be designated and known as "The American  
9     Legion Memorial Highway".  
10    S 2. The highway law is amended by adding a new section 344-d to read  
11    as follows:  
12    S 344-D. PORTION OF THE STATE HIGHWAY SYSTEM TO BE DESIGNATED AS THE  
13    "TROOPER CHRISTOPHER G. SKINNER MEMORIAL HIGHWAY". ALL THAT PORTION OF  
14    THE STATE HIGHWAY SYSTEM CONSTITUTING THE NORTHBOUND AND SOUTHBOUND  
15    LANES OF INTERSTATE ROUTE EIGHTY-ONE IN THE TOWN OF CHENANGO, COUNTY OF  
16    BROOME, BEGINNING AT EXIT SIX OF SUCH INTERSTATE ROUTE, WHICH PROVIDES  
17    ACCESS TO STATE ROUTES ELEVEN AND TWELVE, CONTINUING IN A GENERALLY  
18    NORTHERLY DIRECTION FOR APPROXIMATELY 5.9 MILES, AND TERMINATING AT EXIT  
19    SEVEN OF SUCH INTERSTATE ROUTE, WHICH PROVIDES ACCESS TO STATE ROUTE  
20    ELEVEN, SHALL BE DESIGNATED AND KNOWN AS THE "TROOPER CHRISTOPHER G.  
21    SKINNER MEMORIAL HIGHWAY".  
22    S 3. The commissioner of transportation shall provide for the instal-  
23    lation and maintenance of adequate signing of the state highway system  
24    as designated pursuant to section two of this act. However, to avoid

1 confusion and to limit any possible disruption of commerce, the desig-  
2 nation called for pursuant to section two of this act shall be one of  
3 ceremonial nature and the official name of such highway shall not be  
4 changed as a result of this act.

5 S 4. This act shall take effect immediately.
