AN ACT to amend the education law, in relation to requiring regulations authorizing computer science courses to count towards liberal arts content at institutions of higher learning

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The education law is amended by adding a new section 208-b 2 to read as follows:
  - S 208-B. COURSE REQUIREMENTS. 1. THE COMMISSIONER AND THE BOARD OF REGENTS ARE AUTHORIZED AND DIRECTED TO ESTABLISH RULES AND/OR REGULATIONS AUTHORIZING COMPUTER SCIENCE COURSES TO COUNT TOWARDS THE LIBERAL ARTS CONTENT IN MATH OR SCIENCE REQUIRED FOR EACH DEGREE AT INSTITUTIONS OF HIGHER LEARNING IN NEW YORK STATE.
- 2. FOR PURPOSES OF THIS SECTION, "COMPUTER SCIENCE" MEANS THE STUDY OF COMPUTERS AND ALGORITHMIC PROCESSES INCLUDING THE STUDY OF COMPUTING PRINCIPLES, COMPUTER HARDWARE AND COMPUTER SOFTWARE DESIGN, COMPUTER APPLICATIONS, AND THE IMPACT OF COMPUTERS ON SOCIETY. COURSES MAY INCLUDE, BUT NOT BE LIMITED TO:
- 13 A. SOFTWARE DESIGN;
- 14 B. HARDWARE DESIGN;
- 15 C. CREATION OF DIGITAL ARTIFACTS;
- 16 D. ABSTRACTION;
- 17 E. LOGIC;
