- AN ACT to amend the state finance law, in relation to establishing the public higher education quality initiative endowment fund; and to repeal section 92-ee of such law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 92-ee of the state finance law is REPEALED and a 2 new section 92-ee is added to read as follows:

3 S 92-EE. PUBLIC HIGHER EDUCATION QUALITY INITIATIVE ENDOWMENT FUND. 1. 4 IS HEREBY ESTABLISHED IN THE CUSTODY OF THE COMPTROLLER A FUND TO THERE 5 BE KNOWN AS THE "PUBLIC HIGHER EDUCATION OUALITY INITIATIVE ENDOWMENT", 6 HEREINAFTER, "THE ENDOWMENT." NOTWITHSTANDING ANY OTHER PROVISIONS OF 7 LAW, ALL OF THE ASSETS AND INCOME OF THE ENDOWMENT SHALL BE HELD AND 8 INVESTED BY THE COMPTROLLER AS THE SOLE TRUSTEE OF SUCH ENDOWMENT, 9 EXCEPT SUCH INCOME AS MAY BE ALLOCATED OR DISTRIBUTED BY THE COMPTROLLER 10 PURSUANT TO APPROPRIATION.

2. THE ENDOWMENT SHALL CONSIST OF AMOUNTS APPROPRIATED OR TRANSFERRED 11 ENDOWMENT, AND ANY OTHER AMOUNTS AS MAY BE DEPOSITED IN THE 12 SUCH INTO 13 ENDOWMENT FROM ANY OTHER PUBLIC OR PRIVATE SOURCES. AMOUNTS APPROPRIATED TO, TRANSFERRED TO, OR DEPOSITED INTO THE ENDOWMENT SHALL BE 14 DEDICATED 15 то THE SOLE PURPOSE OF HIRING FULL-TIME FACULTY AND PROFESSIONAL STAFF AT THE STATE UNIVERSITY OF NEW YORK, THE CITY UNIVERSITY OF NEW YORK AND 16 THEIR COMMUNITY COLLEGES AND USED 17 SHALL NOT BE ТО HIRE ADDITIONAL FACULTY OR STAFF TO BE EMPLOYED AT THE STATE UNIVERSITY OF NEW 18 RESEARCH 19 YORK RESEARCH FOUNDATION, CITY UNIVERSITY OF NEW YORK RESEARCH FOUNDA-20 TION OR ANY CAMPUS FOUNDATION OR AFFILIATED ENTITY OF THE STATE UNIVER-21 SITY OF NEW YORK OR CITY UNIVERSITY OF NEW YORK. 1 MONEYS IN THE ENDOWMENT MAY NOT BE INTERCHANGED OR COMMINGLED WITH ANY 2 OTHER ACCOUNT OR FUND.

3 3. THE FULL AMOUNT OF THE PRINCIPAL OF THE ENDOWMENT SHALL BE 4 PRESERVED AND ANNUAL PAYMENTS SHALL BE MADE FROM THE INVESTMENT EARNINGS 5 OF THE ENDOWMENT FOR THE SOLE PURPOSE OF HIRING FULL-TIME FACULTY AND 6 PROFESSIONAL STAFF AT THE STATE UNIVERSITY OF NEW YORK, THE CITY UNIVER-7 SITY OF NEW YORK AND THEIR COMMUNITY COLLEGES PURSUANT TO SUBDIVISION 8 TWO OF THIS SECTION.

9 4. THE AMOUNT OF ANNUAL PAYMENTS FROM INVESTMENT EARNINGS DISBURSED TO 10 THE STATE UNIVERSITY OF NEW YORK AND THE CITY UNIVERSITY OF NEW YORK 11 SHALL BE PROPORTIONAL TO THE NUMBER OF STUDENTS ENROLLED SYSTEM-WIDE AT 12 EACH PUBLIC HIGHER EDUCATION SYSTEM. THE ANNUAL AMOUNT OF MONEY 13 DISBURSED TO THE STATE UNIVERSITY OF NEW YORK AND THE CITY UNIVERSITY OF 14 NEW YORK SHALL BE ALLOCATED TO THE CAMPUSES WITHIN SUCH RESPECTIVE 15 UNIVERSITY SYSTEM.

16 5. ALLOCATION OF ENDOWMENT MONEY TO THE CAMPUSES AT THE STATE UNIVER-17 SITY OF NEW YORK AND CITY UNIVERSITY OF NEW YORK MUST, AT A MINIMUM, 18 PROVIDE THAT EVERY CAMPUS IN SUCH PUBLIC HIGHER EDUCATION SYSTEMS 19 RECEIVES AN ANNUAL ALLOCATION OF FUNDS.

6. THE STATE UNIVERSITY OF NEW YORK AND THE CITY UNIVERSITY OF NEW
YORK SHALL GIVE FIRST PREFERENCE TO QUALIFIED PART-TIME OR CONTINGENT
FACULTY OR QUALIFIED PART-TIME OR CONTINGENT PROFESSIONAL STAFF WHEN
HIRING ADDITIONAL FULL-TIME FACULTY OR PROFESSIONAL STAFF.

24 S 2. This act shall take effect April 1, 2017.
