AN ACT to authorize the town of Hamburg, county of Erie to discontinue the use of certain town lands as parkland and to sell and convey such lands to James Cleary

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The town of Hamburg, in the county of Erie, is hereby
2 authorized to discontinue use of certain parklands more particularly
3 described in section three of this act and sell and convey in fee simple
4 for its fair market value and upon such terms and conditions to James
5 Cleary as it deems appropriate such lands which are no longer useful for
6 parkland recreation purposes.
7 S 2. The authorization provided for in section one of this act shall
8 be subject to the requirement that upon the alienation of the lands more
9 particularly described in section three of this act, the town of Hamburg
10 shall dedicate all proceeds from the sale of such lands for capital
11 improvements to existing park facilities in the town of Hamburg.
12 S 3. The lands authorized by section one of this act to be discontin-
13 ued as parklands, and to be sold and conveyed are described as follows:
14 ALL THAT TRACT OR PARCEL OF LAND, situate in the Town of Hamburg,
15 County of Erie and State of New York, being part of Lot 21, Township 9,
16 Range 8 of the Holland Land Company's Survey, bounded and described as
17 follows:
18 BEGINNING at the west corner of lands conveyed to James F. Cleary by
19 deed recorded in the Erie County Clerk's Office under Liber 10270 of
20 Deeds at page 309, said corner being on the east line of Abel Road;

1 THENCE S 38° 07' 58" E, a distance of 79.14 feet;
2 THENCE N 89° 23' 17" E, a distance of 373 feet, more or less, to the
3 centerline of Berricks Creek;
4 THENCE south along the centerline of Berricks Creek, a distance of 71
5 feet, more or less;
6 THENCE S 89° 23' 17" W, a distance of 536 feet, more or less, to the
7 east line of Abel Road;
8 THENCE N 37° 45' 02" E, along the east line of Abel Road, a distance
9 of 169.32 feet to the point or place of beginning, containing 0.88 acre,
10 more or less.
11 S 4. In the event that the town of Hamburg received any funding
12 support or assistance from the federal government for the purchase,
13 maintenance or improvement of the parklands set forth in section three
14 of this act, the discontinuance and conveyance of parkland authorized by
15 the provisions of this act shall not occur until the town of Hamburg has
16 complied with any federal requirements pertaining to the alienation or
17 conversion of parklands, including satisfying the secretary of the inte-
18 rior that the alienation or conversion complies with all conditions
19 which the secretary of the interior deems necessary to assure the
20 substitution of other lands shall be equivalent in fair market value and
21 recreational usefulness to the lands being alienated or converted.
22 S 5. This act shall take effect immediately.
