- AN ACT to amend the lien law, in relation to employee liens; to amend the labor law, in relation to employee complaints; to amend the civil practice law and rules, in relation to grounds for attachment; to amend the business corporation law, in relation to streamlining procedures where employees may hold shareholders of non-publicly traded corporations personally liable for wage theft; and to amend the limited liability company law, in relation to creating a right for victims of wage theft to hold the ten members with the largest ownership interests in a company personally liable for wage theft

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 2 of the lien law is amended by adding three new 2 subdivisions 21, 22 and 23 to read as follows:

3 21. EMPLOYEE. THE TERM "EMPLOYEE", WHEN USED IN THIS CHAPTER, SHALL 4 HAVE THE SAME MEANING AS "EMPLOYEE" PURSUANT TO THE LABOR LAW OR THE 5 FAIR LABOR STANDARDS ACT, AS APPLICABLE.

6 22. EMPLOYER. THE TERM "EMPLOYER", WHEN USED IN THIS CHAPTER, SHALL 7 HAVE THE SAME MEANING AS "EMPLOYER" PURSUANT TO THE LABOR LAW OR THE 8 FAIR LABOR STANDARDS ACT, AS APPLICABLE.

9 23. WAGE CLAIM. THE TERM "WAGE CLAIM", WHEN USED IN THIS CHAPTER, 10 MEANS A CLAIM THAT AN EMPLOYEE HAS SUFFERED A VIOLATION OF SECTIONS ONE 11 HUNDRED SEVENTY, ONE HUNDRED NINETY-ONE, ONE HUNDRED NINETY-THREE, ONE

1 HUNDRED NINETY-SIX-D, SIX HUNDRED FIFTY-TWO OR SIX HUNDRED SEVENTY-THREE 2 OF THE LABOR LAW OR THE RELATED REGULATIONS AND WAGE ORDERS PROMULGATED 3 BY THE COMMISSIONER, A CLAIM FOR WAGES DUE TO AN EMPLOYEE PURSUANT TO AN 4 EMPLOYMENT CONTRACT THAT WERE UNPAID IN VIOLATION OF THAT CONTRACT, OR A 5 CLAIM THAT AN EMPLOYEE HAS SUFFERED A VIOLATION OF 29 U.S.C. S 206.

6 S 2. Section 3 of the lien law, as amended by chapter 137 of the laws 7 of 1985, is amended to read as follows:

8 S 3. Mechanic's lien AND EMPLOYEE'S LIEN on [real] property. 1. MECHANIC'S LIEN. A contractor, subcontractor, laborer, materialman, 9 10 landscape gardener, nurseryman or person or corporation selling fruit or 11 ornamental trees, roses, shrubbery, vines and small fruits, who performs labor or furnishes materials for the improvement of real property with 12 the consent or at the request of the owner thereof, or of his agent, 13 14 contractor or subcontractor, and any trust fund to which benefits and 15 wage supplements are due or payable for the benefit of such laborers, shall have a lien for the principal and interest, of the value, or the agreed price, of such labor, including benefits and wage supplements due 16 17 18 payable for the benefit of any laborer, or materials upon the real or 19 property improved or to be improved and upon such improvement, from the 20 time of filing a notice of such lien as prescribed in this chapter. 21 Where the contract for an improvement is made with a husband or wife and 22 the property belongs to the other or both, the husband or wife contracting shall also be presumed to be the agent of the other, unless such 23 other having knowledge of the improvement shall, within ten days after 24 25 learning of the contract give the contractor written notice of his or her refusal to consent to the improvement. Within the meaning of the provisions of this chapter, materials actually manufactured for but not 26 27 28 delivered to the real property, shall also be deemed to be materials 29 furnished.

30 2. EMPLOYEE'S LIEN. AN EMPLOYEE WHO HAS A WAGE CLAIM AS THAT TERM IS DEFINED IN SUBDIVISION TWENTY-THREE OF SECTION TWO OF THIS CHAPTER SHALL 31 32 A LIEN ON HIS OR HER EMPLOYER'S INTEREST IN PROPERTY FOR THE VALUE HAVE OF THE WAGE CLAIM ARISING OUT OF THE EMPLOYMENT, FROM THE TIME OF FILING 33 A NOTICE OF SUCH LIEN AS PRESCRIBED IN THIS CHAPTER. AN EMPLOYEE'S 34 LIEN 35 BASED ON A WAGE CLAIM MAY BE HAD AGAINST THE EMPLOYER'S INTEREST IN REAL AND AGAINST THE EMPLOYER'S INTEREST IN PERSONAL PROPERTY THAT 36 PROPERTY 37 CAN BE SUFFICIENTLY DESCRIBED WITHIN THE MEANING OF SECTION 9-108 OF THE 38 UNIFORM COMMERCIAL CODE, EXCEPT THAT AN EMPLOYEE'S LIEN SHALL NOT EXTEND 39 TO ACCOUNTS OR GOODS AS THOSE TERMS ARE DEFINED IN SECTION 9-102 OF THE 40 UNIFORM COMMERCIAL CODE.

41 3. AS USED IN THIS ARTICLE AND UNLESS OTHERWISE SPECIFIED, A LIEN 42 SHALL MEAN AN EMPLOYEE'S LIEN OR A MECHANIC'S LIEN.

43 S 3. Subdivisions 1 and 2 of section 4 of the lien law, subdivision 1 44 as amended by chapter 515 of the laws of 1929 and subdivision 2 as added 45 by chapter 704 of the laws of 1985, are amended to read as follows:

(1) [Such] A MECHANIC'S OR EMPLOYEE'S lien AND EMPLOYEE'S LIEN AGAINST 46 47 PROPERTY shall extend to the owner's right, title or interest in REAL 48 the real property and improvements, existing at the time of filing the notice of lien, or thereafter acquired, except as hereinafter in this article provided. If an owner assigns his interest in such real property 49 50 51 by a general assignment for the benefit of creditors, within thirty days prior to such filing, the lien shall extend to the interest thus 52 assigned. If any part of the real property subjected to such lien be 53 54 removed by the owner or by any other person, at any time before the 55 discharge thereof, such removal shall not affect the rights of the lienor, either in respect to the remaining real property, or the part so 56

removed. If labor is performed for, or materials furnished to, a contractor or subcontractor for an improvement, the MECHANIC'S lien 1 2 3 shall not be for a sum greater than the sum earned and unpaid on the 4 contract at the time of filing the notice of lien, and any sum subsequently earned thereon. In no case shall the owner be liable to pay by 5 6 reason of all MECHANIC'S liens created pursuant to this article a sum 7 greater than the value or agreed price of the labor and materials 8 remaining unpaid, at the time of filing notices of such liens, except as 9 hereinafter provided.

10 (2) [Such] A MECHANIC'S OR EMPLOYEE'S lien shall not extend to the 11 owner's right, title or interest in real property and improvements, existing at the time of filing the notice of lien if such lien arises 12 13 from the failure of a lessee of the right to explore, develop or produce 14 natural gas or oil, to pay for, compensate or render value for improve-15 ments made with the consent or at the request of such lessee by a contractor, subcontractor, materialman, equipment operator or 16 owner, 17 nurseryman, or person or corporation who performs labor or landscaper, 18 furnishes materials for the exploration, development, or production of 19 oil or natural gas or otherwise improves such leased property. Such 20 MECHANIC'S OR EMPLOYEE'S lien shall extend to the improvements made for 21 the exploration, development and production of oil and natural gas, and 22 the working interest held by a lessee of the right to explore, develop 23 or produce oil and natural gas.

S 4. The opening paragraph of section 4-a of the lien law, as amended by chapter 696 of the laws of 1959, is amended to read as follows:

26 The proceeds of any insurance which by the terms of the policy are payable to the owner of real property improved, and actually received or 27 to be received by him because of the destruction or removal by fire or 28 29 other casualty of an improvement on which lienors have performed labor or services or for which they have furnished materials, OR UPON WHICH AN 30 EMPLOYEE HAS ESTABLISHED AN EMPLOYEE'S LIEN, shall after the owner has 31 32 been reimbursed therefrom for premiums paid by him, if any, for such 33 insurance, be subject to liens provided by this act to the same extent and in the same order of priority as the real property would have been 34 35 had such improvement not been so destroyed or removed.

36 S 5. Subdivisions 1, 2 and 5 of section 9 of the lien law, as amended 37 by chapter 515 of the laws of 1929, are amended to read as follows:

1. The name OF THE LIENOR, and EITHER THE residence of the lienor OR THE NAME AND BUSINESS ADDRESS OF THE LIENOR'S ATTORNEY, IF ANY; and if the lienor is a partnership or a corporation, the business address of such firm, or corporation, the names of partners and principal place of business, and if a foreign corporation, its principal place of business within the state.

44 2. The name of the owner of the [real] property against whose interest 45 therein a lien is claimed, and the interest of the owner as far as known 46 to the lienor.

5. The amount unpaid to the lienor for such labor or materials, OR THE AMOUNT OF THE WAGE CLAIM IF A WAGE CLAIM IS THE BASIS FOR ESTABLISHMENT OF THE LIEN.

50 S 6. Subdivision 1 of section 10 of the lien law, as amended by chap-51 ter 367 of the laws of 2011, is amended to read as follows:

1. (A) Notice of MECHANIC'S lien may be filed at any time during the progress of the work and the furnishing of the materials, or, within eight months after the completion of the contract, or the final performance of the work, or the final furnishing of the materials, dating from the last item of work performed or materials furnished; provided, howev-

er, that where the improvement is related to real property improved or 1 2 to be improved with a single family dwelling, the notice of MECHANIC'S 3 lien may be filed at any time during the progress of the work and the 4 furnishing of the materials, or, within four months after the completion of the contract, or the final performance of the work, or the final furnishing of the materials, dating from the last item of work performed 5 6 7 or materials furnished; and provided further where the notice of MECHAN-8 IC'S lien is for retainage, the notice of MECHANIC'S lien may be filed 9 within ninety days after the date the retainage was due to be released; 10 except that in the case of a MECHANIC'S lien by a real estate broker, 11 the notice of MECHANIC'S lien may be filed only after the performance of the brokerage services and execution of lease by both lessor and lessee 12 13 and only if a copy of the alleged written agreement of employment or compensation is annexed to the notice of lien, provided that where the 14 15 payment pursuant to the written agreement of employment or compensation 16 is to be made in installments, then a notice of lien may be filed within 17 eight months after the final payment is due, but in no event later than 18 a date five years after the first payment was made. For purposes of this 19 section, the term "single family dwelling" shall not include a dwelling 20 unit which is a part of a subdivision that has been filed with a munici-21 pality in which the subdivision is located when at the time the lien is 22 filed, such property in the subdivision is owned by the developer for 23 purposes other than his personal residence. For purposes of this section, "developer" shall mean and include any private individual, 24 25 partnership, trust or corporation which improves two or more parcels of 26 real property with single family dwellings pursuant to a common scheme 27 or plan. [The]

28 (B) NOTICE OF EMPLOYEE'S LIEN MAY BE FILED AT ANY TIME NOT LATER THAN 29 SIX YEARS FOLLOWING THE END OF THE EMPLOYMENT GIVING RISE TO THE WAGE 30 CLAIM.

(C) A notice of lien, OTHER THAN FOR A LIEN ON PERSONAL PROPERTY, must 31 32 be filed in the clerk's office of the county where the property is situ-33 ated. If such property is situated in two or more counties, the notice of lien shall be filed in the office of the clerk of each of such coun-34 35 ties. The county clerk of each county shall provide and keep a book to be called the "lien docket," which shall be suitably ruled in columns 36 headed "owners," "lienors," "lienor's attorney," "property," "amount," 37 "time of filing," "proceedings had," in each of which he shall enter the 38 39 particulars of the notice, properly belonging therein. The date, hour 40 and minute of the filing of each notice of lien shall be entered in the proper column. Except where the county clerk maintains a block index, 41 the names of the owners shall be arranged in such book in alphabetical 42 43 order. The validity of the lien and the right to file a notice thereof 44 shall not be affected by the death of the owner before notice of the 45 lien is filed. A NOTICE OF EMPLOYEE'S LIEN ON PERSONAL PROPERTY MUST BE FILED, TOGETHER WITH A FINANCING STATEMENT, IN THE FILING OFFICE AS 46 SET 47 FORTH IN SECTION 9-501 OF THE UNIFORM COMMERCIAL CODE.

48 S 7. Section 11 of the lien law, as amended by chapter 147 of the laws 49 of 1996, is amended to read as follows:

S 11. Service of copy of notice of lien. 1. Within five days before or thirty days after filing the notice of A MECHANIC'S lien, the lienor shall serve a copy of such notice upon the owner, if a natural person, (a) by delivering the same to him personally, or if the owner cannot be found, to his agent or attorney, or (b) by leaving it at his last known place of residence in the city or town in which the real property or some part thereof is situated, with a person of suitable age and

discretion, or (c) by registered or certified mail addressed to his last known place of residence, or (d) if such owner has no such residence in 1 2 3 such city or town, or cannot be found, and he has no agent or attorney, 4 by affixing a copy thereof conspicuously on such property, between the 5 hours of nine o'clock in the forenoon and four o'clock in the afternoon; 6 if the owner be a corporation, said service shall be made (i) by deliv-7 ering such copy to and leaving the same with the president, vice-president, secretary or clerk to the corporation, the cashier, treasurer or a 8 director or managing agent thereof, personally, within the state, or 9 10 (ii) if such officer cannot be found within the state by affixing a copy 11 thereof conspicuously on such property between the hours of nine o'clock 12 the forenoon and four o'clock in the afternoon, or (iii) by regisin 13 tered or certified mail addressed to its last known place of business. 14 Failure to file proof of such a service with the county clerk within 15 thirty-five days after the notice of lien is filed shall terminate the 16 notice as a lien. Until service of the notice has been made, as above 17 provided, an owner, without knowledge of the lien, shall be protected in any payment made in good faith to any contractor or other person claim-18 19 ing a lien.

20 WITHIN FIVE DAYS BEFORE OR THIRTY DAYS AFTER FILING THE NOTICE OF 2. 21 AN EMPLOYEE'S LIEN, THE LIENOR SHALL SERVE A COPY OF SUCH NOTICE UPON 22 EMPLOYER, IF A NATURAL PERSON, (A) BY DELIVERING THE SAME TO HIM THE 23 PERSONALLY, OR IF THE EMPLOYER CANNOT BE FOUND, TO HIS AGENT OR ATTOR-24 OR (B) BY LEAVING IT AS HIS LAST KNOWN PLACE OF RESIDENCE OR BUSI-NEY. 25 NESS, WITH A PERSON OF SUITABLE AGE AND DISCRETION, OR (C) BY REGISTERED 26 OR CERTIFIED MAIL ADDRESSED TO HIS LAST KNOWN PLACE OF RESIDENCE OR BUSINESS, OR (D) IF SUCH EMPLOYER OWNS REAL PROPERTY, BY AFFIXING A COPY 27 28 THEREOF CONSPICUOUSLY ON SUCH PROPERTY, BETWEEN THE HOURS OF NINE 29 O'CLOCK IN THE FORENOON AND FOUR O'CLOCK IN THE AFTERNOON. THE LIENOR THIRTY DAYS AFTER FILING THE NOTICE OF EMPLOYEE'S 30 SHALL, WITHIN ALSO LIEN, AFFIX A COPY THEREOF CONSPICUOUSLY ON THE REAL PROPERTY IDENTIFIED 31 32 IN THE NOTICE OF EMPLOYEE'S LIEN, BETWEEN THE HOURS OF NINE O'CLOCK IN FOUR O'CLOCK IN THE AFTERNOON. IF THE EMPLOYER BE A 33 THE FORENOON AND CORPORATION, SAID SERVICE SHALL BE MADE (I) BY DELIVERING SUCH COPY 34 ΤO SAME WITH THE PRESIDENT, VICE-PRESIDENT, SECRETARY OR 35 AND LEAVING THE CLERK TO THE CORPORATION, THE CASHIER, TREASURER OR A DIRECTOR OR MANAG-36 37 ING AGENT THEREOF, PERSONALLY, WITHIN THE STATE, OR (II) IF SUCH OFFICER 38 CANNOT BE FOUND WITHIN THE STATE BY AFFIXING A COPY THEREOF CONSPICUOUS-39 LY ON SUCH PROPERTY BETWEEN THE HOURS OF NINE O'CLOCK IN THEFORENOON 40 FOUR O'CLOCK IN THE AFTERNOON, OR (III) BY REGISTERED OR CERTIFIED AND MAIL ADDRESSED TO ITS LAST KNOWN PLACE OF BUSINESS, OR (IV) BY 41 DELIVERY STATE IN THE SAME MANNER AS 42 SECRETARY OF THE DEPARTMENT OF TΟ THE 43 REQUIRED BY PARAGRAPH ONE OF SUBDIVISION (B) OF SECTION THREE HUNDRED 44 SIX OF THE BUSINESS CORPORATION LAW. FAILURE TO FILE PROOF OF SUCH A 45 SERVICE WITH THE COUNTY CLERK WITHIN THIRTY-FIVE DAYS AFTER THE NOTICE LIEN IS FILED SHALL TERMINATE THE NOTICE AS A LIEN. UNTIL SERVICE OF 46 OF 47 THE NOTICE HAS BEEN MADE, AS ABOVE PROVIDED, AN OWNER, WITHOUT KNOWLEDGE 48 OF THE LIEN, SHALL BE PROTECTED IN ANY PAYMENT MADE IN GOOD FAITH TO ANY 49 OTHER PERSON CLAIMING A LIEN.

50 S 8. Section 11-b of the lien law, as amended by chapter 147 of the 51 laws of 1996, is amended to read as follows:

52 S 11-b. Copy of notice of MECHANIC'S lien to a contractor or subcon-53 tractor. Within five days before or thirty days after filing a notice 54 of MECHANIC'S lien in accordance with section ten of this chapter or the 55 filing of an amendment of notice of MECHANIC'S lien in accordance with 56 section twelve-a of this [chapter] ARTICLE the lienor shall serve a copy

of such notice or amendment by certified mail on the contractor, subcon-1 2 tractor, assignee or legal representative for whom he was employed or to 3 whom he furnished materials or if the lienor is a contractor or subcon-4 tractor to the person, firm or corporation with whom the contract was 5 made. A lienor having a direct contractual relationship with a subcon-6 tractor or a sub-subcontractor but not with a contractor shall also 7 serve a copy of such notice or amendment by certified mail to the 8 contractor. Failure to file proof of such a service with the county 9 clerk within thirty-five days after the notice of lien is filed shall 10 terminate the notice as a lien. Any lienor, or a person acting on behalf 11 a lienor, who fails to serve a copy of the notice of MECHANIC'S lien of as required by this section shall be liable for reasonable attorney's 12 13 fees, costs and expenses, as determined by the court, incurred in 14 obtaining such copy.

15 S 9. Subdivision 1 of section 12-a of the lien law, as amended by 16 chapter 1048 of the laws of 1971, is amended to read as follows:

1. Within sixty days after the original filing, a lienor may amend his 17 18 lien upon twenty days notice to existing lienors, mortgagees and the 19 owner, provided that no action or proceeding to enforce or cancel the lien OR EMPLOYEE'S LIEN has been brought in the interim, 20 mechanics' where the purpose of the amendment is to reduce the amount of the lien, 21 22 except the question of wilful exaggeration shall survive such amendment. 23 S 10. Subdivision 1 of section 13 of the lien law, as amended by chap-24 ter 878 of the laws of 1947, is amended to read as follows:

25 (1) [A] AN EMPLOYEE'S LIEN, OR A lien for materials furnished or labor 26 performed in the improvement of real property, shall have priority over a conveyance, mortgage, judgment or other claim against such property not recorded, docketed or filed at the time of the filing of the notice 27 28 29 of such lien, except as hereinafter in this chapter provided; over advances made upon any mortgage or other encumbrance thereon after such 30 filing, except as hereinafter in this article provided; and over the 31 32 claim of a creditor who has not furnished materials or performed labor upon such property, if such property has been assigned by the owner by a 33 general assignment for the benefit of creditors, within thirty days 34 35 before the filing of either of such notices; and also over an attachment hereafter issued or a money judgment hereafter recovered upon a claim, 36 37 which, in whole or in part, was not for materials furnished, labor performed or moneys advanced for the improvement of such real property; 38 39 and over any claim or lien acquired in any proceedings upon such judg-40 Such liens shall also have priority over advances made upon a ment. contract by an owner for an improvement of real property which contains 41 option to the contractor, his successor or assigns to purchase the 42 an 43 property, if such advances were made after the time when the labor began 44 or the first item of material was furnished, as stated in the notice of 45 lien. If several buildings are demolished, erected, altered or repaired, several pieces or parcels of real property are improved, under one 46 or 47 contract, and there are conflicting liens thereon, each lienor shall have priority upon the particular part of the real property or upon the 48 particular building or premises where his labor is performed or his 49 50 materials are used. Persons shall have no priority on account of the 51 time of filing their respective notices of liens, but all liens shall be on a parity except as hereinafter in section fifty-six of this chapter 52 provided; and except that in all cases laborers for daily or weekly wages WITH A MECHANIC'S LIEN, AND EMPLOYEES WITH AN EMPLOYEE'S LIEN, 53 54 55 shall have preference over all other claimants under this article.

1 S 11. Section 17 of the lien law, as amended by chapter 324 of the 2 laws of 2000, is amended to read as follows:

3 17. Duration of lien. 1. (A) No MECHANIC'S lien specified in this S 4 article shall be a lien for a longer period than one year after the 5 notice of lien has been filed, unless within that time an action is 6 commenced to foreclose the lien, and a notice of the pendency of such 7 action, whether in a court of record or in a court not of record, is 8 filed with the county clerk of the county in which the notice of lien is filed, containing the names of the parties to the action, the object of 9 10 the action, a brief description of the real property affected thereby, and the time of filing the notice of lien; or unless an extension to 11 such lien, except for a lien on real property improved or to be improved 12 13 with a single family dwelling, is filed with the county clerk of the 14 county in which the notice of lien is filed within one year from the 15 filing of the original notice of lien, continuing such lien and such lien shall be redocketed as of the date of filing such extension. Such 16 17 extension shall contain the names of the lienor and the owner of the real property against whose interest therein such lien is claimed, a 18 19 brief description of the real property affected by such lien, the amount 20 such lien, and the date of filing the notice of lien. No lien shall of 21 be continued by such extension for more than one year from the filing 22 In the event an action is not commenced to foreclose the lien thereof. 23 within such extended period, such lien shall be extinguished unless an order be granted by a court of record or a judge or justice thereof, 24 25 continuing such lien, and such lien shall be redocketed as of the date 26 of granting such order and a statement made that such lien is continued by virtue of such order. A lien on real property improved or to be 27 28 improved with a single family dwelling may only be extended by an order 29 of a court of record, or a judge or justice thereof. No lien shall be 30 continued by court order for more than one year from the granting therebut a new order and entry may be made in each of two successive 31 of, 32 years. If a lienor is made a party defendant in an action to enforce 33 another lien, and the plaintiff or such defendant has filed a notice of 34 the pendency of the action within the time prescribed in this section, 35 lien of such defendant is thereby continued. Such action shall be the deemed an action to enforce the lien of such defendant lienor. The fail-36 37 ure to file a notice of pendency of action shall not abate the action as 38 to any person liable for the payment of the debt specified in the notice 39 of lien, and the action may be prosecuted to judgment against such 40 person. The provisions of this section in regard to continuing liens shall apply to liens discharged by deposit or by order on the filing of 41 an undertaking. Where a lien is discharged by deposit or by order, a 42 43 notice of pendency of action shall not be filed.

(B) A lien, the duration of which has been extended by the filing of a 44 45 notice of the pendency of an action as above provided, shall nevertheless terminate as a lien after such notice has been canceled as provided 46 47 section sixty-five hundred fourteen of the civil practice law and in 48 rules or has ceased to be effective as constructive notice as provided 49 in section sixty-five hundred thirteen of the civil practice law and 50 rules.

51 2. (A) NO EMPLOYEE'S LIEN ON REAL PROPERTY SHALL BE A LIEN FOR A LONG-ER PERIOD THAN ONE YEAR AFTER THE NOTICE OF LIEN HAS BEEN FILED, 52 UNLESS TO SUCH LIEN IS FILED WITH THE COUNTY CLERK OF THE COUNTY 53 AN EXTENSION 54 IN WHICH THE NOTICE OF LIEN IS FILED WITHIN ONE YEAR FROM THE FILING OF 55 THE ORIGINAL NOTICE OF LIEN, CONTINUING SUCH LIEN AND SUCH LIEN SHALL BE REDOCKETED AS OF THE DATE OF FILING SUCH EXTENSION. SUCH EXTENSION SHALL 56

CONTAIN THE NAMES OF THE LIENOR AND THE OWNER OF THE REAL PROPERTY 1 2 AGAINST WHOSE INTEREST THEREIN SUCH LIEN IS CLAIMED, A BRIEF DESCRIPTION 3 OF THE PROPERTY AFFECTED BY SUCH LIEN, THE AMOUNT OF SUCH LIEN, AND THE 4 DATE OF FILING THE NOTICE OF LIEN. NO LIEN SHALL BE CONTINUED BY SUCH 5 EXTENSION FOR MORE THAN ONE YEAR FROM THE FILING THEREOF. IN THE EVENT 6 ACTION IS NOT COMMENCED TO OBTAIN JUDGMENT ON THE WAGE CLAIM OR TO AN 7 FORECLOSE THE LIEN WITHIN SUCH EXTENDED PERIOD, SUCH LIEN SHALL BE 8 EXTINGUISHED UNLESS AN ORDER BE GRANTED BY A COURT OF RECORD OR A JUDGE OR JUSTICE THEREOF, CONTINUING SUCH LIEN, AND SUCH LIEN SHALL BE REDOCK-9 10 ETED AS OF THE DATE OF GRANTING SUCH ORDER AND A STATEMENT MADE THAT 11 SUCH LIEN IS CONTINUED BY VIRTUE OF SUCH ORDER.

12 (B) NO EMPLOYEE'S LIEN ON PERSONAL PROPERTY SHALL BE A LIEN FOR A LONGER PERIOD THAN ONE YEAR AFTER THE FINANCING STATEMENT HAS BEEN 13 14 RECORDED, UNLESS AN EXTENSION TO SUCH LIEN, IS FILED WITH THE FILING 15 OFFICE IN WHICH THE FINANCING STATEMENT IS REQUIRED TO BE FILED PURSUANT 16 TO SECTION 9-501 OF THE UNIFORM COMMERCIAL CODE WITHIN ONE YEAR FROM THE FILING OF THE ORIGINAL FINANCING STATEMENT, CONTINUING SUCH LIEN. SUCH 17 EXTENSION SHALL CONTAIN THE NAMES OF THE LIENOR AND THE OWNER OF THE 18 19 PROPERTY AGAINST WHOSE INTEREST THEREIN SUCH LIEN IS CLAIMED, A BRIEF 20 DESCRIPTION OF THE PRIOR FINANCING STATEMENT TO BE EXTENDED, AND THE 21 DATE OF FILING THE PRIOR FINANCING STATEMENT. NO LIEN SHALL BE CONTIN-22 UED BY SUCH EXTENSION FOR MORE THAN ONE YEAR FROM THE FILING THEREOF. IN THE EVENT AN ACTION IS NOT COMMENCED TO OBTAIN JUDGMENT ON THE WAGE 23 24 CLAIM OR TO FORECLOSE THE LIEN WITHIN SUCH EXTENDED PERIOD, SUCH LIEN 25 SHALL BE EXTINGUISHED UNLESS AN ORDER BE GRANTED BY A COURT OF RECORD OR 26 A JUDGE OR JUSTICE THEREOF, CONTINUING SUCH LIEN, AND SUCH LIEN SHALL BE 27 REFILED AS OF THE DATE OF GRANTING SUCH ORDER AND A STATEMENT MADE THAT 28 SUCH LIEN IS CONTINUED BY VIRTUE OF SUCH ORDER.

29 (C) IF A LIENOR IS MADE A PARTY DEFENDANT IN AN ACTION TO ENFORCE 30 ANOTHER LIEN, AND THE PLAINTIFF OR SUCH DEFENDANT HAS FILED A NOTICE OF THE PENDENCY OF THE ACTION WITHIN THE TIME PRESCRIBED IN THIS 31 SECTION, 32 LIEN OF SUCH DEFENDANT IS THEREBY CONTINUED. SUCH ACTION SHALL BE THE 33 DEEMED AN ACTION TO ENFORCE THE LIEN OF SUCH DEFENDANT LIENOR. THE FAIL-URE TO FILE A NOTICE OF PENDENCY OF ACTION SHALL NOT ABATE THE ACTION AS 34 35 TO ANY PERSON LIABLE FOR THE PAYMENT OF THE DEBT SPECIFIED IN THE NOTICE OF LIEN, AND THE ACTION MAY BE PROSECUTED TO JUDGMENT AGAINST SUCH 36 PERSON. THE PROVISIONS OF THIS SECTION IN REGARD TO CONTINUING LIENS 37 38 SHALL APPLY TO LIENS DISCHARGED BY DEPOSIT OR BY ORDER ON THE FILING OF 39 AN UNDERTAKING. WHERE A LIEN IS DISCHARGED BY DEPOSIT OR BY ORDER, A 40 NOTICE OF PENDENCY OF ACTION SHALL NOT BE FILED.

(D) NOTWITHSTANDING THE FOREGOING, IF A LIENOR COMMENCES A FORECLOSURE 41 ACTION OR AN ACTION TO OBTAIN A JUDGMENT ON THE WAGE CLAIM WITHIN ONE 42 43 YEAR FROM THE FILING OF THE NOTICE OF LIEN ON REAL PROPERTY OR THE RECORDING OF THE FINANCING STATEMENT CREATING LIEN ON PERSONAL PROPERTY, 44 45 THE LIEN SHALL BE EXTENDED DURING THE PENDENCY OF THE ACTION AND FOR ONE HUNDRED TWENTY DAYS FOLLOWING THE ENTRY OF FINAL JUDGMENT 46 IN SUCH 47 ACTION, UNLESS THE ACTION RESULTS IN A FINAL JUDGMENT OR ADMINISTRATIVE 48 ORDER IN THE LIENOR'S FAVOR ON THE WAGE CLAIMS AND THE LIENOR COMMENCES 49 A FORECLOSURE ACTION, IN WHICH INSTANCE THE LIEN SHALL BE VALID DURING 50 THE PENDENCY OF THE FORECLOSURE ACTION. IF A LIEN IS EXTENDED DUE TO THE PENDENCY OF A FORECLOSURE ACTION OR AN ACTION TO OBTAIN A JUDGMENT 51 ON WAGE CLAIM, THE LIENOR SHALL FILE A NOTICE OF SUCH PENDENCY AND 52 THE EXTENSION WITH THE COUNTY CLERK OF THE COUNTY IN WHICH THE NOTICE OF 53 54 LIEN IS FILED, CONTAINING THE NAMES OF THE PARTIES TO THE ACTION, THE 55 OBJECT OF THE ACTION, A BRIEF DESCRIPTION OF THE PROPERTY AFFECTED 56 THEREBY, AND THE TIME OF FILING THE NOTICE OF LIEN, OR IN THE CASE OF A

LIEN ON PERSONAL PROPERTY SHALL FILE SUCH NOTICE WITH THE OFFICE AUTHOR-1 2 IZED TO ACCEPT FINANCING STATEMENTS PURSUANT TO SECTION 9-501 OF THE 3 UNIFORM COMMERCIAL CODE. FOR PURPOSES OF THIS SECTION, AN ACTION TO JUDGMENT ON A WAGE CLAIM INCLUDES AN ACTION BROUGHT IN ANY COURT 4 OBTAIN 5 OF COMPETENT JURISDICTION OR THE SUBMISSION OF A COMPLAINT ТΟ THE 6 AN ACTION ALSO INCLUDES AN INVESTIGATION OF WAGE LABOR. DEPARTMENT OF 7 CLAIMS BY THE COMMISSIONER OF LABOR OR THE ATTORNEY GENERAL OF THE STATE 8 OF NEW YORK, REGARDLESS OF WHETHER SUCH INVESTIGATION WAS INITIATED BY A 9 COMPLAINT.

10 (E) A LIEN, THE DURATION OF WHICH HAS BEEN EXTENDED BY THE FILING OF A NOTICE OF THE PENDENCY OF AN ACTION AS ABOVE PROVIDED, 11 SHALL NEVERTHE-LESS TERMINATE AS A LIEN AFTER SUCH NOTICE HAS BEEN CANCELED AS PROVIDED 12 13 SECTION SIXTY-FIVE HUNDRED FOURTEEN OF THE CIVIL PRACTICE LAW AND IN 14 RULES OR HAS CEASED TO BE EFFECTIVE AS CONSTRUCTIVE NOTICE AS PROVIDED 15 IN SECTION SIXTY-FIVE HUNDRED THIRTEEN OF THE CIVIL PRACTICE LAW AND 16 RULES.

17 S 12. Subdivisions 2 and 4 of section 19 of the lien law, subdivision 18 2 as amended by chapter 310 of the laws of 1962, and subdivision 4 as 19 added by chapter 582 of the laws of 2002, paragraph (a) of subdivision 4 20 as further amended by section 104 of part A of chapter 62 of the laws of 21 2011, are amended to read as follows:

22 (2) By failure to begin an action to foreclose such lien or to secure 23 an order continuing it, within one year from the time of filing the 24 notice of lien, unless (I) an action be begun within the same period to 25 foreclose a mortgage or another mechanic's lien upon the same property 26 or any part thereof and a notice of pendency of such action is filed according to law, OR (II) AN ACTION IS COMMENCED TO OBTAIN A JUDGMENT ON 27 WAGE CLAIM PURSUANT TO SUBDIVISION TWO OF SECTION SEVENTEEN OF THIS 28 А ARTICLE, but a lien, the duration of which has been extended by 29 the filing of a notice of the pendency of an action as herein provided, 30 shall nevertheless terminate as a lien after such notice has been 31 32 cancelled or has ceased to be effective as constructive notice.

(4) Either before or after the beginning of an action by the EMPLOYER, owner or contractor executing a bond or undertaking in an amount equal to one hundred ten percent of such lien conditioned for the payment of any judgment which may be rendered against the property OR EMPLOYER for the enforcement of the lien:

38 a. The execution of any such bond or undertaking by any fidelity or 39 surety company authorized by the laws of this state to transact busi-40 ness, shall be sufficient; and where a certificate of qualification has been issued by the superintendent of financial services under the 41 provisions of section one thousand one hundred eleven of the insurance 42 43 and has not been revoked, no justification or notice thereof shall law, 44 be necessary. Any such company may execute any such bond or undertaking 45 surety by the hand of its officers, or attorney, duly authorized as thereto by resolution of its board of directors, a certified copy of 46 47 which resolution, under the seal of said company, shall be filed with 48 each bond or undertaking. Any such bond or undertaking shall be filed 49 with the clerk of the county in which the notice of lien is filed, and a 50 shall be served upon the adverse party. The undertaking is effeccopy 51 tive when so served and filed. If a certificate of qualification issued pursuant to subsections (b), (c) and (d) of section one thousand one 52 hundred eleven of the insurance law is not filed with the undertaking, a 53 54 party may except, to the sufficiency of a surety and by a written notice 55 of exception served upon the adverse party within ten days after receipt, a copy of the undertaking. Exceptions deemed by the court to 56

1 have been taken unnecessarily, or for vexation or delay, may, upon 2 notice, be set aside, with costs. Where no exception to sureties is 3 taken within ten days or where exceptions taken are set aside, the 4 undertaking shall be allowed.

5 b. In the case of bonds or undertakings not executed pursuant to para-6 graph a of this subdivision, the EMPLOYER, owner or contractor shall 7 execute an undertaking with two or more sufficient sureties, who shall 8 be free holders, to the clerk of the county where the premises are situated. The sureties must together justify in at least double the sum 9 10 named in the undertaking. A copy of the undertaking, with notice that 11 the sureties will justify before the court, or a judge or justice thereof, at the time and place therein mentioned, must be served upon the 12 lienor or his attorney, not less than five days before such time. Upon 13 the approval of the undertaking by the court, judge or justice an order 14 shall be made by such court, judge or justice discharging such lien. 15

c. If the lienor cannot be found, or does not appear by attorney, service under this subsection may be made by leaving a copy of such 16 17 undertaking and notice at the lienor's place of residence, or 18 if а 19 corporation at its principal place of business within the state as stated in the notice of lien, with a person of suitable age and discretion therein, or if the house of his abode or its place of business is not 20 21 22 stated in said notice of lien and is not known, then in such manner as the court may direct. The premises, if any, described in the notice of 23 24 lien as the lienor's residence or place of business shall be deemed to 25 be his said residence or its place of business for the purposes of said 26 service at the time thereof, unless it is shown affirmatively that the person servicing the papers or directing the service had knowledge 27 to the contrary. Notwithstanding the other provisions of this subdivision 28 29 relating to service of notice, in any case where the mailing address of 30 lienor is outside the state such service may be made by registered the or certified mail, return receipt requested, to such lienor at the mail-31 32 ing address contained in the notice of lien.

d. Except as otherwise provided in this subdivision, the provisions of article twenty-five of the civil practice law and rules regulating undertakings is applicable to a bond or undertaking given for the discharge of a lien on account of private improvements OR OF AN EMPLOY-EE'S LIEN.

38 S 13. Section 24 of the lien law, as amended by chapter 515 of the 39 laws of 1929, is amended to read as follows:

40 S 24. Enforcement of [mechanic's] lien. (1) REAL PROPERTY. The 41 [mechanics'] liens ON REAL PROPERTY specified in this article may be 42 enforced against the property specified in the notice of lien and which 43 is subject thereto and against any person liable for the debt upon which 44 the lien is founded, as prescribed in article three of this chapter.

52 S 14. Section 26 of the lien law, as amended by chapter 373 of the 53 laws of 1977, is amended to read as follows:

54 S 26. Subordination of liens after agreement with owner. In case an 55 owner of real property shall execute to one or more persons, or a corpo-56 ration, as trustee or trustees, a bond and mortgage or a note and mort-

gage affecting such property in whole or in part, or an assignment of 1 2 the moneys due or to become due under a contract for a building loan in 3 relation to such property, and in case such mortgage, if any, shall be 4 recorded in the office of the register of the county where such real property is situated, or if such county has no register then in the 5 6 office of the clerk of such county, and in case such assignment, if any, 7 shall be filed in the office of the clerk of the county where such real 8 property is situated; and in case lienors having [mechanics'] liens against said real property, notices of which have been filed up to and 9 10 not later than fifteen days after the recording of such mortgage or the 11 filing of such assignment, and which liens have not been discharged as in this article provided, shall, to the extent of at least fifty-five per centum of the aggregate amount for which such notices of liens have 12 13 14 been so filed, approve such bond and mortgage or such note and mortgage, 15 if any, and such assignment, if any, by an instrument or instruments in writing, duly acknowledged and filed in the office of such county clerk, 16 17 then all mechanics' liens for labor performed or material furnished 18 prior to the recording of such mortgage or filing of such assignment, 19 whether notices thereof have been theretofore or are thereafter filed 20 and which have not been discharged as in this article provided, shall be 21 subordinate to the lien of such trust bond and mortgage or such trust 22 note and mortgage to the extent of the aggregate amount of all certificates of interest therein issued by such trustee or trustees, or their 23 successors, for moneys loaned, materials furnished, labor performed and 24 25 any other indebtedness incurred after said trust mortgage shall have 26 been recorded, and for expenses in connection with said trust mortgage, and shall also be subordinate to the lien of the bond and mortgage or 27 note and mortgage, given to secure the amount agreed to be advanced 28 29 under such contract for a building loan to the extent of the amount 30 which shall be advanced by the holder of such bond and mortgage or such note and mortgage to the trustee or trustees, or their successors, under 31 32 such assignment. The provisions of this section shall apply to all bonds 33 and mortgages and notes and mortgages and all assignments of moneys due, or to become due under building loan contracts executed by such owner, 34 in like manner, and recorded or filed, from time to time as hereinbefore 35 provided. In case of an assignment to trustees under the provisions of 36 37 this section, the trustees and their successors shall be the agents of 38 the assignor to receive and receipt for any and all sums advanced by the 39 holder of the building loan bond and mortgage or the building loan note 40 and mortgage under the building loan contract and such assignment. No lienor shall have any priority over the bond and mortgage or note and 41 42 mortgage given to secure the money agreed to be advanced under a build-43 ing loan contract or over the advances made thereunder, by reason of any 44 act preceding the making and approval of such assignment.

47 S 38. Itemized statement may be required of lienor. A lienor who has 48 filed a notice of MECHANIC'S lien shall, on demand in writing, deliver 49 to the owner or contractor making such demand a statement in writing 50 which shall set forth the items of labor and/or material and the value 51 thereof which make up the amount for which he claims a lien, and which shall also set forth the terms of the contract under which such items 52 53 were furnished. A LIENOR WHO HAS FILED A NOTICE OF EMPLOYEE LIEN SHALL, 54 ON DEMAND IN WRITING, DELIVER TO THE EMPLOYER MAKING SUCH DEMAND Α 55 WRITING WHICH SHALL SET FORTH THE ITEMS OF THE WAGE CLAIM STATEMENT IN AND THE VALUE THEREOF WHICH MAKE UP THE AMOUNT FOR WHICH HE 56 CLAIMS Α

LIEN. The statement shall be verified by the lienor or his agent in the 1 2 form required for the verification of notices in section nine of this 3 [chapter] ARTICLE. If the lienor shall fail to comply with such a demand 4 within five days after the same shall have been made by the EMPLOYER, 5 owner or contractor, or if the lienor delivers an insufficient state-6 ment, the person aggrieved may petition the supreme court of this state 7 or any justice thereof, or the county court of the county where the 8 premises are situated, or the county judge of such county for an order directing the lienor within a time specified in the order to deliver to 9 10 the petitioner the statement required by this section. Two days' notice 11 in writing of such application shall be served upon the lienor. Such service shall be made in the manner provided by law for the personal 12 13 service of a summons. The court or a justice or judge thereof shall hear 14 the parties and upon being satisfied that the lienor has failed, 15 neglected or refused to comply with the requirements of this section 16 shall have an appropriate order directing such compliance. In case the 17 lienor fails to comply with the order so made within the time specified, 18 then upon five days' notice to the lienor, served in the manner provided 19 law for the personal service of a summons, the court or a justice or by 20 judge thereof may make an order cancelling the lien.

21 S 16. Section 39 of the lien law, as added by chapter 859 of the laws 22 of 1930, is amended to read as follows:

23 39. Lien wilfully exaggerated is void. In any action or proceeding S to enforce a [mechanic's] lien upon a private or public improvement or 24 25 which the validity of the lien is an issue, if the court shall find in 26 that a lienor has wilfully exaggerated the amount for which he claims a lien as stated in his notice of lien, his lien shall be declared to be 27 void and no recovery shall be had thereon. This article is to be construed in connection with article two of this chapter, and provides proceedings for the enforcement of EMPLOYEE'S LIENS ON REAL PROPERTY, AS WELL AS liens for labor performed and materials furnished in the improvement of real property, created by virtue of such article. S 18. Section 41 of the lien law, as amended by chapter 807 of the

39 S 18. Section 41 of the lien law, as amended by chapter 807 of the 40 laws of 1952, is amended to read as follows:

S 41. Enforcement of mechanic's OR EMPLOYEE'S lien on real property. A 41 mechanic's lien OR EMPLOYEE'S LIEN on real property may be enforced 42 43 against such property, and against a person liable for the debt upon 44 which the lien is founded, by an action, by the lienor, his assignee or 45 legal representative, in the supreme court or in a county court otherwise having jurisdiction, regardless of the amount of such debt, or in a 46 court which has 47 jurisdiction in an action founded on a contract for a 48 sum of money equivalent to the amount of such debt.

49 S 19. Section 43 of the lien law, as amended by section 310 of the 50 laws of 1962, is amended to read as follows:

51 S 43. Action in a court of record; consolidation of actions. The 52 provisions of the real property actions and proceedings law relating to 53 actions for the foreclosure of a mortgage upon real property, and the 54 sale and the distribution of the proceeds thereof apply to actions in a 55 court of record, to enforce mechanics' liens AND EMPLOYEES' LIENS on 56 real property, except as otherwise provided in this article. If actions 1 are brought by different lienors in a court of record, the court in 2 which the first action was brought, may, upon its own motion, or upon 3 the application of any party in any of such actions, consolidate all of 4 such actions.

5 S 20. Section 46 of the lien law, as amended by chapter 515 of the 6 laws of 1929, is amended to read as follows:

7 S 46. Action in a court not of record. If an action to enforce a mechanic's lien OR EMPLOYEE'S LIEN against real property is brought in a 8 court not of record, it shall be commenced by the personal service upon 9 10 the owner of a summons and complaint verified in the same manner as a 11 complaint in an action in a court of record. The complaint must set forth substantially the facts contained in the notice of lien, 12 and the substance of the agreement under which the labor was performed or the 13 14 materials were furnished, OR IF THE LIEN IS BASED UPON A WAGE CLAIM AS 15 DEFINED IN SECTION TWO OF THIS CHAPTER, THE BASIS FOR SUCH WAGE CLAIM. 16 The form and contents of the summons shall be the same as provided by law for the commencement of an action upon a contract in such court. The 17 summons must be returnable not less than twelve nor more than twenty 18 19 days after the date of the summons, or if service is made by publication, after the day of the last publication of the summons. Service 20 21 must be made at least eight days before the return day.

22 S 21. Section 50 of the lien law, as amended by chapter 515 of the 23 laws of 1929, is amended to read as follows:

S 50. Execution. Execution may be issued upon a judgment obtained in an action to enforce a mechanic's lien OR AN EMPLOYEE'S LIEN against real property in a court not of record, which shall direct the officer to sell the title and interest of the owner in the premises, upon which the lien set forth in the complaint existed at the time of filing the notice of lien.

30 S 22. Section 53 of the lien law, as amended by chapter 515 of the 31 laws of 1929, is amended to read as follows:

32 53. Costs and disbursements. If an action is brought to enforce a S 33 mechanic's lien OR AN EMPLOYEE'S LIEN against real property in a court record, the costs and disbursements shall rest in the discretion of 34 of 35 the court, and may be awarded to the prevailing party. The judgment rendered in such an action shall include the amount of such costs and 36 37 specify to whom and by whom the costs are to be paid. If such action is brought in a court not of record, they shall be the same as allowed in 38 civil actions in such court. The expenses incurred in serving the 39 40 summons by publication may be added to the amount of costs now allowed in such court. 41
