AN ACT to amend the penal law, in relation to requiring proof of liability insurance prior to the issuance of a license to carry a firearm

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Subdivision 1 of section 400.00 of the penal Section 1. amended by chapter 1 of the laws of 2013, is amended to read as follows: 1. Eligibility. No license shall be issued or renewed pursuant to this 3 section except by the licensing officer, and then only after investi-5 gation and finding that all statements in a proper application for a license are true. No license shall be issued or renewed except for an applicant (a) twenty-one years of age or older, provided, however, that 7 8 where such applicant has been honorably discharged from the United 9 States army, navy, marine corps, air force or coast guard, or the national guard of the state of New York, no such age restriction shall 10 apply; (b) of good moral character; (c) who has not been convicted 11 12 anywhere of a felony or a serious offense; (d) who is not a fugitive 13 from justice; (e) who is not an unlawful user of or addicted to controlled substance as defined in section 21 U.S.C. 802; (f) who being 14 15 an alien (i) is not illegally or unlawfully in the United States or (ii) has not been admitted to the United States under a nonimmigrant visa 16 17 subject to the exception in 18 U.S.C. 922(y)(2); (g) who has not been 18 discharged from the Armed Forces under dishonorable conditions; (h) who, 19 having been a citizen of the United States, has not renounced his or her 20 citizenship; (i) who has stated whether he or she has ever suffered any mental illness; (j) who has not been involuntarily committed to a facil-21 jurisdiction of an office of the department of mental 22 ity under the 23 hygiene pursuant to article nine or fifteen of the mental hygiene 24 article seven hundred thirty or section 330.20 of the criminal procedure 25 section four hundred two or five hundred eight of the correction

law, section 322.2 or 353.4 of the family court act, or has not been civilly confined in a secure treatment facility pursuant to article ten 3 of the mental hygiene law; (k) who has not had a license revoked or who not under a suspension or ineligibility order issued pursuant to the provisions of section 530.14 of the criminal procedure law or section 5 6 eight hundred forty-two-a of the family court act; (1) in the county of 7 Westchester, who has successfully completed a firearms safety course and 8 test as evidenced by a certificate of completion issued in his or her 9 and endorsed and affirmed under the penalties of perjury by a duly 10 authorized instructor, except that: (i) persons who are honorably 11 discharged from the United States army, navy, marine corps or coast 12 guard, or of the national guard of the state of New York, and produce 13 evidence of official qualification in firearms during the term of 14 service are not required to have completed those hours of a firearms 15 safety course pertaining to the safe use, carrying, possession, maintenance and storage of a firearm; and (ii) persons who were licensed to 16 17 possess a pistol or revolver prior to the effective date of this para-18 graph are not required to have completed a firearms safety course and 19 test; (m) who has not had a guardian appointed for him or her pursuant 20 to any provision of state law, based on a determination that as a result 21 of marked subnormal intelligence, mental illness, incapacity, condition 22 disease, he or she lacks the mental capacity to contract or manage 23 his or her own affairs; [and] (n) WHO SUBMITS PROOF OF PERSONAL LIABIL-24 INSURANCE; AND (0) concerning whom no good cause exists for the 25 in denial of the license. No person shall engage the business of 26 gunsmith or dealer in firearms unless licensed pursuant to this section. 27 applicant to engage in such business shall also be a citizen of the United States, more than twenty-one years of age and maintain a place of 28 29 business in the city or county where the license is issued. For such business, if the applicant is a firm or partnership, each member thereof 30 shall comply with all of the requirements set forth in this subdivision 31 32 and if the applicant is a corporation, each officer thereof shall 33

34 S 2. This act shall take effect on the first of November next succeed-35 ing the date on which it shall have become a law and shall apply to 36 licenses issued or renewed on or after such date.
