AN ACT to amend the election law, in relation to providing voting materials and translators in French and Creole in the city of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act shall be known and may be cited as the "Haitian-American Informed Voter Act".

2 S 2. The election law is amended by adding a new section 3-508 to read
3 as follows:

4 S 3-508. BOARDS OF ELECTIONS; VOTING MATERIALS IN FRENCH AND CREOLE. A
5 BOARD OF ELECTIONS IN A CITY OF OVER ONE MILLION SHALL PROVIDE THE SAME
6 INFORMATION IN FRENCH AND CREOLE THAT IT PROVIDES IN LANGUAGES OTHER
7 THAN ENGLISH ON ITS WEBSITE. IT SHALL ALSO PRODUCE AND DISSEMINATE CITY-
8 WIDE A BOOKLET THAT INCLUDES: (A) A VOTER REGISTRATION FORM IN ENGLISH
9 WITH INSTRUCTIONS IN FRENCH AND CREOLE; (B) INSTRUCTIONS REGARDING THE
10 CRITERIA AND APPLICATION PROCESS FOR OBTAINING AN ABSENTEE BALLOT; AND
11 (C) A SECTION WITH GENERAL INFORMATION INCLUDING FREQUENTLY ASKED QUES-
12 TIONS. SUCH BOARD MAY INCLUDE OTHER LANGUAGES ON ITS WEBSITE AND IN SUCH
13 BOOKLET.

14 S 3. Section 8-104 of the election law is amended by adding a new
15 subdivision 7 to read as follows:

16 7. IN THE CITY OF NEW YORK, DURING DAYS OF PRIMARY, GENERAL AND
17 SPECIAL ELECTIONS, AT EACH PREMISES WHEREIN A POLLING PLACE OR PLACES
18 ARE LOCATED IN A POLITICAL SUBDIVISION OF THE STATE WHERE MORE THAN FIVE
19 PERCENT OF THE CITIZENS OF VOTING AGE OF SUCH POLITICAL SUBDIVISION
20 SPEAK THE LANGUAGE OF FRENCH AND/OR CREOLE AND ARE LIMITED-ENGLISH
21 PROFICIENT, AT LEAST ONE FRENCH-ENGLISH LANGUAGE AND/OR CREOLE-ENGLISH
22 TRANSLATOR DESIGNATED BY SUCH CITY SHALL BE ASSIGNED FOR DUTY FROM THE
23 OPENING UNTIL THE CLOSING OF THE POLLS.
