AN ACT to amend the education law, in relation to requiring each school in the state to have and maintain a school library in each elementary and secondary school in the district and to employ a certified school library media specialist for such school library

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The education law is amended by adding a new section 411 to 2 read as follows:

- SCHOOL LIBRARIES. 1. EACH SCHOOL DISTRICT IN THE STATE SHALL 411. HAVE AND MAINTAIN A SCHOOL LIBRARY IN EACH ELEMENTARY AND SECONDARY DISTRICT, AND SHALL EMPLOY A CERTIFIED SCHOOL LIBRARY SCHOOL ΙN THE MEDIA SPECIALIST FOR SUCH SCHOOL LIBRARY WITHIN THREE YEARS EFFECTIVE DATE OF THIS SECTION.
- EMPLOYMENT OF CERTIFIED SCHOOL LIBRARY MEDIA SPECIALISTS SHALL BE IN ACCORDANCE WITH THE FOLLOWING STANDARDS:
- 10 (A) IN EACH ELEMENTARY OR SECONDARY SCHOOL WITH AN ENROLLMENT OF NOT MORE THAN FIVE HUNDRED PUPILS, A CERTIFIED SCHOOL LIBRARY MEDIA SPECIAL-11 12 IST SHALL BE EMPLOYED AS ONE-HALF OF A FULL-TIME EOUIVALENT STAFF 13 MEMBER;
 - (B) IN EACH ELEMENTARY OR SECONDARY SCHOOL WITH AN ENROLLMENT OF THAN FIVE HUNDRED BUT NOT MORE THAN ONE THOUSAND, A CERTIFIED SCHOOL LIBRARY MEDIA SPECIALIST SHALL BE EMPLOYED AS A FULL-TIME EQUIVALENT STAFF MEMBER;
- IN EACH ELEMENTARY OR SECONDARY SCHOOL WITH AN ENROLLMENT OF MORE 19 THAN TWO THOUSAND PUPILS, TWO CERTIFIED SCHOOL LIBRARY MEDIA SPECIALISTS SHALL EACH BE EMPLOYED AS A FULL-TIME EQUIVALENT STAFF MEMBER; AND
- 21 (D) AN ADDITIONAL CERTIFIED SCHOOL LIBRARY MEDIA SPECIALIST SHALL 22 EMPLOYED AS A FULL-TIME EQUIVALENT STAFF MEMBER FOR EACH ADDITIONAL ONE 23 THOUSAND PUPILS ENROLLED IN AN ELEMENTARY OR SECONDARY SCHOOL.

3. IN EACH ELEMENTARY OR SECONDARY SCHOOL WITH AN ENROLLMENT OF AT LEAST ONE THOUSAND PUPILS, A FULL-TIME EQUIVALENT STAFF MEMBER SHALL BE EMPLOYED AS A LIBRARY CLERK. AN ADDITIONAL FULL-TIME EQUIVALENT STAFF MEMBER SHALL BE EMPLOYED AS A LIBRARY CLERK FOR EACH ADDITIONAL ONE THOUSAND PUPILS ENROLLED IN AN ELEMENTARY OR SECONDARY SCHOOL.

- 4. THE COMMISSIONER MAY, UPON APPLICATION BY A SCHOOL DISTRICT, WAIVE THE APPLICABILITY OF THE PROVISIONS OF THIS SECTION FOR UP TO ONE YEAR, IF SUCH APPLICATION DEMONSTRATES THE ELEMENTARY OR SECONDARY SCHOOL IS WITHIN A DESIGNATED SHORTAGE AREA FOR CERTIFIED SCHOOL LIBRARY MEDIA SPECIALISTS, AND SUCH APPLICATION DEMONSTRATES THAT AN ACTUAL OFFER OF EMPLOYMENT WAS MADE TO A CERTIFIED SCHOOL LIBRARY MEDIA SPECIALIST; HOWEVER, NO MORE THAN ONE WAIVER MAY BE GRANTED WITHIN A FIVE YEAR PERIOD.
- 14 S 2. This act shall take effect on the first of July next succeeding 15 the date upon which it shall have become law.
