- AN ACT to amend the public buildings law, in relation to bicycle access to public office buildings

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 11 of the public buildings law, as added by chapter 2 819 of the laws of 1987 and subdivision 2 as amended by chapter 126 of 3 the laws of 1988, is amended to read as follows:

S 11. [Pilot program] PROGRAM of bicycle parking facilities. 4 1. Legislative finding. In recognition of the role which bicycles can serve 5 б as a valuable transportation mode with energy conservation, health, 7 PHYSICAL FITNESS and environmental benefits, it is hereby declared to be 8 the policy of the state that provision for adequate and safe bicycle 9 facilities including the use of present facilities for safe and secure 10 bicycle parking be included in the planning [and], development, 11 CONSTRUCTION OR RECONSTRUCTION of all state facilities.

12 2. (a) The commissioner of general services shall undertake a [pilot] 13 program for THE provision and promotion of safe and secure bicycle park-14 ing facilities at state office buildings FOR STATE EMPLOYEES AND VISI-TORS AT SUCH BUILDINGS. The commissioner[, within one year of the enact-15 16 ment of this section,] OF GENERAL SERVICES shall provide, at the 17 principal office buildings under his OR HER superintendence at the Nelson A. Rockefeller Empire State Plaza in Albany[, New York], 18 secure 19 bicycle parking facilities for use by employees and visitors. PROVIDED, FURTHER, 20 THAT THE COMMISSIONER OF GENERAL SERVICES SHALL MAKE AN INVEN-21 TORY OF ALL EXISTING BICYCLE PARKING FACILITIES AT ALL STATE OFFICE 22 BUILDINGS AND OFFICE BUILDINGS IN WHICH THE STATE LEASES OR OCCUPIES

SPACE. SUCH INVENTORY SHALL BE MADE ONLY OF STATE OWNED OR LEASED BUILD-1 2 INGS OR OFFICES WHICH HAVE OVER FIFTY STATE EMPLOYEES LOCATED AT SUCH 3 SITE OR IN WHICH THE VISITATION RATE BY THE GENERAL PUBLIC IS OVER FIVE 4 HUNDRED VISITORS, ON AVERAGE, EACH MONTH. SUCH INVENTORY OF BICYCLE 5 PARKING AND STORAGE FACILITIES SHALL BE COMPLETED WITHIN TWO YEARS OF 6 EFFECTIVE DATE OF THE CHAPTER OF THE LAWS OF TWO THOUSAND SIXTEEN THE 7 WHICH AMENDED THIS SECTION.

8 (b) The commissioner OF GENERAL SERVICES is also authorized, within a 9 reasonable period and where feasible, to provide suitable support facil-10 ities including clothing lockers, showers and changing facilities, and 11 to charge a reasonable use fee.

12 (c) For the purpose of this section, the term "bicycle parking facility" means a device or enclosure, located within a building or installa-13 tion, or conveniently adjacent thereto, that is easily accessible, 14 15 clearly visible and so located as to minimize the danger of theft of bicycles. Such a device shall consist of a parking rack, locker, or 16 17 other device constructed to enable the frame and both wheels of a bicycle to be secured with ease by use of a padlock in a manner that will 18 19 minimize the risk of theft, or an enclosure which limits access to the bicycles and is under observation by an attendant. 20

21 3. UPON COMPLETION OF A STATE OFFICE BUILDING BICYCLE PARKING FACILI-22 TIES INVENTORY PROVIDED FOR IN PARAGRAPH (A) OF SUBDIVISION TWO OF THIS 23 THE COMMISSIONER OF GENERAL SERVICES SHALL DEVELOP A PLAN TO SECTION, 24 EXPAND BICYCLE PARKING TO ENCOURAGE THE USE OF SUCH FACILITIES BY STATE 25 AND THE GENERAL PUBLIC THAT PATRONIZE SUCH FACILITIES TO EMPLOYEES 26 CONDUCT PUBLIC BUSINESS. SUCH PLAN SHALL BE COMPLETED WITHIN EIGHTEEN 27 MONTHS AFTER FINALIZATION OF THE PARKING FACILITIES INVENTORY. SUCH PLAN 28 CONTAIN AND ADDRESS THE FOLLOWING ELEMENTS TO ENCOURAGE STATE MAY 29 EMPLOYEES AND THE GENERAL PUBLIC TO USE BICYCLES MORE FREOUENTLY AT EACH STATE OFFICE BUILDING FACILITY OR LEASED PREMISES: 30

(A) THE INVENTORY OF BICYCLE PARKING FACILITIES SHALL BE RANKED FROM
HIGHEST TO LOWEST BASED ON THE EXISTING UNFULFILLED DEMAND FOR SUCH
FACILITIES AT STATE OFFICE BUILDINGS. SUCH RANKING SHALL ALSO CONSIDER
INCREASED FUTURE DEMAND OR THE POTENTIAL FOR INCREASED FUTURE DEMAND OF
SUCH PARKING AND STORAGE FACILITIES;

(B) IN URBAN SETTINGS, THERE SHOULD BE A PLAN TO DEVELOP AN AMPLE
SUPPLY OF SECURE OFF-STREET BICYCLE PARKING OR ALTERNATE INDOOR PARKING
OR STORAGE FOR SUCH BICYCLES;

39 (C) ADEQUATE POSTING OF SUCH BICYCLE PARKING FACILITIES SHALL BE 40 PROVIDED FOR AND PLACED AROUND SUCH STATE OFFICE BUILDING FACILITY TO 41 ENCOURAGE UTILIZATION OF SUCH PARKING FACILITIES BY STATE EMPLOYEES AND 42 THE GENERAL PUBLIC;

(D) A MARKETING AND COMMUNITY OUTREACH PLAN SHOULD PROVIDE FOR THE
44 DISSEMINATION OF INFORMATION TO STATE EMPLOYEES, VISITORS TO STATE
45 OFFICE BUILDINGS, AND TO THE GENERAL PUBLIC TO ENCOURAGE INDIVIDUALS TO
46 USE BICYCLES WHEN TRAVELING TO SUCH BUILDINGS OR FACILITIES; AND

47 (E) THE COMMISSIONER OF GENERAL SERVICES MAY INCLUDE AND ADDRESS ANY 48 OTHER ELEMENT IN THE PLAN AS HE OR SHE DEEMS APPROPRIATE.

49 4. In undertaking such [pilot] program, the office OF GENERAL SERVICES 50 shall: (a) Consult with and cooperate with (i) [the statewide bicycle 51 advisory council, (ii)] the [New York state] department of transporta-52 tion regional bicycle coordinator[, (iii)]; (II) local bicycle planning 53 groups[,]; and [(iv)] (III) persons, organizations, and groups served 54 by, interested in, or concerned with the area under study.

55 (b) Request and receive from any department, division, board, bureau, 56 commission or other agency of the state or any political subdivision 1 thereof or any public authority, any assistance and data as may be 2 necessary to enable the office OF GENERAL SERVICES to carry out its 3 responsibilities under this section.

4 [(c) On or before the first day of January, nineteen hundred eighty-5 nine, a report shall be submitted to the governor and the legislature 6 which shall include a determination of usage levels, a statement outlin-7 ing first year progress and the elements of a statewide plan for the 8 provision of such facilities.]

9 5. NOTHING IN THIS SECTION SHALL BE CONSTRUED TO REQUIRE THE STATE OR 10 THE OWNER, LESSEE, MANAGER OR OTHER PERSON WHO IS IN CONTROL OF A BUILD-11 ING GOVERNED BY THIS SECTION TO PROVIDE SPACE FOR STORED BICYCLES AT 12 SUCH BUILDING OR BROUGHT INTO SUCH BUILDING OR TO PERMIT A BICYCLE TO BE 13 PARKED IN A MANNER THAT VIOLATES BUILDING OR FIRE CODES OR ANY OTHER 14 APPLICABLE LAW, RULE OR CODE, OR WHICH OTHERWISE IMPEDES INGRESS OR 15 EGRESS TO SUCH BUILDING.

16 6. THERE IS HEREBY ESTABLISHED A TEMPORARY BICYCLE COMMUTING TASK 17 FORCE TO EXAMINE THE DEVELOPMENT OF SHELTERED BICYCLE PARKING IN PUBLIC 18 SPACES.

19 (A) SUCH TASK FORCE SHALL BE COMPRISED OF NINE MEMBERS, INCLUDING THE 20 COMMISSIONER OF GENERAL SERVICES, THE COMMISSIONER OF TRANSPORTATION, 21 THE COMMISSIONER OF MOTOR VEHICLES AND THE COMMISSIONER OF PARKS, RECRE-22 ATION AND HISTORIC PRESERVATION OR A DESIGNEE OF ANY SUCH COMMISSIONERS. THE REMAINING FOUR MEMBERS SHALL CONSIST OF A GROUP OF MUNICIPAL PLAN-23 24 NERS, BICYCLE ASSOCIATION REPRESENTATIVES, BUILDING CONTRACTORS AND 25 ENGINEERS. THEY SHALL BE APPOINTED AS FOLLOWS: ONE MEMBER SHALL BE APPOINTED BY THE TEMPORARY PRESIDENT OF THE SENATE; ONE MEMBER SHALL BE 26 APPOINTED BY THE MINORITY LEADER OF THE SENATE; ONE MEMBER SHALL BE 27 28 APPOINTED BY THE SPEAKER OF THE ASSEMBLY; AND ONE MEMBER SHALL BE 29 APPOINTED BY THE MINORITY LEADER OF THE ASSEMBLY.

(B) THE CHAIR OF THE TEMPORARY BICYCLE COMMUTING TASK FORCE SHALL BE
THE COMMISSIONER OF GENERAL SERVICES. MEMBERS OF THE TEMPORARY BICYCLE
COMMUTING TASK FORCE SHALL SERVE WITHOUT COMPENSATION AND SHALL MEET
WHEN DEEMED NECESSARY BY THE CHAIR.

(C) WITHIN EIGHTEEN MONTHS OF THE TEMPORARY BICYCLE COMMUTING TASK 34 35 FORCE'S ESTABLISHMENT, SUCH TASK FORCE SHALL ISSUE A REPORT TO THE GOVERNOR AND THE LEGISLATURE. SUCH REPORT SHALL INCLUDE, BUT NOT BE 36 37 LIMITED TO (I) AN ASSESSMENT OF THE DEMAND FOR SHELTERED BICYCLE PARKING 38 IN PUBLIC SPACES; (II) AN EXAMINATION OF THE MARKETING AND COMMUNITY OUTREACH EFFORTS NEEDED TO ENCOURAGE THE USE OF BICYCLES; AND (III) 39 40 RECOMMENDATIONS ON ESTABLISHING PARTNERSHIPS WITH ENTITIES TO DEVELOP BICYCLE PARKING FACILITIES IN PUBLIC SPACES. SUCH REPORT SHALL BE POST-41 WEBSITE OF EACH STATE AGENCY THAT WAS A MEMBER OF SUCH TASK ON THE 42 ED 43 FORCE WITHIN TWENTY DAYS FROM ITS SUBMISSION TO THE GOVERNOR. THE TEMPO-44 RARY BICYCLE COMMUTING TASK FORCE SHALL CEASE TO EXIST THREE MONTHS 45 AFTER THE ISSUANCE OF ITS REPORT.

46 S 2. This act shall take effect on the one hundred eightieth day after 47 it shall have become a law.
