Introduced by M. of A. PICHARDO -- read once and referred to the Committee on Higher Education

AN ACT to amend the education law, in relation to certain tuition waivers for police officer students of the state university of New York and the city university of New York; and providing for the repeal of certain provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph h of subdivision 2 of section 355 of the education law is amended by adding a new subparagraph 1-a to read as follows:
2 (1-A) NOTWITHSTANDING THE PROVISIONS OF ANY OTHER GENERAL, SPECIAL OR
3 LOCAL LAW, RULE OR REGULATION, SUCH REGULATIONS SHALL PERMIT POLICE
4 OFFICERS, AS SUCH TERM IS DEFINED IN SECTION TWO HUNDRED NINE-Q OF THE
5 GENERAL MUNICIPAL LAW, WHO ARE ENROLLED IN PROGRAMS LEADING TO BACCALAUREATE OR HIGHER DEGREES AT STATE-OPERATED INSTITUTIONS OF THE STATE
6 UNIVERSITY TO ATTEND UP TO TWO COURSES PER SEMESTER OR QUARTER WITHOUT
7 TUITION, PROVIDED THAT SUCH TUITION-WAIVED ATTENDANCE DOES NOT DENY
8 COURSE ATTENDANCE AT A STATE-OPERATED INSTITUTION BY AN INDIVIDUAL WHO
9 IS OTHERWISE QUALIFIED UNDER THE REGULATIONS PROMULGATED PURSUANT TO
10 THIS SECTION.
11 S 2. Paragraph (c) of subdivision 7 of section 6206 of the education
12 law, as added by chapter 548 of the laws of 2004, is amended to read as
13 follows:
14 (c) Notwithstanding the provisions of any other general, special or
15 local law, rule or regulation, the board of trustees shall promulgate
16 regulations to permit [members of the New York city police department
17 employed in the rank of police officer] POLICE OFFICERS, AS SUCH TERM IS
18 DEFINED IN SECTION TWO HUNDRED NINE-Q OF THE GENERAL MUNICIPAL LAW, who
19 are enrolled in programs leading to baccalaureate or higher degrees at a
20 senior college of the city university to attend [one course] UP TO TWO
21 COURSES PER SEMESTER OR QUARTER without tuition, provided that such

5 S 3. This act shall take effect immediately; provided that:
6 1. section one of this act shall expire and be deemed repealed July 1,
7 2017; and
8 2. the amendments to paragraph (c) of subdivision 7 of section 6206 of
9 the education law made by section two of this act shall not affect the
10 expiration and repeal of such paragraph and shall expire and be deemed
11 repealed therewith.
