- AN ACT to amend the general business law, in relation to prohibiting fees on gift cards and gift certificates

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 3 and 5 of section 396-i of the general busi-2 ness law, as amended by chapter 507 of the laws of 2004, are amended to 3 read as follows:

4 3. The terms and conditions of a gift certificate store credit shall 5 clearly and conspicuously stated thereon. Terms and conditions shall be include the expiration date, whether any fees are assessed against the 6 the gift certificate, THE PROCEDURE FOR and whether a fee 7 balance of 8 will be charged for the replacement of a gift certificate that is lost, 9 stolen, or destroyed, IF ANY. Additional terms and conditions including, but not be limited to, policies related to refunds, 10 warranties, changes in terms and conditions, assignment and waiver shall be conspic-11 uously printed: (a) on the gift certificate; or (b) on an envelope or 12 13 packaging containing the gift certificate, provided that a toll free telephone number to access the additional terms and conditions is print-14 15 ed on the gift certificate; or (c) on an accompanying printed document, 16 provided that a toll free telephone number to access the additional 17 terms and conditions is printed on the gift certificate.

18 5. (a) [No retroactive] FOR GIFT CERTIFICATES THAT ARE ONLY USABLE AT 19 A SINGLE MERCHANT OR AN AFFILIATED GROUP OF MERCHANTS THAT SHARE THE 20 SAME NAME, MARK OR LOGO, NO fees shall be assessed against THE BALANCE

3 (b) [No] FOR GIFT CERTIFICATES THAT ARE USABLE AT MULTIPLE, UNAFFIL-4 IATED MERCHANTS OR SERVICE PROVIDERS AND FOR GIFT CERTIFICATES DEFINED 5 IN PARAGRAPHS (A) AND (B) OF SUBDIVISION THREE-B OF THIS SECTION, NO 6 monthly service fees may be assessed against the balance of a gift 7 certificate prior to the thirteenth month of dormancy, AND NO RETROAC-8 TIVE FEES SHALL BE ASSESSED AGAINST THE BALANCE OF A GIFT CERTIFICATE.

9 (c) For the purposes of this subdivision, "dormancy" shall mean non-10 use of a gift certificate. Use of a gift certificate shall include, but 11 not be limited to, adding value, or purchases.

12 S 2. This act shall take effect on the ninetieth day after it shall 13 have become a law and shall apply to gift certificates issued on or 14 after such date.
