AN ACT to amend the alcoholic beverage control law, in relation to authorizing the state liquor authority to issue a license to sell beer at retail for consumption off-premises to a grocery store located within the town of Copake

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 1 of section 110 of the alcoholic beverage  
2 control law is amended by adding a new paragraph (a-1) to read as  
3 follows:  
4     (A-1) NOTWITHSTANDING THE PROVISIONS OF SUBPARAGRAPH (III) OF PARA-  
5 GRAPH (A) OF THIS SUBDIVISION, THE AUTHORITY MAY ISSUE A LICENSE TO SELL  
6 BEER AT RETAIL FOR CONSUMPTION OFF-PREMISES TO A GROCERY STORE LOCATED  
7 WHOLLY WITHIN THE BOUNDARIES OF THE TOWN OF COPAKE AND THE COUNTY OF  
8 COLUMBIA BOUNDED AND DESCRIBED AS FOLLOWS:  
9     ALL THAT CERTAIN LOT, PIECE OR PARCEL OF LAND SITUATED, LYING AND  
10 BEING IN THE TOWN OF COPAKE, COUNTY OF COLUMBIA AND STATE OF NEW YORK,  
11 AND BEING MORE PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS:  
12     BEGINNING AT A RECOVERED IRON ROD ON THE NORTHERLY LINE OF A PUBLIC  
13 ROAD KNOWN AS COUNTY ROUTE 7A, SAID POINT ALSO BEING AT THE NORTHEAST  
14 CORNER OF THE HEREIN DESCRIBED PARCEL OF LAND AND THE SOUTHEAST CORNER  
15 OF LANDS NOW OR FORMERLY OF DAVIS; AND RUNNING THENCE, ALONG SAID COUNTY  
16 ROUTE 7A, THE FOLLOWING THREE (3) COURSES: 1.) S51° 49'29"W 91.34'  
17 (FEET) TO A POINT, 2.) N87° 08'34"W 39.56' (FEET) TO A POINT, 3.) N70°  
18 14'16"W 40.71 (FEET) TO A POINT; THENCE, ALONG LANDS NOW OR FORMERLY OF  
19 GEISLER, THE FOLLOWING THREE (3) COURSES: 1.) N27° 30'26"E 53.00' (FEET)  
20 TO AN IRON ROD, SAID COURSE PASSING THROUGH A RECOVERED IRON ROD 2.12'  
21 (FEET) FROM THE BEGINNING OF SAID COURSE, 2.) N62° 14'49"W 40.00' (FEET)  
22 TO A RECOVERED IRON ROD, 3.) S27° 30'26"W 53.00' (FEET) TO A POINT, SAID  
23 COURSE PASSING THROUGH A RECOVERED IRON ROD 2.12' (FEET) FROM THE END OF

3 FOLLOWING TWO (2) COURSES: 1.) N25° 29'14"E 61.68' (FEET) TO A RECOVERED  
4 IRON ROD, SAID COURSE PASSING THROUGH A RECOVERED IRON ROD 2.10' (FEET)  
5 FROM THE BEGINNING OF SAID COURSE, 2.) N62° 42'16"W 46.30' (FEET) TO A

10 AFORESAID DAVIS, S60° 10'34"E 153.21' (FEET) TO THE POINT OR PLACE OF  
11 BEGINNING. CONTAINING 0.331 ACRES OF LAND MORE OR LESS.
