CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to section 1 of article 4 of the constitution, in relation to term limits for the office of governor; proposing an amendment to section 1 of article 5 of the constitution, in relation to term limits for the offices of comptroller and attorney-general; and proposing an amendment to section 2 of article 3 of the constitution, in relation to limiting the terms of office as a member of the legislature any person may serve

Section 1. Resolved (if the Senate concur), That section 1 of article 4 of the constitution be amended to read as follows:

3 Section 1. The executive power shall be vested in the governor, who shall hold office for four years; the lieutenant-governor shall be 5 the same time, and for the same term. The governor and lieutenant-governor shall be chosen at the general election held in the year 7 nineteen hundred thirty-eight, and each fourth year thereafter. 8 shall be chosen jointly, by the casting by each voter of a single vote 9 applicable to both offices, and the legislature by law shall provide for making such choice in such manner. The respective persons having the 10 highest number of votes cast jointly for them for governor and lieuten-11 ant-governor respectively shall be elected. NO PERSON SHALL BE 12 13 THE OFFICE OF THE GOVERNOR MORE THAN TWICE, AND NO PERSON WHO HAS HELD THE OFFICE OF GOVERNOR OR ACTED AS GOVERNOR FOR MORE THAN TWO YEARS 14 15 OF A TERM TO WHICH ANOTHER PERSON WAS ELECTED GOVERNOR SHALL BE THE LIMITATION ON THE TERMS OF OFFICE THAT ANY PERSON 16 THAN ONCE. CAN BE ELECTED TO THE OFFICE OF GOVERNOR SHALL NOT APPLY TO ANY 17 THE OFFICE OF GOVERNOR ON THE EFFECTIVE DATE OF THIS SENTENCE. HOLDING

1 LINE OF SUCCESSION AND THE NEXT PERSON IN THE LINE OF SUCCESSION SHALL 2 ACT AS GOVERNOR.

S 2. Resolved (if the Senate concur), That section 1 of article 5 of the constitution be amended to read as follows:

Section 1. The comptroller and attorney-general shall be chosen at the same general election as the governor and hold office for the same term, 5 6 7 and shall possess the qualifications provided in section 2 of IV. The legislature shall provide for filling vacancies in the office of comptroller and of attorney-general. No election of a comptroller or an 9 10 attorney-general shall be had except at the time of electing a governor. 11 NO PERSON SHALL BE ELECTED TO THE OFFICE OF COMPTROLLER OR ATTORNEY-GEN-ERAL WHO HAS PREVIOUSLY BEEN ELECTED TO SUCH OFFICE MORE THAN ONCE. 12 TERMS OF OFFICE THAT ANY PERSON CAN BE ELECTED TO THE 13 LIMITATION THE 14 OFFICE OF COMPTROLLER OR ATTORNEY-GENERAL SHALL NOT APPLY TO ANY 15 THE OFFICE OF COMPTROLLER OR ATTORNEY-GENERAL ON THE EFFECTIVE 16 DATE OF THIS SENTENCE. The comptroller shall be required: (1) to audit vouchers before payment and all official accounts; (2) to audit the 17 18 accrual and collection of all revenues and receipts; and 19 prescribe such methods of accounting as are necessary for the performance of the foregoing duties. The payment of any money of the state, 20 21 any money under its control, or the refund of any money paid to the 22 state, except upon audit by the comptroller, shall be void, and may be restrained upon the suit of any taxpayer with the consent of the supreme 23 24 court in appellate division on notice to the attorney-general. In such 25 respect the legislature shall define the powers and duties and may also 26 assign to him or her: (1) supervision of the accounts of any political 27 subdivision of the state; and (2) powers and duties pertaining to or connected with the assessment and taxation of real estate, including 28 determination of ratios which the assessed valuation of taxable real 29 property bears to the full valuation thereof, but not including any of 30 those powers and duties reserved to officers of a county, city, town or 31 32 village by virtue of [sections seven and eight] SECTION ONE of article nine AND SECTION THIRTEEN OF ARTICLE THIRTEEN of this constitution. 33 legislature shall assign to him or her no administrative duties, except-34 ing such as may be incidental to the performance of these functions, any 35 36 other provision of this constitution to the contrary notwithstanding. 37

- S 3. Resolved (if the Senate concur), That section 2 of article 3 of the constitution be amended to read as follows:
- S 2. The senate shall consist of fifty members, except as hereinafter provided. The senators elected in the year one thousand eight hundred and ninety-five shall hold their offices for three years, and their successors shall be chosen for two years. The assembly shall consist of one hundred and fifty members. The assembly members elected in the year one thousand nine hundred and thirty-eight, and their successors, shall be chosen for two years.

NO PERSON SHALL SERVE AS A MEMBER OF THE LEGISLATURE FOR MORE THAN SIX TWO YEAR TERMS, WHETHER SUCH SERVICE IS AS A SENATOR, ASSEMBLY MEMBER, OR TERMS AS A SENATOR AND AN ASSEMBLY MEMBER; PROVIDED THAT ANY PARTIAL TERM OF OFFICE HELD AS A MEMBER OF THE LEGISLATURE PRIOR TO THE ELECTION TO A TWO YEAR TERM SHALL NOT BE USED TO CALCULATE ANY TERM LIMITATION IMPOSED PURSUANT TO THIS PARAGRAPH.

S 4. Resolved (if the Senate concur), That the foregoing be referred to the first regular legislative session convening after the next succeeding general election of members of the assembly, and, in conformity with section 1 of article 19 of the constitution, be published for 3 months previous to the time of such election.
