- AN ACT to amend chapter 899 of the laws of 1984, relating to the creation of a public benefit corporation to plan, develop, operate, maintain and manage Roosevelt Island, in relation to the management of such corporation; and to amend the public authorities law, in relation to the management of the Roosevelt Island operating corporation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative intent. This act shall authorize the Roosevelt 2 Island Operating Corporation to distribute public purpose funds to not-3 for-profit community organizations whose purpose is to benefit Roosevelt 4 Island residents by enhancing their quality of life through education, 5 artistic and cultural enrichment, improved health or better environment. S 2. Chapter 899 of the laws of 1984, relating to the creation of a б 7 public benefit corporation to plan, develop, operate, maintain and 8 manage Roosevelt Island, is amended by adding a new section 4-a to read 9 as follows:

4-A. NOT-FOR-PROFIT GRANT DISTRIBUTION. 10 S 1. THE CORPORATION IS AUTHORIZED TO PROVIDE FINANCIAL ASSISTANCE IN 11 THE FORM OF TO GRANTS 12 NOT-FOR-PROFIT CORPORATIONS OR GOVERNMENTAL AGENCIES THAT PROVIDE DIRECT SERVICES OR BENEFITS TO THE RESIDENTS OF ROOSEVELT ISLAND, NOT TO EXCEED 13 14 38 OF THE OPERATING BUDGET OF THE CORPORATION, AND UPON THE APPROVAL OF 15 A MAJORITY OF THE ENTIRE BOARD OF THE CORPORATION.

2. ON OR BEFORE MAY 1, 2016, THE CORPORATION SHALL POST 16 A REPORT ON SHALL LIST AND DESCRIBE THE PURPOSE OF EACH GRANT 17 WEBSITE ITS THAT 18 ISSUED BETWEEN 2010 AND 2015. SUCH REPORT SHALL ALSO DESCRIBE THE 19 RESULTING PUBLIC BENEFIT OF EACH GRANT.

1 S 3. The public authorities law is amended by adding a new section 2 2799-dddd-1 to read as follows:

3 2799-DDDD-1. NOT-FOR-PROFIT GRANT DISTRIBUTION. 1. THE CORPORATION S 4 IS AUTHORIZED TO PROVIDE FINANCIAL ASSISTANCE IN THE FORM OF GRANTS TΟ 5 NOT-FOR-PROFIT CORPORATIONS OR GOVERNMENTAL AGENCIES THAT PROVIDE DIRECT SERVICES OR BENEFITS TO THE RESIDENTS OF ROOSEVELT ISLAND, NOT TO EXCEED 6 7 THREE PERCENT OF THE OPERATING BUDGET OF THE CORPORATION, AND UPON THE 8 APPROVAL OF A MAJORITY OF THE ENTIRE BOARD OF THE CORPORATION.

9 2. ON OR BEFORE MAY FIRST, TWO THOUSAND SIXTEEN, THE CORPORATION SHALL 10 POST A REPORT ON ITS WEBSITE THAT SHALL LIST AND DESCRIBE THE PURPOSE OF 11 EACH GRANT ISSUED BETWEEN TWO THOUSAND TEN AND TWO THOUSAND FIFTEEN. 12 SUCH REPORT SHALL ALSO DESCRIBE THE RESULTING PUBLIC BENEFIT OF EACH 13 GRANT.

14 S 4. This act shall take effect immediately, provided, however, 15 section three of this act shall take effect on the same date and in the 16 same manner as a chapter of the laws of 2015, amending the public 17 authorities law relating to the Roosevelt Island operating corporation, 18 as proposed in legislative bills numbers S.922A and A.7430A, takes 19 effect.
