AN ACT to amend the vehicle and traffic law, in relation to authorizing
the creation of a Cystic Fibrosis Foundation license plate; and to
amend the state finance law, in relation to creating the Cystic Fibro-
sis Foundation fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 404-x to read as follows:
3 S 404-X. DISTINCTIVE CYSTIC FIBROSIS FOUNDATION LICENSE PLATES. 1. ANY
4 PERSON RESIDING IN THIS STATE SHALL, UPON REQUEST, BE ISSUED A DISTINC-
5 TIVE CYSTIC FIBROSIS LICENSE PLATE IN SUPPORT OF CYSTIC FIBROSIS AWARE-
6 NESS AND RESEARCH, AND OF A DESIGN APPROVED BY THE COMMISSIONER, AND
7 WHICH SHALL BEAR THE PHRASE "CYSTIC FIBROSIS FOUNDATION". APPLICATION
8 FOR SAID LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM
9 AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.
10 2. A DISTINCTIVE CYSTIC FIBROSIS FOUNDATION LICENSE PLATE ISSUED
11 PURSUANT TO THIS SECTION SHALL BE ISSUED IN THE SAME MANNER AS OTHER
12 NUMBER PLATES UPON PAYMENT OF THE REGULAR REGISTRATION FEE PRESCRIBED BY
13 SECTION FOUR HUNDRED ONE OF THIS ARTICLE AND AN ADDITIONAL ANNUAL
14 SERVICE CHARGE OF TWENTY-FIVE DOLLARS. ALL MONIES RECEIVED AS ANNUAL
15 SERVICE CHARGES UNDER THIS SECTION SHALL BE DEPOSITED TO THE CREDIT OF
16 THE CYSTIC FIBROSIS FOUNDATION FUND, ESTABLISHED AS A REVOLVING FUND
17 PURSUANT TO SECTION NINETY-SEVEN-QQQQ OF THE STATE FINANCE LAW.
18 PROVIDED, HOWEVER, THAT ONE YEAR AFTER THE EFFECTIVE DATE OF THIS
19 SECTION, FUNDS IN THE AMOUNT OF SIX THOUSAND DOLLARS, OR SO MUCH THEREOF
20 AS MAY BE AVAILABLE, SHALL BE ALLOCATED FROM SUCH FUND TO THE DEPARTMENT
21 TO OFFSET COSTS ASSOCIATED WITH THE PRODUCTION OF SUCH LICENSE PLATES.
22 S 2. The state finance law is amended by adding a new section 97-qqqq
23 to read as follows:

1 S 97-XXXX. CYSTIC FIBROSIS FOUNDATION FUND. 1. THERE IS HEREBY ESTAB-
2 LISHED IN THE JOINT CUSTODY OF THE STATE COMPTROLLER AND THE COMMISSION-
3 ER OF TAXATION AND FINANCE A FUND TO BE KNOWN AS THE CYSTIC FIBROSIS
4 FOUNDATION FUND.

5 2. SUCH FUND SHALL CONSIST OF ALL MONEYS COLLECTED PURSUANT TO SECTION
6 FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW, AND ALL OTHER MONEYS
7 CREDITED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT
8 TO LAW, PROVIDED THAT SECTION FOUR HUNDRED FOUR-X OF THE VEHICLE AND
9 TRAFFIC LAW SHALL CONTROL THE METHOD OF PAYMENT FOR THE COSTS OF PRODUC-
10 ING THE DISTINCTIVE LICENSE PLATES AUTHORIZED PURSUANT TO SUCH SECTION.

11 3. MONEYS OF THE FUND SHALL BE EXPENDED FOR THE BENEFIT OF THE
12 PROGRAMS OF THE CYSTIC FIBROSIS FOUNDATION. MONEYS SHALL BE PAID OUT OF
13 THE FUND ON THE AUDIT AND WARRANT OF THE STATE COMPTROLLER ON VOUCHERS
14 APPROVED BY THE CHAIRMAN OF THE BOARD OF TRUSTEES OF THE CYSTIC FIBROSIS
15 FOUNDATION. ANY INTEREST RECEIVED BY THE COMPTROLLER ON MONEYS ON DEPOS-
16 IT IN THE CYSTIC FIBROSIS FOUNDATION FUND SHALL BE RETAINED IN AND
17 BECOME PART OF SUCH FUND. NO MONEY FROM SUCH FUND MAY BE WITHDRAWN,
18 TRANSFERRED, OR USED BY ANY PERSON FOR ANY PURPOSE OTHER THAN AS PERMIT-
19 TED BY THIS SECTION.

20 S 3. This act shall take effect on the one hundred twentieth day after
21 it shall have become a law; provided, however that effective immediate-
22 ly, the addition, amendment and/or repeal of any rule or regulation
23 necessary for the implementation of this act on its effective date are
24 authorized and directed to be made and completed on or before such
25 effective date.
