AN ACT to amend the executive law, in relation to the establishment of the New York state veterans cemetery act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Short title. This act shall be known and may be cited as the "New York state veterans cemetery act".

- The executive law is amended by adding a new section 368-a to read as follows:
- 5 S 368-A. VETERANS CEMETERY FUNDING PROMOTION PROGRAM. THE DIVISION IS HEREBY DIRECTED TO ESTABLISH, PRODUCE AND CONDUCT A NEW YORK STATE 7 VETERANS CEMETERY FUNDING PROMOTION PROGRAM. THE PURPOSE OF THE NEW YORK STATE VETERANS CEMETERY FUNDING PROGRAM WOULD BE TO ENCOURAGE THE GIVING 9 OF FINANCIAL CONTRIBUTIONS, BY INDIVIDUALS, GROUPS AND CORPORATIONS, VETERANS REMEMBRANCE AND CEMETERY MAINTENANCE AND OPERATION FUND, 10 CREATED PURSUANT TO SECTION NINETY-SEVEN-MMMM OF THE STATE FINANCE LAW, 11 WHICH WAS ESTABLISHED TO PROVIDE FUNDING FOR VETERANS CEMETERIES PURSU-12 ANT TO THE NEW YORK STATE 13 VETERANS CEMETERY PROGRAM CREATED SECTION THREE HUNDRED SIXTY-FIVE OF THIS CHAPTER. APPLY ON BEHALF OF THE STATE OF NEW YORK, FOR GRANTS AND CONTRIBUTIONS,

- AND USE BY, THE VETERANS REMEMBRANCE AND CEMETERY MAINTENANCE AND
- 23 OPERATION FUND, FOR THE PURPOSE OF CONSTRUCTING, OPERATING AND FINANCING
- NEW YORK STATE VETERANS CEMETERIES. EVERY YEAR, NOT LATER FIFTEENTH OF DECEMBER, THE DIVISION SHALL PRODUCE A REPORT OF THE ACTIV-
