AN ACT to amend the environmental conservation law, in relation to the regulation of the planting and selling of running bamboo

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The environmental conservation law is amended by adding a  
2 new article 48 to read as follows:

3 ARTICLE 48

4 REGULATION OF THE PLANTING AND SELLING OF RUNNING BAMBOO

5 SECTION 48-0101. DEFINITION.

6 48-0103. PLANTING RESTRICTIONS.

7 48-0105. SALE AND INSTALLATION.

8 S 48-0101. DEFINITION.

9 FOR THE PURPOSE OF THIS ARTICLE, "RUNNING BAMBOO" MEANS ANY BAMBOO IN  
10 THE GENUS PHYLLOSTACHYS, INCLUDING PHYLLOSTACHYS AUREOSULCATA.

11 S 48-0103. PLANTING RESTRICTIONS.

12 1. NO PERSON WHO PLANTS RUNNING BAMBOO OR WHO ALLOWS RUNNING BAMBOO TO  
13 BE PLANTED ON HIS OR HER PROPERTY SHALL PERMIT SUCH BAMBOO TO GROW  
14 BEYOND THE BOUNDARIES OF HIS OR HER PROPERTY. ON AND AFTER OCTOBER  
15 FIRST, TWO THOUSAND FIFTEEN, ANY PERSON WHO VIOLATES THE PROVISIONS OF  
16 THIS SECTION SHALL BE LIABLE FOR ANY DAMAGES CAUSED TO ANY NEIGHBORING  
17 PROPERTY BY SUCH BAMBOO, INCLUDING, BUT NOT LIMITED TO, THE COST OF  
18 REMOVAL OF ANY RUNNING BAMBOO THAT GREW BEYOND THE BOUNDARIES OF HIS OR  
19 HER PROPERTY.

20 2. NO PERSON SHALL PLANT RUNNING BAMBOO OR ALLOW RUNNING BAMBOO TO BE  
21 PLANTED ON HIS OR HER PROPERTY AT A LOCATION THAT IS ONE HUNDRED FEET OR  
22 LESS FROM ANY ABUTTING PROPERTY OR PUBLIC RIGHT-OF-WAY UNLESS SUCH  
23 PLANTING IS CONTAINED BY A PROPERLY CONSTRUCTED AND MAINTAINED BARRIER  
24 SYSTEM OR SUCH RUNNING BAMBOO IS PLANTED ABOVE GROUND IN A CONTAINER OR

1 PLANTER SUCH THAT THE RUNNING BAMBOO DOES NOT COME IN CONTACT WITH THE  
2 SURROUNDING SOIL.

3 3. THE PROVISIONS OF THIS SECTION SHALL NOT BE DEEMED TO APPLY TO ANY  
4 RUNNING BAMBOO PLANTED ON OR BEFORE OCTOBER FIRST, TWO THOUSAND FIFTEEN.  
5 S 48-0105. SALE AND INSTALLATION.

6 EACH RETAIL SELLER OR INSTALLER OF RUNNING BAMBOO SHALL PROVIDE TO  
7 EACH CUSTOMER WHO PURCHASES RUNNING BAMBOO FROM SUCH SELLER OR INSTALLER  
8 A STATEMENT THAT DISCLOSES THAT RUNNING BAMBOO IS A FAST GROWING PLANT  
9 THAT MAY SPREAD IF NOT PROPERLY CONTAINED AND A PLAIN LANGUAGE SUMMARY  
10 OF THE PROVISIONS CONTAINED IN SECTION 48-0103 OF THIS ARTICLE. SUCH  
11 STATEMENT SHALL ALSO PROVIDE RECOMMENDATIONS, BASED ON BEST AVAILABLE  
12 INFORMATION, ON HOW TO PROPERLY CONTAIN RUNNING BAMBOO. ANY RETAIL SELL-  
13 ER OR INSTALLER OF RUNNING BAMBOO WHO VIOLATES THE PROVISIONS OF THIS  
14 SECTION SHALL BE FINED ONE HUNDRED DOLLARS FOR EACH SOLD IN VIOLATION OF  
15 THIS SECTION.

16 S 2. This act shall take effect immediately.
