AN ACT to amend the executive law, in relation to directing the division of homeland security and emergency services to conduct a review and analysis of security measures at rail yards

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The executive law is amended by adding a new section 719 to read as follows:

S 719. PROTECTION OF CRITICAL INFRASTRUCTURE; RAIL YARDS. 1. NOTWITH-STANDING ANY OTHER PROVISION OF LAW AND SUBJECT TO THE AVAILABILITY OF AN APPROPRIATION, THE COMMISSIONER OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES SHALL CONDUCT A REVIEW AND ANALYSIS OF **MEASURES** 7 OWNERS AND OPERATORS OF RAIL YARDS FACILITIES TO BEING TAKEN BY THE 8 PROTECT THE SECURITY OF CRITICAL INFRASTRUCTURE RELATED TO SUCH FACILI-TIES. SUCH COMMISSIONER SHALL HAVE THE AUTHORITY TO REVIEW ALL AUDITS OR 9 REPORTS RELATED TO THE SECURITY OF SUCH CRITICAL INFRASTRUCTURE, INCLUD-10 SUCH AUDITS OR REPORTS MANDATED BY STATE AND FEDERAL LAW OR 11  $\mathtt{ALL}$ REGULATION, INCLUDING SPILL 12 PREVENTION REPORTS AND RISK 13 PLANS, AUDITS AND REPORTS CONDUCTED AT THE REQUEST OF ANY FEDERAL ENTI-14 TY, OR ANY OTHER AGENCY OR AUTHORITY OF THESTATE OR ANY POLITICAL SUBDIVISION THEREOF, AND REPORTS PREPARED BY OWNERS AND OPERATORS OF 15 16 SUCH FACILITIES AS REQUIRED IN THIS SUBDIVISION. THE OWNERS AND OPERA-17 TORS OF SUCH RAIL YARD FACILITIES SHALL, IN COMPLIANCE WITH ANY FEDERAL 18 AND STATE REQUIREMENTS REGARDING THE DISSEMINATION OF SUCH INFORMATION, PROVIDE ACCESS TO THE COMMISSIONER TO SUCH AUDITS AND REPORTS REGARDING 19 SUCH CRITICAL INFRASTRUCTURE PROVIDED, HOWEVER, EXCLUSIVE 20 CUSTODY CONTROL OF SUCH AUDITS AND REPORTS SHALL REMAIN SOLELY WITH THE OWNERS 21

HAS THE MEANING ASCRIBED TO THAT TERM IN SUBDIVISION FIVE OF SECTION EIGHTY-SIX OF THE PUBLIC OFFICERS LAW.

- 2. TO EFFECTUATE HIS OR HER DUTIES PURSUANT TO THIS SECTION AND IDENTIFY RISKS TO THE PUBLIC, THE COMMISSIONER OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES SHALL:
- (A) IDENTIFY AND PREPARE A LIST OF ALL RAIL YARD FACILITIES IN THE STATE;
- (B) IN CONSULTATION WITH THE COMMISSIONER OF TRANSPORTATION AND ANY STATE, LOCAL AND MUNICIPAL OFFICIALS AS MAY BE APPROPRIATE, IDENTIFY RAIL YARD FACILITIES, WHICH BECAUSE OF THEIR STORAGE AND/OR TRANSPORTATION OF, OR RELATIONSHIP TO, SUCH SUBSTANCES IDENTIFIED PURSUANT TO PARAGRAPH (A) OF SUBDIVISION TWO OF SECTION SEVEN HUNDRED FOURTEEN OF THIS ARTICLE POSE RISKS TO THE PUBLIC SHOULD AN UNAUTHORIZED RELEASE OF SUCH HAZARDOUS SUBSTANCES OCCUR; AND
- (C) REQUIRE SUCH RAIL YARD FACILITIES IDENTIFIED PURSUANT TO PARAGRAPH (A) OF THIS SUBDIVISION, AS THE COMMISSIONER SO DETERMINES, TO PREPARE A VULNERABILITY ASSESSMENT OF THE SECURITY MEASURES TAKEN BY SUCH FACILITIES TO PREVENT AND RESPOND TO THE UNAUTHORIZED RELEASE OF HAZARDOUS SUBSTANCES AS MAY BE STORED THEREIN, WHICH ASSESSMENTS THE COMMISSIONER OF THE OFFICE OF HOMELAND SECURITY SHALL REVIEW AND CONSIDER IN LIGHT OF THE SERIOUSNESS OF THE RISK POSED AND VULNERABILITY OF SUCH FACILITY AND, WHERE APPROPRIATE, MAKE RECOMMENDATIONS WITH RESPECT THERETO.
- 3. (A) ON OR BEFORE JUNE FIRST, TWO THOUSAND SIXTEEN, THE COMMISSIONER OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES SHALL MAKE A PRELIMINARY REPORT TO THE GOVERNOR, THE TEMPORARY PRESIDENT SENATE, THE SPEAKER OF THE ASSEMBLY, THE COMMISSIONER OF TRANSPORTATION AND THE CHIEF EXECUTIVE OFFICER OF ANY SUCH AFFECTED FACILITY OR HIS DESIGNEE, AND ON OR BEFORE DECEMBER THIRTY-FIRST, TWO THOUSAND SIXTEEN, AND NOT LATER THAN THREE YEARS AFTER SUCH DATE, AND EVERY FIVE YEARS THEREAFTER, THE COMMISSIONER SHALL REPORT TO THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, THE SPEAKER OF THE ASSEMBLY, COMMISSIONER OF TRANSPORTATION AND THE CHIEF EXECUTIVE OFFICER OF ANY SUCH AFFECTED FACILITY OR HIS OR HER DESIGNEE. SUCH REPORT SHALL REVIEW THESECURITY MEASURES BEING TAKEN REGARDING CRITICAL INFRASTRUCTURE RELATED TO RAIL YARD FACILITIES, ASSESS THE EFFECTIVENESS THEREOF, INCLUDE RECOMMENDATIONS TO THE LEGISLATURE AND THE DEPARTMENT OF TRANS-PORTATION IF THE COMMISSIONER DETERMINES THAT ADDITIONAL MEASURES ARE REQUIRED TO BE IMPLEMENTED.
- 39 (B) BEFORE THE RECEIPT OF SUCH REPORT IDENTIFIED IN PARAGRAPH (A) OF 40 THIS SUBDIVISION, EACH RECIPIENT OF SUCH REPORT SHALL DEVELOP CONFIDEN-PROTOCOLS WHICH SHALL BE BINDING UPON THE RECIPIENT WHO ISSUES 41 THE PROTOCOLS AND ANYONE TO WHOM THE RECIPIENT SHOWS A COPY OF 42 43 REPORT IN CONSULTATION WITH THE COMMISSIONER OF THE DIVISION OF HOMELAND 44 SECURITY AND EMERGENCY SERVICES, FOR THE MAINTENANCE AND USE OF SUCH 45 REPORT SO AS TO ENSURE THE CONFIDENTIALITY OF THE REPORT AND ALL INFOR-MATION CONTAINED THEREIN, PROVIDED, HOWEVER, THAT SUCH PROTOCOLS SHALL 47 NOT BE BINDING UPON A PERSON WHO IS PROVIDED ACCESS TO SUCH REPORT OR 48 ANY INFORMATION CONTAINED THEREIN PURSUANT TO SECTION EIGHTY-NINE OF THE 49 OFFICERS LAW AFTER A FINAL DETERMINATION THAT ACCESS TO SUCH 50 REPORT OR ANY INFORMATION CONTAINED THEREIN COULD NOT BE DENIED PURSUANT TO SUBDIVISION TWO OF SECTION EIGHTY-SEVEN OF THE PUBLIC OFFICERS LAW. 51 THE COMMISSIONER SHALL ALSO DEVELOP PROTOCOLS FOR THE DIVISION OF HOME-52 LAND SECURITY AND EMERGENCY SERVICES RELATED TO THE MAINTENANCE AND USE 53 54 SUCH REPORT SO AS TO ENSURE THE CONFIDENTIALITY OF ALL SENSITIVE 55 INFORMATION CONTAINED IN SUCH REPORT. ON EACH REPORT, THE COMMISSIONER 56 SHALL PROMINENTLY DISPLAY THE FOLLOWING STATEMENT: "THIS REPORT MAY

CONTAIN INFORMATION THAT IF DISCLOSED COULD ENDANGER THE LIFE OR SAFETY OF THE PUBLIC, AND THEREFORE, PURSUANT TO SECTION SEVEN HUNDRED ELEVEN OF THE EXECUTIVE LAW, THIS REPORT IS TO BE MAINTAINED AND USED IN A MANNER CONSISTENT WITH PROTOCOLS ESTABLISHED TO PRESERVE THE CONFIDENTIALITY OF THE INFORMATION CONTAINED HEREIN IN A MANNER CONSISTENT WITH LAW."

- 7 (C) THE DEPARTMENTS OF TRANSPORTATION AND ENVIRONMENTAL CONSERVATION 8 SHALL HAVE THE DISCRETION TO REQUIRE THAT RECOMMENDATIONS OF THE COMMIS-9 SIONER OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES BE 10 IMPLEMENTED BY ANY OWNER OR OPERATOR OF A RAIL YARD FACILITY.
- 11 S 2. This act shall take effect immediately.
